REGIONAL MEETINGS FOR RCA WHOLESALERS **HELD IN FOUR CITIES**

Distributors of All RCA Products Gather to Hear Officials Explain Policies

About 200 RCA Distributors and their executive personnel gathered at the Waldorf-Astoria, in New York, September 13, to hear offi-cials of the RCA Victor Division of the Radio Corporation of America discuss mutual problems and current thinking on postwar dis-tribution of RCA products.

Represented were wholesalers for all of RCA products including radios, phonographs, records, tubes, parts, and commercial sound. To give all RCA wholesalers and their executive staffs an opportunity to participate, similar meetings were held in Chicago on September 16; San Francisco, September 20; and New Orleans, September 25.

H. C. Bonfig Opens Meeting

The program for the New York meeting was opened by H. C. Bonfig, who outlined its objectives, and introduced the speakers.

L. W. Teegarden, Assistant General Sales Manager, outlined the part which wholesalers will play in the postwar distribution of RCA products. He presented the Company's thinking on distribution policies of RCA products for the immediate postwar period, and discussed the Company's projected Sales Department organization for serving distributors.

Vance C. Woodcox, Director of Commercial Research, revealed how scientific studies are being conducted by RCA to obtain more reliable and useful information about selling RCA products.

E. W. Engstrom, Director of Re-search of the RCA Laboratories, described the consolidation of RCA's extensive research activities at Princeton, N. J.

Thomas F. Joyce, Manager of the Radio, Phonograph and Television Department, outlined the Company's advertising programs, which are telling the public of RCA's outstanding wartime record Research and Development, Deand reminding them of RCA's fense Supplies Corporation, Metals peacetime activities.

WPB ORDER L-265 **INTERPRETED AS AID IN PLACING ORDERS**

Under the provisions of WPB Order L-265, issued April 24, 1943, consumers, dealers and distributors may obtain radio tubes and other electronic equipment without the necessity of obtaining priority as-sistance for their order. Order L-265 revokes previous Orders L-44. L-44-A and L-183 which are no longer in force.

The provisions of Order L-265 provide that RCA (or any other manufacturer) may transfer electronic equipment to a consumer or supplier ONLY as follows:

1. TO FILL "PREFERRED ORDERS"

A "Preferred Order" means any order for delivery to or for the account of the Army or Navy of the United States, the United States Maritime commission, the War Shipping Administration, the Pan-ama Canal, the Coast and Geodetic Survey, the Coast Guard, the Civil Aeronautics Administration, the National Advisory Committee for Aeronautics, the Office of Scientific (Cont. on page 2, col. 1)

CIVILIAN RENEWAL TUBE PROGRAM EXPLAINED

"In view of the considerable publicity which has been given to the availability of tubes for civilian renewal purposes and the steps indicated as now being taken to relieve reported shortages, it seems appropriate that we advise you of our position in the matter," states states L. W. Teegarden, recently ap-pointed assistant general sales manager, RCA Victor Division, Radio Corporation of America.

"It is true that the total demand for many types of receiving tubes has been, and continues to be, in excess of our ability to supply. On the other hand there are some types of which we currently have inventories in excess of open orders.

"Moreover, there is some en-couragement in a recent WPB an nouncement that states provisions are now made to include civilian tube requirements in the production and allocation of several renewal tube types. Included among certain 'claimant agencies and customer groups' which have been

Reserve Company, any foreign country pursuant to the Act of March 11, 1941, entitled "An Act to Promote the Defense of the United States" (Lend-Lease Act), or any order bearing a preference rating of AA-4 cr higher.

- 2. TO FILL ORDERS BEARING A PREFERENCE RATING OF A-1-A OR HICHER
- 3. TO FILL AN ORDER FOR ANY COMPONENT PART OF ELECTRONIC EQUIPMENT FROM CONSUMERS OR SUPPLIERS, PROVIDED
 - a. The consumer returns a defective part which cannot be repaired or reconditioned or makes a certification as follows:

CONSUMER'S CERTIFICATE

I hereby certify that the part(s) specified on this order are essential for presently needed repair of electronic equipment which I own or operate.

b. The supplier furnishes us with a certificate as follows:

SUPPLIER'S CERTIFICATE

I hereby certify that I am en-titled to purchase the items specified on the accompanying purchase order under the provi-sions of Limitation Order L-265, with the terms of which I am familiar.

COMMENTS ON L-265

Definition of Supplier

"Supplier" means any person to the extent that his business consists in whole or in part of the sale. distribution or transfer from stock or inventory of electronic equipment, and includes wholesalers, distributors, jobbers, dealers, re-tailers, servicemen, branch ware-houses or other distribution outlets contolled by producers and other persons performing a similar function.

Returned Tubes Can Be Destroyed

To prevent defective replacement radio components from going back into trade channels, destruction of such unsalvagable parts and tubes has been ordered by WPB in an amendment issued July 23 to Limitation Order L-265. The original salvage order provided that no producer or supplier should retain in bis inventory for more than sixty days any "used, defective, ex-hausted or condemned" parts, and then required their disposition through salvage disposal or scrap channels. The new amendment provides that such parts must be destroyed if salvage is not practicable.

Medical Uses, Etc.

Replacement tubes for medical, therapeutic, X-ray and fluoroscopic equipment must have consumers or suppliers' certification. The purchase of tubes for original equipment for this class of merchandise is covered by other priority orders.

Phonograph Equipment

"Acoustic phonograph" is be-lieved to be a phonograph other than one operating by devices involving the use of gaseous or vacuum tubes. Records and needles are not under the Order.

MANUFACTURER'S NAME CIVILIAN RENEWAL TUBE TO APPEAR ON ALL **TUBES SHIPPED BY RCA**

As advised in Mr. Teegarden's letter of May 17, the Army and Navy have indicated their desire that the actual manufacturer's name appear on tubes finding an end use in Army and Navy equipment. To cooperate in the war program RCA has adopted a policy con-sistent with the desires of the Army and Navy. Since it is not possible to determine the end use of tubes at the time of their sale by us, all tubes manufactured and sold by RCA are today being branded with an RCA trade-mark.

As you know, it has been the practice of many tube manufac-turers to purchase unbranded tubes from other tube manufacturers and to resell them with brands other than those of the actual manufacturer. This has permitted tube manufacturers to offer to their customers a more complete line of tubes under their own or their customer's brand name.

There are other tube manufacturers who are also meeting the desires of the Army and Navy and are discontinuing the practice of selling unbranded or private-brand tubes. Therefore, it may happen that we will no longer be able to supply certain tube types with the **RCA** brand name where such tubes are not in actual production on our own manufacturing facilities. Conversely, those who are accustomed to buying tubes under other manufacturers' brands may find some tube types available only with RCA brands.

RCA Not To Rebrand Tubes

It is our feeling that when a tube manufacturer places his own brand upon a tube, the tube should be sold to the ultimate consumer with that brand remaining intact. RCA has no intention to indulge

established by WPB to share in the allocation of various glass broadcast receiver types, distrib-utors, dealers and other suppliers should now receive a reasonable quantity, percentagewise, of the following tube types produced during the period October 1-Decem-ber 31, 1943: 12SK7GT/G, 50L6GT and type 80.

"Briefly, this action means that, although most miniature and metal types and some cathode ray and special types are now under direct allocation by WPB and where no allocation for civilian purposes has yet been made, consideration is

being given to civilian renewal tube requirements. RCA shipments to distributors, of course, will be made as before, based on priority regulations. Supplier's certifica-tions, under limitation order L-265, based on the date of receipt of orders, will continue to be the guiding factor in the allocation and shipment of civilian renewal tubes."

REPLACEMENT PARTS SECTION—ANNOUNCEMENTS, TIPS, SUGGESTIONS

PARTS AVAILABLE FOR RCA 5- and 6- INCH SPEAKER CONES

For some time we have been unable to supply the many types of small cones as used in the Models RL-78, 79, 81, 85 and 86 Speakers. However, due to a new method of stocking and the assignment of new stock numbers, we are now in a position to supply the individual parts of the cones; viz., the diaphragm, the voice coil with sus-pension (includes dust cap), and the gaskets.

To facilitate the ordering of your requirements, we are reprinting below, a tabulation listing the stock numbers of the proper cone and voice coil combinations to be used as replacements for the original units.

The voice coils and cone diaphragms will be supplied in a standard package of five (5). The one exception is the Stock No. 70038 diaphragm, which will be supplied in a standard package quantity of ten (10). The gaskets will be supplied in a standard package quantity of ten (10).

It is suggested that, when practical, the diaphragm only be re-placed. This can readily be accomplished by cutting the diaphragm from the voice coil and cementing a new diaphragm in place. We anticipate being able to fill your requirements for diaphragms; however, we may not be in a position to make complete shipment of voice coils in the quantities remested.

All orders must be in accordance with the terms of Limitation Order L-265.

REPLACEMENT CRYSTAL CARTRIDGES FOR PHONOGRAPHS

Apparently quite a bit of confusion exists with reference to proper procedure to follow to obtain replacement crystal cartridges for phonographs.

In order to continue to supply these replacement parts, it is necessary that defective crystal cartridges be returned to your RCA Parts distributor. We can accumulate, dissassemble, and later reassemble them into the equivalent of new replacement cartridges.

It is essential, therefore, that we have your cooperation and, accordingly, we suggest that you return your defective crystals at once as outlined above. Upon receipt, we will take steps to ship replacement to the distributor with billing at our regularly established prices. We will make every effort to ship exact replacement, and no substitutions can normally be permitted. Distributors should indicate on the packing slip that they want us to ship replacement.

Limitation Order L-265 indicates that defective parts which cannot be reconditioned should be turned over to scrap or salvage channels within sixty (60) days of receipt. This procedure need not be followed in connection with these crystals, inasmuch as they can be reconditioned and should be returned to the distributor.

RCA SUB-STANDARD TUBES SHIPPED TO EASE CIVILIAN REQUIREMENTS

Some Popular Types Now Available to Distributors

With increasing limitations on the availability of many critical materials, together with an overall demand for tubes in excess of the supply, RCA has established a policy whereby sub-standard tubes will be furnished, when available, on orders bearing L-265 supplier's certifications and any other ratings that indicate the tubes are to be used for maintenance, repair and operating supplies. The RCA policy for such sales follows:

1. Since sub-standard tubes will not pass government inspection, and are not suitable for initial equipment in new apparatus, they will be applied automatically against orders filled as a result of customer or supplier certification as provided in WPB Order L-265. They also will be applied against any other ratings assigned by WPB to orders for maintenance, repair and operating supplies.

2. On each carton in which substandard tubes are packed will be marked the word "Sub-Standard" of a type size sufficiently large to make the carton containing such tubes readily identified.


3. Upon each carton containing the sub-standard tube will be printed "OPA Retail Ceiling Price ". This price will be determined by taking 85% of our current list price of each tube.

4. In accordance with WPB directives, each carton will be imprinted "M-R".

34443 OSCILLATOR COIL


Oscillator coil 38338 is an alternate coil which will give equivalent performance to original coil.

Instruction for connecting coil and wiring connection is shown below.



Green lead is capacitor winding and can be used in place of oscillator grid capacitor. If green lead is not used, grid capacitor should be connected to red lead as indicated by dotted lines. Omit grid capacitor if greem lead is used.

DIMENSIONS FOR DRILLING TEMPLATE TO USE NEW-DESIGN RL63 OR RL70 SPEAKER CONES



As stock No. 11258 (12") for early model RL70 Speakers are probably "out" for the duration, we suggest the following:-Drill two holes (1/4" diameter) in yoke plate to use later designed RL70 comes such as 31275, 36145 and 34773. To locate holes, make up a paper template (as sketched), or use metal cone support bracket from any damaged RL63 or RL70 cone available.

Note I-See "Supplementary Information" Bulletins Nos. 6 and 7 for information on assembling breakdown cones and using cuptype suspension.

Note II—Cone gages RCA 35300 for 3/4" Voice Coil and RCA 35301 for 9/16" Voice Coil should be used when assembling cones.

Note III — The following Rim Gaskets are available:

RCA 70042 gasket 5" dia. 5/32" thick RCA 70043 gasket 5" dia. 1/8" thick RCA 70044 gasket 5" dia. 1/32" thick RCA 70045 gasket 6" dia. 5/32" thick RCA 70046 gasket 6" dia. 1/32" thick

Transformers for RCA Models OB2, OB6

Our stocks are gone on #35941 transformer used in RCA models QB2 and QB6. Output transformer for RCA model QB1 (stock #37924) can be used in its place. Following is the color code for leads of 37924 transformer: Primary Start—red Tap—black and red Primary Finish—green (red tracer) Secondary Start—brown Secondary Finish—black.

38327 Capacitor Discontinued Alternate parts for #38327 Ca-

pacitor are: RCA #37892 for sets operating on 220-volt supply.

RCA #70057 for sets operating on 110-volt supply.

RCA 31275 Cone May Be Discontinued for the Duration

Should this 12" cone for RL70 type speakers be discontinued (as is likely) for the duration of the war, the following alternates are available:

Stock 36145 can be used if speaker to be serviced includes metal support bracket which centers cone and mounts in yoke plate by means of two screws. This cone can also be used by adding 36146 support bracket to replace the old-style fiber suspensions used on certain models of RL70 speaker.

Our present stock of RCA 36146 brackets is depleted, but we suggest using salvaged brackets, which are obtainable in most repair shops. In most cases, both RL63 and RL70 replacement cones are supplied complete with stock #36146 bracket. Salvage brackets from defective cones and use as suggested.

Stock 34773 can also be used as replacement on many speakers of more recent manufacture. This cone is identical to 31275 except the metal support bracket has been re-designed and mounts by means of 2 "U" clamps on support frame instead of in yoke plate.

In an emergency, stock 34773 can be mounted in yoke plate by means of screws, washers and nuts. When mounting this cone in the two holes in yoke plate, the voice coil leads are shifted 90 degrees from correct position and it may be necessary to splice one voice coil lead to reach the speaker terminal board.

If necessary, either stock 34705 or 35616 can also be used. These cones omit the metal support bracket.

in any unfair trade practices or misrepresentation which might be involved in the rebranding of tubes. Similarly, it is expected that others will not indulge in such practices with RCA branded tubes.

It is hoped that this information may assist you in explaining to your customers why, under today's conditions, some tube types which they were accustomed to purchasing with the RCA brand are available only under other brands and it will also explain why many tube types previously available under other brands are now only available under the RCA brand.

We feel that previously accepted trade practices are secondary to our desire to cooperate with the armed forces in eliminating all but the actual manufacturer's brand.

RCA 11235 (8") Cone for Early Model RL63 Speakers Discontinued

RCA 31310 cone can be used by drilling two mounting holes in yoke plate as shown in diagram at left.


31495 Capacitor Not Available

This capacitor is discontinued as it is no longer possible to purchase capacitors with screw-base type can. We suggest RCA 32400 F.P. type as an alternate.

It will be necessary to insulate capacitor can from chassis. To mount, use RCA 28452 bakelite mounting plate. Drill two holes in chassis and mount plate, using suitable spacers and hardware.

A cardboard insulating cover is also available as RCA stock 28451, for use on 1" diameter F.P. condensers. Use of this cover will enable you to mount capacitor by means of a ground clamp.

32142 Capacitor Discontinued Use RCA 32240 F.P. type condenser. Mount same as suggested for 31495 replacement.



RCA 34259 oscillator coil as used in the 45E can be used as alternate for stock No. 35116 for RCA models 45X1 and 45X2, with changes as shown in illustration. Circuit diagram will correspond to 45E except for changes shown
