# IMPORTANT!!

In the past several weeks we at NRCI headquarters have received a number of interesting comments, the majority concerning the possibility of changing the name of this club. After careful consideration, those of us in Denver have reached the conclusion that a name change at this time would be unquestionably beneficial to the club. In order to support the proposed name change, the following items have been submitted:

a) The NRCI is by its very name hindered from having a truly world-wide scope. If an international outlook is one of the things we are striving for, a less American name would go a great ways towards accomplishing it, in that the appeal of

the club to persons outside the United States would be increased.

- We have come to realize that perhaps we acted too hastily in forming the NRCI and made some serious errors. Since the Constitution and Bylaws were not ratified in accordance with Article 15 of the Bylaws, we have no real right to the name. We went under the assumption that the documents would be ratified with a majority of those members voting, while in reality the article states that for ratification a majority of the entire membership is needed. Thus the NRCI Constitution and Bylaws have never been ratified and not only is our claim to the name invalid, but the present NRCI is without a foundation. However, we are still no less adamant in our belief that the 37-0 convention vote and the 98-53 special vote constituted a mandate for the reformation of the MRC government, particularly in the light of the fact that the NRC government would never consent to hold a vote on the issue. Furthermore, we still believe that a democratic form of government is necessary for a healthy organization and thus that a constitution and bylaws are a necessity. The 1963 Constitution contained flaws, one of which led to its failure to be ratified, yet we must abide by these flaws so long as we continue as the NRCI. Now that we have a strong base of active members who also believe in the principle of a democratic government, we can ourselves conceive and institute a new constitution and bylaws in a democratic manner.
- c) We do not want to see a democratic club be confused in any way with the dictatorial NRC.
- d) We would like at this time to examine and evaluate the long range policy of this club. Is it to work for co-operation and for a free exchange of information between all DX clubs of the world for the betterment of the hobby? If so, a change in name may indeed be warranted.

The best suggestion for a name to replace National Radio Club, Inc. has been International Radio Club, Inc., or IRCI. Not only would this name relieve the difficulties of the club listed above, but it would afford the minimum withdrawal from the name "National Radio Club, Incorporated." Now, without a constitution and bylaws from which to operate, the NRCI is in a very awkward position. With no precedent established, we are simply asking you, the members of this club, to vote on a special ball of which will be mailed to each of you with the April 14th issue of DX News. On this ballot you will be able to vote either a) for retaining the name National Radio Club, Inc.; (cntd. p.10)

David F. Gleason - 2520 Wellington Road - Cleveland Heights, Chio 山山18 Greetings from the land of confusion! After planning to leave for Guayaquil on the first of April, here I am still waiting. Looks like I will be there about the 11th... after a one day stopover in Panamá. (I plan to visit Radio Aeropuerto while there... maybe I can get veries for my reports. . and anyone else whose report is laying around there. I promise not to raise any flags, though!) And amid everything, I did a little domestic DX. On 3/31 I caught the ET of KOFO-1220 with TT at 2.00 badly QRMed by XEB. That one was verified two years ago, but this is the first time heard since. The r/c of WBOL-1560 on 4/1 made it in well at 2:32, but not reported. on 4/2 at 12:40 an UnID tester was noted under XEX-730, and was off the air by the 1.06 s/off of La Equis. The new 50 kilowatt xmtr of WCPC-940 has been noted at SSS several nights, but not reported. A few veries have wandered in, namely from KAUS-1480 who sent a CM and fact folder, WBT-relay-Shelby-1110 for a rare one caught on a test last January (runs only 1 kw. and is synchronized with WBT Charlotte), WLIL-730, WHSI-1490, one of the new ANers, WWMI-1470, WEVE-1340, OKGM-980, WMBN-1340 whose f/c is the 3rd MM at 12:45 and KCLN-1390. This week has been one of the most enjoyable since I began DXing. great time in Amarillo seeing Jeff Stewart, Phil Scott, and NRCIer Terry Steeden. Terry and I spent two evenings talking DX and seeing each others' veries. He's really been sending out reports and has already heard half the states in the US. I regret I didn't see John Tudenham in Amarillo, but enjoyed talking to him by phone; he will be joining the NRCI this month! Friday 4/3 I had the pleasure of meeting Harvey Young in McAlister, MM, and seeing his fine collection of veries--only 2 short of 100! Harvey has the perfect DXing location, many miles from the nearest station with unlimited space for a long-wire. That evening as Barbara and I stopped at a cafe in Santa Rosa, I heard two men discussing KOMA and WLS. I offered them a sample copy of the NRCI bulletin, and one of them, Glen Sorenson, couldn't wait to join! Glen is from Racine, Wisconsin, and currently is serving in the Navy, based at San Francisco. Welcome to the NRCI, Glen! Saturday I enjoyed very much visiting NRCIer Charles Buckley of Albuquerque, where it was snowing, of all things. Charles uses a selective 12-transistor receiver and has received quite a few good stations, including WBZ and KHOS-940 (only 250 watts). He has a good long-wire and is planning to buy a new Zenith Trans-Oceanic soon. I phoned NRC-member Norm Maguire while in Albuquerque; he has been DXing on the ham bands mainly this season. We certainly have a fine group of DXers in the Southwest! While in Amarillo I DXed on MM 3/30 and heard several unusual foreign stations (details in the IDXD) and found three Australians 3/31. I believe West Texas is a better area for DU reception than Boulder, but poorer for SA and CA stations. Dakar-764 was stronger in Amarillo than Boulder, though other TAs were inaudible. Verie-wise, two new Canadians arrived while I was down south: CKBW-1000-Bridgewater, NS, for my 4th from that province, and CJJC-850 Langley Prairie, BC, for my 15th from that province. Incidentally, I have just received word that NRC musings editor Lefty Cooper misquoted NRCer Dan Phillips on the front page of their bulletin. Dan said he would make the loop plans available to the MRC, but he didn't say "NRC only." Dan also requested that Lefty give him no publicity. I understand Dan is joining the NRCI as soon as possible! Well, 73 to all 'till next week.

I have had all kinds of problems lately. The Grunow is not much good on SWBC and terrible on BCB so I must stick to Ham DXing until I find a way to get my Zenith fixed. And the money I just don't have. My one new station through all of this came shortly after installing the Grunow. A local SWBC and Ham DXer came over to look at the new radio. He was fooling around and happened to stop at a station which promptly IDed. The ID sounded unfamiliar so I waited for another ID. The Grunov has poor sensitivity and poor selectivity as well as very poor calibration on the BCB so it isn't worth much in BCB DXing: Well, I guess that is about the end of this report. Two Alaskan Stations Hit Hard by the Earthquake

Of interest to DXers world-wide is the effect that the Alaskan earthquake had on various radio stations. The Good Friday catastrophe was most severe on KIBH-1340 in Seward as the station was physically demolished by the tidal waves which occurred after the first major earth shocks were recorded. The fate of four of KIBH's employees is still not known. KLAM-,450 Cordova also suffered some damage; however, most of this occurred to the tower. This station is now back on the air. The power failure in Anchorage forced the city's four AM stations (KFQD-730m KENI-550, KHAR-590, KBYR-1270) off the air; however, most of these were back on the air within minutes. No other Alaska stations appeared to have suffered damage, so apparently the quake had its greatest effects on KIBH Seward which may not get back on the air for many weeks. Down in Orescent City, California both KPLY-1400 and KPOD-1310 were forced off the air due to the tidal waves. Sources report KPOD still "silent" by April 2nd.

The LA Scramble for Eleven-Ten

KRLA is vacating 1110 kcs., but it must be a most-sought spot on the dial for LA radio listeners. Already twenty applications have been filed for this facility, and there are probably more to come. Most of the applicants ask to maintain existing facilities (50kw day, 10kw night) but several of the powers range from 500 watts unlimited to the 50kw unlimited. Everybody from Bob Hope to Nat King Cole is names in the various applications. Other nearby suburbs hoping to land the facility include Burbank, Costa Mesa, Newport Beach, and Topanga. In addition, the applications from KCJH Arroyo Grande, KDHI Twenty-Nine Palms, and KFOX Long Beach have been received in hopes of landing KRLA's channel. It may take years to unscramble the log-jam of applicants for 1110 kc., so LA DXers, here's your golden chance: spend a little time now on 1110 kcas well as 1100 and 1120, since KRLA has been ordered to end it's business by May 1st, 1964.

## LATE DX'ES

We have just been notified of a tentative DX program from CKBW-1000 Bridewater, Nova Scotia. They should be on from 0400 to 0500 EST on Monday Morning, April 27th, 1964, running 10000 watts. More details on this NRCI DX soon!

Another DX program we have just heard about is KMED-1440 Medford, Oregon, which will be on from 0400 to 0430 EST for the "NRO" running 1000 watts. The v/s there is Mr. Ellis Feinstein, OTE.

NRCI stationery & other printing is being held up pending the outcome of the May vote.
