Now what is this about me and the constitution? Well, I have been assigned the task of compiling amendments to the proposed NRC document which was created last August in convention. Most of them come to me via our Denver members, and many others are my own. I will arrange them in order of a ballot so that you will be able to vote on them clause by clause. Hy amendments reflect what I feel are the serious flaws and undesirables within the present Constitution and Bylaws. Here are some of those peeves: For one, the By-Laws repeat practically everything (except those on members and amendments) that appears in the Constitution, and I see no sense in this. What appears in one document shouldn't appear in the other. It will lead to unnecessary trouble when we may want to change certain Bylaws if it is also a part of the Constitution. Still another thing is Article TV-Dues. Better to have the members decide this by a vote--taxation without direct representation, I call it. On Article V, Sec. II, Part I--President--although his elected position makes him equal to the entire Board of Directors, there is little he can do without the latter's approval. I want to change this to "action may be taken unless disapproved by the Board of Directors -much simpler that way. And the Secretary-Treasurer must go. This office is hard work, instability, and red tape. I am for the creation of a new office -- Publisher, elected by the members (not appointed). This office will be similar to that of the NRC's Executive Secretary, only he'll be very limited in power and authroity in comparison, so don't worry, hi. Figully, Article XII will have to be done over so that we can find a remedy for irregularities within the Board of Directors. OK, voters, it's your say now. 73's and 4YA.

No "Buffalo issue" this week, so will make my first contribution to the "Denver venture," issue of April 28th, if I make deadline OK ... first 5 issues from Denver have been real good; fine job, lads! The 2nd issue made it here on Friday, others on Monday. Believe local PO touches no 3rd class mail on Sat. or Sun., so once more it will take 1st class mailing if I want "DX News" within 48/72 hours of publishing. Briefly, my equipment here at this relatively new DX location about 8 miles north of Everett, Washington: Receivers--Hammarlund HQ180; Navy DAK3 Direction-Finder; Grundig #5077. Recorders--Grescent, Wollensak, Silvertone (all mono, speeds 1-7/8, 3-3/4,  $7\frac{1}{2}$  ips). Time switches--five in all. Antennas--4 "Is" ranging from 75" to 250" in length, plus very high FII dipole, and a SWL7 designed for SW in attic of carport. My BCB DKing goes back to late 30s when I DXed in Colorado; reactivated in 1952 with purchase of a National NC125, and membership in NRC. First verie in my Washington State collection is KTNT-1400 for ET of 6/3/52. Ly Marysville location is 3rd DX location in the Seattle area, and I'm sure the best yet, although I've been plauged by electric fence noise here. If you wish to establish a domestic listing similar to "Supremacy Ratings" why not set up an "All American DX/61" listing with points awarded at the rate of 1 for each of the 50 states, D. of C., and 10 provinces verified? From time to time "Best verie" in selected states or provinces might add a bit of spice. Re. the story in your DYM on KIBH and KLAH. I understand KAPA (Raymond, Washington) released a 100 watt xmtr which has been shipped to KIBH to replace damaged xmtr. Am certainly glad that I have these two graveyarders verified! I know Dave Gleason is really logging the DX down in Ecuador, and his publication should be excellent. Till May, 73 and good DX.

### What's New In the MRCI?

We are proud to feature KSNO-1260 in Aspen, Colorado, as the NECT Station of the Month. Chief Engineer John Tucker has prepared the enclosed printed bruchures on the station to explain the operations there. Here's one last item of interest: KSNO will shortly begin rebuilding its ground system. Our Industry Advisor says, "Due to the fact there was up to five feet of snow on the building site during construction it was at the time impossible to bury the radials. During the time of rebuilding it will be necessary to operate KSNO with reduced power and with no knowledge of the actual output power of the station. Any DX reports received during this period will be sent not only our usual letter of verification but the letter will contain a personalized 'congratulations' from the station owner. This should be an 'extra points' letter for the files."

The following information was received from Mr. Douglas B. Hirtle, Chief Engineer of CKBW in Bridgewater, Nova Scotia, but arrived too late to be included in the last issue. OKEW went on the air December 24, 1947, with 1000 watts on 1000 kcs., and increased power to 10,000 watts on August 10, 1962 (same frequency). The station is supplementary to the Canadian Broadcasting Corporation but is is wholly owned by local shareholders. All transmitting equipment is RCA, and includes: (1) Main Transmitter BTA-1CU, (2) Standby Transmitter BTA-1NX, (3) Remotely controlled operation from studios, and (4) Three tower array oriented on a line running due East and West. CKBW protects primarily WOFL in Chicago. The staff includes 18 full time members and several part-timers. The station has a very attractive QSL card which will be sent to members who successfully heard the DX program on Monday, April 27. The actual time of the show was changed to 0300-0400 EST, but CKBW was on the air at the scheduled hour (0400-0500) with regular programing, \*

Last week on page 11 of the Forum we listed all of the Western states except for one omission—Wyoming. So, to complete the list, we will add it here. The best bet for logging a Wyoming station is to listen for KWYO-1410's regular frequency check-TT on the third Honday of every month from 0200 to 0220. Another Wyoming station that at times manages to make it back East is KROE-930, also Sheridan, which holds a frequency check with tone on the Second Saturday of each month from 0205-0220.

Also, a few tips on how to log the Eastern Canadian provinces, which were left out last week for lack of space. Newfoundland: About your best chance would be CBN-640 St. John's, 10000 watts, on AN FM. Only interference should come from South of the border. This station carries the CBC AN show, primarily music. Also, time in Newfoundland runs 1½ hours ahead of EST. Nova Scotia: We certainly hope you were able to log CKBV's NRCI DX show, but if they didn't make it last MM, you might try at 0400 on any IM as they are usually on by then. CHNS-960 also is normally on at this time. Both stations often carry clw type programming in the morning. New Brunswick: CBA-1070 seems to be the best bet, on AN HM with the CBC AN program. Also CKCW-1220 can be logged at times around 0415 on their non-D daytime pattern. Best time of year to try for these stations is in September and October or in May.

A hot flash: You will no longer be able to get a refund of your dues payment from the "governing body" of the NRC, since in the new "rules" sheet sent out to members now Rule 15 has been changed so that you must apply for a refund within 10 days of sending in your money, or you're out of luck.

Here is a list of the various radio logs that can be purchased to aid your DXing: The best all-around log for a domestic DXer is the Vane A. Jones Log, which is published yearly. It contains all stations in the Northern Hemisphere by call, frequency, and by state/province, etc The log also gives listings for HI & TV stations. The price for this log is \$1.95 and it can be obtained at any electronics store which carries the Howard W. Sams Photofact Publications -- its number is RSG2. Also, you can send the money to Vane Jones in Indianapolis, 2525 East 36th Street. Another log for domestic DXers is the <u>Broadcasting Yearbook</u>, obtainable by sending \$5.00 to Broadcasting Publications, Inc. at 1735 DeSales St., N.W., Washington, D.C. This log contains a listing of all Worthern Hemisphere stations by frequency, by call, and by state; it also contains the personnel at each station, plus miscellaneous info. on each station. Also, it contains info such as the NAB codes. FCC regulations, lists of consulting engineers, and so on. Another log is the Radio Station Directory published by Television Digest, 911 13th Street, N.W., Washington 5, D.C. The price is \$7 but if seven DXers go together as some of us did in 1962, you can get it at the reduced rate of \$5 apiece. The log contains all II. Hemisphere stations by frequency, call, and state. It also contains station addresses (same as Broadcasting Yearbook) plus a list of all the construction permits applied for in the previous year. Whites Log is a notoriously inaccurate log found in the backs of some Scientific Experimenter magazines for \$.75. We've heard lately that they're improved, but the log still doesn't list nighttime powers and leaves out new CPs. It consists of all NA stations by state, freq. & call. For the forcign DXer an excellent log is the World Radio & TV Handbook, published in Denmark and distributed in this country the Gilfer Associates, Box 239, Park Ridge, This log contains all the broadcasting stations of the world by countries, plus their skeds, QRAs, leading personnel, etc. It costs \$3.25 and is well worth it. Then, this fall will see the publishing of the SACCA Log, by Dave Gleason, on the NRCI mimeograph. The price has yet to be officially determined, but it will not be expensive, and the log will contain all stations of the Western Hemisphere. The PAL Log (Pan-Asian) may or may not be available yet for \$1 from the New Zealand Club, the New Zealand Radio DX League. The address there is P.O. Box 1356, Christchurch, N.Z.
