A big article in the 6/135 issue about WIW, which at the time had 500,000 watts power. All metal objects near thr xr picked up the programs-apliers held near the gate around the tower draws a spark f/the metal fence, and the programming can be hrd 15 ft away! There's also mention of WKBN in the article-seems some homing pigeons released in the area when WKBN was on couldn't find their way, but at night when they were off, everything was fine. Another interesting afticle is in the 6/138 Radio News-"New FCC B.C. Allocations". Many of the calls in the list are familiar butthose that aren't so familiar are interesting, too. On 770 was to be WJZ, WEV, WBAL, KKII. 890 had WENR and WIS. 1000 WCFL, KJR. 1030 had WBZ and WBZA-maybe the WMWG people saw this issue, hi! 1200 had WC/U, KOB, WDGY, WINS & WMAZ. By far the most interesting magazine of all was the 6/122 PS-fully 1/2 the articles and ads pertain to radio. Jack Binns had a column, "On the Crest of the Radio Wave". The CE at KMFC-710 phoned me a few days ago to acknowledge a report, including interference by KIRO (0300 EST). He wanted me to see if I could hear any QRM near sunrise - before KMPC went non-directional, and after KIRO was on with full daytime power. I got none, though, from 0750-0915 on sewral tries. (KBTR and KIRO both audible around 0300). Fact of the month; did you know that multi-hop radio wave propagation is controlled by the ionosphere's condition at the points of initial and final refraction only (not at each refraction point)? As the waves travel from point to point, there is a scattering of the signal after the first reflection, giving continuous coverage past the skip zone. This also explains why distant stns in daylight areas are audible sometimes - the point of first refraction must still be relatively dark (i.e., not ionized). Our usual SRS or SSS is only one-hop, and therefore governed by ionospheric conditions at the midpoint. Good discussion of such phenomena in "Shortwave Radio Propagation" by Stanley Leinwoll (Rider, \$3.90). Rebelde, etc.; this is about the only way to recognize SS stns, for it seems that call letters are rarely if ever given). Spanish words usually sound similar to the way they look. The pronounciation guide in a good EE-SS dictionary will give you an excellent run-down on the pronouniciation of each letter in the alphabet. Also, Bill, KOHO-1170 is 100% JJ. Roy Ackerman -- Broadcasting Yearbook lists all US BCB stns with foreign language broadcasts, from Apache to Yugoslav. WBZA-1030 Springfield-1 kw operated synchronously until deletion in 1962 with WBZ-1030 Boston 50kw DA as the latter's booster. Was similar to WBT's 1 kw DA night amplifier in Shelby, N.C. WFAA-Dallas and WBAP-Ft. Worth share time on both 570 (ABC) and 820 (NBC). Each is owned separately from the other, but the owners cooperate in sharing time and networks. WLS shared time with WENR until the late 1950s, but I don't know the details (FM call letters were WENR-FM until 1964 though both were owned by ABC). Gordon Jarvis -- QTH of XERB is Rosarito Beach, which is 12 mi. south of Tijuana. I agree wholeheartedly with C.A.T. in 3/16 DXF that Directional Antenna info is very important; I also maintain lists which include DA facts. It's too bad that VJ's book, in my opinion the most accurate guide available, does not list DAs. DA facilities play a major role in determining DX possibilities. SUCCESS!!!! A couple days after I wrote my last forumula, I had my rf amplifier working magnificently. At 1st, I didn't think I had to ground the chassis since the amplifier worked about the same without it. When I added a ground lead oscillations were reduced up to 750 kc/s. As I was fooling around I touched the output lead at the variable capacitor with my finger. This completely removed all oscillations. Adding a very high resistance between this point and ground produced the same effect. This lowered the sensitivity somewhat but it was much better than having oscillations most of the way across the broadcast band. A couple days ago the thought suddenly struck me that a feed back control should help. After some experimenting I connected a wire from the output through a switch and potentiometer to the input. Best results were obtained by wrapping the wire around the input lead 3 or 4 times. For some reason this regeneration control gives more signal strength than can be used on all frequencies up to 910 kc/s. After that it acts as a degeneration control. I have always been able to improve reception on the lower frequencies of the broadcast band but the higher frequencies always have room for improvement. I rovd my 6SJ7 tubes today so I replaced the 12SK7 in the amplifier with one. These r inexpensive "Micro" tubes (33¢). One was a little weak. The other didn't produce as good as performance as the 12SK7. I decided to increase the filament by a volt or so to improve performance. I was very surprised to see that this lowered the strength of the signals. I couldn't go below 6 volts on the train transformer I am using so I added a resistor to bring the filament voltage down to 5 volts. Lowering the voltage any more gave the amplifier too much gain. On strong stns I couldn't lower the signal strength below the point of distortion. However, this lowered voltage has no affect on the frequencies up above 910 kc/s. I believe I stated before that the amplifier tunes only to 1300 kc/s. But higher frequencies are also amplified considerably. Total cost of the RF amplifier was \$2.85 (not including "Edu'Kit" parts which would only have been junk if I didn't use them.). I spent  $50\phi$  today for labels. I wish I could give everyone a schematic of the ampli fier but I don't know the inductance of the coils. If someone with an "Edu-Kit" wants to try and build such an amplifier I would be glad to help in any way possible. If anyone can explain some of the odd results I had, I would appreciate a letter. 73.

YOUR BOARD OF DIRECTORS (DEE on 4/23) ---- Thanks to the very prompt action of Dave Johnson and Dal John, I am pleased to announce several proposals which have the sufficient 3 of 5 votes for passing. This is somewhat unofficial as of yet since ballots from Ed and Dave Gleason haven't had time to get here (Dave and Dal sent by air mail to reach here by deadline) but it gives you the idea -- Prop. 1 concerns a section to be edited by Gray Scrimgeour which will consist of Country or State of the Month, general feature articles, and several other things of interest. It has received the necessary 3 YES votes. A Countries List Committee is the object of Prop. 2 by Ed Krejny. It has received 3 YES votes. Mike Worst will now form a committee to make decisions on new countries to be added. I might note that Jack Keene has before the Board (in a later mailing) a proposal that INTERNATIONAL WATERS be counted as a separate country. Let your Directors know promptly of your opinions on the subject. Prop. 3 by Mike Shannon re a Govt. Info Sheet has 3 YES votes. Mike is in charge of this --- write to him with questions, suggestions, etc. Prop. 4 has 2 NO votes but I am withholding my vote for a while. Subject of Prop. 4 and the outcome will appear next issue. Prop. 5 concerns censorship. It proposes that there be no censorship at all. It has received 3 NO votes. Therefore, the present methods of editing will be continued until the editors themselves decide to change. The editing of various items has the full-fledged support of our Secretary-Treasurer, both editors, and Dave and Dal. Prop. 6 concerns whether or not DXF editor had the right to include certain comments on Marv Robbins in DXF. 1 YES and 1 NO vote, DEE abstains for the present time. The proposal was written by DEE and is NOT written to do anything but to give the editor(s) an idea how the Board feels. Prop. 7 concerns a possible contest and vote is 1 YES and 1 NO. Final decision next issue. 8 was re a letter by Allan Cameron in which there was no proposal -- but instead Allan made his feelings known. Prop. 9 by DEE concerns outlaw stns and the use of his POB for rpts for them. 3 NO votes means that the club does not take authority in deciding how he uses his FOB (mine-DEE) and allows for inclusion of information on illegal stns. 10 is pending with 2 NO votes. The proposal, by DEE, would have "dedicated" issues in which members of a certain state or area would be especially requested to report. Unless BOTH Ed and Dave favor it, the proposal will not pass. That is a summary of action by the Board .---- Another mailing is nearly ready for the Board. A proposal concerning counting INTERTATIONAL WATERS as a separate country, a proposal that birthdays be listed in DXM, and a proposal that there be awards (certificates) for IRCAers is on the slate. Others will be added and they will be in the hands of the Directors in time for announcement of result in May issue, I suspect. (DEE). NOTE -names of authors of proposals pending or not passing are not given should the person not wish his name included by some chance.
