A MESSAGE FROM YOUR PRESIDENT

One of the principal responsibilities of your president is to promote the affairs of our club so I am establishing this medium of "messages" to you. In these I shall attempt to keep you informed about what's taking place within our club's administrative circles and other aspects of our club's operations. Although our government's second administration has been in office for only about a month, there has been much going on so let's take a look at what your Board of Directors have been or will be doing.

A legislative battle has been taking place in the Board over two proposals concerning the selection of convention sites in the future. My proposal, 2.1-22, would authorize the members living in the West to vote for a site, based on bids submitted, for their conventions in the even-numbered years and the site receiving the majority vote will be the site for our convention in the next year. This way everyone in our club would have the opportunity to express their choice for the convention site when it is held in their region and those most directly affected -- those who would host and most likely to attend -- would have the final say in the selection of the site. The alternate proposal, 2.1-25, suggested by Larry Godwin and submitted by Dick Heiser, merely expounds on the method now in use, that of selecting the site at the business meeting. Their theory being that those who attend conventions usually attend every convention and with this in mind, it should be the decision of those who will be attending the conventions every year as to where they should be held. Both proposals are before the Board and the one receiving a majority vote of the entire Board will then be sent to you for your individual decision to have it ratified as an amendment to our Bylaws. If you want your views on this to be made public, why not do so in the "DX Forum."

Another major issue soon to surface will be the possibility of changing the format of DX Monitor. There seems to be a consensus among our club's leaders that a change or changes of some form must be affected in the near future to combat the increasing apathy of our mombers to report in our bulletin and to cut down on the increasing cost of compiling and publishing DXM. Several members have suggested ways to accomplish this and I am now considering creating a Publication Format Committee to study the several aspects of these suggestions and the feasibility of incorporating them. Plans including having our editors, publisher, and other interested parties participate in the committee's work and at the conclusion of its research, the PFC will report its findings to our Board along with a revised Editorial Policy for the Board's consideration and approval. Progress along these lines will be reported in future messages.

For you members living in Region 2 (Del., Ed., Pa., O., Ind., Mich., Ont.), due to the tie in the election of candidates for the BoD, at present you are without an official representative in our government. At this very moment the Board is considering this situation and very shortly will announce the appointment from Region 2 a member to represent you in our Board of Directors.

Because of the fact that my spare time to devote to the affairs of the presidency is rather limited (a fact that most fellow-GI members will attest!), out of necessity I am forced to adopt as policy to withhold any proposal from being submitted and acted on by the Board until you send me enough copies of it so it can be sent to each member of the Board. I realize this may cause some delays, but this is the only way to insure they will be acted upon. Hopefully, I may find time in the future to make the additional copies myself, but for now this is practically impossible. Please keep this in mind when you want to send me proposals to be acted on by the Board of Directors.

REGULATION OF BROADCASTING by Larry Colton

This article will deal with the early laws regulating radio stations and the formation of the Federal Communications Commission (FCC). The first law concerned with domestic radio in general was the Radio Act of 1912. At that time, the Secretary of Commerce and Labor was made responsible for licensing radio stations and operators.

The broadcasting of the early days was only experimental and, therefore, noncommercial. By 1919, broadcasters were operating as "limited commercial stations." In 1922 at the First National Radio Conference, recommendations resulted in further regulations by the Secretary of Commerce. A new type of station was born, with a maximum power of 1000 watts and a minimum power of 500 waits. The 2 frequencies of 750 and 833 kc. were assigned for program transmission. 833 kc. was to be used for broadcasting of "important news items, entertainment, lectures, sermons, and similar material."

Because of the rapid growth of broadcasting, at the National Radio Conferences of 1923 and 1924 the Department of Commerce allocated 550 to 1500 kc. for the standard broadcast band, and at the same time authorized operating power of up to 5000 watts.

The great increase in the number of AM stations caused such a mess that in 1925 the Fourth National Radio Conference asked for limitations on broadcast time and power. Because of court decisions which held that the Secretary of Commerce was not granted this power in the Radio Act of 1912, he was unable to cope with this problem. In view of this, many broadcasters jumped frequencies and increased power whenever they wanted to, without considering the effect it would have on other stations. The result of all this was mass confusion on the air. In order to remedy this situation, President Coolidge placed the matter before Congress in 1926. The legislative result was in the Dill-White Radio Act of 1927.

The Radio Act of 1927 created a Federal Radio Commission consisting of five members. The powers delegated to this commission included regulatory powers concerning the issuance of station licenses, allocation of frequencies to individual stations, control over stations's power, and the control over the allocation of frequency bands to various services.

The early efforts of this commission were to a large extent directed at trying to straighten out the bedlam on the broadcast band. It was a difficult task to care for the 732 stations operating; because of the new rules, about 150 of them were forced to give up their licenses.

In 1933 Prasident Roosevelt requested the Secretary of Commerce to appoint a committee to study the overall electrical communications situation. The committee reported that as far as Congressional action is involved, the communications service should be run by one organization. The Communications Act of 1934 established the Fedreal Communications Commission, an independent federal organization consisting of seven commissioners appointed by the President with the advice and consent of Congress. The FCC regulates interstate and foreign communication by wire and radio, including telegraph, telephone, and broadcasting. -30-information from FCC Information Bulletin # 2-B

LOGGING AFRICAN ECB STATIONS. By Ed Krejny.

For most DXers in the United States, the easiest African station to log is Dakar, Senegal on 764 kcs. This is, of course, dependent on the local QRM situation, specifically, how much trouble you have with WJR and/or KFMB. This station normally signs on at 0100 EST, and uses French and African dialects. Tape reports have worked out well with this station, which is in general, quite a good verifier. The next most likely station to be logged is Agadir, Morocco on 935 kcs.. This station broadcasts exclusively in Arabic, and so is hard to get a logging on. In contrast to Dakar it is also difficult to get verified, although two DXers have recently reported some success. The Moroccan stations on 593 (Oujda) and 701 kcs. (Sebaa-Aioun) are

also heard quite regularly in the east. WLW obviously presents a problem for some in the reception of the latter station. Algiers, Algeria on 890 kcs. is frequently heard on MM*s if conditions are good, WLS is not testing, and the Cuban is off. They broadcast in French. Two Egyptian stations, one on 773 kcs. and the other on 818 kcs., are also heard regularly; at least they were last season - both in the evening and in the early morning.

Tunis, Tunisia on 962 kcs. and/or 629 kcs. is another good possibility. Freetown, Sierra Leone-1200 kcs. was logged occasionally, and is worth looking for on MM's if the conditions are good and the Cuban is silent. Although the RNE's Canary Island station is on an even frequency, 620 kcs., DXers in the East might look for it as, with 100 kws., it should get out quite well. It, however, does not sign on until D200 EST. Recently Bamako, Mali has been reported in the East on 1415V kcs. - worth the effort of tracking down if the adjacent channels aren't plagued with locals!

Some of the rarer items logged last season, and through the recent Summer season were: Nigeria on 953, 1088, 1358 and 1458 kcs.; Malawi on 764 kcs.; Cameroon on 1286 kcs.; Mozambique on 737 kcs.; Kenya on 791 and 863 kcs.; Mauritania on 1349 kcs.; Guinea on 1404 kcs.; Dahomey on 1475 kcs.; the Union of South Africa on 728, 764, 782, 845, 863, 908, and 1286 kcs.; other Algerians on 548, 1142, and 1421 kcs.; other Moroccans on 611, 1025, 1043, 1187, and 1232 kcs.; other Senegalese stations on 1304, 1484, and 1538 kcs.; and Cairo also on 707 kcs..

News has just been received that SWL Publications , P.O. Box 9768, Kansas City, Mo., 64134 will be publishing a monthly magazine called "SWL NEWS," starting in January 1966. I've written to see if there will be a BCB section, and will relay any information on this publication. Subscription price will be \$4; editor is Jim Howard. We discussed such an all-band magazine at the Convention. There are enough participants in the DXing hobby now to support a good magazine. More later.

SOME NOTES ON FOREIGN RECEPTION

Recently, NRC-member Gordon Nelcon of Watertown, Mass, sont some very interesting material to me. With Gordon's permission, I'd like to pacs along some of his data and comments on reception of foreign BCB stations and possible "openings" that might occur. For those of you not knowing of Gordon's recent work (published in the NRC DX News), I'll give a brief description. From propogation characteristics and from his DX, Gordon has computed (with a computer at MIT) the times at which stations to the east should fade out at sunrise. You'll notice the term E2O below - this is the time of fade out (loss of 20 db of signal) calculated for normal conditions. He's also working on such problems as the effect of sunspots on BCB DX, times of extraordinary receptions, and generally bringing the modern scientific method to our DX field. Another article in the NRC has described Subaudible Heterodynes, a phenomenon enabling DXers to detect weak carriers under strong ones. Gordon is interested in the times at which TPs fade in, so any information of carrier or audio fade-ins would be appreciated. He says that calculations of Western Sunset effects will be more difficult than the Eastern E20's; fade-in times may be predictable within 20 minutes (rather than less than 20 seconds, for the TAs) only, but this would be quite a help. I'll quote portions of Gordon's letter for the next few weeks, and hope you'll get some good ideas from it.

"In the .. IRCA bulletin (ed. note; in Season Openings column), you comment that the easier TA's should be heard from 9/13 or 9/20. I wonder about these dates a bit; often I think that these September dates that are so frequently tossed about are actually the dates when summer-vecationing DXers start listening again, rather than the dates when the DX returns. Throughout the entire summer I got good reception from Dakar-764, 1304; RNE-584,683,728,737,917 and 935; Spain-809,953; Portugal-755, 782, and 1578; Germany-1538,1586. Except for those stations that are all-nighters, most of this midsummer DX was of course between morning s/on and the corresponding E20 time. As the summer wore on, the E20 time for stations such as Prague gradually caught up with the AM s/on time so that a batch of different TA's were heard later during the summer: BBC-1088 first appeared on 8/2, Cairo-773 on 8/3, Prague-1286 on 8/3, Germans-1358 on 8/5, etc. Because each foreign station reappears on a different date according to its E20 and s/on time, I'm tending to steer away from giving "blanket" dates for the return of TA's." A good point, Gordon. More in following weeks about the effect of sunspots and the equinox DX from DUs.
