#### SOME MORE COMMENTS ON REPORTING:

C.M. Stanbury II sends these comments:

TMy .. reason for writing is your IRCA column of 10/16. I am substantially in agreement with your views. In fact, we may be in 100% agreement, I'm not sure. POINT 1. I'm glad you added if possible to that  $\frac{1}{2}$  hour minimum. Many times when reception takes place at s/on followed by fast fade out, or just before s/off, the DXer must be content with 5 minutes or less. If the station is one which he's not likely to hear again, he must use his brains (a DXer's number one asset) to prove his reception.

POINT 6. As you may have noted in your next column, this one is not always practical. With foreign stations, one simply does NOT KNOW what is in the log. One can always ask did they record that exact time the carrier was turned on, when their national anthem began? When the technical troubles began, what kind of music they were playing at this exact moment? If the DXer has some program data accompanied by EXACT times, I think the only thing he can do is send his report and hope it can be checked. Otherwise he will lose out on most of his really rare catches. After all if a station were easily heard over a long period of time, it wouldn't be rare, hi. Or putting it another way, we can't always hear 3 sponsors names (which to me is the ideal report).

Yes, Stan - I think we agree. Glad you brought these up.

POINT 1. Many listeners are impatient, and won't take time to listen and send a report for reception over a decent period of time. In my opinion,  $\frac{1}{2}$  hour is minimum for decent conditions. But for f/c's, rare short openings, certain types of programming, etc. you can only report what you hear. I usually keep listening if a station fades, but obviously there'd be no use in listening for the same station after a s/off.

POINT 6. Right. But again, I like to get details (and sufficient details) that can be easily checked. Tapes help sometimes in situations like this. It's still imperative to be sure of the station you hear, and if a good DXer can convince <a href="himself">himself</a> he can only do it with details that probably can also be checked by the station. (There is value to a tentative report, as discussed previously, but again this should be used only in extraordinary cases. We must be wary of stations that "verify" without checking details, or without giving specific answers to the DXers tentative ID).

POOR REPORTS FOR GOOD RECEPTION cause problems for DXers. When someone does get a rare catch, and reports what he hears, the station may disregard it or not check it thoroughly because they get so many unnecessarily poorly-detailed reports. They may verify or not, but if they haven't really checked the report, how will the DXer know if his tentative ID or rare catch was correct? I like Glen Kippel's comment of a few weeks ago, that we must verify our reception to the station. Learning to write good reports when you start will help you when you get rare logs later.

I got a verie (and I mean a <u>verie</u>) recently from WSAY, Rochester. It reads "this is to certify that the report which you made on the reception of WSAY ... signifies without any doubt that your reception of our station is authentic." No doubts there. 2AP, Western Samoa has 2 spaces on its QSL; one for verification, and one saying that you have not sent sufficient detail to prove reception. Again, it makes you feel nice to know that some stations do bother to check their logs. Let's give the stations all the help we can, by sending the best reports possible. And sending reports showing good judgement, and by doing as Stan suggests, using our brains.

I am almost certain that this station is CFSE Senneterre, Quebec (assigned 1450 on 1425 most of last season where many of us heard them). On 10/25 they were relaying CJKL Kirkland Lake first with NHL hockey then accidentally with some of CJKL's own programming. Senneterre is the only such base within range of CJKL, BUT I HAVE NOT HEARD CFSE ON 1462 (due to a strong LA) INSTEAD I AM HEARING THE HARMONIC ON 2924. Next, I see where R. Emperador on 840 is supposed to be TGE. But there is already a TGE. the Guatemala City Aeradio on 2952 and other frequencies. This doesn't prove that R. Emperador is not TGE for Guat. has duplicated calls before. But if so, it makes R. Emperador a considerably rarer catch. My point is that BCB DXing is not a world unto itself isolated from other bands. The best BCB DXers know what is going on EISEWHERE. Certainly IRCA should never become an all band club. ## Proposal 2.1-23. By-laws amendment to Article III, Section 2, Part 2, a.

The IRCA Board of Directors approves the following amendment proposal and asks the Election Committee to submit it to the membership for ratification by a majority of members voting: Article III, Section 3, Part 2, a, of the By-laws will be amended by striking it and putting in its place the following: "The world shall be divided into seven regions, each representing as nearly as possible an equal number of IRCA members."

#### Proposal 2.1-26. By-laws amendment to Article XIV.

The IRCA Board of Directors approves the following amendment proposal and asks the Election Committee to submit it to the membership for ratification by a majority of members voting: Article XIV of the By-laws will be amended by striking it and putting in its plac the following: "If a potition is presented to the Election Committee bearing the signatures of 20% of the members, asking the removal from office of the President or Secretary-Treasurer, the Committee shall call a special election at which the membership will be able to vote for or against such removal. If the removal of the officer is approved by 75% of the members voting, the office will be declared vacant.

"If a potition is presented to the Election Committee bearing the signatures of 20% of the members in a certain Region, asking the removal from office of the member of the Board of Directors from that Region, the Committee shall call a special election at which the members in that region will have the opportunity to vote for or against such removal. If the removal of the representative is approved by 75% of the members voting in that Region, the office will be declared vacant."

## Proposal 2.1-27. By-laws amendment to Article XIII.

The IRCA Board of Directors approves the following amendment proposal and asks the Election Committeeto submit it to the membership for ratification by a majority of members voting: Article XIII will be amended by striking the word "names" in line 2 and substituting the word "signatures."

# Proposal 2.1-29. By-laws amondment to Article V, Section 2, Part 3.

The IRCA Beard of Directors approves the following amendment proposal and asks the Election Committee to submit it to the membership for ratification by a majority of members voting: Article V, Section 2, Part 3, will be amended by adding another subsection designated "g" after subsection "f" to read as follows: "All decisions of the Board of Directors including the names of the representatives voting for and against each proposal must be published in DX Monitor as soon as possible after the decision is made. No member shall be held responsible for such decision until they are made public through the DX Monitor."
