It would be a lot of work, but well worth it. Correction: KPRC-950 has 0545 s/on, not 0630 as reported in 1/22 DXM, Hasn't RA been beaten to death? (I would say so, 1rs) I SAY IT'S ON SWAN, for what it's worth. Pat Laird: LA's on 760 possibly CMCD and XEABC, those are most likely. Others in evening are YSKL, YVMV AND HOXO. 750 SS maybe HJDK "La Voz de Antioquia." XEX-730 probably that one, Oloo s/off, was that KGES (daytimer, 0000-05000MM's) or KSVS (0200 s/off) on 1020? Good luck to you, Ed; 'twas a pleasure to contribute, OK, you may sit down now, hi. The longpromised RFS Cuban Station List has been sent to Howie Modell, and it should appear in this issue. Let's all "initiate" Mr. Modell with more DX than he can handle, for he plans to stencil the section on his Day of Rest - Saturday. Best of luck, Howie. LBG's article on "Taped Reports to Foreign Stations" has a lot of good points. And may I take this opportunity to stress the matter on tape speeds: TR's used for radio are precision instruments, highly automatic, and generally equiped for on-the-spot editing. However, they do not record or play at any other speeds than 7.5 and 15 ips. Even if a stn has one or more regular recorders on hand, it is seldom convenient for the CE to pull out the machine and set it up just to play a tape recorded at 3.75", etc., while he can have one at 7.5" ready to go within seconds. Get the point? Whether domestic or foreign, alway record taped rpts at 7.5 ips. And while on the subject of written rpts, be especially sure to include the following data of proof whenever possible: 1) Exact time of all ID's. 20 Title and brief description of the program. 3) The name of the sponsor of all programs, and spot announcements. 4) The exact time a program begins and ends. 5) The exact time of s/on & s/off (i.e., Beginning and end of modulation). 6) The exact time the carrier goes on or off, either mormally, by accident, or during a test. 7) During a test, the exact times a tone begins and ends. All US atns must keep a record of the above for a period of 2 years or face trouble with the FCC, so stress it in your rpts. You can forget about logging musical selections, unless the stn is WCXR, WFIN, or any other "good music" stn, as they generally keep records of music to avoid repetition. So much for that, as I'm over 30 already. More on R. Americas next time. 73.

It's getting on toward the time of year when we can look for some better openings to Australia and New Zealand. Any station you can snag from these 2 countries is real DX. Spring here is often the best time of the year for DUs, with the equinox bringing long all-darkness paths - definitely a good time for southern hemisphere "diagonal" DX for all of us in North America. West Coasters should also get DUs into the summer months, with early morning DM. Best times to try are after about 0300 EST. Zedders sign off at about 0530 to 0700, and the Aussies in their Eastern time zone near 0700 to 0900 EST. A few are NSP (eg. 2RE, 4BC - mainly some commercial stations in larger urban centres). Watch for Australia after interference from your east has been erased by sunrise. Most common stations would include 2NA-1510, 2NR-700, 4RK-840 and 3LO-770 for Australia, and 1YC-880 and IZD-1000 for New Zealand. Here are a few comments on some stations in these 2 countries.

New South Wales. Watch for 2NR, Grafton (700 kc) after WLW fades at sunrise. 2NA-1510

heard here. 5CL-730 and 5AN-890 (both in Adelaide) are best bets for S.A.

Western Australia. 6DL-530 in Dalwalinu is one to watch if your radio has this frequency. 6WA-560 (Wagin) and 6WF-690 (Perth) are both 50 kw.

Tasmania, 7NT-710, Launceston was logged in Alaska last full. What about the Hobart stations 7HO-860 and 7ZZ-940?


Northern Territory. 8DR, Darwin on 650 kc. looks like the only one here that'd be possible in the US. Of the other 4 stations, only 8DN-1240 has any power. Papua - New Guinea. Just now, there are only 2 BCB stations - both ABC. They are 9PA, Port Moresby on 1250 and 9RB, Rabaul on 810 kc. Both are 2 kw.

New Zealand.

Being considerably farther east, New Zealand often gives better signal strength and more frequent reception than Australia. As I said above, listen for 1YC-880 in Auckland. It's heard often, being on a good frequency. Because of the nature of its cultural programming, it IDs at odd times. IZD-1000 in Tauranga and 1YZ-860 in Rotorua share an antenna, and both get out when no other Zedders are heard. 4YA-780 (Dunedin) is another "regular" (if any DUs can be called that). Try it on MMs with WBBM off. 4ZB-1040 (another Dunedin station) has been heard a few times, on SM - either through KHVH or after its sign-off. 4ZA-820 in invercargill, IZB-1070 in Auckland, and 3ZB-1100 in Christchurch are three 10 kilowatters to watch on spring MMs. Amongst the NZ 2 kw stations, try 2XB-840 (Masterton) and 2XA-1200 (Wanganui) and 3YW-1460 (West-port) when reception conditions and interference allow.

Other South Pacific Stations.

It's also possible that some of the other South Pacific stations will be audible when the DUs are in. Try ZCO-1020 kc (Tonga) in the east MM when KDKA is off, and in the west weekdays after KSV/S s/off, if KDKA is weak (KGBS ruins MM). 2AP-1420 in Apla (Western Samoa) is heard once in a while on MMs around 0400. Any others would be rare catches: either Tahiti or Noumea on 1400 kc.; VQO, 1030; WVUV (now 500 watts, but expected to go to 10 kw) 1120 kc.; any of the Fijians (710 kc. might have the best chance); and the one that's tough even in New Zealnad - VL2NI, 1570 (50 watts on Norfolk Island).
