True, I believe we should not have censorship, etc. An easy way not to have ANY censorship and also reduce the load of the editors to merely typing up the reports without the bother of editing--is simply to state that ALL reports will be ent ered as is. That is to say, that all reports from members would be typed up as the member sent them in. With no deletions. This seemed to not have worked the last few months when the editors were doing just that. Either the members begin to become responsible for their COMPLETE report -- OR the editors will have to resume editing to have the bulletin a worthwhile piece of publication. Comments about having a separate section in the DXWV for foreign Forums are somewhat mistaken. You can have general discussions of foreign reception in the standard Forums. The Editoral Policy is included this issue---read it! You will find quickly that our Forums aren't as limited as some have made out. proposals submitted to the BoD written up in the bulletin BEFORE the Board votes on them This is an excellent idea and one that I suggested a year or so back. It really doesn't do the members a lot of gud to see how the BoD voted on proposals -- the members don't even know such proposals are before the BoD so they cannot send their BoD rep their ideas on them. This listing of all the stations currently on the air or in construction in Arizona has been compiled with the aid of <u>Broadcasting</u> magazine, <u>Broadcasting</u> Yearbook (1967), tips from the last three months of DX Roundups, <u>IRCA F/C List</u> (1968), <u>IRCA CoF List</u> (1967), and the C&N listings of the VJ log (1966.) Ishould also like to thank Bill Wilson for his generous help.

The States of the Month for February are NORTH CAROLINA AND SOUTH CAROLINA, and the deadline is January 27, 1968. The States of the Month for March are KANSAS AND NEBRASKA, and their deadlines are February 24, 1967. If you wish, you may include the tips for all four states in the same letter. I would like to have the states separated, and tips such as type of QSL, mx used at s/on or s/off, and type of format used, and of course, the best times to receive the particular station.

This is the first and last time that I will include the entire station listing of the states. Since the cooperation from the members was virtually non-existent, I figured I would show how much help I would like next time. The size of this section is totally up to the members reporting -- if there are none, the size will be small.

The Presumrise Situation

In an effort to make some sense out of the F.C.C. ruling of June, 1967, I have gleaned these operational guidelines from several <u>Broadcasting</u> magazines:

- 1) Class II-D, III-A, and III-B stations with PSA's are permitted operation from 0600 local standard time to sunrise with daytime antennas (directional or not) and limited powers (not exceeding 500 Watts) to protect co-channel non-U.S. demizant stations.
- 2) Class II-D stations (i.e. daytime) on Class I-B channels (680, 710, 810, 850, 1000, 1070, 1080, 1090, 1130, 1140, 1170, 1190, 1500, 1520, 1530, and 1560) cannot sign on before surrise at the location of the dominant stations, and must provide protection to a dominant (if any) to the west.
- 3) Class II-D stations (i.e. daytime) on Canadian or Mexican clear channels (540, 690, 730, 740, 800, 860, 900, 940, 990, 1010, 1050, 1220, 1550, 1570 and 1580 k.) cannot sign on before local sunrise.
- 4) Class II-D stations (i.e. daytime) on U.S. 1-A clear channels (640, 650, 660, 670, 700, 720, 740, 750, 760, 770, 780, 820, 1020, 1030, 1040, 1160, 1180, 1200, and 1210 k.) located east of the dominant stations cannot sign on before local sunrise.
- 5) Class II-A, II-B, and II-D stations located west of co-channel I-A stations can sign as early as 0600 local standard time using full daytime power without applying for PSA's, or can sign on after sunrise at the dominant stations, whichever is last.
- 6) Fulltime Class II and III stations may elect to operate under the new ruling with PSA's, or maintain their previous nighttime powers and directionalized antennas.
- 7) Class II-D, II-A, and III-E daytimers prevously permitted to operate from 0400 local time must cease presunrise operations, and seek PSA's as in 1) above.
- 8) Stations with PSA authorizations may forestall signing on until full power may be utilized.

The commission is expected to liberalize the new rules in future rulemaking by 1) permitting power in excess of 500% on the basis of full domestic protection in addition to foreign protection, 2) dealing with the question of Class-II daytime and limited time stations located east of co-channel I-A stations, (the rules prohibit presunrise operation by such daytimers; affecting only WHCU, Ithaca, MY and WHLO, Akron, Ohio currently, and 3) possible liberalization of the WARBA agreement which specifies 0600 local -- standard -- time (which means 0700 local time during the six months of daylight time) that the presunrise ruling is based upon. ---lcm

The IRCA has a new and active CPC Chairman, Eric Floden. Unfortunately our previous Chairman Dale Wing failed to renew his membership when it expired last August. Eric plans to communicate with committeemen via a regular CPC bulletin. In "An Open Letter to IRCA CPC Committeemen" (11/25/67 bulletin, p. 6), the proposed ANARC CPC-Controlling Committee was described. In a close vote, the Board has decided to at least delay action on this proposal due to the fact our CPC has been operating without a Chairman all season. The proposal may be resubmitted at a later date.

The DX Monitor has a new column for ready verifyers. Chuck Buckley, who is the editor, wrote that he used the verie-signers list primarily to see if stations verify and how (by letter, QSL card, etc.), rather than using the name of the signer. The new column will list stations that have verified recently with the means used (QSL or letter) and the length of time it took: to arrive after the 1st report was sent. Send your latest verie info to Chuck at 2200 University S.E., Box 3, Albuquerque, NM 87106. The first column will appear soon.

After extending an invitation to ANARC to share convention facilities with the IRCA the past two years, and receiving a negative reply both times, the Board decided we would not extend the same invitation this year.

The IRCA will cooperate fully with an ANARC project to compile a loose-leaf reference binder treating various aspects of the radio hobby. The club gives its permission for ANARC to reprint pertinent articles appearing in the bulletin and in our publication The Principles of BCE DXing, with proper credit going to the author and to the IRCA. Also, the individual author of each article reprinted must give his permission to the editor, Art Glover. Art estimates the project will take 2 years to finish.

The club has been losing money charging only 10ϕ per sample; the new price is 25%.

World Publications Report

I have just received a complimentary copy of the 1968 World Medium Wave Guide, which is available at the IRCA discount price of \$1.90 (or \$3.40 airmail). Separate from the book itself is a rather large chart giving the location of European BCB stations by frequency, indicating the power by length of a solid line. Rather than listing all BCB stations in foreign countries in one section, this year there are separate sub-sections for Africa, Europe, East Siberia-Asia-Far East-Pacific, and Latin America. Each entry (by frequency) gives the call, location and power; in addition, for Latin American stations, the slogan is given. Following the foreign sections is a listing by frequency of North American stations, with power indicated. Next is a list of NA stations by location with power omitted, and finally a list of NA stations by call letters. The book is a handy reference for foreign DXers and it would seem an asset for domestic DXers, too, especially in view of the \$10.00 price tag on the new Broadcasting Yearbook, and the many errors in the last Jones Log.

Radio stations continued to attract listeners with better-than ever programming variety, community service features, and techinal improvements. Several signs point to Alberta's radio and television as fertile graund for advertising dollars. Existing broadcasters are expanding their staffs and facilities to better deliver entertainment, service, and commercial messages to a young and growing broadcasting-oriented audience. Local businessmen are showing their faith in their communities by investing in proposed new radio stations. Finally, the interest by major communications corporations in the Alberta broadcasting industry is indicative of a vigorous business climate. One new radio station will be on the air in Alberta early next year. The Board of Broadcast Governors has also approved two new rebroadcasting centres for Edmonton television stations. Edson, centre of a forestry and coal mining area 120 miles west of Edmonton, is the location of the new AM station. Ernest Mushtuk, an Edmonton broadcaster representing the license-winning company, told a BBG hearing that the Edson-Whitecourt-Hinton-Jasper area had some 24, 000 residents, and was a region "big enough and buoyant enough" to support a local xxx radio station. Three radio station applications were turned down by the BBG. The BBG refused to license a proposed station in Westlock, 35 miles north of Edmonton. Two applications for a station in Wetaskiwin were also turned down. The BBG siad the Westlock area was served by Edmonton stations, and the type of service promised by the Westaskiwin applicants was being adequately by station CFCW-790, in Camrose (cw-JEP). Biggest ownersip change in Alberta broadcasting came late in 1966 when Voice of the Prairies Ltd., operators of Calgary's CFCN Radio was acquired by Maclean Hunter Publishing Co., Toronto. CFCN Radio was founded in 1922, making it one of Canada's oldest stations. It began 10kw broadcasting in 1931, and moved into the longrange 50kw class in 1965. Several major personnel changes have come in the wake of the purchase, and give CFCN top-flight management. R.W.Lamb (Don) is now vice-president in charge of Finance and Engineering (v/s-JEP), while E.W.Chapman(Ted) is vice-president and manager of TV. Other appoinments, in CFCN, include R.F. (Bob) Irvine, vice-president and manager of Radio; Don Thomas, assistant manager and production manager; Don McKinstry, sales manager; Don Woods, promotion manager; and Roy McDonald, director of Special Client Services and Research, (more later. On the list, the manufacturer and model number are given first, followed by the speeds (1=1-7/8 ips, 3=3-3/4 ips, $7=7\frac{1}{2}$ ips), then the number of tracks, type of drive (capstan or rim), and largest size reel it can take.

Remember when tapesponding, that the speeds must match, and it is advisable that only capstan match with capstan, and rim drive with rim drive (in other words, it is not advisable to send a capstan recorded tape to someone with only a rim-drive recorder). In some instances, however, it can be done; it is not advisable, though, since on rim-driven recorders the speeds change as the tape moves from reel to reel.

Relation Between Geomagnetic Measurements and MW DX Conditions

by K.G. Scrimgeour

Because a variety of physical and chemical states of the ionosphere are responsible for differing reception conditions, it is difficult to find any useful measurement that can be used as a criterion of DX conditions. However, I would like to suggest that geomagnetic indices can be correlated to MW reception in at least a gross fashion. Since July of 1965, I have been receiving weekly reports from the U.S. Government of geomagnetic values for each day of that week. Over the 2½ years, a period going from just after a sunspot minimum to near the peak of solar activity, DX conditions over very long paths have varied from quit good in Fall, 1965 to poorer (i.e., much less frequent) in late 1967. From a comparison of reception conditions with geomagnetic records, I would suggest that low geomagnetic activity is a necessary but not sufficient requirement for long distance east—west medium wave DX, and will illustrate and discuss this a point below.

The measurements made by ESSA are reported as A_Fr units for each day of the week reported. A_Fr stands for Geomagnetic A-Index as measured at Fredericksburg, Virginia by the U.S. Coast and Geodetic Magnetic Observatory. A-Index values (on a linear scale of O-400) measure the strength of geomagnetic disturbance. The A_Fr is an average of 8 readings taken 3 hours apart during the day, so that marked changes during the day are not obvious from the average values. In any case, the A_Fr is a readily obtained physical measure of ionospheric conditions for individual days. Values of A below 4 are low, and above 25 quite high, in terms useful to short wave users 9 specially with reference to paths near the polar zone). I have defined values of A_Fr of 3 or less as low geomagnetism, and values of 15 or above as high geomagnetism, as related to MW DX. There have been numerous days of A of O during the past 2½ years, and the highest reading - 156 was on May 26, 1967, during a 3-day ionospheric disturbance.

There is a seasonal variation of geomagnetism. Days of high geomagnetism occur most often during the August-October period, with a lower peak, occurring at the other equinox period in March. Values for the 1940-1951 period show that both March and September had about the same number of days of very high geomagnetic : activity, but that August and October were well above February and April in occur rence of very high geomagnetism. These data also showed that days of very low :: activity 9equivalent to A of D - 2) occurred most frequently during the Novem-1 ber to February period/(1005 days, compared to 776 days for March to June, and i 713 for July to October). These figures would appear significant to me in suggesting lower geomagnetism (and hence a more stable ionosphere) during the months nearest the winter solstice. In Table I, I have summarized the number of days of low and high geomagnetism in each month of the past 2½ years. Fewer days of low activity occurred during the periods of higher sunspot number and poorer day-today MW DX (e.g., column 1 figures for October-December for each of the spast 3 years). Noticeable also is the September, 1966 period of good auroral DX, with 14 days of high A. The correspondence between high geomagnetism and auroral conditions is well established. Although this summary of data does show interest-ing trends, it is when we examine data for individual days that more striking correlations can be made.

As a measure of exceptional reception conditions, I have used TA reception from Southern California. There are several reasons for this: (1) the occurrence of split frequency stations relatively free from interference (e.g., ABC-1214, RTF-1205), (2) the rarity of reception, and (3) my interest in logging these stations during 1965 and 1966. I checked the band almost daily from early October, 1965 to January, 1966 during the first season, for example. Using dates of reception of West Coast North American stations in Britain (supplied by Ken Brownless),

and dates of my own European reception from La Jolla, I have observed that a period of low geomagnetism was associated with each of these receptions. Certainly, there were days of low A_F, when these stations were not logged, but many factors are involved in exceptional reception, not just the presence of low geomagnetism. But all cases checked were during periods of low A (below 4 in almost all cases). Table II shows the comparison between presence (and quality) of reception and A_F. Note that reception times are for early AM EST, and A_F is for the whole day. Days of TA reception with higher A (eg, Nov. 22, Nov. 30, and Dec. 18) were at the end of a multi day opening, and it is likely that the increase in A was later in the day than the TA reception (and possibly may have been related to the cause for ending of the opening). My TA reception during the autumn of 1966 was much less frequent but also occurred on days of low A.

Reciprocal reception of Europe and WC NA would appear not to be the only path showing this characteristic of requiring low A. Reception of TP Asia from Massachusetts (NRC) occurred during a period of low A (Oct. 20, 1965), and clearest receptions of deep TP Asians (eg., Macau-738, Thailand-843 and 1123, stations on 955 kg, Kiangsi-843, and the Philippines and/or Okinawa on 780 kc) from California (DXWW, 1965) occurred when the A was 8 or less (3 or below in all but 5 cases). In some cases, these were the same days on which TA reception occurred.

If the relationship of low A to chances for excellent BCB reception over long paths, and the high A to auroral DX, were to be of direct use to DXers, it would be necessary to show what the geomagnetic conditions were at any particular time, and what they were expected to be in the following hours. Unfortunately, such data is rarely available to us. During the IQSY (1964-1965), WWV did broadcast "alerts" of geomagnetic calms or storms expected. The usual propagation forecasts broadcast by WWV are intended for SW, and do not have much use for MW DXers.

Testing of the suggested association of excellent BCB DX on long east—west paths with low A would require a longterm systymatic study of reception conditions, and access to more complete geomagnetic records. The latter is not difficult. The reasonably good direct correlation between this physical measurement and DX conditions reported here suggest that a closer examination would be worthwhile.

An Open Letter to the DX-Clubs and Bulletins of the World - from Richard Wood

I wish to thank all the many DX papers, in six countries, which kindly published the "Open Letter" written last summer by Victor Jaar, Cesar Objio and myself.

The following letter expresses my own thoughts, not necessarily those of the A.N.A.R.C. CSL Committee or of any club or group.

Some DXers and bulletin editors have claimed that, due to trickery and malpractices, the QSL has lost all or most of its value. This is untrue. The value of the QSL will stand or fall with every value and every concept in our hobby. If our hobby fails, it will fall completely or not at all. Receiving, reporting, verifying, sending tips to clubs, etc. — all will fall together...or else all will survive and maintain their standard. Not just survive; they must all improve!

For, in recent months, not merely false verifications, but false tips and reports have been featured, notably in an old, established, formerly respected European station's DX Bulletin.

The problem is not dishonesty on the editors' part. It is gullability and lack of discrimination, possibly an unwillingness to offend. But standards are standards, and an editor must maintain them. An editor must be an editor. He should know, for instance, that medium—wave propagation from New Zealand to Southern Europe at O200 GMT, 2 P.M. N.Z. time in the N.Z. summer, is impossible If he does not know this, he should not be publishing medium—wave tips at all.

The QSL the main problem? Never! Our hobby!s standards, and hence its very existence, are under attack, and we have a responsibility to our fellow-DXers; to maintain standards — in logging, in reporting, in verification, in every way. They all go together, and we all rise or fall together.

The 1968 editions of Medium Wave Guide, the World Radio-TV Handbook, and the Foreign Broadcast Information Service station lists are now available from their respective sources. Gordon Nelson, editor of the NRC's IDXD, has received the FBIS, updated to June, 1967, and made the following comments: "The new issue is very disappointing in its foreign 8C8 coverage...much of the information presented is far out of date (for example, they've still got Barbados on 785 — and they switched to 780 in June of 1966!). While there does seem to be new information here, it's our opinion that most DXers with 1966 editions needn't bother getting the new one..."

Your editor has received the World Medium Wave Guide, which shows considerable improvement in the format and information presented. The log is separated by reception areas, Africa, Asia and Pacific, Europe and Middle-East, South America and North America. More reliance, it appears, has been made on listener reports, in addition to station lists provided by the individual governments. Alistair Woodland has done a commendable job in presenting the European and Asia/Pacific sections, while Stewart Drake has compiled the North and South American sections. In a list on Page 5 is some of the new Pacific/Asia info, gleaned in a rather hasty manner this week. In summation, this log has become probably the best quick-reference guide for the foreign listener, and is useful to the domestic DX, since it includes a list of U.S. stations. Hopefully, the 1968 edition of WRTVH will include further data on the stations newly listed in the MWG.

Radio Libertad

From the "Establishment" Press, or more accurately, the Boston Record-American Sunday Advertiser magazine comes the following exchange in a question/answer

- Q-I understand there is a top-secret U.S. radio station broadcasting propaganda to Castro's Cuba. The station is called "Radio Libertad". Where is it and who operates it?-S.B.C., Cohasset
- A-"Radio Libertad" if it exists is so top-secret that nobody knows about it. It's unlikely that a new station has been created recently; probably you're thinking of Radio Americas, which broadcasts into Cuba from Swan Island in the Caribbean, or "Radio Free Cuba", a program broadcast from Miami, Key Sest, New York, and New Orleans until about seven months ago. The "commercials" are strictly U.S. government, and the sponsor — though it has never been said officially is the CIA." (Clipping from Ralph Vatalaro, 3r.)

In the November issue of Popular Electronics an article, "Clandestine Broad casters" by one Thomas Kent speculated (in fact, almost insisted) that Radio Libertad (reportedly 1400 kHz) was broadcasting from Andros I. in the Bahamas. The sole basis for this rather wild speculation was that the manager of ZNS, whe asked to listen for Libertad, stated he couldn't hear it; Kent then charged that the manager was withholding information to hide the Andros location.
