In regard to the argument that tapes should count incases of non-verifiers, just what is a non-verifier? stations have QSLed at one time or another and some of the worst verifiers suddenly started to verify at one time or another. a look at WHOT-1330 before Jerry Starr and Wes Boyd worked there. One of the worst verifiers for years and years has been HJED-820 yet I have three different veries from them for a single report. As an alternative, may I suggest either adding a third figure for number of stations on tape to your totals or counting "heard" totals rather than verie totals. Frank LaBelle - 319 Beaubien East - Montreal 326, Canada Greetings from Canada"s Metropolis! This is my first report to the East coast DX Forum, as I have Joined the IRCAonly a few weeks ago. So let me introduce myself. I turned 19 on Jan. 25 and am working as a grocery store messenger in order to gather the money I need to pay for a radio announcing course because I want to make broadcasting my career. I have been a DXer for about 8 years, now. I can still recall the thrill I experienced when I first heard WOWO & WBZ way back in '61. I had been trying to find a local station where I could hear some fine music; instead of hearing a local station I heard WOWO a station located over 600 miles away! Although there was some fading I nevertheless kept tuned to that station in amazement. quickly became interested in trying to log more distant stations. I ended up with about 20 out-of-town stations. I've gone a long way since I first became interested logging WOWO. I've now purchased decent receivers and those 20 stations have now become 233! I first heard of QSL cards in Nov.1967 & of DX clubs in 1968. So, 73's until next report. (Welcome to IRCA, Frank! I had to shorten your report in order to keep within the 15 line maximum.-MD)

CPC Results WFBR's William Hoos, Chief Engineer, writes that only 6 reports were received for their DX program. This compares with a regular 5 weekly. Reports were from Ontario, Canada; Missouri; Mich.; Penna.; N.J.; and Mass. So, IRCA members, either an awful lot of you already had WFBR verified or couldn't receive the program (interference was naturally heavy) or you just don't care. If you've already verified a station which conducts a test, you might drop a post-card telling them they were heard and explaining you've already received verification. At least the station will know somebody tuned in.

KURL-730 received reports from Gary Peterson, Oklahoma City, Oklahoma; Bill Block, Portland, Oregon; Donald K. Kaskey, West Sacramento, Calif.; and David Kulka, Greenbrae, Calif.

The new World Radio TV Handbook is out and is the best yet. There are 360 pages this year and the best part is that the Medium Wave Guide has been incorporated. The last 45 pages are devoted to listings of BCB stations by continent by frequency, although the North American listing omits many low-powered stations. An advertisement for the IRCA in the USA section on page 198 has already brought a number of requests for sample bulletins. The WRIH's ordered by surface mail should arrive soon.

As was mentioned previously, <u>The Principles of BCB DXing</u> will be reprinted soon. Attention authors: If you would like to add to or change the articles you wrote for the first edition, please contact me immediately. If anyone would like to write a new

article for the booklet, also please let me know.

The IRCA Achievement Award Certificates have been shipped to Percy Kesteven and he is mailing them out to members who have applied. If you haven't sent him your application yet, refer to the regulations printed in the 6/15/68 DX Monitor. Write to Percy at 13112 134th Street, Edmonton 44, Alberta. The certificates are printed in two colors on colored stock and measure about 8" x 11".

The Board will vote soon on a printed report form. If you would like to sug-

gest changes in the present form, please let me know soon.

As you know, the Board will also soon decide whether it will be the IRCA's policy to count tape recordings as verifications. There have been many comments in the bulletin on this matter, and here are some more facets to be considered before the Board takes a vote. Would the new policy be prejudiced against members who do not own tape recorders, and give tape-DXers an unfair advantage? Theoretically a DXer could verify (for example) 25 stations a night merely by recording the ID's. Should the tape contain a definite ID, or merely the mention of a key city, or a key country for foreign stations? Would a network (e.g., CARACOL in Colombia) be sufficient if only one such station is listed on the frequency? Should there be a minimum time segment on tape, e.g., 3 minutes -- or would the taped ID be sufficient, if lasting only 10 seconds? If tapes are counted as veries, should they be on a par with letters and cards, or should they be counted separately in verie totals? The Board decision will affect the achievement award program and DX Records.

Here are two further proposals to be sent to the Board soon:

1 Amend Article X of the Bylaws to the effect the annual convention shall <u>normally</u> be held on the 4th weekend in August, to avoid making this date mandatory.

2 Expand the achievement award series for countries to increments of 5, e.g., 10, 15,

20, etc. At present the series is in increments of 10 countries.

One of the most interesting developments in the hobby has occurred recently. The National Radio Club has converted from mimeographed to offset printed bulletins. As of January 11, the \overline{DX} News is printed in booklet form on $8\frac{1}{2}$ " x 14" paper folded once. The type size is decreased and more pages can be included at the same postage rates. According to Gordon Nelson, the savings of postage and elimination of ink, stencil, paper, and envelope costs (the bulletin is folded and stapled without envelopes) almost exactly balance the additional cost of printing. One of the advantages of their system is the ease of reproduction of graphs and drawings, which are planned for the near future. Apparently the NRC is continuing its established dues of \$10.00 per year 1st-class and \$7.50 via 3rd-class mail. A few bugs that have developed are expected to be taken care of soon.

ANARC Report

A number of amendments to the ANARC Constitution and Bylaws have been proposed and voting among the reps is in progress. The complete documents, as amended, will

appear soon in the DX Monitor.

Jerry Starr's BCB Committee reports that WKNX is now verifying. The new ANARC Abbreviations List is near completion and it is estimated the cost will be \$1.00/copy. The New York State DXers Assn. has applied to ANARC for membership. Bill Sparks has been appointed as ANARC Parliamentarian. A mutual countries list compiled by ANARC and its European counterpart EDXC is in the fire. Also the possibility of a world-wide DX contest on the BCB, a la NRC simultaneous listening contest.

An ANARC financial statement as of October 20, 1969, showed cash on hand of

Logging Trans-Atlantic Stations by Gray Scrimgeour

"Reception of Trans-Atlantic stations on the BCB depends on location, type of radio, and reception conditions. If you live on the eastern seaboard, reception will be quite common and TA stations can be logged on even portable radios or car radios. On the West Coast, at the other extreme, a communications receiver is essential for TA reception and there are only a few days each year when conditions are suitable for TA's. Naturally, local QRM on cochannel or close slots will affect the receptions drastically. Dakar-764 was the only TA, for example, that I could hear in California with a 6 tube radio, because 760 was weak and 770 silent after 0300 EST (before KFMB moved from 540), and 764 fell in to a relatively slop free channel . The sunspot cycles (currently near the peak, and hence giving less frequent TA reception) is another factor which is very important for long east-west path reception (cf. previously published material correlating the geomagnetic index and the reception of TA's on the West Coast. Gordon Nelson of NRC has recently analyzed the geomagnetic requirements for outstanding reception, which would include TA's from the West Coast, and will soon be presenting a unified theory of geomagnetic effects in the NRC's DX News - an article of exceptional use to foriegn DX'ers. Briefly, it will show that an extended time of low AFr is neccessary for long DX paths east-west, and will further apply geomagnetic meisurements to all types of observed DX opening patterns.

On the West Coast, it has been observed that the best season for TA's is from September to January in the Northwest, and from October to December in California. Sunset reception is rare on the West Coast, with most loggings coming from 2300 EST to as late as 0400 EST. Farther east, in the mid-west and on the eastern coast, sunset reception of TA's is quite possible, and many TA's are heard on the east coast at sunset before cochannel interference from western domestics is a problem. The other peak listening time is, of course, the 2300 to 0300 period again. TA's have been logged in Ontario during the summer, even, but that is rare. Schedules for TA's in the WRTH should be consulted for s/on and s/off times, as at these times ID's are easiest; sometimes characteristic interval signals are broadcast.

Because many of the TA stations have low modulation, there will be many days when hets or open carriers (seemingly) will be all that you can detect. The European stations do not seem to me to have (with the exception of the Albanian on 1394, which uses a Chinese transmitter) the audio levels of the stronger TP's (eg., China 1040, the NHK powerhouses, and North Korea). But on the rare conditions to France are good (really good), then 1554 kcs. has a near-perfect signal. Normally, the French stations have good carrier, but weak audio, so watch them for indicators for other good stations. Reception here in Ontario is most common on the frequencies above 1500 kcs. There are many more evenings with high-end reception than with TA's all the way down to the low end. Because the high-end stations are propagated by a slightly different mode, these may be only more common in high sunspot years, but I don't know."

Gray also adds that most European stations are very good verifiers, but too many are automatic verifiers, so beware of thier value as a proof of reception. My guess is that it would be best to keep a good tape of a reception here. Also, here also, as in IA, it is best to write your reception report in the language of the station.
