IRCA Convention Auction The fourth consecutive IRCA Convention Auction will be conducted presumably on Sunday afternoon or evening. This year's auction will entail special problems for those planning on donation items to the auction. Because of customs, it will be more difficult to send anything by mail or even to bring it with you. As an alternate, it is suggested that those items you can not bring with you be donated by a proxy card, similar to the method used last year. If you have something you wish to donate, please fill out a post card with the item, your complete name and address, and whether or not the item will be postpaid to the purchaser. Please do not mail these cards at this time; details will be given next issue. Among the items that have been donated and auctioned are radio magazines, logs, WRTHs, club stationery, bumper stickers, surveys, and 'odd' items like beer-stained shirt, autographed deck of cards, a genuine part for a beer can vertical antenna, souvenirs of past conventions, etc. All proceeds from the auction go directly into the club treasury to be used in the manner decided by the Board of Directors.

Reception Reports With some space to fill up on this side of the form, it would seem appropriate to make a few more comments on reception reports considering the quality of those reports being obtained from radio stations for the membership committee. Report from Australia-Allen Evans, 4A Watson Street, Glen Iris, Victoria 3146. I have recently joined IRCA and received my first magazine this week. I particularly enjoyed reading DXWW, and hope that I'll be able to use much of the information in future. By way of introduction, I have been interested in both MW and SW DX for about 5 years, and in the post two years have restricted my DX activity to MW only. Australian Pirate Stations -- Allen Evans

Two new pirate stations are planned for operation off the Australian mainland in the near future. First news of these appeared in the newspaper this morning (Melbourne Age--April 25). One of these will be called "Freedom I" and will operate off the coast of Virtoria commencing on May 15. The station will be operated by Revolution Sound Studios (Melbourne), and will play Australian and English pop music. The reason for this is that Australian Commercial radio stations will be banning Australian and English records, from May on, because they refuse to pay royalties to the record companies. The record companies which distribute the records are therefore going to broadcast from their own pirate station. The frequency will be MW, but will be varied from day to day depending on the appearance of jarmers. Hours of operation will be 3p.m.-3am weekdays (0000-1200 EST) and Ban-3am (1700- 1200EST) on weekends. The other station will start within the next month and is also MW. This will operate from outside the heads of Sydney harbour. The vessel used is at present expected to be the Tiri II, which was used by Radio Hauraki off the coast of Auckland, N.Z. No other information available at present.

The RC Network: in Guadalajara: New Sophistication in Mexican Radio—Richard E. Wood Almost unnoticed over the last few years, Mexico has turned into a modern, industrialized society. A growing sophistication is evident in many aspects of Mexican life, and nowhere is it more clearly visible than in the field of radio. Technical standards are rapidly improving, programing is catering to new, more sophisticated and discriminating tastes, and a new sense of responsibility is felt both by the governmental authorities which supervise radio standards and by the station owners themselves.

Second in size only to Mexico City itself, and perhaps the most famous of all Mexican cities other than the capital, Guadalajara—the spiritual capital of the nation, home of the sacred Virgen de Guadalajara—provides an insight into the tastes of the modern Mexican radio listener and the way in which a network of stations has arisen to cater to them.

A single company, R.C., Radio Comerciales, S.A., headquartered at the intersection of Juan Manuel and Lopez Mateos avenues in the heart of the city, has established no less than 5 AM stations, plus an FM outlet, each with a distinctive format in the American sense of the term. Distinctive musical styles are programmed, catering to distinct social and age groups of the population. And, in a continent where, all too often, the provincial cities are totally overshadowed by the national capital, the R.C. network of Guadalajara has turned the second city of Mexico into the headquarters of a network of stations serving a large area of the country.

The stations of the R.C. Network in Guadalajara are as follows:

XEBA, El Gallo en Musica Mexicana, 820 kHz.

The rooster is the symbol of Ranchero music; it is bright, wake-up music associated with the morning hours. Hence, El Gall, XEBA, plays exclusively Ranchero music, Mexican country music. And it serves a country audience; it aims its music and its commercial messages at an adult country audience. The rural Mexican likes nothing better than to hear his own name on the radio; so most of the programing consists of request music, with personal dedications. News is broadcast at 1000, 1500, 1700, and 2000 EST daily.

XELT, Radio Tapatia, 920 kHz.

This is a city station, beamed to middle and lower middle class audiences. The music is Mexican, but more sentimental in vein. Love ballads predominate, with poetry intertwined. The appeal is primarily adult. News is stressed, with bulletins at 1000, 1500, 1700, 2000, and 2100 EST, and a complete newscast at 2330. This is a 24 hour station.

XEHL, Musica de Peque, 1010 kHz.

Music with a beat, beaned to "young people of all ages." Besides the music, which consists of current hits both Mexican and foreign, there is sports coverage: football (soccer), boxing, and bullfights. It is on the air 24 hours a day, is the most powerful station in the network (lokw), and thanks to its clear channel, is widely heard throughout North America and as far as Hawaii. Newscasts are at 1000, 1500, 1700, and 2100, with the big daily roundup at 2300.

XEAD, Radio Internacional, 1150 kHz.

Foreign hits are the specialty of this station, with the Beatles and other English-language artists the main fair. It is beamed to an urban, youthful, upper and middle class audience. On the air from 0800 to 2400 EST, the programing from 2030 till sign-off is entirely in English; the tourist market is catered to, also. News is heard at 1000, 1500, 1700, and 2000.

XETIA, La Cotorra Tropical, 1310 kHz.

As the name implies, this is a tropical-music station, with the thythms of Cuba, Venezuela, the Dominican Republic and other tropical countries. It is beamed to a lower, urban, middle and lower class audience. On the air from 0800 to 2400, there are newscasts at 1000, 1500, 1700, 2000, and 2100, and the daily surmary at 2200. Listeners are mainly adults.

This, then, is the varied and sophisticated fare provided by the R.C. network in Guadalajara. All this, despite strong competition from other stations in town, themselves affiliated to large, well-operated networks, including the local affiliate of XEW, Mexico City's leading station, XEWK. The promotional material of the

R.C. Network is very sophisticated indeed, carefully written and beautifully printed. 'Stan' Stanbury II has the following comments regarding the mention of the satellite on page 20, May 2 DXM: "The freq. announced by Radio Peking was 20009 kHz and during each of my two loggings (1908-1912 Apr. 25 while over European USSR, and 1337-1342 Apr. 26, position unknown) the frequency seemed closer to 20009 than 20014. Art Peterson's logging on 20014 may therefore indicate the transmitter was drifting somewhat. This satellite could turn out to be extremely important for all DXers as, technically speaking, it is the first BROADCAST station to operate from space, i.e., it is the first satellite to transmit program material (R. Peking's signature tune for 40 seconds out of each minute) intended for direct reception by the public. This could readily set off a chain reaction which would force all the other major powers into satellite broadcasting. Incidentally, on that weekend of the launch, Radio Peking provided more details on how to hear their satellite broadcasts than have been aired before by any SWBC station for any space vehicle - even more than R. Moscow provided on SPUT-NIK I. If the Chinese satellite does set off a chain reaction, it will drastically alter the whole structure of broadcasting."

Radio Northsea International Stan adds that this station has begun tests on 1385 kHz but there is quite severe interference from the Soviet outlet on that channel; it had not been heard by Stan yet.

WFEC Harrisburg, Pennsylvania 1400 kHz Quentin K. Brown received the following letter from William O. Kuntz, Director of Engineering, The Scott Stations (WFEC): "This station does not normally answer DX reports on frequency measurements programs. As far as we are concerned, it is a waste of time, since we are not interested in 'how far we get out.' We are interested mainly in our primary coverage area. However, since you did forward a second request for verification of your DX report, your report was correct."
