Tower Dollars Now Total \$12,960

(North Pole, Alaska, Nov. 70 - 'All-Alaska Weekly') Tower Dollar contributions to the North Pole radio stn KJNP totals \$12,960 this week, according to stn mgr, Don Nelson. The new 450' tower, to replace the one toppled by vandals 2 months ago, is being erected. Nelson recently returned via the Alaska Highway with the 50kw tx from a factory in Quincy, Ill., which will make KJNP the strongest radio stn in the state. No date has been set for the stn to start operating with increased power. Bad wx cx are preventing the stn from testing the equipment. Nelson said that the Tower Dollars, a fund to help the church sponsored stn recover from their loss, continues to grow. They are still \$19,000 short of replacement cost. Contributions to Tower Dollars come in from Fairbanks area residents and listeners throughout the state.

1970 ANARC Man of the Year is LeRoy Waite of Ballston Spa, New York. LeRoy is perhaps best known for his 17 years as editor of the Amateur Section of the NNRC bulletin. During those years, he built the section into the NNRC Bulletin's largest, and developed it to the point where it receives regular recognition from the DX Columns in $\overline{ ext{CQ}}$ and QST. The column is probably one of two in the world to have successfully dealt with amateur DXing on a listening basis, the other being the ISWL in Longdon. Roy continues to serve the hobby through the ARRL SWL Bureau. In 1957, Roy founded the bureau to handle the many cards coming in from hams to listeners. Currently the bureau handles from 100 to 200 cards per month, distributing them to SWLs. DX Census. A volunteer is needed to take over the census of DXers in North America not belonging to any ANARC clubs. This is the work that Dave Cheek, of the IRCA, began before his death. Several DXers have indicated a willingness to assist on the project, but someone is needed to supervise the work. (Contact Wendel Craighead.) Possible New Associate Member Clubs include the Rocky Mountain DXers Association and the Idaho DX Association (both headed by IRCA members, incidentally). Any DX organization may become an ANARC associate member for \$1 per year and mailing the club bulletin to ANARC headquarters. To become a full member, however, requires that a club have amminimum of 50 members.

1971 ANARC Convention. Those Interested in hosting the ANARC Convention should consider getting their bids together. IRCA has, in the past, volunteered to host a joint ANRAC/IRCA convention, but somehow the organizations haven't gotten together. This might be something for prospective 1971 IRCA convention hosts to consider, however. Section 1.- Frequency of Elections; Term of Office

Regular elections shall be held in odd-numbered years to elect the officers listed in Article V of these Bylaws, including the Chairman of the Board. All terms of elective office shall begin at 0001, Mountain Local Time, on September 15 of odd-numbered years (or, in case of replacements, at 0001, Mountain Local Time, on the date of the DX Monitor in which the results of elections are announced), and shall expire at 2400, Mountain Local Time, on September 14 of odd-numbered years.

Section 2 - By Whom Elected

Part 1 - The President and Secretary-Treasurer shall be elected by the membership-at-large. Each member in good standing shall have one vote for each office.

Part 2 - The seven members of the Board of Directors shall also be elected by the membership-at-large. Each member in good standing may vote for seven of the candidates seeking Directorships.

Part 3 - The Chairman of the Board of Directors shall be elected by the Directors on the Board in accordance with Article III, Sec. 6.

Section 3 - Eligibility to Hold Office

Any member in good standing, regardless of where he lives, shall be eligible for regular election to any office provided he has held one year's continuous membership in the IRCA as of April 15 of the election year. For purposes of special elections, the requirement shall be one year's continuous membership as of the effective date of vacancy of the office in question, such date to be determined by the President. It is not necessary for an eligible member's name to be printed on a ballot for him to be elected.

Section 4 - Authority for Elections

The Election Committee Chairman (ECC), appointed by the President and confirmed by the Board, shall handle all aspects of all elections of officers, whether regular or special, with complete authority.

Section 5 - Regular Elections: Procedures and Dates

Part 1 - The President shall be responsible for announcing in the DX Monitor full details concerning the upcoming elections approximately February 15 of election year.

Part 2 - Nominations shall be open for President, Secretary-Treasurer, and the seven members of the Board of Directors from March 1 through April 15. Only one nomination each for President and Secretary-Treasurer, and only seven nominations for the Board, shall be allowed each IRCA member. All nominations must be submitted in written form to the ECC by April 15.

Part 3 - As soon as possible after April 15, the ECC shall send to the Secretary-Treasurer a list of all nominees. The Secretary-Treasurer will return the list to the ECC as soon as possible, indicating which nominees have been members in good

standing for the required one-year period.

Part 4 - The ECC shall notify by letter all eligible candidates concerning their nomination by May 1. Each letter of nomination shall contain the names of all eligible members who have been nominated for the particular office in question. Such letters must stress that the nominee must reply in writing if he accepts the nomination, and each such letter must request from each nominee a campaign statement, not to exceed 15 stencil lines, to appear in a June issue of the DX Monitor.

Part 4 (Cont'd) - However, a nominee is not required to submit a campaign statement provided he has duly notified the ECC of his intention to run for office. An IRCA member may be nominated for more than one office, but he must decide for which he prefers to run and so notify the ECC. A nominee who has indicated his intention to run for an office may not be considered as a write-in candidate in the same election.

Part 5 - All letters of acceptance of the nomination, and all campaign statements, must reach the ECC by May 20. The ECC shall prepare the ballot and the campaign statements and submit them to the Publisher by June 1. Ballots shall contain spaces for write-in candidates.

Part 6 - Ballots and the campaign statements are to be mailed to all members with a June issue of the DX Monitor.

Part 7 - The deadline for receipt of ballots by the ECC shall be August 1.

Section 6 - Election of the Chairman of the Board

The ECC shall ballot the Board of Directors soon after each regular election to determine the Chairman of the Board, who will be the spokesman for the Board and will be responsible for assuming the President's office in case it is vacated during the current term. In the event the Chairman of the Board becomes club President, he shall be required to resign his Board position. No election to determine a new Chairman of the Board shall be required due to a change in the composition of the Board during the current term.

Section 7 - Special Elections of Officers

In the event the Secretary-Treasurer, the Chairman of the Board, or a regular Director on the Board resigns, or in any other circumstance requiring a special election of officers, a special election shall be conducted as soon as possible by the ECC, in accordance with the relevant procedures outlined above. If advisable, the various deadline dates fixed in Article III, Section 5 shall be altered by the ECC, but the relative timing of the various procedures will be retained.

Section 8 - Determining Winners

The seven eligible members who receive the most votes cast shall be deemed winners during a regular election of the Board of Directors. In all other elections, whether regular or special, the eligible member who receives the most votes cast shall be declared the winner.

<u>Part 1 - In the case of a tie in the balloting for President or Secretary-Treasurer, the Board of Directors (to be polled by the ECC) shall break the deadlock. In the case of regular elections, such deadlock shall be broken by the newly-elected Board members.</u>

Part 2 - In the case of a tie in the balloting for the Board of Directors, a run-off election among the persons who tied will be executed immediately by the ECC. In the event there is a tie in the run-off election, the elected members of the Board shall determine the winner. A deadlock in the Board voting shall be broken by the President, or in the event his office is vacant, by the Secretary-Treasurer.

Part 3 - In the case of a tie in the balloting for the Chairman of the Board, the President (or in the event his office is vacant, the Secretary-Treasurer) shall cast the deciding vote.

Part 4 - In case no persons are nominated to fill the office of President or Secretary-Treasurer, or in case fewer than seven eligible members are nominated to the Board of Directors, and

4.2-15. Following is the (annotated) proposed amendment to the IRCA Bylaws: "Article V - Officers and Duties

Section 4 - Replacements

Part 1 - If an IRCA officer's membership in the IRCA expires during the current term and he fails to renew it within two weeks, he will be deemed to have resigned his position. Part 2 - Should a Director on the Board fail on two successive

occasions to communicate to the President his vote on club business within the period prescribed by Article V, Section 2, Part 3 of these Bylaws, he will be deemed to have resigned his position.

Part 3 - Should the President resign, the Chairman of the Board will immediately assume the Presidency for the remainder of the current term.

Part 4 - Should the Secretary-Treasurer or any Director on the Board resign, a special election shall be conducted as soon as possible in accordance with the procedures outlined in Article III of these Bylaws, provided at least six months remain in the current term. In the event the Secretary-Treasurer resigns, the Cahirman of the Board shall assume his duties on a temporary basis until the new officer is elected by regular or special election.

Note that Article V, Section 3 was deleted in the proposed redrafting of Article III. Thus the above section dealing with replacements would become Section 3, and there would be no section 4.

After spending the past MM trying almost vainly for some of those elusive foreigners, I have decided that my problem is that I don't know enough about the condition of the frequencies as far as foreigners are concerned. Synchronous Transmitters

Several weeks ago I raised a couple of questions about anychronous transmitters (particularly those of NHK) on the same frequency. Both Richard Wood and Don Kenney replied, although on different aspects. Richard answered the immediate question at hand: "Yes, they are synchronized with network programming; however, twice during the evening hours, once at sign-off after the Anthem, all give individual local ID's, followed by a varying number of repeats of the network IS (each cutting audio and/or carrier at different times)."

Don's answer dealth with the effective power radiated by a group of synchronous transmitters. Since I should have realized that what I said was not entirely correct, I want to thank him for refreshing my memories on this point. To clarify his answer for others, a bit of wave mechanics is needed.


In simple terms, a point source of waves, S, sends off waves in all directions at the same rate of speed (the speed of light in the case of radio waves). Suppose that a second point source, S', is producing waves of the same wavelength as those from S and in phase, i.e., a crest of a wave is produced at the same instant by both surces. Suppose you are the same distance from each source. Then each crest (or trough) produced by S will reach you at the same time exactly as the corresponding crest (or trough) produced by S'. The effect will be that of adding the amplitudes (sizes) of the two waves, producing a wave twice as large as each one individually (supposing them both of the same size initially). (Figure 1). If you were one wavelength (or any whole number of wavelengths) further from S' than from S, the effect would be similar, except now the strength of the signal from S' would be weaker because of the extra distance. The effect still would be still a strengthening of the signal, but not to the same degree as when you are equidistant from S and S'.

However, suppose that you are ½ wavelength (or 3/2, 5/2, ... wavelengths) further from S' than from S. Now the waves from the two sources are out of phase, i.e., a crest from one source would reach you at the same time as a trough from the other source. The effect would be to diminish the strength of the signal, through destructive or sub active interference. The two signals would cancel out (if they initially were both of the same strength and the distance to the two sources is approximately the same distance); you would be in a null. (See Figure 2). If you were somewhere in between being in phase and completely out of phase, there would be a slight increase in signal strength over the strength of one source alone. (Fig. 3)

All directional stations use the principle of destructive interference to produce a pattern which blankets their primary coverage area efficiently while sending out very weak signals in other directions to prevent interference with stations in those directions. This is accomplished by two or more towers properly spaced, and by phase delay in the signal sent to the various towers.

Basically what has been described above applies to the original problem of synchronous transmitters. The big difference is, of course, that the sources (or stations) now are many miles apart, instead of sources (towers) approximately a wavelength or less apart. Don comments as follows, "I think that the effect of receiving several synchronous transmitters on the same frequency is a lot more complicated than just adding the powers...Considering the distances involved for most DX stations plus the fact that minor changes in the height of atmospheric layers, etc., will affect the pahse relationship, it's hard to predict what the effect would be.

"I suspect that for a very large number of synchronous stations, the average effective power would be something like the square root of the sum of the squares of their powers, but that's just a suspicion based on the fact that a lot of things work out to answers like that. I doubt that I could work out the math to derive the real answer, and I'm not about to try."

Pirates- Terry Greenhill, Hertford, Herfordshire, England
In the November issue of "Medium Wave News" it stated that the RNI ship, "Mebo II'
is to broadcast from the coast of Africa. Likewise in the "monitor" the publication
of the International SW League, the Mebo has been sold to a Moroccan gent! To make
the matter more mysterious, in the music paper, "Disc" of 11/14, in an interview
with RNI's manager, Larry Tremaine, he still states that the Mebo II has not been
sold, is still up for sale, and is still anchored off Holland with all DJ still on
board. The owners of RNI, Miester and Bollier, are to be in Hamburg on 12/2 for the
auction of the ex-Radio London ship, the M/V "Galaxy". The Balaxy, and old US minesweeper, still has the studios and transmitter on board; if anyone is interested
it can be theirs for \$54,000.

Capital Radio's ship, the M/V "King David" went aground at Nordwijk, some 20 miles south of Amsterdam, on the evening of 11/9. This ship, which had battled against a Force 10 gale, was soon attended by a Dutch Lifeboat which took off 5 woman and a man, all DJs. The captain and crew stayed on board.

The French government has refused to broadcast anymore "Radio Geronimo" programs over Radio Monte Carlo. It seems that the London-based Gernnimo owes the French ± 300 for their broadcasts. A new station "Radio Monte Carlo International" was to have started programmes over Radio Monte Carlo on 11/13, but as yet (11/15) nothing heard. Like Geronimo, R. Monte Carlo International is British based and employs some of the BBC's Radio One DJs.

Finally, Terry asks if anyone can trace a VOA station heard almost nightly under Bucharest, Rumania, on approximately 755 kHz. It doesn't seem to be in any of the lists. It seems to come from the Mediterranean area.

Congo The Congo will soon acquire the most pewerful voice in Africa, equalled only by Egypt. Completion is due shortly of a 600 kW radio transmitter, equal in power that that of Radio Cairo. It will surpass the VOA, R. Moscow, and R. Peking facilities on the European continent. (Associated Press, via Glenn Hauser)

Bermuda Bermuda's only daily newspaper and the island's only two radio stations were fined a total of \$5600 and three newsmen associated with the companies were fined a total of \$1500 after being found guilty of contempt of court for publishing a statement from the Black Beret cadre, a militant black youth group. The statement which referred to the colony's magistrate court as a "Fascist kangaroo circus" was issued last month during the disorders after a leader of the Black Berets was sentances to six months in jail for taking part in a flag-burning incident. Capital Broadcasting Co, which operates radio station ZFB, was fined \$500 for broadcasting a condensed version of the statement and the station's news director, Ira Philip, was fined \$250. The Bermuda Broadcasting Co., which operates station ZBM, was fined \$100 and its night news editor, Percy Ball, was fined \$50. (Globe and Mail, Toronto via C.M. Stanbury II.)

England The manager of Radio Leeds has ordered his news broadcasters to wear diner jackets at the microphone after 5 PM even though their audience can't see them. The 35 year old manager of the Yorkshire outlet for the BBC, Ray Beatty, says, "An announcer is influenced by his firess. If he wears a sweater his reading may be sloppy." Beaty says the announcer will be paid a dress allowance and he has no plans to take formality any further." He ways, "I will not, for instance, insist on short hair." "I did think of insisting on morning suits for news bulletins during the day, but that would be unfair to those starting work at 5:30 AM". Angus Turner, who reads the news on Radio Leeds most evenings, approves of Beaty's order, saying "Wearing the right clothes gives you a sense of occasion and definitely improves the news reading". But another newscaster, David Williams, says it is a "waste of time" and has called a union meeting to fight the regulation. The BBC says it has no rule about dress, and regulations for local stations are the responsibility of the station manager. Last night, one of the BBC's top TV newscasters, Jimmy Kingsbury, appeared before the viewers in a pink shirt, pink and purple tie, flecked gray trousers, blue jacket, blue socks, and buckskin shoes. (A news service AP?, via GH)

England Radio Carolina is a new station about to start operation in East Anglia. The broadcast is planned to come from Reach, a small Cambridgeshire village. According to Mr. Leonard Warren, a member of Newmarket Rural Council, the village was granted the right of self-governemtn in 1201 by King John. Mr. Warren, self-appointed successor to the last "ruler", claims Reach is still entitled to the status of an independent kingdom. He has given Radio Carolina permission to broadcast from his "kingdom". The population of Reach is 269. Seventeen-year old Chris McCarthy, a programme director of Radio Carolina, claims the station is ready to go on the air. Several thousand pounds have been spent on equipment. The ministry of Posta and Telecommunications has been asked to provide a wavelength, but have not done so. (SCDX)
