CBXQ-540 revisited Repeating last issue's item, CBXQ-540, according to verie, will increase power from 40 watts to 50 watts, per Steve Kamp. The correct spelling is Ucluelet, not with E; your pub's mistake entirely.

KREL did air the DX program until about 0730 EST, starting at 0300 EST. The program was pre-recorded on cartridges except for live news and some comments. 500w night pattern was used. Program was definitely received in Seattle by Chuck Albertson (per phone comparison of programming) but very poorly. Not heard by Mike 'DOC' Hardester in Modesto. Conditions were as poor as could be possible with bursts of thunder every so many minutes, something unusual in SoCal. And Pub Hdq was pelted with semi-snow. Request for phone calls to stn at about 0430 EST was without results; later collect calls were requested; results same. Reports are wanted whether you desire a verie or not; the stn would also like to know if KEEN was on the air. There is a chance the program will be conducted once again when conditions are better. Program was done by Beautiful Bob "The Boob" Brulte (chief announcer and soon-to-be IRCA member), Steve "Sadistic" Simonsen (who prepared segments on DX in each of the 3 IRCA regions), James R. "Periquito Rojo" Miller (responsible for SS IDs & CE) and Bill G. "Billy Boss-Jock" Powers (who taped a 15-minute article on sending reception reports). Everyone at the station had fun; a successful program even if no one heard it. Pobre Guillermo! -CENSORED

NEW RADIO NETWORK As earlier predicted by radio tradepeople, a new "underground" or "alternative" radio network will soon be a reality. The FIFTH ESTATE RADIO NETWORK will provide sixteen newscasts a day for contemporary and underground stations, beginning early next year. Feb. 1, when operations begin, 12 Calif. stns will be on the line. Full national operation should commence by Sept. Programs will consist of hard news, interspersed with topical satire and music. Anchormen will include former ABC-TV host Les Crane. FIFTH ESTATE's network studios are located in Los Angeles. -via Dave Alpert, source unknown.

PRIVATE CANADIAN RADIO NET OKAYED The Canadian R-TV Commission has okayed formation of the first privately owned radio network in Canada. Though there are many private stns, only the public-owned CBC is permitted to operate networks--FF and EE language ones. It has TV opposition, though, in independent CTV. The license won't be granted, however, till the US-controlled Famous Players Canadian (51% owned by Gulf and Western-controlled Paramount Pictures) has sold all but 20% of its 50% slice of Television de Quebec, which plans the new network. It will have only three stations at first---but they'll include one in Montreal and another in Quebec City; the third is in fair-sized Chicoutimi, Quebec.

San Francisco (UPI) - A high power radio beam RADIO BEAM HEATS SKY HIGH OVER COLORADO aimed at the Colo. sky has heated up a portion of the upper atmosphere 185 miles above the earth, a government scientist reported 11/30. Dr. William F. Utlaut, deputy director of the Commerce Dept's Inst. of Telecommunication Sciences at Boulder, Colo., said the 2 million watt beam raised temp's by 30% over 2700 square miles of the ionosphere. He said the skywarming experiments, started last April, caused some odd changes in the upper sky. The heated zone expanded like a 60-mile wide bubble and emitted more infrared light than usual while radio echoes from the bubble became unusually fuzzy. The ionosphere is a region of spare, electrically charged air molecules which begins 30 miles above the earth and merges indefinitely with space. At 185m, radiation from the sun strips electrons from the sparsely scattered air molecules. The resulting ionized gases form a thin shell around the earth that reflect low-frequency radio waves and make round-the-world communications possible. Utlaut said the effects of heating the ionosphere quickly dissipate after the transmitter north of Boulder is turned off. It is used only for brief intervals, he said.

Oriental language heard at 1347, but the het against 1180 seemed to disappear at 1400. This coincided with the arrival of more local images here, so can't judge whether VOA has a unfavorable antenna change at 1400. (GM)

THE DRAKE MODEL SPR-4 COMMUNICATIONS RECEIVER

-- By Percy R. Kesteven

As this receiver is very new (having only been out for about a year) this review of it will be quite extensive.

MANUFACTURER: R.L. Drake Company, 540 Richard Street, Miamisburg, Ohio 45342 PRICE: \$449.00 U.S. for the receiver, \$65.00 for the optional noise blanker, about \$20.00 for the crystal calibrator, \$5.00 for each additional crystal, \$5.00 for the DC Power Cord (for running the rx off the car battery). Other

options include a loop antenna, transceive adaptor, and speaker.

CIRCUITRY: All solid state with single and dual gate FET's used throughout the signal path.

FREQUENCY COVERAGE: 150 to 500 kHz and .5 to 30 mHz (latter in 500 kHz bands). One crystal is used for each tuning range.

MODES OF OPERATION: AM, CW, SSB (upper and lower) A product detector is used on SSB, making the tuning of that particular mode easy.

- 4.8 kHz @ 6 db, 10 kHz @ 60 db SELECTIVITY: MSSB - 2.4 kHz @ 6 db,7.2 kHz @ 60 db

- .4 kHz @ 6 db,2.7 kHz @ 60 db

The selectivity is automatically selected for the operator when the mode of operation has been chosen.

Dual conversion on all bands. 1st IF 5645 kHz four pole INTERMEDIATE FREQUENCIES: crystal lattice filter, 2nd IF 50 kHz four pole Hi-Q Ferrite LC filter

At room temperature, drift for all causes (including # 10% FREQUENCY STABILITY: change in line voltage) is less than ± 100 Hz.

.25 microvolt gives 10 db S+l/N SSB and CW: SENSITIVITY: AM: .5 microvolt with 30% modulation gives 10 db S/N

AUTOMATIC VOLUME CONTROL: AVC on all modes. The attack and decay times are preset for optimum efficiency on each mode and are switched in automatically upon choice of modes. There is no way to cancel the AVC to MVC. Audio output is held constant to 6 db ever a 100 db range of input signals

CALIBRATION: Dial is accurate to better than # 1 kHz when calibrated to nearest 100 kHz calibration point

HUM AND NOISE: More than 60 db below rated output.

Those are the basic specs (as supplied by the manufacturer). With regard to my personal opinion on the performance of this machine, I can only say excellent. Of late I have been using it with the Worcester ferrite loop antenna (see below for review of that) and the results have been outstanding. Although somewhat confusing at first, the dial (consisting of two concentric transparent plastic discs which rotate at different speeds) gives extremely accurate readings. Each kHz is marked out and there is a distance of 1/8" between each marking. This means that to tune from one domestic channel to another (say 660 to 670) you must rotate the dial a good  $l_{+}^{\frac{1}{4}}$ "! Needless to say, tuning is simplicity itself and there is no need for a bandspread. The dial is linear, which means that the distance between one kHz at any particular point on any band is always the same. The frequency one is tuned to is read by adding the frequency on the Crystal Selector switch (a form of bandswitch) to the sum of the numbers on the two concentric dials. This takes getting used to at first, but after a few days at the receiver one is quickly "spoiled" and unhappy with any other arrangement which does not give direct frequency readings. It is possible to read in half-kHz too, as I recently logged an

```
unID SS on 1208.5, right next to KGYN-1210, Guymon, OK! This dial accuracy is
accomplished by the use of crystals for each band. Drake supplies you with 10
tuning ranges with the rx, including IW, all MW, and 7 SW bands. Although this is
not a SW review, SW signals every 5 kHz are noted often on "open" bands. The
stability of the rx is amazing-even when tuned to a critical SSB signal, banging
on the top and dropping the rx a couple of inches has no effect on the signal.
Also, warm-up drift is negligible. I have never heard any hum whatsoever on the
SPR-4, with or without an antenna connected, due to the well-designed power supply.
The AVC is mandatory--you cannot get rid of it. In almost all instances this is a
good thing, with the exception of strong locals. There is an RF gain control but
it appears to have no effect whatsoever on the rx's operation. Reducing the RF gain
makes no change in the signal until about 50% RF gain has been reached, then the
signal quickly dies. No doubt this is due to the AVC. The AVC is absolutely
fantastic in its performance. When one has selected a mode of operation, the AVC
setting for that mode is switched in. During the summer I often listened despite
the high noise levels. However, not once did a loud burst of static intrude upon
my tender ear drums -- the AVC cut in, reduced the static to the exact level the sig-
nal had been before (with a corresponding drop in signal strength, of course), then
slowly allowed the signal to fade in again. The noise blanker, while very expensive,
is a must for the BCB DXer. Unfortunately, I received mine after the T-storm sea-
son, so I can't evaluate it's effect on that type of static. On random atmospheric
noise, the blanker has no effect whatsoever. However, on all power line noises such
as clicks from light switches, furnaces, etc., it is 100% effective. I leave it on
all the time--the blanker cuts out the noise completely. On antenna noise of the
pulse type variety, it is also very effective. Many kinds of buzzes (and, on the
higher bands, ignition noise) are severely reduced or completely eliminated. In all
cases, there is no effect whatsoever on the intelligibility of the signal. Selec-
tivity is very good, mainly due to the type of circuitry and the frequency of the
IF stages. The SPR-4 features a notch filter--this filter is used to remove a cer-
tain narrow band of audio, such as the frequencies immediately around 2000 Hz. It
is continuously tuneable and will remove any band of frequencies. It can be used as
a kind of tone control, but its main function is the disposal of hets. Many a het
has been eliminated (with only the split DX signal remaining, along with a bit of
sideband splatter from the domestic channel). The rx has a built in preselector
which serves to set up the correct tuned frequencies -- no antenna trimmer is needed.
Sensitivity is excellent, and I must sing praises (as did CQ Magazine in its re-
view of the rx in November 1970 issue) of the Drake's signal handling capabilities.
These include a high resistance to cross-modulation, r.f. intermodulation, desen-
sitization of a weak signal by a strong one, overloading of the set by strong
signals, and blocking. CQ didn't mention which receivers were tested, but it
claimed that the SPR-4 equals or out-performs the signal-handling characteristics of
the two vacuum-tube sets which had previously set the standard. The crystal
calibrator option is not really necessary for the BCB DXer as he has so many sta-
tions to calibrate the dial. It is handy, though, for SW. Rarely will you find
the dial calibration out by more than one kHz over an entire band. Resetting is
easy. Fothing is perfect, and the Drake rx is no exception. I must criticize the
lack of control over RF gain and AVC (as explained earlier). The S-meter is the
most stubborn one in my experience. It seems to be heavily muted (by the way, it
is served by a special PC board complete with IC) and strong signals move it not.
With the Worcester loop higher readings are had, but above about an S-5 the meter
responds to the audio or modulated part of the signal. I cannot understand why
Drake ever let this particular flaw pass inspection as its disadvantages are ob-
vious. The headphone jack, located on the front panel, is located between two con-
trols, making access to these controls awkward unless a 900 phone jack is used.
Judging from my experience, I would certainly not recommend purchase of the Drake
loop antenna for use with the set. Basically it consists of a single turn of wire
on a frame 18" by about 30". The loop is untuned and plugs into a special socket
in the top of the receiver. Although it hooks into a special loop amp, I found
    many many dead channels on my set when using it. All that I logged were
locals and very strong semi-locals. Graveyarder DX? -- forget it! So either build a
box loop of your own or buy the Worcester loop or use a long wire-- the loop is not
recommended ... i You will find the DC power cord very handy if you want to take
```

both car and rx out from under the locals to get some new stuff.

Well, I hope that this report has given you an accurate run-down on the set. I trust that it was technical enough for advanced DXers and simple enough for beginning ones. As you have gathered, it is my opinion that this machine has to be one of the hottest sets on the market today. Maintenance has been minimal—my local dealer gave me a replacement pilot light for one which flickered, hi. Please write me (address below) if you have any questions about the set.

### THE WORCESTER FERRITE LOOP

### --By Percy R. Kesteven

The worcester Ferrite Loop Antenna is an idea conceived by Joe A. Worcester, R.D. 1, Frankfort, MY 13340. I gather from talking to Joe by LD that he was once a design engineer for GE. In a February 1970 DXM Joe laid out plans for building and experimenting with a 12" ferrite bar available for \$5.00 plus postage from him. Joe has another article on how to build a complete loop and amplifier on tap at pub. HQ--it will be printed soon. I purchased a complete loop, assembled and ready to go, from Joe. The cost was \$29.50 plus postage. (Joe also has an illustrated sheet on the loop available on request.) Loops are available (from Joe) to anyone.

With regard to workmanship and layout of the loop, an excellent job has been done. You can get the loop complete with a base, but I had a tapered piece of wood made on a lathe. This piece fits into a standard mike holder on a mike stand and leaves the loop at just the right hight. It's easy to rotate it when sitting down. The loop itself consists of a ferrite bar 12" long and  $\frac{1}{2}$ " in diameter. The bar rests on a cork cushion along its length and the whole thing is secured by means of nylon cord to a phenolic base. An aluminum shield covers the other sides. Total dimensions are 12" x 3" x 3". The bar is wound, with the windings going to a two transistor amplifier mounted inside the box (which is open at each end). The amp is shielded. Outside the box is a battery holder (for a standard 9V battery), a vernier tuning dial, and two switches. One turns the loop on and the other cuts the amp in.

What about performance? Well, with the SPR-4 any antenna's output is fully utilized. The Worcester loop (I hope Joe doesn't mind me calling it this, hi) has sharp peaks and deep nulls. The vernier tuning ratio is needed as each frequency requires separate tuning. Nulls on some clear channels are so deep that only atmospheric noise remains. On regionals it is easy to null one or the other of two stations at 90° and, with a little more effort, one can read three stations on such a frequency by getting rid of the others. The high-Q means that it's very easy to copy stations right next to locals (i.e. 10 kHz away). Splits are also easy-Belize-834 is in every night like a ton of bricks, despite a good signal from WHAS-840 and a very strong one from WCCO-830.

Speaking comparatively, does the Worcester loop equal or beat other antennas? Here is a comparative rating. IN is long wire, 300' in length and in a triangular shape making it omni-directional. DCL is a direct coupled loop (as designed by Fish). WL is the Worcester loop without the amp on, and WLA is the Worcester loop with the amp on. All readings are in S-units.

Taking a typical signal such as the Belize one, we find that the IW picks up every click, buzz, and scratch available and has a poor signal to noise ratio. The DCL does better, but the WL outshines them all with very quiet reception and a susceptibility only to the most local QRN.

Do you need a Drake SPR-4 to get full use out of the Worcester Loop? Not at all I have a Philips (U.S. name is Norelco) standard table radio (an All-American Five) which has an antenna and ground connection. With the WL it picks up a signal on nearly every channel. These radios are not noted for selectivity, yet it picked up 1250-CKOM Saskatoon, Saskatchewan, in null of local CFRK-1260, 50 kw, (tower 2 miles away). It also logged CJIB-940, Vernon, B.C., in null of local CJCA-930, 5 kw.

What can I say in conclusion? Just that the Worcester loop looks like a very hot item—should be interesting for someone to compare it with GPN's FET Altazimuth Air Loop. Let me second Art Peterson's comments in a recent DXN. The Worcester loop, compact, directional, hot? (Percy R. Kesteven, 13112-134 Street, Edmonton 44, Alberta. I'll be glad to answer any questions you may have.) -end 12/19/70 DXM.
