Hi! I received a letter from Joseph W. Jones of WDEL Radio. He said that the results of the DX test were "somewhat disappointing". There were about 25 reports received altogether from OH, NJ, MO, MI, IL, VA, NC, FL, ONT, MA, PA, IN, & NY. OH sent the most. I have two new freq. checks to report, the first being from WHLW in Lakewood, NJ. WHLW will have a monthly f/c every 4th MM between 0530-0545 w/1 kHz tone & IDs will be given every minute. The 2nd is from WIDG in St. Ignace, MI. They will hold their monthly f/c's every 2nd WM w/tt's beginning @ 0000 & ending @ 0015. All of the above info was received direct from the stns. There was a typo in my last report which stated that I had 16 foreign countries hrd instead of 16 foreign stations hrd. Thats all the info I have so 73s & good DX.

<u> Thomas R. Sundstrom - Box 205 - Willingboro, NJ 08046</u> Have been able to do only a little DXing, a LA & TA opening on 3/23 producing good signals from all the regulars plus an unID SS on 1017 which was not YSC & probably not CMAC 1019. Info to DXWW, ideas on the 1017 stn appreciated. Had a week-long cold around 3/29, so only MM DX was via tape; one brief ID on WISE on 3/29 DX. Was a bit disgusted w/cross modulation problems when tuning splits, so I borrowed a scope & r.f. signal generator last weekend & realigned the HQ-150 & the B&W #730 SSB receiving adaptor. Significant improvement in selectivity & sensitivity, particularly on 10 & 11 meters. Oddly though both on-the-air receptions & on the test tench w/the scope show the HQ-150 to be more sensitive in the crystal position #1 than w/the se_ectivity off; yet the i.f. curve does not move (except getting more peaked) as I increase 1 thru 5 on the selectivity control. one explain it?

Not too much happening except that DF has struck again so that we have to retype a portion of the EC sections over. How about everyone sending in rpts. to the DXFs this summer telling about their locals? -Brh

MATERIAL FOR WCDXR

- It was requested a few issues ago, that editors disseminate exactly what was desireable material for their columns. As long as I edit the WCDXR, I would appreciate the following requests be remembered when reporting:
- 1. No clear channel stations. A clear can not be classified as DX.
- 2. No UNID stations. They are usually on local freq's, when <u>anything</u> might be possible, and I think that it should be good policy to hear the call before the station is logged. There are too many "maybe's" possible.
- 3. \underline{DX} rather than a great ammount of stations. I'd rather get three good ones than fifteen poor ones.

MATERIAL Cont.

- 4. Reports be in <u>frequency order</u>, and neat (readable) they may be on postcards, beer cans, whatever, just get them in.
- 5. Current DX. DX that has been sitting around for weeks decreases in value as time goes on. This is the reason for going weekly in the wintertime.
- 6. As a rule of thumb, remember the WCDXR is to help your DX friend elsewhere, <u>NOT</u> to show off all the stations you've heard in a week. Also, I make mistakes, so expect them. This past period while I've been editor has seen roughly 10% carry the load for the West Coast. You might also remember the IRCA is what you make it. Report!!! (I am told 10% is a excellent turnout for a column of this type thanks!)

The system will derive its income from spot advertising between programs and will becontrolled by the Independent Television Authority which already runs the commercial TV rival to BBC. India A Yugcslav-made powerful MW transmitter has been set up at Rzjkot (Gujrat) for services beamed to West Pakistan and Western Asia. (WRB) (No frequencies listed)

Pakistan According to press releases, a new Mw station is being set up with Russian collaboration at Islamabad. The total cost will be 4.2 million dollars. (WRB)

International Waters Radio Sovereign is expected to be back on the air on April 1, operating on 1324 kHz, from the motor vessel Osbian. Address is Schipperstraat 1, Scheveningen, Holland. Capital Radio on 1115 kHz is expected to be back on about the same time, from 0500-0100 GMT. (WRB)

British Clandestines The following belong to the Independent Radio Association, 91 Park Street, Hcrsham, Sussex, England: Radio London, 1125 Khz; Galaxy Radio, 1136 kHz; Radio Horsham, 1115 kHz; Britain Radio, 1180 and 1385 kHz; Radio Ajax and Radio Reigale on unknown frequencies, and Radio Malvern on 1000 kHz. Radio England operates on 1299 kHz with a power of 300 watts from 0900-1300. Radio Free Caroline operates on 1430 kHz from 0900-1300. (WRB)

Monaco Prince Rainier and the French government are putting up \$2.4 million to launch a commercial station beaming pop music at Britain. It would compete directly with the BBC, and is expected to be extremely profitable since the BBC carries no ads. It would be a 800 kW station. (Nyack Journal-News, via Tom Hartloff, 3/20)

In the movie Midnight Cowboy, Joe Fraveled from Texas to New York on a Greyhound bus listening to a radio all the way. Pon't you believe it! Voice of the Coast "Fact" Sheet -- C.M. Stanbury II

- 1. Voice of the Coast was first reported operating in 1966 on 6183 kHz. At that time its claimed location was Sharjah. But contrary to what was reported in the Feb. 27 DX News (and one section of NASWA's Frendx for March), VofC has never claimed to operate from Abu Dhabi. Further, the coordinates given by DX News for Abu Dhabi are in fact Sharjah's.
- 2. Three different radiomen, all of whom had been in Sharjah after VofC was first reported on the air (the last leaving in January 1969), all stated in writing that they knew of no SWBC station operating from Sharjah and, in fact, they did not believe any SWBC was located in Sharjah. At least two of these witnesses were active SWLs.
- 3. Witness #3 (in Sharjah from December 1967 through January 1969) noted that a MW Arabic station did transmit from Sharjah. This station and the RAF's Forces Radio Sharjah were, he stated flatly, the only stations operating from Sharjah.
- 4. In addition to the earlier 1966 report, a late 1968 SW logging was reported in a New Zealand bulletin (that would have definitely been while witness #3 was still stationed at Sharjah), and a January 1969 logging on 6040 kHz (same frequency as in the NZ report) were made by the editor of the Radio Club of Sweden.
- 5. Whatever the VofC's secret is (or $\underline{\text{was}}$), security was clearly on the lax side. However, after witness #3 had volunteered his original statement, he refused to answer

any further questions on the subject. Thus we don't know what ID the MW Arabic station at Sharjah was using.

- 6. VofC admits that they are <u>now</u> in the process of building a SWBC (and MW) transmitter site on the Trucial Coast (at Dubai); one which does not coincide with the originally claimed location.
- 7. VcfC's presently listed frequencies are, on MW, both 737 and 1250 kHz, and on SW, 6040 kHz.

Editor's note: It seems to me that all discussion of this station depend very heavily on hearsay—three mysterious radiomen, whose names are never revealed, and whose jobs in the Trucial Coast aren't indicated; a mysterious Arabic station in Sharjah whose call ID is unknown; all this leads me to take with a grain of salt anything said by anyone about this station. I hope that we do not hear any more about this until hard facts are obtained so that all this speculation about the 'secret" of Sharjah will end.

Mali-The Mali government has offered Malian Christians time on a new radio station in Bamako as soon as it starts operation. This will be one of the largest stations in Africe, expressly built by Red China for broadcasting propaganda. However, since the military coup of November 1968, the Chinese are no longer popular in Mali. (Family Radio News, via Tom Hartloff)

Okinawa The Far East Broadcasting Company has operated three stations on Okinawa under the American administration: one in Japanese for the local population, one in English for U.S. servicemen and their families, and a third broadcasting in Chinese to the mainland, 400 miles away. Discussions are being conducted with both the U.S. and Japanese governments to try to maintain these stations after the Ryukyu Islands revert to Japanese rule in 1972. No decision has been reached yet. (Family Radio News)
