5.1-1 A proposal that the Board approve the use of one entire issue to a discussion of antennas. Submitted by Mike Daniels. Defeated

5.1-2 Proposal that, failing the passage of 5.1-1, the IRCA publish a package of material on antennas. Submitted by Mike Daniels. Defeated

5.1-3 Proposal that the IRCA print DX Monitor on 3-hole pre-punched paper. Submitted by Robert Kramer. Defeated

5.1-4 Proposal that Mike Worst be appointed Domestic Station Changes Editor. The job would involve listing Canadian and U.S. station changes in DX Monitor. Submitted by Percy R. Kesteven. Passed

Proposal that the post of Editor-In-Chief be created. The Editor-In-Chief would be charged with the responsibility of examing all material submitted for publication. The purpose of this examination would be the seeking of material which violated IRCA Editorial Policy as currently stated. Such unacceptable material would be deleted. The Editor-In-Chief would be submject to the same conditions, including reprimand if necessary, as other editors. Usually the Editor-In-Chief would be the same person as the Publishing Committee Chairman for reasons of expediency. Commentary

(Thinking back to the days when I wasn't on the Board, and even when I was on the Board, I seem to distinctly remember something of a lack of understanding concerning the validity of Board decisions. In future, the membership can expect important proposals, such as 5.1-5, to be reproduced unabridged. This will help the ordinary member understand better, I hope, what it is that the Club Government is trying to accomplish. Also, again remembering earlier days, I was often puzzled by Board decisions, often unfavorable, on what seemed, on the surface at least, to be perfectly sound ideas. That is the purpose of this section, Commentary, which will appear whenever there are Board decisions which may not be clear to the general membership. It will list any views which I passed along to the Board for aid in consideration of submitted proposals, plus any Board feedback which I receive along with the Board member's ballot.)

Proposal 5.1-1 and 5.1-2 are good ideas but unnecessary ones. Don Erickson informed me that all material of value which has ever been printed on antennas is included in the New Member Packet. Hence, all members already have every available piece of writing on antennas. To have a special <u>DX Monitor</u> or "package" of new

writings on antennas would be impossible, due to the lack of authors.

Proposal 5.1-3, according to the submitter, would have cost the IRCA about 8ϕ extra be ream (500 sheets) of paper. IRCA could afford this. However, Don Erickson informed me that this figure would be true if we were still using the same weight of paper as was used several months ago. Using the current paper weight, the cost to the Club would be over 50ϕ per ream, a figure much too high.

Mike Worst, for several years now, has been listing the information from the FCC and CRTC in DX Monitor. Proposal 5.1-4 merely acknowledges this fact in a formal sense and gives credit where credit is due. Mike's work is deeply appreciated

by many club members.

Proposal 5.1-5, creating the new editorial post, and 5.1-6, naming an appointee, was one which was very carefully planned. I discussed its implications with many club members during my recent U.S. visit, as well as with the editors (see President's Report, October 23, 1971, Page 9). Richard Wood voted against 5.1-5 (and, naturally, 5.1-6) because he felt that it would involve an automatic redefinition of all the other editorial positions in the club and as such involves a change in the status of each of them. As such I am sorry to say that I regard your proposal as unconstitutional and must vigorously oppose it." Apparently, the rest of the Board does not agree with Richard.

The following positions are available in the Club. Applicants should express their desire to fill a vacancy by sending an IRCA Application Form to me. This form appeared in the September 18, 1971 DX Monitor or they can be obtained by writing directly to me. ALL APPLICATIONS FOR POSITIONS AVAILABLE MUST BE ON THIS FORM. It is the only way I can make sensible decisions when choosing the best applicant for the job.

Association of North American Radio Clubs Representative (closing date for receipt of applications is December 15, 1971) Standby Editor (closing date is December 15, 1971)

The ANARC Rep (our club has three) is charged with voting in ANARC elections. He holds one of the three ballots for our Club in every AMARC election. As such, the Representative should be actively involved in IRCA affairs and sensitive to the Club's feelings on such matters as may arise from time to time. the AMARC Constitution was printed a few years ago in DX Monitor and is probably available in the New Member Packets. (The reason for the vacancy at this time is the resignation of AWARC Rep Randy Seaver.)

The Standby Editor is a position in which the holder may be called upon at any time to type the stencils of any Forum, Roundup, or DXWW section in the Moniton Applicants should know how to type stencils and be prepared to take over any section at any time should an editor resign unexpectedly. Normally, the period during which the Standby Editor will operate during an emergency will be limited to about

two months at the maximum.

Miscellaneous

Those people who author special features material are reminded that said items are to be sent to Special Features Editor, John P. Lombardo, NOT to DEE.

DEE also requests that editors and committee chairmen DO NOT add Forum reports at the end of their stencils. This makes the stencils "dated" and they must be printed immediately to avoid obsolescence. This complicates publishing considerably. (Note: The aforementioned does NOT apply to DXF, DXR, and DXWW editors.)

I apologize for the fact that I am behind on some aspects of Club work. The Convention Bid, which should be voted on before the end of the year, will probably have to await a January election. Also, all editors and committee chairmen are supposed to be reconfirmed in their appointments in September. Some, those whom I know for certain are still active and interested, are be reappointed by the BoD in the November BoD letter. Others, of whom I'm not certain, are being queried as to their continuing interest in their post. They will be reconfirmed in December. All these delays were caused by the confusion in the changeover between Mike Northam and myself. All files have now been exchanged and things should run smoother in future.

Proposals Going to the Board of Directors in January

5.1-21 A proposal to more accurately describe the three reporting regions of IRCA. While in common usage, the terms "East Coast', "West Coast', and "Midwest" are in acurate as applied in IRCA. No geographer would agree that Arizona is on the west coast, Texas is in the Midwest, or Michigan is on the east coast. This can be rectified by renaming the respective sections "Eastern", "Central", and "Western", with corresponding abbreviations EDXR, EDXF, CDXR, CDXF, WDXR, WDXF. References in DXWW to the reporter's region would also be changed to "E", "C", "W". Submitted by Glenn Hauser.

President's Footnote: Glenn is referring, in his proposal, to the confusion over Arizona being west coast, etc. created by proposal 4.2-55 which designates that reporters are to base the criteria for the DXF and DXR sections they report to on the basis of longitudinal location and not time zones. Had your fill of mixed-up time zones? We may not be able to repeal DST, but the best way to cope with it is to employ GMT exclusively, year-round. I've kept my own MJ logs on GMT for the past 13 years, and believe me, it's the only way to go. It's an unchanging reference point, and it means the same thing to everyone, everywhere. If clubs such as IRCA would agree to list all times, domestic and international, in GMT, things would be much simpler for everyone in the long run. Also, it would eliminate the preferential treatment the eastern zone has long enjoyed. GMT is the language DXers should talk to each other, but of course it will always be necessary to speak local time with stations when arranging tests or sending reception reports. No problem there, and no more of this silly confusion twice a year when daylight shifting time comes and goes. For example, DEE's well-intentioned explanation at the head of the 23/10 DXM was wrong; the change takes place at 0200 EDT, 0200 CDT, 0200 MDT, 0200 PDT, etc., not all at once at 0200 EDT only for the entire nation. We can rise above all this -- by keeping our logs in GMT and reporting in GMT. Why not give it a trial? Remember what they say aboard the Soviet vessel "Ulan Bator": "UTIK" -- Universal Time Is Keen! (Your reports always make sense, Glenn. Wish all reports were done up like yours. Have given consideration to using"(sic)", but still undecided. -LDB) JOHN G. Pips vs. Chimes-- Glenn Hauser

There seems to be some confusion about the distinct differences between pips and chimes. For instance GM's question on BBC-1214 kHz in the October 30 DXWW. Pips, as those with precise chronometers will confirm, come just before the hour, and whatever their number or configuration, their only purpose is to signify that it is the hour, not which hour in particular it is. Thus the BBC's 6 pips (actually the Greenwich time signal) heard at 0600 do not signify that the local time was 6 AM. The same 6 pips can be heard at any hour of the 24 that the BBC relays them. The same goes for most other European and Asian stations. The final pip is precisely on the hour. Now, some stations, in addition to or instead of the pips, have chimes following the hour. These do in fact tell us the local time at the station. When BBC rebroadcasts Big Ben during the summer, for instance, the chimes are on BST, i.e., one hour more than GMT. In contrast to pips, which are invariably scientifically precise, chimes may vary somewhat and should not be taken as precise markers of 00:00, but instead as informing us which particular hour of the 12 it is. I hope this clarifies the matter. Editor's note: several people have asked for descriptions of the various TA and TP pips (and/or chimes, hi.) I haven't had the opportunity to sit down with Art Peterson's Asian tape and do this. I'll try to do it soon. Perhaps one of our EC members could do the same for the TA stations that have pips and/or chimes.

Polar Night Reception-Gene Martin

The winter period when the sun lies far down below the Equator offers DXing opportunities that are probably missed many times because the DXer fails to understand how darkness and daylight are located on this planet at a given time.

Worse yet, it is even probable that fine DX catches have been achieved, but went unrecognized and rejected, because of this lack of understanding.

To make it specific: Murmansk in the USSR, 150 kw at 656 kHz, is located at 69 degrees, North. Murmansk lies in the Polar night, with no sunrise, no sunset, all the way from Nov. 26 to Jan. 16. So between these two dates every year, the DXer should realize that he has a path of darkness to Murmansk at any time when it is dark at his location. During periods of fine high latitude reception, Murmansk is surely worth looking for anyplace in the U.S. right up to the time of your local sunrise.

By strange coincidence, another fine DX target which spends time in the Polar night is also on 656 kHz, the 50 kw station at Verkhoyansk, Eastern Siberia. Verkhoyansk, at 67 3/4 degrees North, lies in the darkness from Dec. 4 to Jan. 9, and between these dates a U.S. DXer ought to realize that he has a path of darkness to it, beginning with his local sunset.

One fellow who probably had Murmansk at one time, but ruled it out as a possibility was Larry Godwin, on Jan. 5, 1970. (See DXWW, Jan. 24, 1970). The time of Larry's reception was 11:13 AM in Murmansk, but I think Larry didn't realize that Murmansk was quite dark at that time, and that it was, in fact, the only conceivable TA he might have been hearing.

Editor's note: There are several other stations which are located north of the Arctic circle. At least one of these, Thule, has been reported fairly often. After researching the Asiatic Russians, I have found that there are several which are considerably closer than Verkhoyansk, and thus should be even easier to hear on the West Coast. They have not, however, to my knowledge, been reported in North America. Verkhoyansk, of course, has been reported several times this season already.
