The latest information on special MW DX test broadcasts will be included. This is a pilot, and if there is sufficient listener response, it may become a regular feature on 800 kHz--the only MW DX program in the western hemisphere. Clerical Error In copying a report here a couple of weeks ago about Radio Bangadesh, I added city names to the listed frequencies. Later I realized that Karachi is in West Pakistan, not Bangladesh.

Caribbean Countries -- Mike Worst, Country List Committee Chairman The Netherlands Antilles includes the ABC islands, Saba, St. Eustatius, and St. Maarten. The last three are referred to as the Netherlands West Indies because that is what the people of the ABC islands refer to them as. The Netherlands Antilles is a single government in equal partnership with The Netherlands, but the ABC islands are also well within the 50 mile separation of each other.

The British West Indies islands listed in the country list all have their own governments and are considered to be independent from each other. The one exception is Carriacou, which is administed by Grenada. They are well within 50 miles of each other.

C.M. Stanbury adds the following: From short wave monitoring I have learned that the station inGrenada is now identifying as R. Grenada instead of W.I.B.S. This would seem to indicate that either the Windward Island Broadcasting Service is defunct or drastically revamped. The individual political units of the Windward Islands don't count as separate DX countries because of the distance between them but because each is administered as a separate semi-independent state (I think the official term is Associate State) while the Netherlands Antilles are all administered as one from the capitol Willemstad.

Radio Northsea International On 12/19, RNI closed its World Service. According to a statement by Mr. Edwin Bollier of Zurich, a new world service will commence on the first Sunday of February on 1115, 6205, and probably also on 9935 kHz. This service will be on the air on Sundays only. On weekdays the MW transmitter will serve only as a standby for the transmitter on 1376 kHz. (SCDX)

Clandestine Khalistan Radio started operating on 1050 kHz on 12/13 with a daily program in Punjab at 1215-1300 GMT.It claims to be located in Indian Punjab and is operated by Sikhs. Reception is good in West Pakistan. (SCDX)

Qatar Qatar Broadcasting Service, P.O. Box 1414, Doah, Qatar, has started a program in English at 1200-1300 on 675 and 9570 kHz. (SCDX)

Swazi Radio -- C.M. Stanbury II According to a South African/Rhodesian press eport (authored by one David Earritt) Swaizi Radio is scheduled to go on the air February 1 at a site just 400 meters from the South African border. Daytime coverage of the Republic will be accomplished via a 49 meter transmission, but they are counting primarily on MW reception at night (according to Glenn Hauser, the frequency will be 1376 kHz). The station is somewhat uncertain about their Cape Town coverage and, according to this account, "are prepared to bukld another transmitter beamed directly at the city if quality is not good enough". Included on the Board of Directors of Swazi Radio are General J.P. Gaus (former Commissioner of the South African police) and Natie Kirsh (a Swaziland real estate "tycoon"). The station will be on the air from 0400GMT to 2200, 2300 weekends. The Barritt account also states, "The SABC recently took over LM Radio (the commercial service of R. Clube do Mocambique--CMS) and so just at a time when it seemed they had eradicated their main competitoor, they face a new competitor based 100 miles nearer the Rand". Swazi Radio will carry no news. Their General Manager, Peter McIntosh, is quoted as saying they will "ensure that no objectionable music is broadcast, but, unlike the SABC, would not censor pop music".

Finally heard Haiti clear enough to be able to send a report. Funny thing wer that Grant Manning heard 4VEF on 830 and 9770 but couldn't get 1035; all I got, about 7 miles from Grant, was 1035 and not the other two frequencies. XEGM-950 has cleaned up its transmissions somewhat, but still is overpowering. I spent some time this past week indexing all foreign reports since June. It's strange how some stations which you might expect every foreign novice to report just haven't been listed that much, PJB, for instance, has been reported only four times. It's also interesting to note that most TPs reported have been between 635 and 890, with only 22 stations reported above 1178, and 5 of those from the Philippines by CAT. 73.FJP.
