They claim to operate u/FCC authority. S/off is currently 1900 EST. Jerry K. Conrad, P. O. Box 691, Orlando, FL 32802, is interested in who owns the call WMEL. Jerry hrd it advertised on a local TV station though it has been on 610 for years, some 350 miles away. C. M. Stanbury II notes WBET, Brockton, Mass., noted on approx. 1457 kHz at 1730 EST 2/15 and still there evening of 2/16. Stan notes CJRN made their switch to 710 from 1600 (see also EDXR). The switch came at 1910 EST 2/16 w/WOR and another, presumably CKVM, audible under their s/on at Stan's location, 4 miles west of their new xmtr site.

#### ACHIEVEMENT AWARDS COMMITTEE

As you probably remember, back on March 29, 1941, all of the stations in North America on the BCB were moved slightly in frequency. They were moved in solid groups, and this applied to the graveyard stations. It has been decided by the AAC to allow the counting of graveyarders on both the old and new frequencies for the purpose of obtaining a Graveyard Channel Award. The following schedule is to be used when submitting stations for the Award:

Attention: All old timers

ON OR BEFORE MARCH 28, 1941: 1200-1210-1310-1370-1420-1500 (freq's in kHz) ON OR AFTER MARCH 29, 1941: 1230-1240-1340-1400-1450-1490 (freq's in kHz)

Thus, a station verified on 1200 kHz on or before March 28, 1941, may be counted for the purpose of an award. The same station verified on or after March 29, 1941, on its new frequency of 1230 kHz may also be counted as a separate station. I hope that many of you old timers will take advantage of this opportunity and apply for the largest number of GY's verified before and after the March 29th date. Thanks and deep appreciation for this information are extended to Raleigh Biss.

Swan Island According to an item in the Chicago Sun Times, the final disposition of the "station" here (i.e., the transmitter and antenna installation pictured several times in various publications and visited by EI in 1968) and whether it will be used again by the CIA, "will be subject to negotiations". (C.M. Stanbury II) (Per Dave Alpert in 2/12 DXM, the transmitters were given to the Hondurans. Ed)

England 24 hour radio, permitted since the British government lifted restrictions on such broadcasting hours (in January) was firmly rejected by the BBC. D. Muggeridge, controller of BBC light and popular programs, said there is no forseeable prospect of ANing. (Reuters News Service, via John Oldfield)

Caribbean The British West Indies are no longer British, and the different islands, such as Barbados and St. Vincent are not under a single government, as are the islands of the Netherlands West Indies, which form a single colony. The ARRL (radio hams association) calls only St. Maarten separate from the rest of NWI for geographical reasons. In general I think IRCA should follow the "ARRL countries list", simply because they have been many years at this problem of "what is a country" and their criteria are generally sensible. (Mike Muench, Toronto, Ont.)

One overlocked verification: 1367, Radio Northsea International sent a QSL card almost by return mail for reception of 1/28. I consider this my second best (or perhaps I should say second "most important" European QSL. Meanwhile, Paul Harris (a former section editor fot ehe World DX Club) has authored his second book on off-shore radio. This one alleges that RNI is financed by East Germany and that similar stations are under construction there. However, if RNI really were East German backed, it is difficult to understand why they worked so hard for the Conservative Party in the 1970 British election. (C.M. Stanbury II)

Hopefully most of the squabbles which have plagued IRCA in the past are behind us, and now we can get on to the real business of providing the best and latest information on MW DX to our members. However, it's up to you to provide your editors with the information they need. We can't expect a top-notch bulletin unless you are contributing. That means that, in some cases, people have to be willing to overcome their petty grudges and contibute. Pouting because you didn't get something your way won't help the hobby. Enough said on that. DX here has been hindered by high noise levels and by lack of time. This coming MM (2/21) is free, so I plan to stay up later than usual. This is the time to start watching for the Aussies and Zedders. They should be starting to arrive shortly. TP reception since the midwinter anomaly set in during November has been non-existent. A few people have reported a few of the powerhouses, but the majority of us on the WC haven't heard much from that direction in recent months. An application by Lakeland Broadcasters Ltd. for a lOkw voice at St. Paul, Alta. just may be in a remote enough area to receive CRTC approval. Canada's CRTC does not give away CPs the way the FCC has done. Compare Saskatoon, Sask's (120,000) three stns (one French) with a city in the USA of equal size, and you'll easily see that Canada does not have an equal # of stns/pop. like the USA. Try and find any vacant regional channel in the Vancouver-Victoria area when the FCC "gave away" the dial to the Seattle/Tacoma area. Bill Hardy: The FCC has also looked at the idea of having 25KW regionals. Canuck regionals like CKNW-980, CKVN-1410, CHQM-1320, and CFAC-960 (all 50kw) beam mostly northward nights. CKVN is heard all day here (in season) at 500 miles. Pattern vs. power is the name of it. Also, someone mentioned Canada's lOKW graveyarders. Again when a stn is in Canada and beams N, who would it interfere with in the USA? My DX Special score is great this year, and so is my phone bill. Will Swan River ever top Edmonton's 58° below zero?
