Mysterious Receptions and Unearthly Things

Ear ly some morning you may be at the dials and hear faint voices from an unidentified station which <u>must</u> be some exotic far-off location that you're after. Let me give an example which involved a midwestern DXer recently. He was listening on 660 on a MM, heard a man weakly but definitely talking in EE, but caught no ID. Then WNBC started testing and wiped it out. Since he had read a report that :4VUE broadcasts in FF, this left only KFAR Alaska and 2YC Australia. Should it be concluded that he definitely received one of the two? It's mighty tempting, but let's investigate any other factors first. After thinking about it, there are no less than six alternatives that come to mind:

(1) Daytimers KOZII, WESC, or KSKY may have been conducting a test. Although tests usually do not contain newscasts or long talks sounding like news, there are exceptions. I believe the FCC rules forbid newscasts, spots, etc. on ETs in the case of stations licenced to operate normally daytime only (am I right?) but some stations, especially in recent times, have been breaking many FCC rules. One that caused a lot of confusion: a couple of years ago was daytimer KIRL-1460 which, for quite a while, conducted ETs on MMs sounding just like their regular programming, right down to spots and newscasts.

(2) Station 4VUE, although reportedly broadcasting in FF, may have just started partial programming in EE, perhaps including newscasts for American tourists.

(3) Possibly it was a bootleg station. Usually signals from a bootlegger are accompanied by a heterodyne tone, since most bootlegger's transmitters drift slightly off frequency. However, remember the time a couple of bright teenagers broke into an Ohio station, ran off with some of its equipment, and built a high-quality bootleg station with it?

(4) Reception could have been from a carrier-current station at some college or university. These stations normally cover only a radius of a few hundred feet but sometimes the lines have been mistakenly connected into outside lines allowing the signals to get out statewide.

(5) There is the possibility of a spurious image or response in the receiver from a strong station on another frequency.

(6) There just could be a slight chance that the signal originates from an unearthly source! Yes, there have been many instances of very mysterious signals, ranging from guttural jabbering in unearthly languages on VIF to Indian war whoops and wierd voices interrupting Apollo transmissions from the moon to NASA HQ on the microwaves. On the BCB, many people in the Midwest heard strange voices on the radio, interrupting programs, claiming origin from outer space, and warning them to discontinue preparations for war. This was back in 1954. For full details on many mysterious radio shenanigans, check your local bookstore for Our Haunted Planet by John A. Keel, a 75¢ paperback. Also revealed is the fact that a large majority of all UFOs, humanoids, and wierd unearthly monsters seen by thousands of people tend to occur in areas called "windows", where there are disturbances in the earth's magnetic field. I have noted that three of these "window areas" are also hotbeds of outstanding DX reception: Southern Michigan, the Ohio Valley (especially Ohio-W. Va.), and South Florida. Other suspected window areas are northwestern Indiana and Riverside, California.

What this all boils down to is that possibly these areas of disturbance of the earth's magnetic lines are also areas of outstanding DX reception due to the magnetic conditions there. These conditions also periodically result in the waves of UFO and monster sightings. I suspect that this is a large factor explaining why certain DX ers seem to enjoy outstanding reception. And the excitement of having a much better than average chance of seeing something from out of this world!

NOTES FROM THE JANUARY 1972 ANARC NEWSLETTER

"As of January 1, 1972, DX Stamp Service has a new address: G.N. Robertson, W2AZX, 83 Roder Parkway, Ontario, New York 14519. For those not familiar with this service, DX Stamp Service has, for several years, supplied DXers with current mint stamps of almost every country of the world--stamps which often would be difficult, if not impossible, to obtain from any other source. In view of the recent devaluation of U.S. dollar on the world market, it would probably be a good idea to get a current price list from DX Stamp Service before placing an order."

The NRC reports that a 31 page list of information on Spanish Medium Wave stations is abailable from Benelux DX Club, P.O. Box 2027, Den Bosch 4004, Holland. Jan Burger prepared the list which contains details on networks, a station index arranged by province, and a station list by frequency giving power, network, address, director's name, schedule, telephone number, and QSL policy. There is also a Spanish/English form letter and a list of Spanish DXing terms. Price of the list if six International Reply Coupons.

A new listing of clandestine stations, including their frequencies and mailing addresses, is available and will be sent by air for two International Reply Coupons by writing Japan Radio Club, Terou Kataoka, 21-10, Koshien 7-Bancho, Nishinomiya 663, JAPAN.
