Commentary

Most Board members felt that there was nothing to be gained by establishing a Letters to the Editor Column, as most such material can be expressed in a DX Forum, Director Worst noted that a similar column was proposed some years ago, and rejected for much the same reasons.

Proposal 5.1-60 has not yet reached a final form and corrections are still being made. Hence, it may not appear for membership ratification for some time. Proposal 5.1-59 is not of great urgency and will await 5.1-60. Also, Percy R. Kesteven has proposed a revised version of 5.1-25 for general membership polling. When all of these proposals have reached final drafting, they will be presented to the membership.

5.1-67 "I propose that the volume and issue number of <u>DX Monitor</u> on the anniversary date in 1974 be Volume 11, Number 1. The issue numbers of Volume 10 are to be increased to 58 to make up the difference, or if this proposal is early enough, the extra numbers may be divided between Volumes 9 and 10, or added entirely to Volume 9, whichever is decided to be the most practicable by the publisher." The election completed on February 17, 1972 resulted in the approval of the three bylaws amendments (4.2-51, 4.2-52, and 4.2-53). The proposal (4.2-45) concerning the effective date of taped verifications was also passed. Greenwich Mean Time was selected as the time standard for the Foreign Section since it received more votes than the 2/3 majority required by Proposal 4.2-38. However, the matter of selecting a time standard for the Domestic Sections is still unresolved since no alternative received the required 2/3 majority of the votes cast. A run-off election will be held between the two alternatives that received the largest number of votes: Eastern Local Time and Eastern Standard Time. In the run-off election a simple majority of the votes cast will decide the issue.

880 KRVN Lexington, Nebraska By the time this is in print in both DX NEWS and DX MONITOR, many Diers will have logged 880 KRVN running tests after 0100 EST which commenced on 2/15/72 and which should continue for about 2 weeks. IF test prove satisfactory, an STA will be obtained and RS may well begin within the month of March in time to provide most DXers with another catch this season. Daily sked will be 0500-2400 CST (0600-0100 EST) with 50kw directional nights and non-directional days. The transmitting facilities are located just NW of Holdrege, Nebr., and a 900 mHz STL repeatered at Overton will provide the audio baseband from the Lexington studios. The antenna system is a four tower array consisting of equally spaced 300' monopoles driven with nonuniform currents in both phase and amplitude so as to produce a a very wide "almost" null of some 15 mv/m at 1 mile 15° either side of the line of the array towards WCBS. The line of towers lies on the great circle path between 880 KRVN and 880 WCBS and has a bearing of 81°. The front portion of the directional pattern is a very nice 2.5 VOLTS/m at 1 mile so that few on the WC should have difficulty with KRVN. The proof of this system has been carefully made with a most competent CE at the helm and the technical difficulties not less than state-of-the-art in some major cases. More on the technical layout of KRVN will be published in future issues of the bulletins pending availability of space.

To date a number of DX reports have been received by 880 KRVN during their tests which have consisted of OC with station IDs each half hour. About 10 reports from the WC and one from New Zealand are presently on hand. The following information will be helpful to those DXers logging or taping KRVN and wishing to verify their reception. First, the CE is Bob Bitner, WØSOK, a very top notch technical chap with many years of experience who is devoted to BCB and interested in having KRVN DXed. His responsibilities are many, much more so than most CEs, and his day (to put it mildly) is hectic! Thus, all correspondence from KRVN will be handled by Fish in Lincoln. Specifically, DX reports should be sent to: Bob Bitner, CE, Radio Station KRVN, 104 W. Eight St., Lexington, Nebr. 68805 and the envelope clearly labeled "DX REPORT". Bob will review each report for its correctness and then indicate whether or not it is to be verified and mail them to Lincoln where the verification will be processed. General correspondence concerning KRVN-880 will also be handled in this manner--Fish will answer all questions the CE feels can be handled from Lincoln. Special DX Test will be arranged and there will be plenty of ET and f/c with and without the directional pattern. Thus, CPC boys take note. Club policy of including return postage will be expected and reports lacking return postage run the great risk of not receiving a reply. Please state your club affiliation(s) on your report forms and tapes are extra postage, too. Tape reports are very much requested; tapes at 1-track @ 3.75 ips or $7\frac{1}{2}$ ips are acceptable. Tape will be returned only if return postage is included. Bob Bob and I hope this will work well for the DXers and we cordially invite you to "tune in". More to come on KRVN etc. in the future. -de Fish, Lincoln, Nebraska

I have seen several reports in DAM lately of DXers definitely logging stations because the station in question "was the only one listed on at the time" or was the "only possibility". I'd like to take this opportunity to offer my opinion on the matter. There are just too many other possibilities to consider before logging anything without an ID. For instance, if someone was listening to a frequency on a PAM when every station is listed off except one, and this DAer hears a station with the same format as has been reported for the AN station, does this constitute a positive log? Not necessarily. Perhaps a station is ETing with the same format. Daytimers are authorized by the FCC to operate during emergency times, and many use RS type pgmg. A schedule change for another station is yet another possibility. This is why I feel that a DXer should have a call-letter ID, location ID, or other definite proof before positively logging a station. 73 and good DX, but make <u>sure</u> you're hearing what you think you're hearing!

Now every DKer should know that if he lives a mile away from such a station, and is able to hear it, then it is operating illegally and is a proper subject for a complaint to the FCC! In the past 18 months, I have recovered 660 and 670 as good DKing frequencies by complaining to the local FCC about the University of Denver and Regis College dormitory transmitters operating too strongly. I live 3/4 of a mile from the U Of D, eight miles from Regis. You can be fairly certain that nothing will happen to cure such problems at the local level unless you make such a complaint.

With Bill's sudden hospitalization, Dan took over the job of getting "Frendx" out for March 1972 and did an excellent job. NASWA becomes the 3rd North American radio club to go to offset. NASWA is exclusively SWBC, the only club of its type. The other offset publishing clubs are National Radio Club (strictly medium-wave DX) and SPEEDX (multi-band). The Voice of the Patriotic Sword Front (?, Vietnam by CIA) in Vietnamese at 0500, 0900, 1400 on 1537 kHz. The Voice of the Revolutionary Party for Reunification in South Korea w/Korean on 950 kHz. A Voz de Libertad (Voice of Freedom) in Algeria, Portuguese on 890 at 0015-0115 GMT on Sundays. German Soldier's Station, in East Germany, in German, Italian, Spanish, & Turk, on 935 kHz w/250kw. German Freedom Station, East Germany, same as above, on 908 kHz w/250kw. Only US stn listed is WGHP on 7285 at 0300-0330 GMT in EE w/R&R and anti-establishment annmts. QTH (location) unknown; presumed in Eastern or Midwestern USA...not hrd here. -Mike Hardester

Denver CP for 1090 The FCC has granted approval for construction of a 50kw stn to serve Denver and Colo., federal records disclosed Wed., 2/23. 50kw is the max. AM pwr permitted; the only other 50kw stn in Colo. is KOA which was licensed in 1924. The new stn will be the first AM stn to be built in Denver in about 10 years. Proceedings seeking the new stn moved quietly and many Colo. broadcasters were surprised to learn of issuance of a max.-pwr license in the state. The stn's call letters weren't immediately determined, but the license applicants sought KOLO. The operation will be on 1090 kHz. Final federal approval came 2/16. FCC documents show that approval came after the applicants, Radio Colorado Corp., reached agreement with another applicant, identified as the Denver Unified Investors Group, which had sought to broadcast on the same frequency. -excerpted from Denver Post news clipping dated 2/23, submitted by Bill Nittler who notes, of course, that KOLO is already in Reno, Nevada, on 920 kHz. Note from this issue's Broadcasting Info; this station will be daytime only.

KHJ Wants XEGM out of California RKO General Inc., licensee of KHJ-930, Los Angeles, has asked the FCC to take away the authority of a Mexican AM facility to originate programming from a Hollywood studio due to allegedly illegal engineering practices. RKO has filed an opposition to the renewal of authority of Adolfo and Elias Lieberman to transmit program material from their Sunset Blvd. studios to Tijuana, BCN, Mexico, where it is broadcast over XEGM-950. The company (RKO) claimed that XEGM is violating a 1957 agreement between Mexico and the US authorizing it to operate with 2.5kw on 950 kHz, by operating with 10kw daytime and 5kw at night on that frequency. KHJ has repeatedly complained to the FCC that XEGM's operation with the higher power has caused severe interference to its own signal and the signals of several other SoCal stns. KHJ is on 930 w/5kw fulltime, employing dir. antenna at night. Since it increased its power in 2/69, RKO said, XEGM has caused distortion to KHJ's signal on a regular basis, largely through overmodulation. It argued that XEGM should not be afforded a studio in this country because it does not conform to the standards of good engineering practice. -from Broadcasting, Feb. 14, 1972, minus their typos, plus my typos, submitted by Bill Coleman.

ARTICLE III - ELECTION OF OFFICERS

Section 1 - Frequency of Elections; Term of Office

Regular elections shall be held in odd-numbered years to elect the officers listed in Article V of these Bylaws, including the Chairman of the Board. All terms of elective office shall begin at 0001 Mountain Local Time, on September 15 of oddnumbered years (or, in case of replacements, at 0001, Mountain Local Time, on the date of the DX Monitor in which the results of elections are announced), and shall expire at 2400, Mountain Local Time, on September 14 of odd-numbered years.

Section 2 - By Whom Elected

Part 2 - Nominations shall be open for President, Secretary-Treasurer, and the seven members of the Board of Directors from March 1 through April 15. Only one nomination each for President and Secretary-Treasurer, and only seven nominations for the Board, shall be allowed each IRCA member. All nominations must be submitted in written form to the ECC by April 15.

Part 3 - As soon as possible after April 15, the ECC shall send to the Secretary-Treasurer a list of all nominees. The Secretary-Treasurer will return the list to the ECC as soon as possible, indicating which nominees have been members in good

standing for the required one-year period.

- Part 4 The ECC shall notify by letter all eligible candidates concerning their nomination by May 1. Each letter of nomination shall contain the names of all eligible members who have been nominated for the particular office in question. Such letters must stress that the nominee must reply in writing if he accepts the nomination, and each such letter must request from each nominee a campaign statement, not to exceed 15 stencil lines, to appear in a June issue of the DX Monitor. However, a nominee is not required to submit a campaign statement provided he has duly notified the ECC of his intention to run for office. An IRCA member may be nominated for more than one office, but he must decide for which he prefers to run and so notify the ECC. A nominee who has indicated his intention to run for an office may not be considered as a write-in candidate in the same election.
 - Part 5 All letters of acceptance of the nomination, and all campaign statements, must reach the ECC by May 20. The ECC shall prepare the ballot and the campaign statements and submit them to the Publisher by June 1. Ballots shall contain spaces for write-in candidates.

The official publication of the IRCA shall be known as DX Monitor. It shall be issued 34 times each year, except in cases of emergency. With the permission of the Board the number of issues may be changed. DX Monitor will normally be published beginning with the first Tuesday in October, up to and including the last Tuesday in March, twice in April and September, once in May, June, July, and August.

ARTICLE VII - COMMITTEES

The Board of Directors may, from time to time, establish various committees to carry on the activities of the IRCA. The Board shall have the power to establish guidelines and policies relative to the functions, operations, and authorities of any committee, but, in all other respects, committee chairmen shall have complete authority over the operations of their committees. For purposes of these Bylaws, the editors and publishers of the DX Monitor and any official agents of the IRCA are considered to be committee chairmen.

ARTICLE VIII - CONVENTIONS

Section 1 - Annual Meeting

The annual meeting of the IRCA shall be held in conjunction with the annual convention for purpose of presenting the reports of officers, committees and boards, and such other business as may lawfully come before the meeting.

Section 2 - Special Meetings

Special meetings of the IRCA may be called at any time by the Board of Directors or its own motion, and must be called by the Board of Directors on petition of at least 10% of the membership. Such meetings shall be held at such times and places, either within or outside the state of Colorado, as the Board of Directors or petition herein specified shall determine.

Section 3 - Convention Location

The Board of Directors shall solicit during September of each calendar year bids submitted by those wishing to host the annual convention. The Board shall subsequently cause a special election to be held among the members to select the convention site and date. Such special election shall be conducted during the final third of each calendar year. The Board may, on its own motion, determine any bid made as unqualified prior to the special election. Each site deemed qualified by the Board of Directors shall be allowed to print a statement of thirty lines in the DX Monitor promoting their bid. Such statements shall be printed in the issue which contains the ballots for the election of the convention site.

Section 4 - Voting

Each member shall have one vote on each and every matter submitted to a vote of the members. At all meetings except as otherwise provided by law, the members entitled to vote who are present shall constitute a quorum. All action except as otherwise provided by law, by the IRCA's Constitution or bylaws, shall be by majority of those members present and voting. Presence and voting by proxy may be allowed at the discretion of and in accordance with rules prescribed by the Board of Directors.

ARTICLE IX - SUGGESTIONS AND PROPOSALS

All suggestions and proposals shall be submitted to the President in written form, who will then submit them to the Board for action (along with any specific recommendations he may care to make). The final decision as to any action to be taken rests with the Board of Directors. A proposal that receives more "yes" votes than "no" votes will be considered passed. A proposal which is related to the activities of an IRCA committee or the club Treasury will first be submitted to the respective Committee Chairman or the Secretary-Treasurer for his recommendations, which will subsequently be submitted to the Board along with the primary proposal.

ARTICLE X - IRREGULARITIES, REPRIMANDS. DISMISSALS

Section 1 - Irregularities

Any irregularity of club policy must be brought to the attention of the Board of Directors and the President. A statement of the irregularity and the member or members charged must be made in written form and must bear the signature or signatures

Section 3 - Dismissals

If the nature of the offense is serious enough to cause further action than a reprimand the President must, with the final approval of the Board issue a letter or letters clearly stating the nature of the offense and that dismissal proceedings are being taken. The aforementioned letter(s) are to be sent by registered mail, return receipt requested. A sufficient amount of time must be allowed for the accused to answer the serious charges. If the reply is not forthcoming or if it does not meet with the satisfaction of the President, a letter or letters of dismissal may be sent with the final approval of the Board of Directors, removing the membership of the accused. ARTICLE XI - REFERENDUM/INITIATIVE

If a member cannot get action on a proposal in the prescribed manner, he can submit a petition bearing 20% of the signatures of the club membership to the Election Committee to effect a special election on the matter. This pertains to matters other than those concerning the contents of these documents.

ARTICLE XII - RECALLORIDADE SED OTAL SEDO VILLERAS If a petition is presented to the Election Committee bearing the signatures of 20% of the members asking for the removal from office of the President or Secretary-Treasurer, the Committee shall call a special election at which the membership will be able to vote for or against such removal. If the removal of the officer is approved by 75% of the members voting, the office shall be declared vacant. If a petition is presented to the Election Committee bearing the signatures of 20% of the members in a certain Region asking for the removal from office of the member of the Board of Directors from that Region, the Committee shall call a special election at which the members in that Region will have the opportunity to vote for or against such removal. If the removal of the representative is approved by 75% of the member: voting in that Region, the office will be declared vacant.

ARTICLE XIII - AMENDMENTS AND CHANGES

These Bylaws may be amended by the submission of a By-Law amendment in written form to the President. He, in turn, must submit the proposal to the Board for consideration. With the approval of the Board, the proposal is then submitted to the Electio Committee who shall arrange a special election. A proposed By-Law amendment petitio containing the signatures of 20% or more of the membership must be presented by the Election Committee to a vote before the entire membership. To be enacted as an amen dment, the proposal must receive a simple majority of those members voting. An amen dment to the Bylaws goes into effect immediately after its adoption, unless the proposal to adopt specifies a date for its going into effect.

ARTICLE XIV - RATIFICATION

The ratification of a 2/3 majority of those members voting shall be sufficient to establish these Bylaws and Constitution as the official documents of the International Radio Club of America, Inc.

Panama Revisited--Bill Hardy

As a follow-up to the questions I raised last November, the 1972 WRTH indicates HOG-830 moved to 810 to allow for the Radio Libertad station on 840. A previously unlisted "Radio Caracol de Panama" (small distorted operation, probably unrelated to Colombia's CARACOL), which I'd heard on 850 during 1970, is now listed on 1190, using the HOL47 call and old facility of the 1970 Radio Libertad. R.P.C., Panama's biggest network, moved its Bocas del Toro station from 810 to 860. (I don't understand that, since Panama City and Bocas del Toro are 300 miles apart, but Panama does not assign two stations to the same frequency.) R.P.C. also moved its David outlet from 660 to previously-unused 580. As CMS's pennant indicates, the Radio Libertad outlets on 770 840, and 890 are all 10 kw; 1090 and the new unlisted outlet on 910 are both 1 kw.

Overlooked Verie-- (somehow, Stan, I always seem to do this to you...Ed)

Netherlands Antilles, Bonaire verified by return mail my reception of their special MW DX program. Front of card has a map of Madagascar on it, hi. (CMS,E)

Ryukyu Islands "The Voice of America medium wave station on Okinawa begins its regular program transmission schedule at 1100 GMT. No special transmission was conducted for the National Radio Club. However, we did suggest to them the dates and time when we felt observers in the United States would have the best chance of hearing the Okinawa station." (Letter from George Jacobs, Chief, Frequency Division, Broadcasting Service, U.S.I.A., to C.M. Stanbury II)

Hawaii "KIKI, along with most other Hawaiian stations, do broadcast a variety of language programs usually early in the weeday mornings and in the weekends at various times. There are many races in Hawaii and the most common is Japanese so besides two fulltime Japanese language stations and one TV station, Japanese programs are broadcast on about ten Honolulu stations, then there are Philipino, Korean, Chinese German, you name them.

"KIKI's control room is located about two feet from one of the legs of the tower which is erected in a small twentyfeet by twenty feet courtyard surrounded by office buildings. The tower carries five AM stations, KGMB, KORL, KIKI, KHVH, and KZOO so the RF field in the control room is very high, there being more than 95 amperes flowing into the tower from these transmitters." (Alan Roycroft, Broadcast Services, Inc. 2877 Kalakana Ave., !Hoppululu 96815 in letter to Ruff Sanserini.)
