5.1-92 It is proposed that Donald E. Erickson, IRCA publisher, be reprimanded for recent actions in which he wrote in my bulletin comments without my request, detracting from the appearance of my bulletin. Submitted 26 April 1972 by Kevin L. Slater.

5.1-93 I propose that the Publishing Committee cease and desist from the practice of writing on member's bulletins and bulletin envelopes. Any such future writing on said surfaces will be allowed only with the express written consent of the member involved. Submitted 4 June 1972 by Percy R. Kesteven.

5.1-94 It is proposed that the IRCA adopt a report form suitable for use by the members when writing tips to their DX Roundup Editor. Submitted 29 May 1972 by Paul Petersky.

5.1-95 I propose the immediate purchase of an A.B. Dick 530 to supplement the present A.B. Dick 418 and to eventually replace it. The price will be \$795 plus sales tax. Submitted 2 June 1972 by Donad E. Erickson.

#### Commentary

Proposals 5.1-92, 5.1-94, and 5.1-95, due to their rather lenghty and detailed wordings, were paraphrased and shortened to extract the basis concept behind each of them.

The President felt that 5.1-92 was too severe for the nature of the offense and suggested 5.1-93 as an alternative.

Complete details of the Form mentioned in 5.1-94 will be worked out in the coming weeks. An announcement about this will appear soon.

Dr. Richard E. Wood did not return his ballot card for this voting round, hence the abstensions.

Let me state clearly once again that Lynn D. Brooks has left the Club. In a genuine, hand-written letter he notified me that he was consciously letting his membership lapse due to lack of time and interest in the hobby. Thus, both his Board position and editorship are open. Deadline for applications for the post of Central DX Forum Editor is SEPTEMBER 1, 1972, as announced in the July 15, 1972 DXM.

I would like to state that the Constitution and Bylaws of the IRCA, as printed in the March 11, 1972 issue of DX Monitor, is true and current. There are no revisions whatsoever and it is to stand for the summer printing required by Article V, Section 1, Part 1, i. of the IRCA Byalws. Alaska + Trans-Pacific & Hawaii + Down-Under

Last October saw the best cross-Pacific DX conditions in years. Crossing our fingers, and hoping that improved (lower) sunspot counts will give us another month of record-breaking receptions, SCECPSDX's leaders have designed a contest for all long-haul DX'ers. Yes, TP's have been heard on these frequencies in the East, too. There are problem frequencies for almost everyone included, so please don't accuse the originators of Southern Californian provincialism. (We included 640, and KFI will probably be AN on the morning in question. Unless, of course, one of the judges makes a certain phone call).

This is complete with judges and prizes -- and no entry fee! Four notorious DX'ers have volunteered to serve as monitors and mildly anonymous judges. (They are Mant Granning; Jay Mollar, D.D.S.; Rabbi Jack; and Ruff Sanserini). Prizes include an NRC Pattern Book (courtesy of some outfit called the Boston Publishing Committee), a current copy of WRTH (courtesy of Toyland), a fall issue of the Radio edition of SRDS (courtesy of the Christal Company, a well-known station representative firm), and an ancient copy of Wireless World's Guide to Broadcasting Stations (courtesy of whatever Hollywood bar Bisyn's currently pouring booze for, we guess). In about that order.

Rules? Afraid so. If you misidentify a station, it will cost you one point. If we catch a fraudulent entry, the two Orange County judges decide which can use your paperwork as kindling. (In case they have to suffer through a below-freezing night like the one three winters ago). And one last rule: all entries must also be sent to either or both the NRC or IRCA foreign columns. While they're still current.

Now to the contest. Any station in Hawaii, Alaska, Australasia, other Pacific Islands, or those portions of the Far East requiring signal paths across Alaska or the Pacific is eligible for reception. Each logging must reflect a minimum of five minutes of successful listening (with fades between spurts of reception included as reception), and any applicable station can be logged once in each of the ninety-minute listening periods. Note that each twenty kilocycle (the sponsoring organization, SCECPSDX, has yet to accept this new-fangled term, khZ, or whatever it is) block is featured on one night. Each night offers three different listening periods. They are 0000-0130 PST (0800-0930 GMT), 0200-0330 PST (1000-1130 GMT), and 0500-0630 PST (1300-1430 GMT), and your contest entry may be written in either Pacific or Greenwich Mean Time. So if the first time-period seemed to be fruitful, you can increase your score by relogging in the next time-period, and possibly add some additional catches as well. So you can report the same frequency block more than once!

Here are the frequencies and dates: 825-845 KC -- Monday, October 2, 1972; 750-770 KC -- Monday, October 9, 1972; 1020-1040 KC -- Sunday, October 30, 1972; 640-660 KC -- Monday, October 23, 1972; and 870-890 KC -- Monday, October 30, 1972.

Five different nights with three time-periods each. That's fifteen different opportunities to enter. All you have to do is select your best five for those are the ones that count. As an additional concession to those removed from the big pond, any DX'er whose locale is not located in a state or province bordering the Pacific need only select his best four, and we'll pro-rate them to represent his "best five."

Scoring? Simple. Any station successfully heard and reported to DXWW (IRCA) and/or IDXD (NRC) can be counted within that time-period. (So if you count two the same night, report two separate receptions of the station with appropriate detail, to the columns). If the station is 200 to 2,200 miles away, it's worth one (1) point. From 2,200 to 3,300, it counts two. From 3,300 to 4,400, figure three. And over 4,400 miles, it counts four points. One thousand or one million watts - it's still the same. We're counting distance. If you can measure your distances, to make up your own scores, please do so. (Or we'll do it, if one of us learns how to read a map in the meantime).

Remember that other guys are also logging stations during the same time-periods on the same frequencies, so be careful. We'll be watching the programming you list and looping and interference details.

And even if you don't do well, please enter anyway. We promise some articles go grow out of this if we get enough reports -- and that includes your notes on unproductive time-periods, or your difficulties in DX'ing from the bottom of a coal mine (please turn over)

(continued from other side) or with an SX-16 or whatever.

So even a low-scoring entry will be helpful, and will help produce future articles that may prove useful for all of us. A facsimile entry form is on Page 2.

# SOME TIPS ON HOW TO IMPROVE YOUR SCORING IN THE GRAND OCTOBER ACROSS THE BIG POND SIMULTANEOUS LISTENING CONTEST

Some literature is worth re-reading if you're a little rusty -- or totally inexperienced -- in chasing Pacific DX. From the fall of 1970, the feature article "Trans-Pacific Reception Exists" is still reasonably good. Easterners in the NRC might also read Gordon Nelson's companion piece "TP Reception on the East Coast." One key change since involves the Japanese powerhouse: the NHK2 station on 870 has increased power from 100 KW to 500 KW. Art Peterson's features on "pips" will be useful as well; perhaps the club bulletin might reprint them. For the Hawaiian, Polynesian, and Australasian possibilities, there's last fall's "DX'ing Polynesia and Beyond."

The key source, of course, is World Radio TV Handbook; the station ID's and IS's are listed as well as the frequency-listed material in the back of the book. Don't forget the possibility of parallels if you've got a good standby rig. You can dig them out of WRTH with a little advance planning. Take 750 on October 9, for instance. If 300 KW JOIB is barely audible, other NHK1 possibles such as JOBK on 670 may be better, offering the clearer audio to lock up the identification. (It's extremely likely that the North Koreans will tune up Wonsan at 877 again this year. If they do it, it may or may not be // to super-power 655; if not, it will be // to 725 and 785 as it was a few years ago).

If all the Oriental languages sound alike, or if you've experienced the can't-tell-if-the-weak-one-is-Spanish-or-Japanese problem especially facing West Coast DX'ers, a suggestion. Brush up on language characteristics up on the SW bands. Or buy a copy of Art Peterson's tape, as noted in the bulletins.

Don't forget to give every likely frequency or split a full two minutes on every pass. The further away your target, the likelier you'll encounter long fades with no sign of an audible signal. Try ninety seconds of unmeasureable signal strength followed by thirty seconds of audio--the middle ten seconds alone being readable. It happens. Especially with the Down Unders.

And if you've got a loop, but haven't figured your bearings to such likely targets as Honolulu, Tarawa, Korea, Japan, and New Zealand, why not do so in advance? A loop antenna bearing can supply extra strength to a tentative logging after it helps you secure reception. If you live well east of the Pacific Coast, however, this contest will be extremely difficult without a loop or Beverage antenna. For East Coast residents, the Beverage offers your best shot at success in this contest, with the Hawaiians the top target, and Tarawa, Tonga, and the Down-Unders close behind. Those in the northeastern quarter of the U.S. or in Eastern Canada will find the Alaskans and East Asians more difficult than the Island stns in any case, unless we have the lowest levels of auroral quiet in seven years. While those favorable conditions are likely to occur sometime this season, it's a little foolhardy to predict them on given Monday mormings this coming October. For those without WRTH, we offer some of the feasible bets for many readers, conditions permitting:

Earlier that day, WKBW reported on its 1300 newscast that Army technicians were on their way "from Arizona" to set up communications facilities in Corning. While it's impossible to tell from the WKBW report exactly when the technicians and their gear left AZ (Fort Huachuca), it appears we had some Sharjah-style technology right here in MY State. This special station was last heard 7/2. During that evening they announced WCLI would return to the air on 1450 the next was morning at 0600. New procedures for address changes and dues As announced on page 1, all changes of address and dues should be sent to IRCA. Don Erickson, 6059 Essex St., Riverside, Calif. 92504. Please make all negotiables payable to IRCA. Cash will not be accepted for dues except at your complete risk. No claims will be considered for dues sent in unless you maintain your money order receipt or can provide copy of your cancelled check. This is no problem except that it points out that any member sending cash will have no recourse; when cash is received, it will be returned to you at your own risk each way and you will need to re-send the proper funds if you desire to maintain membership. This hard-nosed approach is of absolute necessity for the protection of both the member and the club. Because of the method used (gummed labels prepared from mimeo stencils), a change in mail service at expiration will not cause a delay in processing your renewal (as is presently necessary). In all cases, checks will be forwarded to the Secretary-Treasurer and/or the bank; if your check fails to clear and your renewal is not credited in due time, don't become alarmed and stop payment at the bank (an expensive procedure most places). Just advise DEE and a search will be made. No particular problems are expected but let's all co-operate and make things simple for everyone concerned. A note on the subject of under- or over-payment. In cases of slight underpayment, your expiration date will be sooner; if underpayment is considerable, your renewal will be processed only when the correct amount is sent. In cases of overpayment, you will receive extra issues. And, yes, you may send mint postage stamps, either Canadian or US, if it is not convenient to send check or money order. They will be very gladly accepted provided they are mint, useable, and of denominations of 50¢ or less, no special delivery. Advantages of the non-computer system? Yes, there are advantages as well as the disadvantage of greater manual effort. The most obvious advantage will be speed; a renewal becomes effective the minute it is received; new memberships are processed within a few days; changes of address will be made almost immediately. -Don Erickson

#### ANARC REPORT

Frequency Recommendation Committee— Three new members have further extended the geographic coverage of this committee. They are Doug McClellan of New Mexico, Kevin Axelson of Colorado, and Robert Jacobs of Washington. Chairman Glenn Hauser has resigned because of lack of time. The chairmanship of this committee requires considerable time, and the success of the committee during the past year is an indication of the time and effort Glenn has spent in re-organizing the committee and contacting stations. Glenn has published a monthly newsletter for members, and several SW stations have changed frequencies as a result of committee efforts.

Changes -- the Batesville Shortwave Association has been merged into the Rocy Mountain DXers Association. The Club des DXers du Quebec has decided not to renew its membership in ANARC.

Anniversary -- CIDXC celebrated its tenth anniversary in July.

Publications -- The European DX Council Newsletter for March announced two new publications for DXers:

Latin American Commercials has been edited by two Swedish DXers, Henrik Klemetz and Nils Ingelstrom, who have travelled extensively in Latin America. The 25-page offset printed guide includes a list of trade marks used in various LA contries, a list of commercial establishments, and information on IDing Latins and reporting to them. It also lists the minimum and maximum times for reply from each station. The price of the list is two IRCs. Arabic Reporting Forms -- Siegfried Rambaum, whose offer of Arabic language report forms was announced some months ago, has asked ANARC's help in locating someone who ordered forms but failed to include his return address. The order was signed by "Reggie B..." and the check was drawn on the Howard Savings Institution, Newark, N.J. If you know who this is, please contact him or Siegfried. <u>DX Alliansen</u>—This is the European equivalent of ANARC. It consists of about 30 clubs, all except two of which could be called local. Most publish weekly or fortnightly, and have local meetings. All office holders in DXA are paid, and budget proposals are made to the Swedish Youth Concil for; support. They have proposed that 1973 be proclaimed World Year of DXing. This is an area in which ANARC can cooperate very closely with DXA and EDXC. Publicity must start now since lead time for commercial magazines is about four months.

Allow me the courtesy to once again state the circumstances: viz--I did indeed arrange the test and did spend two hours at the station several days before the test making the (monotonous but very effective) ID tape. Response in the form of reports was excellent -- something like 100 reports or so from coast to coast, Canada, and several from N.Z. Quite likely it was one of the best heard tests of that DX season. The CE was well pleased and I visited the station a few weeks (or months?) after the test for the purpose of looking over and reading some of the reports received. I recall explicitly my request for the CE to consider veries as promptly as convenience would allow. The quality of reports was exceptionally good and I expressed to the CE the fact that considerable effort was made by many in reporting and a decent response was certainly deserved. He agreed and expressed his intent of including a CM in all veries. As I recall, some of the reports were verified as reported by some DXers in the bulletins. Then some months later, several DXers wrote to me concerning the status of the situation. I called the station to find the CE had left their employ (graduated from the Univ. and moved to Calif., I believe) and "they" didn't know anything about the test much less the reports. Eventually or during this time, RUMORS were passed that I had the reports or was holding them to verify for the station or whatever else I was said to be doing with them. Now I state the following as FACT IT IS!!! (a) at no time were these reports in my possession, much less removed from the station for my musing interest; (b) at no time did I act on behalf of the station to process any of the reports for verification although I did offer to provide typing services to the CE (who declined); (c) at no time did I play a role in the decision of whether or not a given report was acceptably correct for verification or non-verification; (d) later I did agree to accept f/ups sent directly to me to present to the station with a sincere inperson request that they be answered -- of the dozen or so f/ups I received, only a handfull were verified even though I made the request personally to the engineering staff in every case. Also, those DXers who sent f/ups were understandably considerate in most cases and I was glad to attempt verification on their behalf.

The situation today is, to the best of my knowledge, that the station has little knowledge of the test and does not know the whereabouts of all those reports. The CE who performed the test (his first, by the way) left the station some months thereafter and with him went most of the hope of verification (and possibly the reception reports and tape????).

To those serious DXers who sent reports, I do feel badly about this matter of KECK and am disappointed that the veries were never produced and as you know it was not in my control. To the ingrates and rumor-passers, the final nail has been placed in the coffin; now bury the darn thing!

"DXers" TAKE NOTE--The question raised in all this is explicitly: Is the DXer who is responsible for arranging a DX Test also to be held responsible for obtaining the veries? THE answer is emphatically NO! But, as I have done, most CPC-type chaps make an honest effort to help out their fellow DXers in such matters. It is quite apparent that SOME ingrate "DXers" put the verification monkey on the back of the test arranger. This is extremely GROSS inconsideration. There have been other cases of the 1530 KECK 1968 situation in which the test arrangers have driven a hundred miles or more to personally plead for verification--in some cases to type them out themselves at the station and even pay for the postage--and still end up with these ingrates. Another point: the test that has been scheduled in the bulletins but fails to come on the air or fails to meet the announced schedule or programming, etc., will also output as much garbage from these non-thinking excuses for membership in this hobby. THE CPC DESERVES CREDIT FOR GUTS!!!!!

To end, this speaks to the few who make this hobby extremely unappealing. The vast majority of the membership is considerable and does appreciate the efforts of the CPC-type and they often express this to the test arranger as well as the station even though they may have already verified the tester. To you, it's a pleasure to "walk the extra mile". -de Fish, Lincolnland

Not much ECB work done here recently; most of my time has been devoted to TV DX. Did nab #600 heard with WJFC. Most of my recent veries have been from TV.

An intro is needed for some of the newer members, re-intro for the rest- I'm 19 and have been DXing for a little over 2 years. I'm a sophomore at Ball State University in Muncie, Indiana, majoring in Radio-TV and journalism, and work at campus stations WBST and WSAS. My main interests, other than DX and radio news are hockey, baseball and of course GXing, hi.

Thanks for the fine support of GYDKR so far, and hope to see many more of you report in the future. 73 and a word from DEE:

Geomagnetic Storm This time you didn't even have to read the bulletin or listen to WWV to know a geomagnetic storm of considerable severity had occurred; every radio network news service, newspaper, and TV news all had it. The daily indices appear in Father Jack's section. The storm index was 195 for the storm that started Aug. 4. And another storm was underway on Aug. 9. Auroral conditions have been noted by some but no one has advised of anything spectacular. For the newer members, high geomagnetic indices (A-values) indicate auroral conditions which show up as absorption of signals from the North and enhancement of signals from south (the South, Latin America, etc.). During auroral conditions, check frequencies normally dominated by stns to the north (New England, Canada, etc.).

COX BUYS KFI-640 The 50,000-watt, clear-channel Los Angeles station reached agreement with Cox Broadcasting Corp. to sell its operating assets for \$15.1 million. KFI went on the air in 1922 as a venture of the late Earle C. Anthony, a prominent automobile dealer here. Since Anthony's death in 1961, the station has been held by the Earle C. Anthony Trust, whose profits have been divided almost equally between Cal Tech and UC Berkeley. The Federal Communications Commission must approve the sale to Cox, which has 17 radio and television properties in Georgia, North Carolina, Ohio, Pennsylvania, Florida and Northern California. (From Business and Finance section, Los Angeles Times, July 21, 1972, via Joel Brill.)

Joel also sends along info from a WSB QSL that the other Cox stations include WSB-750 Atlanta; WHIO-1290 Dayton, Ohio; WSOC-930 Charlotte, N.C. (all AM-FM-TV); WIOD-610 (and FM) Miami; and TV stations in Pittsburgh and San Francisco. WSB, like

KFI, is a class I-A clear channel.

Joel has a KFI 50th Anniversary QSL from May of this year listing KFI firsts: first remote broadcast on the Pacific Coast (1922); first rebroadcast to England (1924); first pickup of full-length opera from state; first Presidential Inaugural broadcast (Pres. Coolidge); first Pacific Coast football broadcast; first West to East transcontinental sports program (Stanford-Alabama Rose Bowl game, 1927); first broadcast of Hollywood Bowl summer concert season; first origination of network broadcasting on Pacific Coast - all are KFI "firsts." KFI has been a faithful NBC affiliate since the first days of the network; through the years NBC has made repeated unsuccessful attempts to buy KFI and have an owned-and-operated station in Los Angeles, especially a 50-kw clear channel. Broadcasting quotes Anthony as telling NBC, "I wouldn't sell my wife. Why should I sell KFI?"

Broadcasting (July 24) also reports that WGN Continental Broadcasting and Globetrotter Communications, both based in Chicago, were among the final bidders for

KFI along with Cox. Cox Broadcasting also has extensive cable-TV holdings.

The first homemade KFI transmitter, 50 watts, began broadcasting on April 16, 1922. Presently KFI operates 24 hours daily, non-directional, with 50 kw on 640 kHz (the frequency is unchanged from the 20's) from a 750-foot antenna located just off Interstate 5 in La Mirada, outside of Los Angeles, near Disneyland and Anaheim in Orange County. (This info also from Joel Brill. Thanks, Joel.)

KBTR-710 SALE APPROVED The FCC has approved the sale of KBTR Denver (see 6/17 DXM, p. 30) to Mission Denver Co. for \$1.5 million, despite the proposed change of format from all-news to C&W. Four citizen groups and KLAK-1600 Lakewood, Colo. had opposed the sale for the format-change reason. The FCC held that enough news was available on a 24-hour basis on the other 20 Denver-area stations (a total of 291 hours, 39 minutes per week) that the public interest would not be hampered by the format change. In addition, KGMC-1150 Englewood and KOA-850 Denver are now "all-news" in prime time.

KBBQ-1500 SALE APPROVED The FCC has approved the sale of KBBQ Burbank, CA by the estate of George E. Cameron Jr. to Burbank Broadcasting Co. for \$2.2 million (per July 24 Broadcasting). KBBQ, an NSP C&W station with 10 kw-D and 1 kw-N, DA-2, has a construction permit for 10 kw fulltime, DA-2. For many years the station was graveyard rocker KBLA-1490. In the mid-60's it moved to 1500 and upped power, but shortly afterwards Cameron bought the station and changed it to C&W KBBQ (that's for BarBeQue, Glenn Hauser). Lately many of the people who built the ratings for KBBQ have been migrating to KLAC-570 in Los Angeles proper. Rumors in Bilboard are that the station will go back to rock; the new owners have already applied for the call letters KROQ.

KRUX-1360 AND KTKT-990 SOLD The FCC also approved the sale of two Arizona stations from Leland Bisbee Jr. and others to Arizona Lotus Corp. for \$1.36 million. KRUX, in Glendale, Arizona, is currently in a ratings battle with Phoenix rocker KRIZ-1230. KRUX is 5 kw-D, 500 w-N, DA-N. KTKT Tucson is 10 kw-D, 1 kw-N, DA-2. Arizona Lotus was told by the FCC to complete a modification of KTKT's daytime directional pattern within 60 days of consummation of the sale - it sounds like that would be to avoid overlap with KRUX. (Based on July 24 Broadcasting)

KIRO-710 DUMPING CBS "Network radio is passe," Jon Holliday, KIRO (Seattle) program director, explained as he sealed the envelope that contained a disaffiliation notice.

After more than 30 years as a CBS Radio outlet, KIRO wants out. Jack Adamson, new station manager and vice president of KIRO, Inc., signed the letter and issued a statement.

"We have determined that in today's highly competitive situation, a station with KIRO's commitment to its audience must tailor its programming to the best interests of the people in our 50,000-watt coverage area," Adamson said.

"In recent years the radio networks have been almost solely news services with

total emphasis on national and international news."

As an independent station, Adamson said, KIRO would devote more news and information time to events within the coverage area. Adamson said the news department had been preparing for independent operation for several months.

Dick Bingham, KIRO news director, said his staff has new "tools of radio journalism, including mobile units and handic-talkies." UPI Audio news lines will be

installed.

The expiration date has not been negotiated with CBS. Where Walter Cronkite, Lowell Thomas, Abigail Van Buren, Chris Shenkel and other CBS voices will go next has not been discussed by CBS. (From July 16 Seattle Times, by Radio Editor Victor Stredicks, via Dave Christensen.)

KIRO is an AM-FM-TV operation and will keep CBS-TV. KIRO is owned by Bonneville International Corp. (Mormon Church), which also owns class I-A KSL-1160 Salt Lake City, which is also an AM-FM-TV CBS operation. Will they follow suit? --BH.

NO TAX BREAK FOR RKO General Inc. may end up scrapping plans for breaking up its commonly-owned AM-FM stations in major markets, following FCC rejection of a favorable tax ruling. RKO owns AM-FM-TV stations in Boston, Los Angeles, New York and Memphis, and AM-FM combos in San Francisco and Washington, D.C.

RKO had planned to undertake a "corporate one-to-a-market plan" aimed as splitting up its AM-FM combinations, which RKO said would be "more prudently" achieved if it were allowed a tax break on selling the stations. The FCC would have had to issue certificates allowing RKO to avoid paying capital-gains taxes on the transactions.

The FCC says that since the sale of a radio-VHF combination to a single interest is now prohibited, and a proposed rule would require existing combinations to be broken up, it will issue the certificates when the owner of a radio and VHF-TV station in the same market voluntarily spins off one of the properties. However, since no such rules apply to ANI-FM combinations, the voluntary breakup of AM-FM operations does not earn the seller a tax break.

KOOK-TV CALL CONTEST KOOK-TV Billings, Montana has had to sell its radio outlet, KOOK-970. The RADIO station is keeping the KOOK call letters, so the TV station is running a contest to re-name the station, mainly intended for potential advertisers and agencies. Those of you who read Broadcasting will find the details in a delightful ad on page 25 of the July 10th issue. For the rest of you, expect no change in the call letters of KOOK-970 despite its being sold.

MUTUAL AFFILIATES An item in July 10 Broadcasting tallies the Mutual Black Network at 55 affiliates, Mutual Spanish Network at 21 stations, and the basic MBS network at more than 550 affiliates.

Two items of about 20 lines apiece (they won't fit here, hi) that can wait for next issue are doing just that. A really outstanding show of support this time, people! Many thanks. TIJUANA FM PROBLEM Officials of the FCC and State Department are going to Mexico City to try to resolve complaints of San Diego broadcasters over a proposed U.S.-Mexican FM allocations agreement. And if this case sets a precedent, it might eventually affect the numerous BCB Mexican-border stations.

The FM agreement, reserving some 414 protected commercial and noncommercial FM assignments on the U.S. side of the border, and 419 on the Mexican side, was to have been signed in June. But the signing was postponed at the urging on Congressman Lionel Van Deerlin (D-Calif.), whose district includes San Diego, after complaints

from both AM and FM broadcasters in that city.

The broadcasters, the State Department, and evidently Rep. Van Deerlin also, are concerned about promotional pieces for HIS, HERS and OURS. XHIS and XHERS are 200-kw English-language Tijuana FM stations operated by Paul Schafer, former owner of Schafer Electronics Corp., a leading supplier of broadcast automation systems (evidently XHIS and XHERS use such a system). XHIS' assignment on 90.3 MHz (right in the middle of the U.S. educational FM band) would be "grandfathered" (permitted to continue) in the new agreement. (In all Tijuana would have 11 assignments, four of which would be capable of reaching San Diego.) XHERS' assignment on 100.1 MHz would not be grandfathered, and presumably it would move to one of the three remaining channels that would reach San Diego. Proposed 50-kw XOURS would probably get one of the other two. The promotion pieces describe XHIS and XHERS as "progressive rock stations" (a description not 100% accurate-BH) and identify them as San Diego outlets, not Mexican; the rate-card promotion piece drops the "X" from the call letters. And on the air, the "equis" is heard only in the hourly Spanish-language ID's, never in the frequent English promos.

In the U.S., one licensee may operate only one AM and one FM station per city. There is no such limitation in Mexico; in fact, in Guadalajara one owner operates no less than five AM's and four FM's, and there are several multiple owners in Mexico City. Another advantage to Mexican vs. San Diego operation is freedom from the requirements of carrying news and public affarrs programming. And 200 kw is well in excess of the present 100-kw ceiling on FM in the U.S. generally and the 50-kw limit on FM in Southern California. Given these facts, it comes as no surprise that San Diego broadcasters want FM stations in both Tijuana and San Diego to directionalize in order to suppress reception across the border, and to program at least 75% in

their native language.

Such an agreement for programming on FM is without precedent on the BCB. But in the event Mexico agrees to even a portion of the San Diego broadcasters' demands, it could set a precedent that could conceivably eventually affect the existing Mexican-border AM's in Tijuana. Presently, four program in English, and although they are heard over equal areas of Mexican and U.S. territory, they are obviously seeking U.S. listeners. They are beautiful-music XETRA-690, religious XEMO-860, soul XEPRS-1090 (the old XERB, actually in Rosarito Beach), and soul XEBG-1550 (at 1 kw, reaching only San Diego). XETRA and XEPRS are 50-kw stations with major lobes over Los Angeles and have often identified with that city. In addition, Spanish-language XEGM-950 cranks up its power and modulation to try to reach Spanish-speaking workers in Los Angeles, causing interference there to 5-kw locals like KHJ-930 and KFWB-980.

Whether these stations are ever asked to stop programming to the U.S. is a subject only for speculation at this time. But it would be nice if the U.S. could get them to clean it up technically, on such items as overmodulation, XETRA's stereo slopover, and the totally ridiculous interference that only XEGM radiates. -BH.

THE EARLY DAYS OF DX'ING:

A SILENT NIGHT (Well, 99.75% Silent!) by Gene Martin

One station which achieved undying fame in the early days of DXing was KPSN, Pasadena, California, a 1,000-watt station owned by the Pasadena Star-News. The station operated on 950, although in those days we called that frequency 315.6 meters, for kilocycles had not been introduced to the radio public of the mid-1920's. And kilohertz was an inconceivable thing that was not to come along until about 30 years in the future.

The KPSN leap to fame came about because the station owners were out of touch

with what was going on in radio in January, 1926.

DXing was firmly established as a burgeoning hobby at that time; almost every listener was a DXer. In the Midwest, we thrilled to hear KDKA at 309 meters, KFI at 468.5 meters, and PWX, Havana, at 399.8 meters. KFI, incidentally, still transmits on 468.5 meters, but not many U.S. stations are still located at the same spots on the dial which they occupied in 1926.

One Sunday night in January, 1926, the 400 or so existing stations in the U.S. agreed voluntarily to sign off and leave the airwaves silent so that American listeners could make an effort to hear Europe. I recall it vividly, and the information from Gene Allen of Vallejo, California, places the date at January 24.

Word of this silent night appeared in the newspapers and in Radio Digest, a weekly publication of that day (15 cents) mainly concerned with programs and personalities of this marvelous new toy which brought music, information, and entertainment through the "ether" into the home. At that time, it was six or seven years before the first news broadcasts on radio. The first deejay was about 15 years into the future, although radio networks were to come along within one year.

I do not recall here in 1972 exactly how long that sign-off period lasted, but it was at least one hour, and I believe longer than that. At that time, I was 14 years old, living in Wichita, Kansas, and the family had a fine, new radio, a six-tube battery set, plus a large loud-speaker, about 18 inches tall, and at least ten inches wide across the speaker-opening. The make of the radio was Thermiodyne; it was one of the first sets to feature one main dial to tune the broadcast band, but it was equipped with four vernier dials to refine tuning, one vernier for each condenser.

All U.S. stations signed off at the appointed hour that night. The silent period began in the area of 8:00 or 9:00 p.m. EST. I believe that all Canadian stations must have followed suit, as well as the very few Cuban and Mexican stations which

existed in 1926.

I began the search for Europe up at the top of the dial, 545 meters (550 kHz), for that frequency becomes the "top" when your frame of reference is meters. The log books of that day showed that Britain operated powerful transmitters at Daventry there in the long wave area. The Thermiodyne, however, could not reach the Daventry wavelengths.

Step-by-step, I tuned across the dial to hear nothing but the grumble of static, the popping of interference. The South Main streeteer line, on which I lived, kept right on running during the silent period, now and then blanketing reception with the unparalleled interference which only a trolley creates.

All the way from 550 to 950, the broadcast band yielded only audio silence. Eighty feet of overhead long wire could pick up nothing in the way of audio.

But here at 950 was voice. Great excitement! Through the noise, it became plain that the voice was speaking English. It had to be Europe! It had to be England!

Soon, after adjusting all the verniers, and centering on the signal, it became apparent that the broadcast was a church service. It went on and on, and I began to doubt that Europe was coming in. Still, I didn't want to leave 950 and look into the other frequencies farther on (960 to about 1380), for I feared losing what I had.

Finally, there came on the hour, I suppose, an announcement: "KPSN, Pasadena, California." And if memory serves me correctly, it had been a broadcast from the First Baptist Church of Pasadena.

I recall seeing in Radio Digest later on that listeners across the nation heard KPSN that night and it was explained that KPSN's operators just didn't know they were supposed to be silent at that time.

A full account of this extraordinary event in the history of radio could surely be found by checking the files of the New York Times in late January, 1926. Additional information might be found in the files of the Chicago Daily News, for the News was devoting considerable coverage to radio developments in those days.

In any event, nothing like this night ever happened again in U.S. radio; there never was an occasion after this when all American stations observed a simultaneous silent period for the benefit of DXers. The fact that it happened at all, however,

serves to indicate the widespread popularity of DXing in 1926.

Gene Allen's recollections on this event say that he received word from Radio Digest listing an entire week of trans-Atlantic tests, Jan. 24-30, 1926. He recalls that all U.S. stations signed off around 10:00 p.m. CST for this week. During this test period, Allen reported reception of 5SW in Scotland heard one night. At that time, Allen was living in Doniphan, Kansas, the northcast corner of the state, using a 3-tube set operated on batteries from a super DX spot on a high hill in a rural area.

My own recollections on this event are entirely from memory, for I was only a couple of months into DXing at that time, and had not yet begun to keep a logbook. Neither had Allen, for he wrote me, "I have only memories, a few veries, and certificates of those early days."

Ben Veio of San Jose, California, another old-time DXer, wrote me that his log during January, 1926, doesn't reflect anything unusual. In those carly days, of course, DX clubs were non-existent, and there was no information machinery set-up to disseminate DXing information to all who might have been interested.

Gene Allen, who began DXing in 1923, even recalls that when he began listening to radio, all stations in the United States transmitted on the same wave, 360 meters. Nowadays, that wave belongs to WCCO, 24 hours a day, 365 days a year.

By late 1925, when I began listening, the upper and lower limits of the broadcast

band were from 1380 to 550.

As to that silent night more than 45 years ago, one thing about it seems note-worthy now, although it didn't seem unusual at the time. Not one Spanish-speaking station was heard during the silent period, although nowadays you would hear them on every frequency during such a test period. Perhaps it's just as well that no Latin American could be heard then, for I would surely have believed it to be a Spaniard.

DXing from Alaska-- Glenn Hauser

Wayne Plunkett, Richard Wood, and I spent four weeks in June and early July driving through British Colombia, Yukon, and Alaska; we visited virtually every radio station on our route, including some LPRTs, such as "CBDX". Wayne made nightly checks of skywave reception (which dwindled to less than an hour as far north as Circle, Alaska--and which was totally wiped out during the June 18-19 magnetic storm, in Whitehorse. Imagine tuning across the BCB in the middle of the "night" and hearing absolutely nothing -- ground or skywave!) No doubt a far cry from optimum winter-night conditions. At this time of year nothing from outside NA was heard on MW. However, at McBride, B.C., on June 12 around 0700 GMT, we heard a carrier on 1423 kHz, occasionally fading up with march music. Ideas? Reception from east of the Mississippi was poor-to-nonexistent. Stations that could be counted on to appear if any did were CKVN-1410, KRED-1480, KGA-1510, and XEPRS-1090. At AFRN HQ, Elmendorf AFB (Anchorage), Wayne copied down a station list from a map; it may or may not prove to reveal new information. We did learn that the Kodial stations have closed. And it's not AFRS, as in the NRC Log. As for the W- calls perpetuated by Vane Jones, personnel at Fort Greeley-980 had never heard of "WXLL". Tok-1400 was listenable as we passed through the area, as were Clear-1490 and Elmendorf-860. The adjacent Fort Richardson-1360 was closed some years ago due to lack of manning support from the army. Nevertheless, one of few signals audible at Circle, Alaska, (the furthest north one can drive on a continuous road) on June 23 when the sun but grazed the horizon was an AFRN on 1360 (Fort Wainright?).

Of the dozens of stations we visited, KJNP-1170 stands out. The operation at North Pole must be seen to be believed? Manager Don Nelson gave us a grand tour of the facility which on the outside looks like a log cabin, but inside becomes an immense studio/transmitter/office/housing/commisary complex. Most of the staff are volunteers who "live in" at the station. Rev. Nelson talked very knowledgeably about propagation and technical problems, and revealed plans to apply for BCB off-the-air relays at places in Alaska still lacking local radio (e.g., Dillingham, Barrow). Next time you're in the Fairbanks area, a visit to "King Jesus North Pole" is a must. And contrary to my expectations, it turned out to be a very reasonable and moderate

gospel station.

By the way, you may be surprised to learn, as we were, that there have been some changes in time zones. A northeastern triangle of B.C., including the Alaska Highway from Dawson Creek on up is on MDT (GMT-6hr). Whe one crosses into the Yukon (and that happens four times on the road) the clock jumps back to "Yukon Eastern Time" (GMT-8h, year-round). A western slice of the Yukon is on YWT (GMT-9h), with Dawson the only major metropolis in the zone. Alaska is now on daylight time, which means that at the border there is no time change in the summer, but it's called ADT (GMT-9). This includes Fairbanks, Anchorage, and much of the state. Nome and the western portion of the mainland area are on Bering Daylight Time (GMT-10h), while almost all the panhandle (and the remainder of B.C.) is on PDT (GMT-7h). I suppose the frontier people are trying to keep up with the rest of North America—there is certainly no earthly reason why areas where it never gets dark in the summer need to advance the clock to "save daylight"!

The greatest discovery on our trip was an American LPRT, tax-supported, in Skagway, Alaska. This town of 700 sits on an inlet with high mountains blocking most of the horizon. A long wire atop one of them is said to be necessary to receive any domestic radio in the daytime/summer...hence, an LPRT on 690 was put on the air around 1959 to relay KINY-800 from Juneau. About 1968 it was changed to KJNO-630. There was some conflict of opinion among the residents we interviewed, as to which of the Juneau stations would be more popular today. When it began, the transmitter was supported by voluntary public subscription on the order of \$3 a head. The tiny

transmitter (judging from its spotty coverage of the town, not more than 5 watts) is not the expense, but the line charges to haul in the audio from Juneau, are. Currently the relay is supported by the city government, which in turn levies a <u>license fee</u> on all the residents based on the number of radio sets in the household (car radio excluded)—much like in Europe. The station transmits from a longwire on the City Hall, and is controlled by a timer to operate between 0600 and 2400 (sometimes 0100) local time (currently PDT). To the best of our knowledge, this type of operation is unique in North America, and was previously unknown to the DX world (and the FCC?). Lest you despair of ever hearing this outlet, we were never quite sure the transmitter was exactly on 690....

#### Cheju Island

The Far East Broadcasting Company recently lost their station on Okinawa when the island reverted to Japanese rule. Japan rescinded FEBC's license to broadcast into China. FEBC is now building a 250,000 watt transmitter on Cheju Island, "the Hawaii of Korea", off the southern tip of Korea. 36 acres were purchased. It's the first time an Asian government has permitted a non-government private agency to operate

with such massive power. The Cheju station is FEBC's biggest project in its 25 year history. The Cheju location is more strategic than the previous Okinawa site, since it is only 250 miles from Shanghai. The Cheju station will be  $2\frac{1}{2}$  times more powerful than the Okinawa one. (FEBC pamphlet on Cheju Island, via Mike Hardester)

#### Percy R. Kesteven

In the past few months a considerable amount of interest has been expressed in the feasibility of our Club adopting offset printing for the <u>DX Monitor</u>. In this article, I will attempt to point out the strengths and weaknesses of the concept, without attempting to reach any conclusions. I trust that this effort will assist the membership in viewing the overall question.

What is Offset Printing?

Before answering this question, perhaps a word of explanation concerning IRCA's present printing system is in order. Currently in use is a stencil process called memeographing. A sheet (called a stencil) made of a paper substance and covered with wax on one side, is placed on a hollow metal cylinder. Ink from inside the cylinder passes through areas of the wax which have been broken previously (by drawing or typing on the stencil) on to the paper which passes underneath. Thousands of sheets of paper may be printed from one stencil. Stencils may be used, stored, and re-used.

In offset printing (its complete name is photo-offset) a rather different approach is utilized. The material to be printed is photographed (in "black and white"). In fast print shops, such as ones which would do our printing, the Itek or paper plate process is most often used. A paper plate goes where the negative (or film) in a camera would be found. The plate is exposed directly to the copy material, then developed and placed on the press. The plate is inked, as in letter press printing, and one sheet at a time is placed against the plate, to absorb ink from it. This method can produce thousands of copies. With respect to the number of copies, neither method holds any particular advantage or disadvantage as far as the IRCA is concerned. What are the Advantages of Offset Printing?

(When discussing "advantages" and "disadvantages" of offset, the reader should bear in mind that we are comparing offset, a possibility, to mimeo, a present reality.)

The first advantage of offset involves the type of material which can be reproduced. Typed material is handled easily, as are newspaper clippings and most drawings. Photos, by the use of a halftone negative, can be printed with good resultant quality. Photos cost more, as do certain types of colored inks which must be photographed with a special filter. A few kinds of verie cards would not reproduce well, but most verie letters could be handled. Editors, instead of typing stencils, would simply retype their material on sheets of paper and submit these. In some ways (e.g., correction of errors) this would make the task of editing and typing somewhat easier.

One of the reasons for adopting offset would be cost, a factor discussed later in this article. To reduce costs, smaller bulletins (in physical size only, not in terms of information) might be produced. An  $8\frac{1}{2}$  x ll piece of paper, such as the one you are presently reading, would be printed in such a way that four pages of information would be contained upon it (instead of the two--back and front--now in use). To visualize this (if you haven't seen an NRC or SPEEDX or ASWLC or NASWA bulletin), fold this sheet so that bottom meets top to produce two halves, each  $5\frac{1}{2}$  by  $8\frac{1}{2}$ . Turn over the folded page so that it faces you with the longer side running away from you, in the same manner that the longer sides of this sheet go away from you. All the information on this page could be printed on one of the four quarters of your folded sheet. The negative made by the printer is used to reduce the page size and make smaller printing possible. Another method of increasing information per square inch of paper; might be the two-column method used for the "IRCA Convention Highlights," a sheet which appeared in the Jly 15, 1972 issue of DX Monitor. (It should be noted that while the typewritten print approximates the quality which might be realized through regular offset publication, the photographs do not. This is due to improper preparation and handling of the original photos.) Though either of the aforementioned methods could be used on several sizes of paper,  $8\frac{1}{2}$  x ll sheets would likely be utilized because this particular sizw is a very popular dimension and is available at low cost.

Reduction of difficult physical labor for the publisher is another strong argument for offset printing. The publisher has the task of collecting, completing, and finally, mimeographing, all stencils. Then the tedious, monotonous job of collating (putting together in order), folding, sealing, labelling, and stamping all the

envelopes follows. No man can be expected to handle this amount of work for overly prolonged periods of time. Including sample soulletins, the publisher performs the entire collate, -fold, -seal, -label, -stamp task 500 times per issue, 34 issues per year. Quick arithmetic reveals that 17,000 bulletins are assembled annual in this fashion! Because of the enormous amount of labor involved, our Club membership is regulated somewhat by the publisher so that it never exceeds 500. This restriction, controlled mainly by the number of sample shulletins mailed to prospective members and tempered by non-renewals, is necessary to equalize and stablize the work load and keep it within reasonable limits. It is necessary, but it does limit Club growth. With the offset printing method, the larger the number of copies, the less the cost per copy. Thus unlimited Club growth would not only be encouraging, it would be highly desirable.

As things presently stand, our Club is entirely dependent on the publisher for its output. In the event of an accident or ill-health (an unpleasant but necessary thought) publishing would cease immediately. Although requests have been put forth in the past for a volunteer standby publisher, none has been found. A professional printer would need only the completed sheets of material. Though perhaps in a less competent manner than the regular publisher, this material could be prepared by an emergency crew for the duration of the immediate crisis.

Finally, the smaller offset booklet would result in more material in less space (assuming the small booklet format was adopted). Even the two-column format, while still occupying  $8\frac{1}{2}$  xll, would be thinner.

What are the Disadvantages of Offset?

Firstly, there is the matter of cost. This, and this alone, is the true key to the IRCA's failure, up to this point, to adopt the offset method. In late 1970 an Offset Committee Task Force, headed by Chairman Saralie B. Northam, studied the cost problem in detail by soliciting estimates from various printers. (The bulletin format was to be the folded booklet mentioned earlier.) It was discovered that, assuming a membership of 500, it would would cost the IRCA between \$4,250.00 per year and \$10,710.00 per year. (These figures reflected the choice of printers.) There were a number of assumptions made for the sake of simplicity. This cost compares very unfavorably with the present prince (using volunteer labor) of \$1,478.00. (All of the figures quoted exclude postal expense.)

Father Jack Pejza, Chairman of the newly formed Offset Publishing Committee, is investigating once again the possibility of changing to an offset format. This time a number of page designs and structures will be explored and estimates for each solicited from printers.

There appear, at present, to be only four logical methods which could be incorporated if offset is to become a reality.

1. Higher dues must be charged, OR

OR

2. Bulletin size must be reduced (i.e, fewer sheets of paper due to reduction)

3. The number of issues must be reduces, OR

4. We must obtain a Second Class Mailing Permit from the U.S. Postal Service. (Because postage amcunts to one-half of the present total cost of mimeograph production of <u>DX Monitor</u>, it is; an important factor in considering offset costs. Postage costs would be drastically reduced if the Postal Service decided that hobby clubs were qualified for non-profit postal rates. Alas, this hasn't happened thus far.)

Microprinting, an apt nickname for the relatively tiny printing which emerges when a standard size bulletin is reduced to about 66 2/3% of its original size (as is done in the NRC bulletin), certainly emerges as another undesirable aspect of offset printing. One possible solution might be to reduce the type size to only 90% of its original while retaining the page size(s) mentioned earlier. This would entail smaller margins on the original material for printing (and hence less information) but there is no reason why margins at the top and bottom of each page could not be extended to the limit, thus making up for the loss. (Those top and bottom margins found in NRC's DX News and some other DX club offset publications, definitely do not utilize all the available space.) As things presently stand, the U.S Postal Service willnot acceppt as Second Class Mail material which has standard typewriter letters. In order to obtain a less exepnsive method of mailing bulletins, it may be necessary to reduce

type size to  $66 \ 2/3\%$  (despite the resultant microprinting) to qualify as an organization not using standard typewriter letters in its publication.

Though the smaller bulletins would mean more information in less space, some members might find that their current pet practices (such as saving only the front page with the DX Calendar, and the "yellow pages") difficult, as material would be much more tightly knit. This would be especially true if the booklet format (a la NRC) were chosen.

Finally, the moment a switch is made to offset printing, the Club loses some of its independence. We become tied to printer's deadlines. etc.

In Conclusion

I attempt no conclusions with this article. I only hope that some of the confusion existing in members' minds over the issue of offset printing has disappeared. Percy has given the membership a good introduction to some of the problems involved in a possible switch to offset in the above article. As he has pointed out, the main factor involved in such a switch is the cost. We would go from a situation where all of the work is volunteered, to one where we would pay a printer to do the job. The question really becomes then, is the additional cost worth the advantages? To my mind, the two main advantages are a reduction in the workload of the publisher, and the appearance of the pulletin. Let's face it—we are competing with other DX clubs for members. Not everyone can afford to, or wants to, belong to every DX club in existence. A prospective member will evaluate the sample bulletins he gets both with: regard to content and appearance. I'm not going to argue here that our content is superior to that of the other clubs; I'm only going to say that I think a club with an offset bulletin has an advantage over one with a mimeo bulletin, from the viewpoint of appearance.

One further comment on Percy's article— I do not consider "microprinting" an objectionable feature of offset printing. Reducing the typed master copies to 90% of their original size, even with decreased margins, would cancel out the space—saving advantage of reduction. 66 2/3, or perhaps 75% reduction, would be the only practical method of reduction.

At the moment, I am the only member of the committee given the task of looking into the possibility of offset printing. If you are interested in this topic, please let me know if you wish to aid me on this committee.

Minority Report, Offset Printing My opinions on which are advantages and which are disadvantages are quite different than PRK's. For the most part, I agree with Father Jack that "microprinting" is not a large problem. And a 90% reduction would hardly be noticeable or worthwhile. Percy's statement that the membership is held below 500 is at least a year out of date—at present, there is no likelihood we'll reach 500 until late this fall; with the second mimeo machine now in use, there is no practical limit on growth—obtaining new members is no easy job. There will be more comment on offset printing in months ahead. —DEE
