No CDXF Next Issue John Zondlo advises that there will be no CDXF for the 12/23 issue due to other important responsibilities during the Christmas holidays. In addition, Bruce Heimburger will be home from school for a couple of weeks. Andy Hecker's stencils will be done by DEE in Riverside. No other changes in schedule are known at present. For the future, editors are requested to PLAN AHEAD and make arrangements with HQ so that members know in advance when there will be no issue so they can mail to an alternate area, or to an alternate editor.

Roughly equally, members have spoken for deleting "dead" countries; for counting them separately from active countries; and for lumping them all together. The case of WFEA is interesting, as they used to be an excellent verifier; I have a nice glossy card from them a few years back. Wonder what turned them off? Perhaps angry, demanding DXers, or bad reports? In any case, half the fun of DXing is applied psychology, looking for the loophole, the personal approach: Dave suggests writing the DJ. just one of many possible approaches. DXing is a highly personal, intimate thing - which is one reason I say that non-persons (agencies, bureaus) have no place in our ranks. 15 years of DXing have convinced me there's no such thing as a non-verifier; which doesn't mean to say I don't have plenty of hold-outs (including KGMO Cape Girardeau MO which S.J. Hill inquires about). And remember: a Swedish DXer reported a Venezuelan stn in 1947. The verie was delivered to his son in 1969. This season, both Christmas Eve and New Year's Eve fall on Monday mornings, something that happens every six years or so. These dates, particularly Christmas eve, present unusually good Latin American DX opportunities for a combination of reasons; first many domestic stations should be off (since it's Monday morning); then many LA stations should be on (since it's Christmas eve). In particular, look for LA stations broadcasting midnight Masses (starting, depending on time zone, from 0400 to 0800 GMT) and lasting about an hour. Look for hymns or carols (not necessarily the same ones we use), a sermon, but don't look for frequent IDs, as the stations would probably only cut in on the hour or half-hour, in these remote broadcasts. In the past I have listed stations which have been heard on Christmas Eve, but I decided not to do so this year. Many of the stations which I had listed haven't been heard on Christmas eve for several years, so there might be some question as to whether they still have a Christmas eve program. Then too, no one apparently DXed ( or at least heard anything worth reporting) last Christmas eve, as I can't find any LA stations at all listed for 12/25 for last year.

New Year's Eve might not present quite as good an opportunity as Christmas eve. For one thing, I don't think most LA countries go in for the celebration quite as much as we do, and hence might not be on with a special broadcast. Then too, the possibility exists that some domestics will stay on. But try both nights—you might come up with some excellent receptions.

While I'm on the subject of Christmas, I want to wish each and every one of you a very happy and blessed Christmas, and a prosperous and peaceful New Year. Unfortunately, I am not in a position to send each of the many contributors to this column (and to the many others in the hobby whom I know) a Christmas card. So for most of, this will have to be my best wishes.

From time to time I note the words "EE (accented)". I think this is a meaningless, subjective term: one man's "accent" is another's standard speech. Perhaps the BBC announcer would consider our EE "accented". If a specific form of language is used,

(and would aid identification), it should be dispassionately characterized and desscribed. (Editor's comment: How about using "British accent"? This would, it seems to me, describe the particular form of speech somewhat better.)

Effects on Broadcasting of Martial Law in the Philippines -- Charles A. Taylor By presidential order, all BC and TV stations were closed, including the governmental Philippine Broadcasting Service and Voice of the Philippines (for 36 hours, in the cast of PBS and VoP) on Saturday, September 21, 1972. As of November 4, approximately 45% of the broadcast stations have been authorized to resume operations. However, two of the national networks, Elizalde Tri-Media Network (based on the old Manila Broadcast Corporation and other Elizalde broadcast holdings), and ABS-CBN Broadcast Corporation; are still at least partially silent. Rumor has it that in the case of ABS-CBN the sole stockholder, Eugenio Lopez, will have to divest himself of his holdings. Also, the Associated Broadcasting Corporation (owned by the Manila Times) may have suffered the same fate. Needless to say, all the silent stations are a boon to DXing. The absence of locals and semi-locals on some frequencies has enabled me personally to log many domestics (Philippine type) that would remain covered by stronger signals. Those stations that remain on the air are more subdued and have certainly toned down their constant, vitriclic "yellow-journalism"-type attacks on the Administration. The declaration of martial law will probably allow tightening of many technical standards, of broadcasting, such as frequency tolerances, distortion standards, frequency separation standards, minimum efficiency requirements for antennas, etc. Currently, in the greater Manila area, the following stations remain in operation: DWKD-555(ex-DWKY-560, DZBB-580, 10 kw; DZAS-680, 40 kw, (FEBC); DZFM-710 (PBS), 10 kw; DZBM-740, 5 kw; DZRJ-780, 5 kw; Radio Veritas-860, 50 kw; Voice of the Philippines-920, 50 kw; DZFE-1030, 5 kw (FEBC); DZHP-1130, 10 kw; DZRM-1190, kO kw; DWWW-1280, 25 kw; DZCP-1500, 5 kw (PBS); also DZFM-FM, 103.5; DZCP-FM, 104.5, and DZBU-FM, 107.9.

Bill Hardy sends along the following item from the 11/25 <u>Billboard</u>:
Manila--Three more radio stations in this city have resumed operations after being cleared by the Department of Information and the Department of National Defense, following the recent ban--DZBM, owned by Mareco Broadcasting; DZBB, sister station of Channel 7; and DZRJ. Both DZBM and DZRJ broadcast in English and program foreign records in English. DZBB now broadcasts in pidgin Tagalog and programs domestic productions.

#### Policy on Listing Stations heard on Harmonics

It is my policy to print reports submitted on BCB stations heard on harmonics (e.g., a station on 1000 kHz heard on 2000 kHz) solely for the purpose of establishing that such a station is actually in operation. Many of the stations reported in the past are stations which would not ordinarily be heard on the fundamental BCB frequency because of interference from other stations, domestic or foreign. I will list them with slogans, etc., only once or twice. The purpose of this column is not to list all loggings on all frequencies—this is not a shortwave club. However, on some occasions, such stations have been reported on their BCB fundamental frequency later. Hopefully, the inclusion of such harmonic information has helped ID such stations.

### Time-Zone Lines

Several issues ago I made a comment that the boundary between MST and PST, following the boundary between Baja California and Baja California Sur (running East-West) was possibly the only place in the world where one could lose or gain an hour by travelling north or south. I have been informed by several members that such boundaries are far from unique; there's one between Texas and New Mexico, within Idaho, between British Columbia and Yukon; Glenn Hauser comments that many generally N-S boundaries have jogs in them allowing a time change by going N-S at certain points. I stand corrected, on my spur-of-the-moment comment.
