NEW FCC ID RULES On page 17 of the 11/25 DXM we promised to publish the new FCC rule on station ID's as soon as it became available. Mike Northam has kindly sent a photocopy of the Federal Register, pages 23723-23726, 11/8/72, so we can now fulfill this promise. Thanks, mbn.

The station ID rule is Section 73.1201 under Subpart H, "Rules Applicable in Common to Broadcast Stations," so the rule covers AM, FM, educational FM and TV broadcast stations. Paragraph (a) was changed to provide for hourly ID's on both radio and TV, as close to the hour as feasible, rather than within a 2-minute limitation, and the ID on the half-hour was eliminated for radio (it was not required for TV before). Furthermore, paragraphs (d), (e), and (f) were eliminated. Paragraph (d) pertained to program interruption (breaking for ID's in sports events, concerts, or other continuous broadcasts), (e) pertained to deferred station ID's (postponed by any of the above), and (f) provided for ID's up to 15 minutes late during equipment performance measurements. Since (a) now states "as close to the hour as feasible," the detailed rules in (d), (e) and (f) are now unnecessary. Paragraphs (b) and (c) are unchanged, and are reprinted below.

Here is the new regulation, effective December 15, 1972:

Section 73.1201 Station identification.

(a) When regularly required. Broadcast station identification announcements shall be made: (1) At the beginning and ending of each time of operation, and (2) hourly, as close to the hour as feasible. Television broadcast stations may make these announcements visually or aurally.

(b) Content. (1) Official station identification shall consist of the station's call letters immediately followed by the name of the community or communities speci-

fied in its license as the station's location.

(2) When given specific written authorization to do so, a station may include in its official station identification the name of an additional community or communities, but the community to which the station is licensed must be named first.

(3) A licensee shall not in any identification announcements, promotional announcements or any other broadcast matter either lead or attempt to lead the station's audience to believe that the station has been authorized to identify officially with cities other than those permitted to be included in official station identifications under subparagraphs (1) and (2) of this paragraph.

NOTE: Commission interpretations of this paragraph may be found in a separate Public Notice issued Oct. 30, 1967, entitled "Examples of Application of Rule Regarding Broadcast of Statements Regarding a Station's Licensed Location."

(FCC 67-1132; 10 FCC 2d 407).

(c) Channel--(1) General. Except as provided in subparagraph (2) of this paragraph, in making the identification announcement the call letters shall be given only

on the channel of the station identified thereby.

(2) Simultaneous AM-FM broadcasts. If the same licenses operates an FM broadcast station and a standard broadcast station and simultaneously broadcasts the same programs over the facilities of both such stations, station identification announcements may be made jointly for both stations for periods of such simultaneous operation. If the call letters of the FM station do not clearly reveal that it is an FM station, the joint announcement shall so identify it.

You might be interested in the FCC's accompanying order printed in the Federal Register and what it had to say about changing the ID rule. "Requirement for more frequent identification of AM's and FM's is unnecessary. Identification at a natural break in programming is a simplification and restatement of the present 2-minute provision and its allowable variations." The FCC later states that all seven rule changes (see 11/25 DXM) will be "to the benefit of many and to the detriment of none; and that they will better serve the public interest. Therefore, prior notice of rule making and public procedure thereon are unnecessary..."

Really, unless a station has an uninterrupted hour of dinner music or underground, you probably won't hear the call letters any less often. You just may not hear the city of license at the bottom of the hour (like, KISN vancouver?). --BH.
