About the only thing reported here recently to SDPC is news of Rev. Carl McIntire's Radio Free America. According to news clippings sent by Angel Garcia, Vern Maxham, and Bruce Portzer, RFA went on the air on regular schedule at 12:23 PM September 19 on 1160 kHz. (Tom Sundstrom heard an ET on 9/12--see DXWW). The ship, the Oceanic (to be rechristened the Columbus) was originally anchored three miles off Cape May, NJ, lost an anchor Friday, 9/14, and came into port, then moved 12 miles off the coast. After complaints of interference from WHLW-1170, Lakewood, NJ, McIntire voluntarily shut down on Sept. 20. The next day, a federal judge in Camden, NJ signed an order for-bidding RFA to broadcast. The FCC filed a complaint that RFA was interfering with WHLW and KSL-1160. McIntire was ordered to shut down until October 1, when a court hearing will de-termine whether he should be silenced permanently.

Along the same lines, hearings in Washington are considering whether or not to close down KAYE, Puyallup, WA, another right-wing station.

Gilfer Associates has just purchased the remaining copies of the 1973 World Radio-TV Handbook from the publisher. They are offering the remaining copies for \$4.50 postpaid. They pass on the word that the 1974 WRTH will increase in price and probably won't be available in North America until very late in January. Gilfer's address is P.O. Box 239, Park Ridge, NJ 07656.

SWAZILAND Official permission has been granted for the construction of a new Trans World Radio station in Swaziland. The station is expected to be on the air in early 1974. At first a 50 kw MW transmitter will be used, but later a 400 kw MW transmitter will be put on the air. (SCDX) JAPAN -- Glenn Hauser

Regarding Gene Martin's case for reception of VOA Okinawa on the east coast, in 9/22 DXWW: I have always believed that radio signals must follow great circle paths, with only slight variations caused by ionospheric discontinuities. If this is true, there is no "long way" between Okinawa and the East Coast via the Soviet Arctic! Between these two points the signal may travel in either of two directions 180° apart. The conventional short path passes over the eastern Soviet Union, across the Arctic Ocean and the NWT, Hudson Bay and on into New York, for example, from the NNW. The long path (about twice as long as the short path) goes SSW from Okinawa over the Philippines, Indonesia, just misses western Australia, cuts across Queen Maud Land in Antarctica, the passes over the entire length of Brazil and enters New York from the SSE. This path might be possible during twilight at certain seasons, but would be much less likely than the short path be-cause of the directional pattern of the station; lots of tropical thunderstorms in Indonesia and Brazil; general absorption due to distance; and south polar auroral zone absorption would presumably be just as much of a problem as in the north. True, Okinawa often makes it to Sweden, but the signal proceding on from there along the great circle would pass over the eastern Atlantic and hit Brazil, missing eastern North America by a long shot. If there is some means by which the signal can take a turn of some 45° over Sweden, I'd very much like to hear about it! By the way, Korea is due north of Okinawa. I don't know what azimuth is actually employed, but I doubt it's NE. The Korea beam is certainly more favorable for us in NA, but I doubt we're getting the full benefit of it, unless we're in Newfoundland or Greenland.

LISTENING TO TP's EARLY IN THE SEASON (And also being a few thoughts that apply equally to the Down-Unders and longest-distance South Americans)

#### JAY MURLEY

Within a short time, the trans-Pacific stations ought to be rolling in. Rolling in so well that West Coast DXers can  $\frac{1}{2} \left( \frac{1}{2} \right) = \frac{1}{2} \left( \frac{1}{2} \right) \left( \frac$ simply bite a long-wire with two teeth fillings and plug the big toe into the nearest wall socket for guaranteed reception. It better be--we've waited a long time for a repeat of the low sunspot counts of the early fifties.

In the meanwhile (this is written in mid-August...and maybe you'll read it before the band breaks wide open), you

can still DX TPs.

The secret is knowing what a five thousand mile plus signal is like. It is not like getting up ten minutes before sunrise in hopes of finally logging WXXX signing on twelve seconds before WYYY and WZZZ because the other two happened to have over-sleeping or hung-over disc jockeys. It is not like dialing your local 50,000 watter on a Monday morning in hopes that they're finally taking a few hours off for engineering—and opening up a 30 kHz bandspread.

The trans-Pacific signal is like a long Pacific ocean swell. It always fades in and out a bit. Sometimes all the swells are quite pronounced overall. But every so often, what surfers used to call the ninth-ninth wave, will carry some real beauts past Western antennas. If your set is on, if you're at the right frequency, and if your loop is pointed just so, great. The name of the game is waiting and waiting for a surge big enough to carry those TPs to your set's reception requirements.

Once you get on, the TP signal may have a lot of flutter. Keeping our wave analogy going, the swells may be choppy--eliminating any possibility of good, clean waves. From\_a technical point of view, the long rolling swells

exist in TP DXing for the same reason such waves exist best on the Pacific Coast. It's the big ocean--two-skip DX is the minimum; three-skip DX accounts for most Chinese, and fourskip DX is the rule of thumb for most Aussies and the far inland Chinese (particularly Urumchi). The closest they'll see to this back East is the summer DXing of Chile, Argentina, and the various South African states.

The flutter is a little more complicated. Let's assume that a signal from JOXX to your home has a great circle route right over Anchorage, Alaska. Let's also assume that the great wet blanket in the absorption layer that eats night-time skywave signals whole has a border that night of Anchorage-Juneau-Edmonton-Winnipeg-Ottawa. That border will be circular, of course, heading well out to sea between Anchorage and Juneau. Poof! There go all your prospects for TP DXing, right?

Wrong. That blanket's lower edge sits fifty or sixty miles up in space. Multiple skip radio signals travel at incredibly low angles, providing you offer no obstructions of terrain to block reception. Good old JOXX might be coming in for a second bounce somewhere off the Alaskan panhandle. If JOXX sneaks in under the blanket, part of its signal is going to wobble a bit from the near miss. Net result, flutter.

And don't always expect to hear anything decent at your

location. On Friday, August 17, I started with 830 kHz.Pre-dictably enough WCCO and KIKI were fighting it out. Neither the Minneapolis MoR with its farm advertising or Hawaii's second rocker count as DX from here, so I sat on 830 from 1120 GMT on. 1126:55 brought me twenty seconds of realization that a third station was back in the soup; the way it faded assured me that I wasn't dealing with one of the three Mexicans. There were only two decent snatches of audio: half a minute each at 1134:20 and 1142:00. By 1147 GMT, I was tired of 830 so I went hunting, sitting on a few likely split channels in case my BFO could pick up a swell. 655, 725, 844, and 877 were all unproductive. A wasted hour? Maybe--but I didn't expect anything colossal. So I wrote this article as I sat. Had it been different, four or five early receptions might have been reported--instead of the two unreportable near misses on 830 and 877. Great moral lesson in the sky--long-haul foreign DXing happens to require patience most of the time. And when all hell breaks loose, and you lock a standby rig onto a far eastern superpower so you can log all the low-power network repeaters (boosting, say, your North Korean heard totals from three to eight in half an hour), it helps to know what you're doing--or failing that, be very conscious of how to use the WRTH, IRCA Foreign Log, and such aids as the Worldwide Sunrise-Sunset Maps.

RAMADAN is the Moslem holy month of fasting. Pious Moslems do not eat during the day from Sept. 28 or 29 to October  $\,$ 28 or 29, but after the sun goes down, there are great occasions for feasting, etc. Most stations from Moslem countries, such as those in North Africa, stay on the air all night during Ramadan, and a great many new stations have been logged here in North America during this period.

### **CLUB NEWS**

Now that the term of office for the new club officials has begun, some people are probably wondering how things will be done this term.

Outwardly, most aspects will remain the same. There will be a Board letter each month, done about the first week-end of the month. There will also be a President's Report in the DXM, along the same lines as before. In these respects, things will not be changed.

respects, things will not be changed.

I believe the new Board feels the way I do, in that we are "management" in a business sense (IRCA is incorporated under Colorado laws as a non-profit organization), as opposed to a "government" in the political sense some would have us believe. This change in attitude will be the main change from previous administrations.

All those wishing to bid for the convention to be held during the summer of 1974 must contact me prior to Nov. 30th. Convention bid forms will be sent to all those who request them. FECIAL PROJECT:

I hope during my term of office to compile a cross-reference card file of all proposals which have been sent to the Board during all administrations. I feel that nobody in this club has complete knowledge of all the proposals, approved by the BoD's over the past nine years, by which this club is supposed to be "governed". To date, there are about 700 of them. Not all were approved, and several have since been rescinded.

SPECIAL REQUEST:

Though circumstances may warrant otherwise, I hope to continue with the CDXR column. However, my reports are requested to make things as easy for me as possible. While I run a Wednesday deadline, I would prefer to get reports on Tuesday or before.
MINI-REPORTS:

From time to time, I may have some small items of "government" which I wish to pass along to the membership without waiting for the first of the month President's Report. These might be found at the end of my CDXR column, particularly if there is a time value attached.

The majority of the August ANARC Newsletter consisted of a summary of the convention and ANARC business. Steve d'Adolf has been appointed Chairman of the Public Relations Committee, He will be assisted by Woody Seymour and Dave Browne. The goals of ANARC were outlined, as indicated by discussion at the convention. They included: clearing house for clubs, generator of cooperation, crystalizer of ideas, promoter of clubs and hobby. More cooperation with European DX Council and similar organizations elsewhere in the world is being sought. In news from the clubs, NASWA reports on rules for sending taped reports. Article 22.7 of the Postal Service Manual allows a tape and an attached letter to go at a nice rate as a "combination package." Letter goes regular postage, tape goes "AO"; the average is about half of the usual rate for a four-ounce taped report.

#### SPECIAL FEATURE BILL HARDY, ed.

RADIO FREE AMERICA AND REV. CARL MCINTIRE

As "Flash Tips" in the 9/22 DXM pointed out, Carl McIntire's "Radio Free America" has been on the air. (I believe the start date should be Wed., Sept. 19, rather than Sept. 12, as the first item KGHO received from Associated Press saying "McIntire began broadcasting...today" is dated 9/19.) However, he was off the air the next day. Another AP dispatch received at KGHO, this one dated 9/20, indicates that McIntire left the air because of interference with MiLW-1170, 5-kw directional daytimer in Lakewood, NJ, 75 miles north of Cape May, NJ, the southern New Jersey resort which McIntire is anchored more than three miles offshore from.

The president of WHLW says McIntire telephoned the station the night of 9/19 after receiving word that he was interfering with WHLW by his operations on 1160 kHz. The WHLW president, Seymore Abramson, says McIntire told him he had no intention of interfering with the WHLW signal. Abramson said a telegram complaining about the interference also was sent to the FCC in Washington, but the FCC had no immediate comment.

McIntire was not immediately available for comment, but a spokesman confirmed his station went off the air at 10 pm (EDT) the night of the 19th.

In the AP story of the 19th, FCC lawyer C. D. Roberts, Jr., was quoted as saying the ship broadcasts were illegal, but added that the FCC will have to take "a few preliminary evidentiary steps" before moving legally to stop them.

Radio Free America operates with a 10-kw transmitter aboard a converted minesweeper, the Columbus. An article in September 10th Broadcasting (information used by permission) reports that although McIntire is operating from outside the territorial three-mile limit of the U.S., thus seemingly outside any U.S. authority, an FCG lawyer has pointed out that Section 301 of the Communications Act of 1934, as amended, bans the use of radio by anyone "upon any vessel or aircraft of the United States" who does not have a license under the act. And Dr. McIntire reports that the ship is a U.S. vessel. The Communications Act provides penalties up to one year in prison and a \$10,000 fine for violations of its provisions.

In the <u>Broadcasting</u> article, McIntire reported that Radio Free America would begin operations on 1160 kHz, as it ultimately did for one day 9/19, but could shift back and forth among several other frequencies - 692 kHz, 1613 kHz, and 535 kHz - if interference does result. It will certainly be worth the while of all DXers to check all these frequencies during the coming weeks, and keep an eye on Flash Tips, for the latest on Dr. McIntire and his fight to stay on the air - license or no license.

An NBC technician's strike, which would have started 9/22 at midnight was averted. Thus no MM silent periods as sometimes materialize during strikes. This from Bill Hardy.



# New Communications Technique Uses 'Whispering Gallery' Mode



New "whispering gallery" mode of radio propagation recently demonstrated is shown schematically as well as conventional multi-hop high-frequency mode.

Air Force Cambridge Research Laboratory and General Electric scientists recently demonstrated a new type long-range radio communications technique that employs a "whispering gallery" mode of propagation. The experiments were conducted at frequencies of 220 kc. and 440 kc. over a distance of approximately 1,000 mi. between Chico, Calif., and Alamogordo, N. M.

The technique is called the "whis-

The technique is called the "whispering gallery" mode because of its similarity to situations where low-level sound travels over a considerable distance inside a dome-shaped structure, such as St. Paul's Cathedral in London.

The whispering-gallery mode could be used for moderately long-range emergency communications at times when ordinary high-frequency radio will not operate because of solar storms or nuclear explosions that adversely affect the Flayer of the ionosphere from which HF radio signals normally are reflected.

The new technique was initially pro-

The new technique was initially proposed by GE scientists Len Humphrey

and Clayton Roberts, and subsequently extended by AFCRL scientists Gary Sales and John Videberg. The recent experiments were conducted using a small, low-power transmitter on a large balloon at an altitude of approximately 120,000 ft., near Chico, with a similar balloon carrying a receiver stationed at the same altitude near Alamogordo.

The 1,000 mi. range was achieved using pulsed signals radiated at a peak power of only 50 w., with an average power

level of only 3 w. The whispering gallery mode provided gains of at least 40 db. above those that would be achieved in a conventional ground propagation path, according to Videberg. The whispering gallery mode is expected to be usable at frequencies up to nearly 2 mc.

In simplified terms, the new mode of propagation involves two reflections of the signal from the lower D-layer region, instead of multiple-hop reflections of the F-layer region for conventional HF radio. In reality, there are numerous different points of signal reflection from a wide region of the D-layer in the vicinity of the transmitter, and a similar situation occurs near the receiver.

At certain altitudes and distances from the signal source, these multiple D-layer reflections combine to provide an extremely strong signal, a region referred to as a "caustic." Some distance farther, another caustic is formed. The distances and altitude at which these caustic regions of strong signal occur depend in part on the altitude of the transmitter.

During the recent experiments, AFCRL and GE scientists found a caustic region at an altitude of 57,000 ft., which is within range of high-altitude drones, such as the new USAF Compass Cope vehicles. A high-altitude drone could be used to couple into the high-altitude whispering gallery propagation channel and to relay messages to and from the ground. The experiments were conducted using Laboratory Director's Discretionary Funds.
