

Rew Sound for AM

AM radio has a new sound today at 770 on the dial.

It is KTWG, a "nonprofit, nonpolitical, noncontroversial" interdenominational Christian station which was to begin its first broadcast at 6 this morning.

morning.
"We will have good-quality, inspirational Christian gospel programs, good music, classical and semiclassical," said Dr. Paul E. Freed, president and founder of Trans World Radio, an international radio network of which KTWG is a member.

"We are particularly interested in Guam because of its strategic position - because of the Orient, We can reach Mainland China, Southeast Asia, east Russia and Indonesia," Freed said.

Freed said.

The radio station and transmitter of KTWG, located in Nimitz Hill, are the initial steps in establishing a larger transmitter in Merizo for

international broadcasting, he

The projected Merizo station, KTWR, will have 200,000 watts of broadcasting power and will reach locations bordering and within the Pacific Basin.

The present station in Nimitz Hill has a transmitting power of 10,000 watts and will broadcast to Guam and adjacent islands, it was reported. The studio is only temporary and later will be linked to the Merizo transmitter, Freed said, with the studios and offices later located downtown.

The station will "start with local personnel," he added with the number depending on the rate of expansion.

The station's staff now is several missionaries and their families, supported by Christian churches and individuals in the United States.

The target audience is "all the people -- whoever is home, the housewives, children, youth and we may even put on a short Vietnamese program," Freed said,

The station, which was built in three months, will begin with primarily music and later will add a variety of Bible programs. National and international news from Associated Press wires will be broadcast each hour, it was reported.

"We are interested in the people locally and in serving them," Freed said. "When we broadcast we will be talking about Guam and our asset to Guam will not be in money."

The broadcasts will informother countries about Guam and will promote the island, he added.

Freed estimated that the station normally would cost about \$2-3 million but "expects less because of the staff, which is not paid for labor, and facilities, which are already owned or given to us."

The studio's tape recorder, speakers, turntables and several other pieces of equipment were donated by the men of the nuclear submarine tender Proteus, Freed said.

ITU MEDIUMWAVE CONFERENCE IN GENEVA ADOPTS UNIFORM 9-KHZ WAVE PLAN FOR AUSTRALASIA AND EUROPE

PEOPLE'S REPUBLIC OF CHINA NOTIFIES I.T.U. OF ITS PRESENT MEDIUMWAVE ASSIGNMENTS; REGISTERS 1,100 CURRENT ASSIGNMENTS AND CORRESPONDING 9-KHZ WAVE PLAN REQUIREMENTS

MALAYSIA NOTIFIES I.T.U. OF LOCATION OF 1475-KHZ TRANSMITTER

JORDAN AND BANGLADESH OPEN NEW MEGAWATT MEDIUM-WAVE STATIONS

Bangladesh (MWN) The new 1000-kW at Dacca on 690 is now in operation. Noted in Calcutta from 0400 to past 1600 (International DX Club of India).

Brasil (MWN) The Ministry of Communications announces new frequency allocations to be operative from 1.11.75, opening way for 370 new mw stations. All stations will be required to reduce power at night. According to R. N. Brasilia, the power limit will be 200 kW. (New Zealand Radio DX Association via NRC)

China, People's Republic Nearly 1,100 mw Transmitters of 0.3 to 500 kW have been registered by PRC with the International Frequency Registration Board (IFRB) of ITU, distributed on most -10 kHz channels, plus some -5 kHz channels. Only one 500-kW transmitter is registred: Urumqi shi 1520 kHz. 300 kW is registred for 1040 Changzhou (between Nanjing and Shanghai, used in foreign service to Japan and Korea); 1190, 1210 and 1300 all in Kunming (Yunnan) probably used in foreign service to South East Asia (1300 kHz observed while in Philippines 1970-71 ed.). 200 kW is registred for four outlets (670, 1270, 1380, 1540) in Dehua ("Tehwa") in Fujian prov. (probably for Fujian Front programme). (all observed in Philippines 1972-75 ed.) Also 585 Lanzhou ("Lanchow") in NW China (to Inner Mongolia?), 840 Wuhan (Central China), 1170 Qabdo (in NE Tibet) (pronounced approximately Chabdo ed.) and on 1480 Wencheng, Fujian prov. (Special Taiwan service?) (Zhōngyang Rénmín Guangbo Dientai, Taiwan Guangbo, observed in Philippines ed.). 150 kW is registred for 590 Wenchang (Taiwan programme ed), 640 and 720 Beijīng ("Peking"). There are 25 of 100 kW, e.g. 1020 Changchun (Manchuria used in Japanese service?), 1210 Yanji (used for programs in Korean), and 1460 Huhhot (Mongol Service). It is not known whether all those 1,100 transmitters are actually on the air, or if some registrations reflect future plans. Our personal comments would be a surprise over the "low" powers registred for the famous 1525 Urumqi, as well as some of the other FS "power-houses" like 1040 and 1190. (Lars Ryden, Järfälla, SWEDEN) It is my opinion that about half of the assignments registred are projections only. Nevertheless, the ITU list received from PRC is an unprecedented breakthrough. (ed.)

Cyprus (MWN) BFBS has moved moved from 890 to 881; sign-off 2115 (Danish Shortwave Club International).

France (MWN) Radio France is to construct a synchronized relay of the longwave France Inter transmitter. Will be near the south coast of France where reception of present station is very weak. (Le Monde via Alistair Bawden)

Hong Kong Commercial Radio's English service on 1050 is now identifying as "1050 Radio" (Lar Ryden, Jar-falla, SWEDEN).

Japan A closed-circuit, all-English radio program is now available at major hotels in Tokyo. It is identified as "K-O-X Cable Radio, Tokyo", or simply "KOX Radio". Program is DJ music shows, sports 24 hours, plus news every hour at :55. The format and sound reminds very much of FEN. Some of the announcers are ex-

FEN. (Lars Rydén, Järfälla, SWEDEN) (Believe that it is this organization that grunched up/spit out Glenn Hauser's hopes for employment in Tokyo ed.)

Malaysia (Sabah) 1475 is not located at Sandakan but at Tuaran, which is a place some 10 miles up the coast from Kota Kinabalu. Registred power is 600 kW, coordinates are 116011'E 06011'N. Location is to be shown as Kota Kinabalu in WRTH76. (Lar Rydén, Järfälla, SWEDEN)

Netherland (MWN) Hegalo to go to 890 and Halsberg to 1493 (both now on 1594). (Distance)

Netherland Antilles (MWN) PJB2, Voice of Bonaire, now on 1400 ex-1385. (Distance)

Saint Lucia (MWN) Lovis Aubree reports that R. Caribbean is soon due to broadcast both in French and English, using two frequencies (Emph mine ed.)

Thailand A ban has been put on all English (and other foreign language) broadcasts from commercial and military stations. There was a growing number of such beasts, all on FM. The only EE service now available on Thai radio is that of Radio Thailand announced in Bangkok newspapers to be beast every morning 0630-0830 local time on 920, 9650, 11905 kHz and FM 97 MHz. (Lars Rydén, Järfälla, SWEDEN)

Timor According to Far East newspapers, a "Radio Lorosai" is operated by the anti-Fretilin Timorese Revolutionary Front. Location somewhere on Timor. (Lars Rydén, Järfälla, SWEDEN)

EUROPE

A report on Radio Nederland's DX Juke Box on 5 December gave the results of this fall's mediumwave conference in Geneva. 9 kHz has been adopted as the uniform channel spacing throughout Europe, Africa, Asia and Australia. It will take about three years to implement the new mw plan. Channels will run from 531 to 1602 kHz with the last becoming an additional graveyard. While not stated, this span implies that all present Eurafrican channels will shift one kHz higher, except the high end where the present 8-kHz spacing will become 9 kHz at 1548, 1557, 1566, 1575, 1584, 1593, 1602. Also, lw channels are to be added between 255 and 281 kHz. On 6 December the BBC Monitoring Service reported that DPA said WDR-1586 would move to 1594, and that BR-1602 would move to an unspecified channel. (Note that Eurafrica would lose a channel in this redistribution ed.) While the advent of 'split' allocations in Australasia has been anticipated, the shifts in the existing 9-kHz areas, if correct, will open up an entirely different picture fr Eurafrica as well. (Glenn Hauser, WILL, Urbsna)

OUT OF ORDER

Jordan: (SCDX) Reliable sources indicate that the new domestic service on 912 kHz is located in the Ajum area, and uses 1200 kW.

<u>Kuwait</u> (SCDX) Radio Kuwait is now scheduled to broad-cast in English 0800-1100 and 2000-2300, and Urdu 1800-2000 on 1133 kHz, according to schedule (Hans A. Fleu, Herzogenrath, W. Germany).

Zaire (SCDX) The La Voix du Zaire regional station at the Muzaba Broadcasting Centre, Bandundu, has been heard carrying out tests with a 50-kW transmitter on 1007 kHz. La Voix du Zaire is now silent on 692 kHz at the present time. The 836-kHz outlet has been noted on 838 and 844 kHz. (Richard Ginbey, Vanderbijlpark, Transvaal, S.Africa).

That is all for this fortnight. I hope to publish more specifics from the PRC registrations to the ITU, such as location and power, at a later date. No doubt such would be of interest, esp. to our WCNA, Zedder, and Aussie.



Hi there! It's me again, Charley Keleher, with another column to entertain and enlighten all you enthusiastic DXers.

The old "State of the Month" and "Province of the Month" columns, which appeared in DXM from 1965 to 1973, were quite a success. The general idea was to provide the DXer with a useful body of information about particular stations. While the "Roundup" columns deal primarily with recent DX catches, the SoM/PoM served as a "back-up" for info on such things as formats and verie policy, plus an idea of how well stations could be heard in various areas.

The "Spotlight" is an extension of the SoM/PoM with a slightly different setup. I will handle states and provinces east of the Mississippi, with Wisconsin and Ontario forming the northwest boundary of the region. Hopefully we will soon have another editor to handle the western states. Two editors should make it possible to cover all the S/P's at a more rapid rate.

Since not all states were printed in the old column, we will deal first with the ones that were omitted. The first "Spotlight" state will be GEORGIA; deadline is March 1. Other states in my area which haven't been covered are AL, IL, KY, MI, MS, and TN; watch for deadlines in this and future columns.

Almost every DXer should be able to provide some info for the column. A particular S/P, or station, may be a pest for you, but you can pick up knowledge which would be very useful to someone else out there, who's wondering if he really heard it. If you're far from the place in question, and have only a few loggings, others in your area would like to know that such-and-such station can, indeed, be heard.

Well, then, what to report? First, of course, are powers and patterns, although powers are not always important since I can look up most of them. If you know something unusual about a station's pattern, send it along with your report. For example, WSBT-960 is only about 60 miles from here, but I can hardly hear their 5 kw at night, since the pattern is very directional. If I were reporting Indiana stations, that would be a useful piece of information to someone, perhaps. Try to be factual, without being overly lengthy. Many things will be condensed in the editorial process, particularly if the column threatens to go beyond reasonable size.

Next, the format. If you have only heard WAAG in a few "DX instances," tell us what you heard in general terms. Those closer to a station can tell whether they really play R&R all the time. Also useful is network affiliation, particularly if a station has changed recently. Unusual things about a station's programming may give it more of a personality. To avoid confusion, though, it's best not to report something you only heard once. If WAAG signs on with an alarm-clock sound, and you want to report it, fine, if they really do it regularly. The format section is also a good place to report info you acquired on trips, which is not really DX for you, but may be useful to someone.

It's also nice to know how well a station gets out, and when. Can you hear WAAG when WZXY, on the same frequency, is on, or only when WZXY goes off on NM? Can WAAG be heard at sunset almost anytime, or only the first 2 weeks in January? Info on regular receptions, ETs, and so forth, can be very useful too, so report it.

Last, but not least, is verie info. About all you can do is say that a station sent you a verie for your report, (and what kind of verie), or that they didn't. While veries probably exist from almost every station, there are many "erratic" and "reluctant" verifiers. We will try to work the most recent info in, as much as possible.

As mentioned before, the first column will be on Georgia. This is not a hard state to log, as practically anyone can hear WSB-750. But, in this area anyway, there are only a few other stations that can be heard from Georgia on an average night, and their signals are not very strong. So, many DXers may find their best loggings from this state are at sunrise, sunset or on ET's.

Following is a report, such as I might send in, on a (fictitious) Georgia station:


