

From what I can tell, it looks like there is already an impressive number of DX Tests for us DXers to look forward to. As we are entering a new DX season, I have great hopes for some real great catches. Let us all look forward to adding at least 50 or more new stations to our logs. Up to this point I really have not concentrated on logging foreign stations. This season I hope will be different as I set a goal of 10 new countries to be logged to add to the 10 I have already logged. From the looks of DXWW the foreign DX season is already in progress. 73's and good DXing.

Mark Connelly-52 Amsden St.-Arlington, MA 02174 The purpose of this forum submission is to give the novice DXer on the East Coast a coherent working procedure to hear Trans-Atlantic DX. Enough has been written about receivers and antennae, suffice it to say that receiver selectivity, local noise, and domestic station QRM are the usual limiting factors, rather than receiver sensitivity. The game plan is as follows: half an hour before local sunset, check Dakar on 764, re-check it at local sunset & then try Morocco on 818 & France on 1554 to give an idea about which end of the band seems better. Lowabout which end of the band seems better. Low-band tends to win out at this time. With a good signal on 818, reception of the low-band Iberians and North Africans can be expected. After 818, check 529, 548, 575, 584, 611, 638, 665, 683, 701, 719, 737, 755, 773, 782, 827, 854, and 935 kHz. With good signals on most of these frequencies, further low-band digging is in order. Key highend channels should also be checked at sunset before interference levels from stations to the west become too great. Turkey/West Germany on 1016 is a good indicator: if strong, a good opening is in progress with viable high-latitude paths. Top end channels 1394, 1439, 1466, 1529. paths. Top end channels 1394, 1439, 1466, 1529, 1554, & 1586 should be up well, if this is the case, further high-end exploration is in order. As the night progresses, conditions may appear to drop: part of this may be a real drop in signal strengths, but it may also be a consequence of increased domestic QRM and the fact that many of the Europeans have signed off for their early morning hours. At this juncture, it may be wise to take a break or concentrate on Latin America, until about an hour before European sunrise. Then the key channels to check periodically are BBC-647, Spain-737, Dakar-764 (at s/on), Andorra/Morocco-818, BBC-1214, France-1554, and Langenberg, W. Germany on 1586. These early morning hours are the times to hunt Africans, particularly in the autumn and spring. To mount a successful DX strategy, a copy of the World Radio/TV Handbook, the most recent LBCA Foreign Radio/TV Handbook, the most recent IRCA Foreign Log, and recent DXWW's will prove to be of great value.

Ray Arruda-48 Woodlawn St.-New Bedford, MA 02744 Not much going on in the way of DX, but in the past two weeks I have been sitting on the right frequency at the right time. In two weeks I've logged two new Wyoming stations, KTWO-1030 on 9/20 and on 10/4, KRNK-1530 conducting ET with varying TT and IDs approximately every 30 seconds. This from 3:10-3:25 & 3:52-4AM. The signal was very clear except for some slight QRM from KFBK. I almost mistook it for WCKY testing. Have added eight new stations to the logs since 9/20 and have a few reports out with three veries received from CBY-990, KTWO-1030 (took 7 days, state #46), and a v/l from WRDI-1580. The 9/25 WSKW-1150 Test was not heard, just WCOP/CHSJ. 73

Charles Taylor is reworking the countries list and is trying to change some of the criteria for deciding what constitutes a country, but wants more suggestions from the members. One suggestion was to condense all the republics of the USSR into

Interest was expressed in the success of the KDWN DX program but Bill Harang was not present to tell about it.

Contests: 30 members entered the domestic contest but the foreign contest didn't seem too popular.

NEW INTERCONNECTED NETWORK IN NEW YORK STATE The New York Network began operations June 10th from its key station, WABY-1400 Albany, NY. Nine other AM stations (plus one affiliated FM) were to hook up by July 1st.

Officials say the interconnected network will offer 18 five-minute newscasts each day, a morning and an afternoon 15-minute news roundup each weekday, 42 sports reports, 40 business reports (including hourly reports from the New York and American Stock Exchanges), and 27 news features each week. They say that the feeds are scheduled to avoid any conflict with national networks and audio news services.

Greetings. As of the 27th, my workhours have shifted to 2050-0520 GMT (1650-0130 ELT) at my own request. This leaves Monday mornings open for DX, despite the slight (to us) inconvenience to social life. Correspondence has been squared away to a large extent, but to those whom I'm owing: patience.

This number of DXWW II \ leads off with a IDXF from Bjarne Hansen, Vadso, Norway:

Bjarne Hansen, Blåbaerveien 11, N-9800 Vadsö, NORWAY Greetings from the cold and frozen North! DXing here in Vadsö is difficult, especially between 6 a.m. and 12 midnight. Y'know: 20,000 watts banging in on most channels from two tx towers half a mile away (Finnmark County-701 kHz, acc. to Bjarne.cat). The worst QRM can be eliminated by simply turning off the grounding, but then I get all kinds of noise. Life ain't easy! A brief intro: I'm 18 years, and I'm here in Vadsö on High School, studying Math, Physics, Chemistry and Biology, among other things. I hope to get a job in Norwegian radio when I'm finished here-preferably on some local station with FM outlets only...! I started DXing in 1972, and I became an (almost) full-time BCB DXer 2 years ago, mostly hunting North America, but also a bit of Asia. I've heard 120 stations from NA, my favorite catches being KNEW-910 Oakland, CA; CJAR-1420 The Pas, MB; and KAAY-1090 Little Rock, AR. I am a member of two other DX clubs: Medium Wave Circle in England and DX Listeners Club here in Norway. My equipment is a Kenwood QR-666 rx and 240 ft longwire, 12 ft high. I'll probably sell my Kenwood next summer, cause I'm not satisfied with it. The selectivity isn't good enough, and the calibration isn't worth talking about. The summer, with sun 24 hours a day from May 16 to the end of July, doesn't allow much DXing, so the only QSL received since April is KICY Nome, AK 850 v/q and newsletter. That's all from here, best of DX and 73 de Bjarne. (Check your atlases, Vadsö is closer to Murmansk, R.S.F.S.R., or about 115 miles, than to Oslo'cat)

Português), Regua-962 (500 w), Lisboa-1034 (ex R.C.P.) and Santa-rem-1522 (ex R. Ribatejo). All have separate programming. Programme 3 (Local) 0600-2200 GMT over Lisboa-1594 (ex Em. Assoc. da Lisboa), Opôrto-1578 (ex Em. do Norte Reunidos). Non-nationalised stations: R. Renacença-1286 and 1169 (Power on 1286 to be increased) R. Altitude-1496, Garda: Em. Beiras-1460, Caramulo. A new one is reported on 1007 parallel to 1034. (Distance)

PUBLICATIONS (MWN Mar 76) World Radio Bulletin ceased publication at end of August 1975 at the request of the publisher, David McGarva. Financial difficulties was the reason given for the suspension.

SPAIN (MWN Mar 76) Radio Nacional de España now announces as Radiotelevisión Española. REM and CAR have merged and the resulting network is Radio Cadena Española. EAJ64, R. Segovia, is now on 1430 vice 1412. (Distance) (MWN Jun 76) EFJ50, R. Juventud de Calahorra (listed on 1365 as R. Juv. de la Rioja) is noted on 1385. This one is a constant drifter. (EBU/Distance)

Cayman Islands (SCDX 1393) According to a newspaper report, Radio Cayman went into full operation on July 22. The station, south of Cuba, is using 1555 kHz. The report said that the station would be audible in ell three islands of the colony as well as in neighboring countries.

Colombia (MWN Jun 76) Ondas del Caribe-840 is now 30 kW. Ecos del Cobeima now 1025 vice 1170. La Voz de Medellin now 1030 ex 990. Ondas del Valle now on 1090 vice 1190. (DSWCI)

Egypt (SCDX 1395) The Palestine Liberation Organisation has been regranted air time since 1 July on Egyptian radio. Currently broadcasts 1000-1100 on 1106 and 1700-1830 on 872 kHz. (Berd Bluman, Tel Aviv) According to the W. German newspaper <u>Kirchenzeitung für das Erzbistum Köln</u>, Radio Koran, the Moslem counterpart of the Christian broadcast stations, is broadcasting from Egypt. Radio Koran will revive the religious values of the koran and Islam. No frequencies were given. (Peter Bell, Cologne)

Mexico (SCDX 1392) Radio Universidad de Sonora at Hermosillo was reactivated on 2 Aug. Station is XEUS 850 kHz, with 1 kW; sked is 1600-0300 GMT. (Sergio Rayas Solis, Hermosillo, Sonora, Mexico)

Rhodesia (SCDX 1387) Rhodesia has entered the propaganda war with a daily transmission in Portuguese beamed to Mozambique. The programme is called A Voz da Africa Livre (The Voice of Free Africa) is broadcast on 998 kHz 1800-1900. At no time is there any indication that the station is located in Rhodesia. Broadcasts are anti-Frelimo and consist of pop, Portuguese and Latin American music, (screwy categorization. cat) talks and regular identification. The station opens at 1755 with an instrumental piece of music and repeated identification "Esta é a Voz da Africa Livre transmitindo para a Moçambique". This is the only time that this high-power transmitter is used. (Richard Ginbey, Vanderbijlpark, S. Africa)

Taiwan, Rep. of China (SCDX 1392) AFNT, the American Forces Network Taiwan, has closed down operations. (Werner Nagel, Oberhausen, W. Germany; Jean-François Sonntag, Bischheim, France)

U.S.A. (SCDX 1387) WGU20, the Civil Preparedness Station (179 kHz, Olney, Maryland) has been put on standby due to economics. There will probably be occasional tests to keep the station in operating order. (R.C. Watts, Louisville, Kentucky, U.S.A.)

Venezuela (MWN Jun 76) R. Visión (860) is ex R. 860, and is in San Cristóbal. R. Visión in Caracas is soon to be 100 kW. R. Valles del Tuy (1030) is now 10 kW. New is L.V. del sur del Lago (1350 kHz, 10 kW, YVLT), Caja Seca. YVZO-1420 is now R. Visión, ex Motiradio Marabina. (DSWCI)

In 1968, Yellowstone National Park began a project - conceived of several years previously - of installing six transmitters along an experimental stretch of the park's road system. These transmitters were of low power, operated on a standard AM frequency, and provided the park visitors with general information about the park and safety precautions. So successful was the experiment that Yellowstone now operates a system of thirty transmitters, of low power - 100 milliwatts each - throughout the park.

Gradually, other agencies began similar operations in an effort to better inform visitors, to their parks, etc., of local attractions, items of safety, or traffic information. Shortly after the earthquake which struck the Los Angeles County area, the California Department of Public Works set up temporary transmitters and successfully re-routed traffic from closed portions of Interstate 5 along open routes.

In June of 1975, the Federal Communications Commission announced a "Notice of Proposed Rule Making in the Matter of Amendment of Parts 2 and 89 of the Rules to Provide for the Use of Frequencies 530, 1606, and 1612 kHz by Stations in the Local Government Radio Service for the Transmission of Certain Kinds of Information to the Traveling Public." The proposal was assigned the Docket No. 20509, and comments were solicited. An extension was allowed on the soliciting of comments, and though research for this article began in mid-1975, presently—March of 1976 - there has yet to be any response from the FCC regarding a final decision in the matter of TIS.

As presented to the FCC, the TIS would be limited to the above-mentioned frequencies, and power output would be limited to a maximum of 10 watts, though the majority of those TIS stations presently in use operate with only 0.1 watt - 100 milliwatts. Further, hours of operation are unrestricted.

The transmitters and other equipment are commercially manufactured, and consist of an AM transmitter, gain antenna, power supply, timer, and a book of instructions. In January of 1975, the preceeding equipment was priced at \$1200; for an additional recorder and/or repeating unit. \$750 was to be added, and thus a complete unit is just under \$2000. The power output, up to 15 watts, and operating frequency, one of the three mentioned above, is selected by the purchaser and preset by the manufacturer.

Regarding the TIS concept, the FCC states: "For some time the Commission, together with other Federal Government agencies, has been studying the need for and feasibility of using low power radio transmitters to communicate certain kinds of information to travelers. For example, radio might be used to alert motorists to road hazards, to inform them of available food, gasoline, or lodging, or to direct them to local points of interest. Also, Federal Government agencies have expressed a desire to use radio at parks and other national tourist areas to inform and advise travelers and to control traffic during emergencies such as forest fires. It appears that the use of radio can, in many situations, offer significant advantages over road signs or other methods now being used for these purposes."

At present, several Federal agencies operate low-powered stations conforming to the FCC proposal, and most notably are the National Park Service, Bureau of Land Management, Forest Service, U.S. Customs Agency, and a few international airports. Following is a brief list of stations currently known to be operating, and for the most part they are located in the Western United States.

There are several TIS-type operations in California, and most fall under the jurisdiction of the Forest Service. The Tahoe National Forest uses two transmitters near Donner Summit on Interstate 80 across the Sierra range. The system has been in operation since the Fall of 1975; both transmitters are battery powered, have a range of 1000 feet, operate on 830 kHz, and deliver 0.1 watt of power. Another unit is planned for the summer of 1976; it will be placed in operation at the southeast corner of Lake Tahoe - Visitor Center, but no further information is available at this time.

Moving south, we note the use of two transmitters, since 1974, at Sequoia and Kings Canyon National Parks; both operate on 650 kHz, and are limited to "Less than 1/10 watts." In the Los Angeles area, the Angeles National Forest has been operating one transmitter since 1973.

As is occasionally noted with government agencies, one department may be unaware of the other department's activities, and such is the case at Cabrillo National Monument, located in San Diego County. Cabrillo has supposedly had two transmitters in operation, on 530 and 1606 kHz, since February of 1975. Trouble is, no one bothered to tell the page 68 October 23, 1976

Park rangers of this. Not only are no transmitters in operation, no one from the Park Superintendent on down has ever heard of such a plan, let alone the concept of TIS!

Moving even further south to within a mile of the United States/Mexico border, we find another station in operation. Operated by U.S. Customs Agents of the Treasury Department, a station on 1600 kHz provides bilingual information to travelers, in the United States and Mexico, approaching the border. Despite a stated power output of one-tenth watt, the station, located in San Ysidro, California, claims a radius of 3 miles, and has been heard by a DXer in El Cajon, California - a distance of approximately 15 miles. Operation betan on August 1, 1974. (Cf. The San Diego Union, 8/2/74, unknown page; or DX Monitor, 9/7/74, p. 5.)

Moving northeast to Nevada, there are two known TIS stations in operation. One is at Lake Mead, and, like others, it operates with less than a watt of power on 530 and 1606 kHz. Another station is located in the Lemon-Caves Wheeler Peak Area of the Humboldt National Forest in northern Nevada.

The last two known operating TIS stations are located in separate, adjoining states: Utah and Colorado. At the Flaming Gorge National Recreational Area, Ashley National Forest, in northeast Utah, one unit operates on 1580 kHz to provide visitors with information regarding the National Recreational Area. Also providing information, "after hours," from sunset to sunrise, a unit at the Idaho Springs Visitor Center in Idaho Springs, Colorado, informs visitors of attractions at Arapaho National Forest; the frequency is 1610 kHz, and has been in operation since July of 1973.

Though this article is directed at TIS operations in the United States, one cannot ignore similar operations in Canada. Presently. there are six stations in operation, utilizing graveyard frequencies and operating with 0.1 watteach. In Jasper National Park, Alberta, there is CBPA-1490, and CBPB on 1230 kHz. CBPC-1490 and CBPD-1230 are located in Glacier National Park, British Columbia. The remaining two stations are CBPE-1490 and CBPF-1450, both located in Cape Breton Highlands National Park, Nova Scotia. CBPA, CBPC, and CBPE provide information in the English language; CBPB, CBPD, and CBPF provide information in the French language. Like many TIS stations in the United States parks, the stations in Canada provide general information to park visitors.

And now, a rather unusual station which is and isn't a TIS station: KQ2XUB on 530 kHz. This station is located at Los Angeles International Airport. Though it provides general information to airport users, unlike other TIS stations it is an FCC-licensed experimental station, and operates with 10 watts of power. From Los Angeles International, this description: "We are presently licensed as an experimental station by the FCC, and transmit traffic and parking information to airport bound motorists on 530 kHz. We utilize a buried cable as our antenna system so our signal can only be picked up on the main approach road to the airport, and inside the main airport complex. The cable is fed by 10 watts of RF power for each leg, and there are two transmitters broadcasting at the same time, normally with different information on each one. This is possible due to the extremely short range of the signal emanating from the cable (about 60 feet laterally from the cable). We have on the air to the public since November 1972." The San We have been Francisco Chronicle reported operation began on November 10, 1972. (Cf. DX Monitor, 12/9/72, p. 20.)

The latter item on Los Angeles International brings forth a point: most TIS stations feed into a regular antenna, above ground, and as such are heard over varying distances, depending or the surrounding terrain. The buried-cable concept is more closely aligned with carrier-current stations of the type operated by some high schools and many colleges, with the intent of providing a service to the confines of the campus. So, please do not confuse the "true" TIS concept with the concept of carrier-current stations.

By now the question on many minds might we be, "What are my chances of hearing a Tis station?" The answer: "Excellent Confused? Lock at it in this manner: a present to none." list of stations operating, in the United States, states 191 stations are in operation in virtually all states in the United States, excluding Alaska and Hawaii. Most of these stations are operated on a part-time basis - tourist season. Also, recall the previous mention of the supposed operation at Cabrillo National Monument. While many of the stations are supposed to be on, there is no accurate way of determining whether or not they are in operation. Going one step further and assuming all listed stations are on the air, then there is a fair-to-good chance of hearing one. Recall the 15-mile reception of the border station located in San Ysidro; also, many West Coast DXers will recall CBXQ, 540 kHz, in Ucluelet, B.C. being audible throughout much of the West Coast in recent years and the power: 40 watts! Further, look at the continual reports of Canadian LPRTs. The only major drawback to long-distance reception is the terrain surrounding the

As this is being read, there is no guarantee these stations are still on the air, and even if on how long they will remain on. Further, new stations may appear daily, and unless noticed by an observant DXer, such a station may go "undiscovered," until noted by chance.

Only rarely does a new area of DXing open up, and most often it is an area which has existed for some time, but emphasis on the area has been lacking. Such is true of Traveler's Information Service. While it is aimed at providing information to the general public, it also provides DXers with an opportunity to test patience, skill, or just plain luck at logging stations in a new area of DXing.

Oh, yes - many stations will respond to correct reception reports if a stamped, self-addressed, prepared form card is sent with the report. Such reports are of little, if any, value (unless reception was within the "target area"), and any reply received should be looked upon as further luck owing to the usual lack of knowledge of a ranger regarding the hobby of DXing. Thus, a reply with simply "Thank you for your letter" may be received in lieu of the expected full-data card. The definition of a "valid QSL" from a TIS station must be left with the DXer involved.

So, there you have it: a new area of DXing with emphasis. It's never too late to start checking out the frequencies mentioned, and while on vacation this summer. you might check road signs or park entrances for an alert to a new adventure in DXing - - oh, by the way, the information you hear might be of interest, too.

# Officials Dispute Time of First Warning by BOR

Project construction engineer Roberf Robison said Sunday in a memo, however, "The sheriff's offices in Madison and Fremont counties were notified by 10 a.m. to alert citizens for potential flooding from Teton Dam and be prepared to evacuate the area downstream.

The Madison County sheriff's de-partment in Rexburg could not be reached by phone Thursday. Worrell said that after deputies re-ceived the call, they began making calls to area radio stations, telling them a leak had developed in the dam and to pass along the informe-

them a leak had developed in the dam and to pass along the informa-tion, but that "there was no need for alarin."

"We sent an officer to the area and about 35 minutes after that, he called and said the dam was gone," Worrell said. That was all the notifi-cation the Fremont sheriff's office

got.
Ted Austin, owner of radio station KIGO in St. Anthony, said he got a call "between 9 and 10 a.m." and

cail "between 9 and 10 a.m." and checked the story with Robison.

He said that at that time the main concern was to let residents below the dam know that water might start to rise rapidly in the river, "but there was no need for con-

Austin said Robison told him they

Austin said Robison told him they had "men and equipment working on a leak in the dam, and men and equipment working on opening a diversion channel."

Austin said the radio station broadcast the information "four or five times" between 10 and 10:40 a.m. Then he went out to the dam and saw the seriousness of the situation.

"I went in an engineer's office and grabbed a phone and started broadcasting live from there," Austin said. From 11 a.m. when he went on

air, until shortly before noon, the hole "just kept crawling up the face of the dame." He continued the broadcast until the dam burst shortly before noon

ly before noon.
"I started to yell into the phone that people should evacuate. I was cut off when the phone and power lines went out simoultaneously," Austin said.
He left the area and drove to a farm

He left the area and drove to a farm house on Idaho 33 and made another phone broadcast of what he had seen. Austin's country-western station interrupted its programming with his initial phone-report, and since has been broadcasting only emergency information.

Another Austin-owned station, KADQ in Rexburg, also got the word of impending disaster from Austin, and broadcast evacuation notices "until it was knocked off the air about 2:30."

Rexburg's other radio station, RXK, apparently carried the story continually from 11 a.m. until it went off the air about 2:30 p.m. Rexburg was still isolated from telephone communication Tuesday night and KRXK could not be reached.
In Idaho Falls, KID's receptionist "took" a call from Fremont County sheriff at 10:45 a.m. telling us they had/experienced a leak at Teton (Dam), not to panic.— it was just a leak;" Station Manager Roy Southwick said.

## WMAL Radio In Washington Is Sold by Star

WASHINGTON, Sept. 28 (AP)—The American Broadcasting Companies Inc. agreed yesterday to purchase two affiliated radio stations here from Washington Star Communications Inc.

The agreement in principle, specifying a purchase price of \$16 million in cash for WMAL-AM and WMAL-FM, was announced by the two corporations after the network's board formally approved it. The purchase is subject to a final agreement between the two companies and approval by the Federal Communications Commission.

"The decision to sell these stations was not based on normal business judgment in that Washington Star Communications would prefer to retain them," Joseph L. Albritton, chairman of the company, said in a prepared statement.

In addition to its Washington properties, Washington Star Communications owns network-affiliated radio and television outlets in Lynchburg, Va, and Charleston, S. C.
