Bill Hardy informs us that effective Monday, December 31, 1979, the CBS Mystery Theatre will be aired Monday through Friday only. The program is presently aired 7 days a week. In a similar vein, the Sears Theatre will move to the Mutual Network. See page 8.

I kind of goofed a couple issues back when I announced that Sigvard Andersson was the most distant caller to the CJVB test. He was the most distant caller during the program...however, the call-in period lasted until 2400 PST (the program only lasted until 2330). During that half hour, CJVB got calls from Australia and New Guinea. So the winner of the free trip to Vancouver is Chris Martin of Australia, who was listening on a Beverage antenna on a beach near Brisbane. See page 21 for more details.

This must be the week for stations' transmitters to act up. Larry Godwin noted KYSI-1450(normally) in Montpelier, Idaho, operating on 1466 kHz on Sunday evening 12/16. Kirk Farley of Nevada, MO, noted harmonics of WFSH (1340), Valparaiso, FL on 2680 kHz and KXEL(1540), Waterloo, IA, on 3080. Kirk, as well as C.M. Stanbury, noted a distorted KXEL spur on about 1645-1650 kHz.

WARC DECISION ANNOUNCED... A longer band for broadcasting.

There will be extended by 110 kHz, according to allocations announced at the conclusion of the World Administrative Radio Conference. extension will be implemented as follows:

 $525-535~\rm kHz; ~i.e.$, one new channel with stations limited to 1 kw day and 0.25 kw night (to insure protection to existing marine communication services including the emergency channel at 500 kHz). The FCC could act to allocate this channel immediately. A consultant for the National Elack Media Coalition, David Honig, announced he would petition the FCC to freeze any further applications for TIS stations in that band. The NEMC is interested in the plan because it would allow for new stations under minority ownership. Despite the low power ceiling for stations on the new channel, 530 will not be the same as our current "graveyard" channels, on which the power level is also 1 kw/0.25 kw, because groundwave signals travel much farther at the lower frequencies than at the higher ones. For example, a 1 kw station on 530 kHz would have almost an identical coverage area as a 50 kw station on 1040 kHz, given identical ground conductivity and antenna. 0.25 kw at 530 would be roughly equivalent to 5 kw at about 1110 kHz. Thus 530 kHz will accomodate fewer stations than the graveyard

channels where coverage at 1 kw is only in the 60 to 70 mile range.

1605-1665 kHz. This band will become available in 1987, after an allocations conference scheduled for 1985. The first 20 kHz will be for the exclusive use of broadcasting; the remainder will be shared with radar services, although broadcasting will have primary use of the band. This proposal is a bit better than the U.S. had hoped for. The U.S. plan called for equal sharing with other services in the 1605-1800 kHz. However, the U.S. lost on efforts to add a band exclusively for broadcasting between 1805 and 1865 kHz.

This band will be allocated the same as the 1625-1665-1805 kHz. 1665 kHz band but will not become available until 1990.

Finally, these allocations apply only to the Western Hemisphere. Information on allocations was drawn from the Dec. 3 and Dec. 10 issues of <u>Broadcasting</u>. Used by permission. AM radio scheme also jeopardized Electronic Design^{-bp} December 20, 1979

A plan to create up to 700 new AM radio stations in the U.S. by expanding the AM band has also run into trouble at the WARC. Canada, Mexico and most of the South American nations fear that such expansion would interfere with their own communications systems. Other opponents say the areas just outside the present AM band have been set aside by their countries for other uses, including amateur radio.

Another U.S. proposal to expand the number of AM channels in use would reduce channel spacing from 10 kHz to 9 kHz. But this plan has also drawn fire from neighboring countries. The narrower channels are currently used in Europe and Asia, but not in the Western Hemisphere.

I'm 29, originally from Los Angeles and have been DX'ing since 1963 when I bought a 1941 Patterson 12 tube console. My current equipment includes a McKay Mymeck DA5 antenna and the following Grundig receivers: Satellit 2100, C9000, Signal 500 and Signal 300. I've just ordered a Satellit 3400 Professional with digital readout from Radios International in Texas, so that should arrive within the next two weeks. Until recently my record of stations heard has been only a listing by frequency, call letters and location, kept since late 1976. As of today, from this QTH the total is 233. Last month I started a more precise log by date, frequency, call letters, location, times and program details, similar to the Round-Up columns. The last several days have been the best yet from here with many new loggings including: KYJC 1230 Medford, CHGR 810 Calgary (w/KGO silent) (What! A KGO SP---damn-RtH), ----- 747 Japan (JOIB-RtH), (my first TF DX!), plus many others. Lately I have been sleeping in the early evening during "TV/Dimmer Time" and getting up between 0800 and 1000 ELT. It's been well worth the effort and the results "spoke for themselves". I tried for the CJVB 1470 DX contest test on 01 Dec. No luck! XEBBC and KXOA predominating instead. But did take a new logging on KSEM Moses Lake, WA from 0200-0209 ELT. Very strong signal. The following, reprinted verbatum from Broadcasting, appeared in that magazine's Open Mike section in the Nov. 26 issue and seems apropos:

EDITOR: There have been many letters appearing in the trades recently touting the death of AM radio. It has almost turned into a conditioning process -- if we hear about it long enough, we'll all start to believe it!

I am concerned that individual stations are not rising up to encourage more debate on the 9 kHz proposal (which could pass soon).

The need for establishing additional AM stations seems questionable at best. Is it so important to fragment AM listening even more, allowing new

stations to flounder in the marketplace?
Of course there is a need for many daytimers to become full-time outlets (to better serve their markets), but should it be done at the expense of quality?

As AM programmers, we already face the poor receiver problem, coupled with the fact that many stations are processing their audio to the point that it is further distorting quality. All of these things and more are making listeners believers in the "AM is dead" theory. We are <u>letting</u> AM erosion happen.

At the National Association of Broadcasters conference in St. Lo is, one panelist mentioned that the FCC hears from so many different factions within our business that they seem to be telling us, "Hey, come back when

you get your act together!"

+ Regular nightly in BC. NSP I believe. (Hall-Patch)

- + A powerhouse here at night (about 600 miles away), and one of my top dozen stations at night without a background. Hrd all day in winter w/a weak to loud signal. In summer, even hrd once in a while at noon. (Meehan)
- + In nightly w/strong signal. MOR/pop mx evenings, c/w mx AN w/"Jock Radio" ID's. Sent a v/q about 15 years ago; present verie status unknown. NSP. (Portzer) (Bruce, I received a large v/q about a year ago, so it would seem they still verify. -SMM)

- Aztec, U1 1000/250.


 Heard once on RS in 1969. Not noted since, but still possible I guess. (Portzer) (Great catch, Bruce! -SMM) 1340 KHAP

As those who occasionally scan the BCB during the midday hours already know, high noon DX is not only challenging but can be rewarding as well. In fact, just this morning WLW-700 was audible in Florida a full four hours after local sunrise---not quite high noon, but far enough past sunrise skip to warrant mention. And Mort Meehan's recent logging of KRVN-880 at a distance of over 1000 miles from his California location certainly also indicates that BCB DX in the middle of the day is far from impossible.

In order to recognize some of the better midday BCB catches, maybe stimulate interest in this kind of DX'ing, and perhaps even learn something about the factors affecting midday DX, MIDDAY DX RECORDS has been born. To get the column started, I've been appointed by IRCA President Father Jack Pejza to serve as its first editor, at least on a temporary

basis.

The exact form this column will take will be determined by the level of member contributions but, as presently envisioned, the column will appear about every four weeks and will include the five or so most distant catches for a selected set of around 10 BCB frequencies. As far as determining the quality of a catch goes, a great deal of thought (and debate) has been devoted to this problem. To properly equate reception conditions so that all DX'ers would be on equal footing would require accounting for differences in ground conductivity, differential field strengths due to antenna patterns, the degree of D-layer absorption at the time of reception, and so on. Because there does not presently exist a "catch rating formula" that considers all factors that bear on midday BCB DX, NO ATTEMPT TO RANK CĂTCHES OTHER THAN BY DISTANCE WILL BE MADE. Additional information such as listed power, sea vs. land paths, time of day, etc. will be provided to allow the reader to "adjust" the listing according to his or her own criteria. An attempt will be made to categorize station powers so that all classes are represented, but the success of this effort will be determined by contributions and space constraints. (Refinements to the preceding position will be adopted as needed.) Besides this Distance Records section, also appearing in the column from time to time will be a listing of Midday DX Totals--the number of stations, states, and provinces (countries too) that members have logged during the midday hours.

Okay, so what exactly is "midday?" For the purposes of this column, MIDDAY is defined as THE PERIOD BETWEEN TWO HOURS AFTER LOCAL SUNRISE TO TWO HOURS BEFORE LOCAL SUNSET. (Propagation during this period is primarily via groundwave but, on those days when the absorptive D-layer is slow to form or is weakened, ionospheric skip can occur.) Also, for the purposes of this column, only those stationsproducing audio will be eligible--carriers don't count.

Here's the information needed when you submit your loggings: *Your NAME.

*Your LOCATION. If you want me to calculate Great Circle Distances for you, it would be great if you could provide the coordinates (in degrees and minutes) of your location and the location of the station(s) you logged. If you don't have access to a good atlas or set of encyclopaedia, I'll be happy to look up the coordinates for you. However, if you DX from some place like Galva, Iowa (which isn't on any map I own), I'll have to insist that your provide the coordinates (hi). By the way, loggings from DXpeditions are perfectly acceptable as long as they are so designated and the location of the site is given. *FREQUENCY, CALL, LISTED POWER, and LOCATION (coordinates, if possible) of the station. *DATE and TIME (in HOURS and MINUTES AFTER YOUR LOCAL SUNRISE (designated +0:00) or BEFORE YOUR LOCAL SUNSET (designated -0:00)) of logging. For example, my logging of WLW-700 this morning would be 11/30/79, +4:00. (If a station was audible all day, state NOON.) *State whether the path between your location and the location of the station was mostly

one of land (L), sea (S), or both (L+S). *GREAT CIRCLE DISTANCE---If you can calculate this distance for your catches, that would be SUPER! If not, I have access to a computer program and would be happy to do those calculations for you. (See the IRCA and NRC reprint lists for the how-to on GCD's.)
*RECEIVER and TYPE and SIZE of ANTENNA used.

So, send in your Midday Totals and your most distant catches for each frequency (or at least for those frequencies which will appear in the first column---the "Even Hundreds"---600 kHz, 700 kHz, 800 kHz, etc. (the following column will be the "Tens"---610 kHz, 710 kHz, etc.))......Deadline is four weeks after the date of this issue of DXM.

• HOW TO IDENTIFY A NETWORK (pp. 67-69)

There are two new networks and a name change to report. "The Source," a service of NBC Radio designed for album-rock stations, began operations in May 1979 and has now been heard on the AM band. (See 10/27/79 DXM, page 12.) The "RKO Radio Network" began operations 10/1/79. Headquarters are in New York; RKO's WOR-710 seems not to use it, but WOR's FM sister, WXLO-98.7, does. Details are sketchy so far. In fall 1979, the Mutual Black Network changed names to "Sheridan Broadcasting Network" to reflect the names of the black network's new owners. It still shares Mutual lines.

"The Source" is fed at :15 past the hour for two minutes. (In morning drive time hours, it is also fed at :45 past the hour for two minutes.)
"RKO Radio Network" news is on the hour, but no other details. "Sheridan Broadcasting Network" (formerly Mutual Black) is at :50 past the hour. Anyone with newscast formats for The Source, RKO, Sheridan, and/or the National Black Network, please send them in!

Mutual feeds two 60-second commercial breaks each hour in conjunction with Mutual newscasts. Either or both may have two 30-second ads or else one 60-second ad apiece. These commercials are fed at :28:50 and :58:50

past each hour (except during Larry King overnight). Both ads are carried in the newscast at half past the hour. One network ad is carried in the newscasts at :55 past and on the hour. This system gives stations flexibility. As long as they carry both network commercials sometime within the hour (even on tape), local affiliates may run their own local commercials in place of network commercials in Mutual news, and may choose to drop out of a newscast early for local news or other programming. We'll change the Mutual newscast formats to reflect these new breakaway opportunities. We'll switch to "fine print" for changes in the chart on pp. 68-69: At :04:00 the cue now ends "Radio." (:30 network or local ad, or :30 news story) [Delete the "story about (topic) in a moment," and "But first..."] APR Is a full five minutes, so change the ending as follows: :03:30 "This is the AP Radio Network." LIST OF BROADCASTING STATIONS BELOW 5950 KHZ: A REVIEW

On returning to the United States from Okinawa, my wife and I traveled around the country and one place we visited was the United Nations in New York. While there, I checked out the U.N. Bookstore, in the basement, which offers ITU publications. I had hoped to pick up a couple of current "lists" for DX purposes, but was more than a little unhappy to find the selection poor and outdated. However, I was able to review some lists which I had heard of but had no idea of the material contained within. was on this occasion that I had the oppurtunity to look through a very Τt dated copy of the ITU publication List of Broadcasting Stations Operating in the Bands Below 5950 kHz. After looking through the book, I was convinced it had potential value and decided to purchace a copy from the ITU in Geneva. I waited until the Tenth Edition, February, 1979, was available, figuring it would have current information including the changes brought about by the November, 1978 switch to a 9 kHz allocation. Was I ever wrong! The book, printed in English, French, and Spanish, clearly states, "The present edition of this list is printed from information recorded in the Master Internantional Frequency Register at 1st February, 1979." It goes on to mention that a computer had been used in preperation of the material for publication, so I assumed the information would be very current. Wrong again! Continued on page 34

DXing Latin America and the Caribbean: Country by Country (December 1979)

This article is designed to assist both beginning and more experienced DXers who are interested in receiving many Latin American & Caribbean countries on the MW BCB. While all of the tips here concern reception from the northeastern U. S., many of the tips apply generally throughout the U. S. & Canada. What can and cannot be heard will depend upon the individual DXer's local stations, as well as his or her ability, perseverance, equipment, and location. Coastal locations are a definite help for a variety of reasons beyond the scope of this article. A loop antenna or Beverage is also advantageous because these antennae can establish directionality to the south whilst nulling to the east and to the west.

Now is the time to DX LA's since the sunspot count is high and many nights will be auroral with poor reception of northern TA's and weakened or totally inaudible high-latitude domestics. This clears frequencies for LA's. A knowledge of Spanish is not necessary: one can soon learn to pick an ID out of a jumble of otherwise incomprehensible audio. Many LA's do not have the frequency stability of U. S. stations; therefore, different "drifter splits" will show up on different nights. The "growls", or audible low beat tones, heard on LA stations result from poor standards of frequency-maintenance

accuracy.

This article lists the countries of interest in approximate order from easiest (1) to most difficult (45), based upon receptions from the New England-Long Island-New Jersey region. DXers should be reminded that the sun sets earlier at the same longitude at a QTH to the south of them during the period from the vernal equinox (about 22 March) to the autumnal equinox (about 22 Sept.) Therefore, DXing the Caribbean Guring the spring & summer seasons will give a greater amount of time around sunset during which desired DX stations will be free of domestic QRM. During the autumn and the winter, noise levels will be lower, but the DXer will be much more dependent on an aurora to clear away the domestic QRM. The reader should also be aware of the fact that daytime domestics go off before their local sunset times during the last halves of the months of January through June and during the first halves of July through December. DXing during these sunset periods will afford lessened daytime-domestic QRM of desired LA DX stations.

Times in the following list are GMT. It is assumed that the DXer has a World Radio-TV Handbook with which to look up station slogans $\boldsymbol{\epsilon}$ call letters. Most of these were omitted from this article for the sake of brevity. Except for the Mexicans, most SS LA's use slogan ID's much

more frequently than call letters. GOOD LUCK!

- CUBA Our neighbour to the south has many very easy stations from which to choose: 590, 600, 630, 640, 690, 720, & 780 are all a cinch. Most Cuban stations play distinctive martial music with their hourly ID. Radio Reloj ("Radio Clock") stations (e. g. 760, 1180, 1560) have continuous news in SS with clock ticks in the background. Time checks & tones are heard once a minute. Many weaker stations run programmes parallel to the stronger stations; this makes Cuba easy to DX extensively.
- 2. NETHERLANDS ANTILLES Trans World Radio (PJB) on the island of Bonaire with 500 kW. is presently the most powerful station in the Western Hemisphere. It is heard nightly over or under CKLW on 800; PJB programmes religion in EE, SS, PP, & Dutch.
- 3. ST. KITTS In the early evening Radio Paradise 1265, with religious pgms. in EE, can be received often at levels equalling or surpassing the strengths of the adjacent 1260 & 1270 domestics. ZIZ on 555 is also an easily-heard split.
- 4. $\frac{\text{VENEZUELA}}{670$, $\frac{700}{700}$, 720, 750, 830, 950, 1020, 1070, 1110, & 1200.

- 5. COLOMBIA Try the Sutatenza outlets on 700, 810, & 960; these should dominate during auroral conditions ('AU CX'). La Voz de Barranquilla 760 & R. Reloj 1100 are easily heard. Colombian network ID's heard often are RCN (erray-say-ennay), CARACOL, R. Sutatenza, & TODELAR. HJED-820 usually over-rides WBAP in the eastern states. HJAZ, Emisora Sinu 1160 in Monteria has been dominating the channel late at night.
- 6. SURINAM SRS on 725 is easy even on unsophisticated receivers in the early evening. 600 & 640 are frequently heard at Cape Cod and at other coastal sites during the local-sunset period. 820, 914 & 1030 are rarer. Surinam stations programme Dutch, Hindu, and numerous other languages; similarly, musical content is extremely variable.
- 7. ANTIGUA The EE religious broadcasts & BBC news relays of the Caribbean Radio Lighthouse on 1165 can be copied early in the evening before WWVA-1170 becomes strong. ZDK-1100 can be heard mixing with the Colombians during AU CX; even during 'normal' cx. it dominates quite well at coastal sites at local sunset between WHLI s/off & HJAT/WWWE fade-ups.
- 8. HAITI 4VEC on 1035 is easy with WBZ looped or phased; this is heard early in the evening. Also try 4VEF-840 & 4VRS-1170 at local sunset during AU CX. 895 is a split sometimes noted during good Latin American conditions.
- 9. CAYMAN ISLANDS 1555 is easy most nights; 1205 also makes it through rather often. Both are heard best when AU CX diminish the adjacent-channel domestic splatter.
- 10. COSTA RICA R. Nacional (TIRN) 575 makes this country easy. Other good bets are R. Sonora - 675, R. Uno - 775, R. Titania - 825, & R. Casino - 1176. 725 is heard after SRS s/off, or w/SRS nulled.
- 11. PUERTO RICO WHOA on 870 can be heard in EE with Top 40 before WWL fades in for the night. WKAQ-580, R. Reloj, gets out very well with its SS all-news format. WAPA-680 is often heard well outside the immediate vicinity of domestic pests such as WRKO & WCBM. WKVM-810 can be heard mixing with other LA's during AU CX; the KVM (Kah-Vay-Em) ID's are easily distinguished.
- 12. BRITISH VIRGIN ISLANDS ZBVI on 780 can be heard at sunset, before Cuba/WBBM fade-ins. This is best at coastal sites, but it will make the trip inland. The format is basically soul/disco/reggae with a crazy & heavily-accented male announcer who talks over records and dumps in sound effects including wolf howls & Star Wars-style raygun noises.
- 13. $\frac{\text{GUADELOUPE}}{\text{before Cuba & Venezuela fade in.}}$ heard at sunset mixing with Surinam before Cuba & Venezuela fade in. Programming is all in French.
- 14. DOMINICAN REPUBLIC R. Universal on 650 is commonly heard. Other possibilities are 830, 890, 1120, 1160, & 1180. R. Clarin 860 was the best bet before Hurricane David. It came back on the air, but at a much lower power than before.
- 15. MEXICO XEWA on 540 "La Voz de la America Latina" is sometimes the dominant station on 540 after CBT/CBEF s/offs. Others likely to be heard are XEX-730, XEW-900, XEQ-940, XEG-1050, XERH-1500, XEVIP-1560, & XERF-1570. Mexicans are best heard in the early morning hours.
- 16. BELIZE 834 is heard often between YVLT/WCCO-830 & WHAS-840 until s/off at 0510 GMT.
- 17. ST. VINCENT R. St. Vincent on 705 puts out a good signal but the modulation level is weak. As with all Caribbean stations, the best time to try is at sunset during auroral conditions.
- 18. DOMINICA D. B. C. on 595 is a good bet in EE or try for R. Caribbean International w/ FF on 1210 or 1150. R. Jumbo - 545 is long gone, unfortunately.

- 19. BARBADOS R. Barbados on 900 requires an auroral disruption to weaken CKTS/CHML. The best time for Barbados-900 is at sunset before YVMD & HJEY fade up.
- 20. NICARAGUA R. Sandino on 750 can usually be heard u/WSB w/YVKS looped later in the evening. Also try 540 & 620.
- 21. PANAMA R. Peninsula- 825 ID's often and it can be heard fighting for control of the channel w/R. Titania in Costa Rica. Other possibilities include HOL80 on 840 & HOL55 on 860. The splits on 965 & 1045 may be received on a communications receiver during reasonably-good Latin American conditions.
- 22. EL SALVADOR YSS R. Nacional on 655 is not too difficult unless you DX from a site too close to WNBC or WSM. Try YSCF-1155 which has an American-sounding Top 40 & disco format w/SS announcers.
- 23. BAHAMAS ZNS3 is sometimes heard on Monday mornings with WGY off on 810. ZNS1 on 1540 makes it to New England when AU CX kill WPTR's skywave; those living south of Albany (in the WPTR null) can easily log this one before KXEL fade-up.
- 24. JAMAICA J. B. C. outlets are found on 550, 560, 580, 620, 700, 720, 750, & 770. All stations are 5 kW. Radio 1 on 700 seems to be the most easily heard; it's often audible with WLW nulled. The Jamaicans sometimes run all-night, despite indications to the contrary in the World Radio-TV Handbook.
- 25. GUYANA The best bet is R. Demerara on 760 at sunset during AU CX. This is heard well at coastal sites such as Delmarva, south Jersey, & Cape Cod. Action Radio on 560 can also be heard in severe AU CX if you're lucky enough to have no serious WGAN or WFIL problem; the last report I've seen on this one was from Bob Foxworth on Long Island.
- 26. HONDURAS R. Panamerica on 944 is the best bet. R. Aeropuerto on 1085 & R. Danli 1365 can also make it during the best conditions. Those without a selective receiver will have difficulty logging this country. W.R.TV.H. lists a 25 kW. station on 1160, but nobody ever hears it.
- 27. GRENADA R. Grenada on 535 can be heard at sunset with a poor to fair signal. Reception tends to deteriorate later in the night as slop & noise levels increase. 535 suffers from the severe TV birdies, light-dimmer buzz, & powerline-leakage noise problems which plague the lower end of the band.
- 28. MONTSERRAT ZJB on 885 in EE is the easiest, but modulation levels are low and it's difficult to get an ID through the WCBS slop.

 R. Antilles 740 can be heard occasionally w/FF programming, best during AU CX at sunset before the SS LA's fade in. The 200 kW. station on 930 has a very unfavourable directional pattern for U. S. reception; it beams to the northeast. It is heard more often in Europe than in North America.
- 29. TRINIDAD & TOBAGO There are two stations here: 610 & 730. Both require AU CX to be heard. A coastal receiving QTH is advisable. These stations have reputedly increased power to 50 kW. but they don't seem any easier to hear. Check for Caribbean-accented EE talk and Caribbean-style music.
- 30. ECUADOR Frequencia Mil on 995 & R. Melodia 735 will be at least readable most nights if a communications receiver is used. 945 is more difficult. Tropicana 540 is heard during AU CX.
- 31. ST. LUCIA R. Caribbean on 840 can occasionally make it through the QRM at local sunset.
- 32. BRAZIL R. Mundial on 860 can be heard w/R. Clarin & the Cuban R. Reloj after CBH/CJBC s/offs. This runs all night with U. S. Top 40, disco, & an occasional PP folk-rock song. Most nights this can be heard at the coast at poor to fair quality. Occasionally, it is strong enough to penetrate inland. Long deep fades are common. R. Globo 1220 can also be heard at sunset during AU CX. The stations on 1100 & 1000 can also be received occasionally.

- 33. ANGUILLA R. Anguilla on 1505 programmes a variety of music; it is heard best at the coast early evenings before WTOP becomes too strong.
- 34. BERMUDA ZFB on 960 is occasionally heard with Top 40/pop/soul/discomusic during semi-auroral conditions o/u HJHN with the mainland QRM nulled. This is best at East Coast sunset. Those of you who like 'graveyard' DX can try 1230 & 1340 during a moderate aurora. But don't hold your breath waiting hi. Really deep AU CX will knock out Bermuda, though, as Bermuda is not very far to the south.
- 35. <u>U. S. VIRGIN ISLANDS</u> WVWI on 1000 may be heard occasionally at sunset during AU CX. Check early because the channel is quickly dominated by the Venezuelans & Colombians. WSTX is another AU CX possibility if you have no strong groundwave pest on 970.
- 36. GUATEMALA TGW on 640, "La Voz de Guatemala", can be heard late in the evening under CMQ; s/off is at 0600. TGK-1240 has been heard during deep AU CX. TGTL sometimes drifts to 939, where splittable from 940 on a good receiver. TGJ used to be common on 880 before WCBS went All Night operation.
- 37. PERU Because of the horizon-blockage effect of the Andes mountains, Peru is received better on the west coast than in the east. R. Nacional on 854 on a Monday morning with WHDH off or running OC is the best chance to log Peru. R. Union 880 & R. America 1010 have been heard in the west; they used to be heard in the east when WCBS & WINS had Monday morning silent periods. There are also two 10 kW. Radio Nacional transmitters on 1120 in the cities of Tumbes & Iquitos in northern Peru, away from the Andes. These might be possibly received along with other co-channel LA's when KMOX is knocked out by AU CX.
- 38. ARGENTINA LRA1 on 870 has been heard at sunset and also at 0900 s/on. ID is R. Nacional. Listen for the LRA pips on the hour. They are 6 pips with the last one prolonged. Usually these pips are heard through much QRM. You might hear R. El Mundo 1070 or R. del Plata 1030 on day power of 25 kW. when WBZ is occasionally off on early Monday mornings. These stations will fade by 0830 GMT during our winter, so wait until spring to hear them on day transmissions. 1070 R. El Mundo runs all night. Also check 950.
- 39. FRENCH GUIANA Virtually the only possible time to hear this country is at sunset during extreme AU CX before the more westerly LA's fade up. The 0930 s/on will likely be buried by YVMA, HJAG, & HJCG. FF talk or music will be the tip-off here. A recent shortwave QSL said that the power on 1070 is now 20 kW., but based upon its strength compared with that of stations from Guyana & Surinam heard at the same time, it seems that if this is 20 kW. it is very inefficient; more likely, it still uses 4 kW.
- 40. PARAGUAY R. Caaguazu on 645 is very difficult, but it was heard by several DXers on Cape Cod last season. R. Presidente Strössner is on 885 or 890 with 25 kW. & a listed schedule of 0900 0415. It might be heard if all factors were right. Other long-shots are ZP5 on 760, ZP70 on 780, & ZP28 on 860. Additionally, ZP10 is listed as being on 1305.
- 41. TURKS & CAICOS ISLANDS 1550 is very difficult to receive due to its low power and a more westerly location; even during AU CX there will be QRM from the southern U. S. regionals at sunset. The format is EE disco/soul/top 40.
- 42. MARTINIQUE This French colony had a 50 kW. transmitter on 1310 which was rarely heard in the U. S. but made it occasionally to Europe. This was reported to have been destroyed during Hurricane David but, hopefully, it will return.
- 43. BOLIVIA There's little hope of receiving Bolivians on the crowded broadcast band of today, unless some of its stations raise power. R. Illimani 1020 is on 24 hours a day; it might be heard on a Monday morning if YVRS decided to go off. Other s/ons to look for (if you pray a lot hi) in conjunction with 'pest' silent periods are CP57 on 1090, CP27 on 730, & CP34 on 680. CP34 was heard about 12 years ago.

- 44. URUGUAY At present, it's a very tough catch. R. Carve on 850 s/on at 0830 might be heard on a Monday morning with WHDH off. Another possibility is R. Oriental on 770 with s/on at 0900 if WABC goes off on a Monday morning. SODRE 650 is soon supposed to increase power to 200 kW. This would make Uruguay considerably easier to log at sunset in the spring, summer, and autumn.
 - 45. CHILE This country is extremely difficult for Easterners to log because it offers no all-nighters on clear frequencies. As it lies in western South America, its stations are QRM'ed by the time that they fade in during the early evening. Chile's s/ons are too late to be logged free of QRM on a Monday morning in the East. Three 50 kW. stations offer the best chance: CB106 on 1060, CB114 on 1140, and CB138 on 1380. These might be possible with phased Beverages on the coast during AU CX. CB118 1180 which had been heard on the west coast is no longer on the air. As is the case with Peru, the Andes mountains restrict some otherwise-viable modes of propagation from Chile to eastern North America.
 - 46. FALKLAND ISLANDS For you dreamers here it is: F. I. B. S. on 536 with over a quarter of the distance around the world to span with its humble 5 kW. transmitter. This has never made it to North America, but set up miles of wire to a southward-facing beach and you just might be the first to log it. Remember to tape this because no one will believe that you heard it.

The reader is also advised to consult the IRCA Foreign Logs for other articles of considerable use to the Pan-American DXer. The writers feel that two similar companion articles - one by DXers in the southeast & Gulf Coast states (e.g. Hutton, Schatz, Baskind, Thomas) & one by western DXers (Portzer, Martin, Tomer, Peterson et al) - would help greatly in filling in the whole nationwide Pan-American DX picture.

The best way to keep informed, of course, is to read the international DX columns regularly. New stations take to the air frequently; furthermore, existing stations change slogans, calls, power, schedule, format, verification policies, and frequencies often enough that constant updating of the body of available knowledge is essential. All DXers should inform others by habitually reporting their LA DX catches - routine stations once a season (4 times a year) & less-common catches whenever heard. Any verification data should be reported. Best of luck in your efforts!

Before mentioning some of the errors noted, the format should be mentioned. The main section of the book is divided into "countries" based on the ITU abbreviations for the countries. Before the main section are 36 pages (12 for each language) of instructions on how to use the list. After the main section are 24 pages of explanations from the "Remarks" colummn. Under each country are 10 columns: supposed transmitter site (in alphabetical order), frequency in numerical order for each city, station call-sign (if any is known), geographic coordinates, the area of intended coverage (local, all the country, etc.), power in kilowatts, antenna direction (most are listed as non-directional), sign-on/sign-off times, the operating agency/company, and remarks.

If the information contained in the publication is accurate, it would provide an excellent source by which transmitter sites of European longwave, BCB, and shortwave broadcast stations could be confirmed. Additionally, the dispute over transmitter site by frequency could be resolved. However, this would be true only if the information were considered accurate. The ITU states that the information in the list is from information on file, so it is either the error of the ITU computers or the broadcasting agencies involved which allowed these errors.

After reviewing the book, it would appear to have very limited value for most DXers, and at US\$42.00 or so (plus approximately US\$10) it isn't something you add to your reference shelf just because somebody else has one! With the exception of the listing of coordinates, the information can be found, in a more up-to-date form, in the current WRTH. If, for whatever reason, you decide you need a copy, it can be ordered direct from the ITU in Geneva. I would, however, suggest you write the ITU to check on the current availability, price, and surcharge for airmail delivery, if desired. And when sending payment (not to advertise...), I have found the most widely accepted form of payment, and the least expensive, when a personal check will not be accepted, is an American Express Money Order.

Divvying up the airwaves

(First of a two-part series) By Larry Green Washington Post

WASHINGTON — A little-noticed reference in paragraph 276 of the final document of the recent meeting in Cuba of nonaligned nations warns that the next battlefield on which the developing and nonaligned countries will engage their industrialized counterparts is broadcasting.

It is a reference to the World Administrative Radio Conference (WARC), a littleknown, 10-week conclave that will have a profound effect on the world's use of the airwaves for the next two decades.

The developing countries have come of age in the telecommunications world and are now a force to be reckoned with. More than that, they now realize that they have the power to exert great influence over the communications services that will — or will not — be made available to everyone in even the most powerful nations. Since technological restrictions keep the number of available slots on the radio bands limited, a block of votes from several developing countries could decide, for example, whether there will be 700 more AM radio stations in the United States.

There are some 90 developing countries out of the 154 members, giving the Third World a disproportionately powerful voice.

The International Telecommunication Union has sponsored WARC conferences approximately 20-year intervals since 1865, when 20 European states met to adopt the Morse code as a uniform telegraphic code for international communications.

Until this year, WARC conferences have been little more than club meetings of the top communications technicians from the most advanced countries who quietly discussed problems and breakthroughs in communications, and how they best could serve their respective countries.

Times have changed, and the number of countries participating in WARC 1979 is almost double the 87 that attended WARC 1959. In addition, virtually all of the newer member countries are less developed countries with sharply different needs and priorities than the developed nations.

The communications business also has changed since 1959, when the sky had yet to be littered with even its first communications satellite. Technology is developing so quickly that some forms of communications that didn't exist in 1959 already are obsolete. And international cooperation is needed now more than ever to insure that radio signals don't interfere with each other.

The US has sent a 65-member delegation with 36 additional technical and administrative staffers to the conference, under the direction of delegation chairman Glen Robinson, a University of Virginia law professor and former Federal Communications Commission member signed on by the State Department for this purpose.

Armed with 2000 pages of position papers on major issues, which have been worked on by subcommittees for years, the delegation—made up of representatives from all segments and interest groups, ranging from the government to consumer groups—is prepared to haggle over even the most technically difficult issues.

Third World nations have watched for years as the industrial giants have grabbed the frequencies and bands they needed for whatever services they sought to develop. Now, as the limits of technology have crept up to the point where the telecommunications spectrum is becoming crowded, the developing nations have begun to call for a "New World Information Order."

"The US and USSR, the two most technologically developed countries; have 15 percent of the world population and use 50 percent of the world broadcast spectrum," said Thomas A. Hart Jr., treasurer of the National Black Media Coalition.

The US policy is to seek maximum usage of the airwaves, to allow those who can use the spectrum now to do so and to work out a sharing program when others are ready. That concept is viewed with skepticism, to say the least, by many Third World nations fearful that what they give up today, they never will be able to retrieve.

Battle of the bands

(Second in a two-part series) By Larry Kramer Washington Post

In most developing countries, communications are in the hands of one entity: the government. Those countries can present a more united front and are in better positions to negotiate than the United States, which must worry about its many constituencies.

The United States, in its own interests and those of American business, has proposed the following:

- Expanding AM broadcasting in the low-frequency and medium-frequency range to accommodate 700 new radio stations.
- Sharing the UHF portion of the band now used mostly for television with mobile radio users on land. This proposal has met with opposition from Canada, which fears that US mobile land users will interfere with their broadcast band.
- Increasing significantly in high frequency (HF) bands international broadcasting for such groups as the Voice of America and Radio Free Europe, and maritime mobile services, with more accomodation for mateur services. Such expansion, however,

is sharply opposed by developing countries, which still use HF for such basic services as domestic telephone systems. The developing countries fear US proposals to share this portion of the band because they feel they don't have the technical know-how to ensure themselves of adequate representation in the sharing process.

- Expanding the ultra high frequency (UHF) realm to allow such communications services as CB radio, mobile telephones and microwave relay to grow. The United States also has proposed "a critically important frequency allocation to accommodate a new satellite navigation system that promises to revolutionize radio navigation through the use of a 24-satellite system providing constant position information to ships and aircraft." Further support is being sought to permit two-way satellite communications in the UHF spectrum for such things as the Post Office's electronic mail program, and satellite monitoring of weather conditions by scientists.

— Approving a special allocation for a satellite information-gathering system, a Department of Defense request that is being supported only by the NATO countries, who are tied to our defense system.

These are just some of the hundreds of specific proposals floating around the WARC. There can be many winners and losers after the dust settles at WARC 79.

Huge companies in need of their own private international communications systems could be affected tremendously. Banks, transportation companies, multinationals all have an interest in what services may or may not be made available to them because of WARC decisions. Firms as small as a taxi company with 10 radio-equipped cars also could be affected.

Companies such as Motorola might be able to offer new, more expensive CB radios to consumers. Bell Telephone and other communications companies such as Western Union, Consast and others might be able to offer a whole new realm of communications services to customers if the right segments of the radio band are opened up.

Comsat, for example, is planning to offer pay television beamed directly to individual homes through minireceivers on the roof, sort of a cable television system without the cables. But the radio "winds" will have to blow in the right direction for Comsat to be assured of having the frequencies it needs to provide such a service on a large-scale basis. WARC observers say, for example, that Satellite Business Systems is critically dependent on new satellite allocations for services it is planning to offer. Things could get tight for SBS, Comsat and others if the WARC in any way limits the number of orbital slots.

Countries such as Japan that export electronic goods to the United States could have a significant windfall if the American public suddenly is offered a whole new batch of communication services.

Consumer life could be affected dramatically. What kind of radio equipment can be used, how international telephone calls will be relayed, how many television stations will be on the dial, and even the type of microwave ovens available are all issues that can be affected by decisions made at WARC.
