Odds & Ends

A flash tip: KNIX-1580 in Tempe-Phoenix is now on full time. Station is being heard well in the Los Angeles area despite proximity to KDAY; see WDXR for details. A check of 1580 while working on the bulletin 1/14 revealed only XEDM of presumed KDAY (soul mx), suggesting KNIX is beaming everything into New Zealand or beaming a roughly east-west figure 8. Eastern/DU members might want to watch for them. 1580 is a Canadian clear channel, so KNIX probably has to protect western Canada, even though there are no stations in western Canada on 1580.....

Last week I put in a plug for the IRCA Goodie Factory. I should probably mention that if you've placed an order for reprints, etc., please be patient. The G.F. proprietor, Phil Bytheway, and his wife are expecting a new family member in early February - the result being that his DX shack is being converted into a nursery and the attic is being converted into a DX shack, thus slowing down the reprint processing processes. If your reprint order takes forever to be processed or if you get a cigar in the mail instead of an Almanac, that's the reason....

A reminder to reporters that all loggings should include day, time, program details and reception quality details. There have been some reports recently that have been missing one or more of these. I agree with Ernie Cooper's remarks about the danger of printing too detailed programing descriptions in the loggings. Some time back a CDXR reporter told me that he knew of a case where someone used the loggings in DX Monitor to compile reception reports. From now on I will not include any long lists of specific program details such as local sponsors in CDXR. I will allow one sponsor's name to be mentioned in each logging but only when the exact time of the commercial is not given. I think that it is more important to report the general type of programing (type of mx, nx, sports, wx, ads, etc.) rather than specific program details (names of sponsors, DJ names, names of songs, etc.). Certain specific details such as slogans, program names, networks, etc. should be reported since they are useful to other DXers. Well, off the soap box there, I really didn't mean to give such a long sermon, hi. Locally, WWQM seems to have shifted their automated format from FM to AM with no change from its slightly softer than average top 40 format. I doubt their AM and FM changes will have much effect on their ratings since they're no different from any of the local rock stns. Attention Mike Brooker and anyone else confused about KCJJ: KCJJ is off from Iowa City sunset to Bakersfield (KPMC) sunset. This is to protect WQXR during this period. WQXR uses their daytime pattern until Bakersfield sunset and apparently puts more power out this way with it and needs more protection than their night pattern. At least this is what I gather from my KCJJ verie of a while back. 73.

If EDXF had the penguin flipper award, I'd be willing to take my lashes.
My report of CHTN several issues back should have read 1637 in SSS (not 0437 in SRS). A word of warning to fellow Superadio owners: we don't have the ultimate mediumwave DXing equipment. Torontonian Neil Wolfish has reported logging 80 NY stations. I've achieved totals of 86/69 in Empire State loggings, with the advantages of two OTHs (Watertown for a year). I'm not ready for the big league equipment in the forseeable future, but all the more power to our well-equipped northern neighbors. In the process of moving a couple of months ago, I unearthed a couple of long-forgotten gems- two C-120 cassettes from May 15, 1970, when KFRC aired the Top 100 of the Sixties. It was complete with IDs and commercials at some points and both tapes sounded surprisingly good for being idle over seven years. Since my home at the time was Alameda Naval Air Station, I suppose I could count the tapes as my first verification and extend my DXing career (backwards) over six years. Attention BARFers: Does KFRC plan to do the Top 100 of the 70's in May? LXXIII's from the DXless Flower City (Jack Frost, where are you).

Mark Connelly-30 William Road-Billerica, MA 01821-2 Jan 1980 (My apologies to Mark- he was the "mystery DXer" in the January 5th DXM-jz) "Boston Radio during the '70's". The '70's started with WNTN-1550 having a true progressive format (they played everything from Steely Dan to Steeleye Span); DJ's were the "whispering" type common on late '60's progressive rockers. I alternated between WNTN and Maxanne Sartori on WBCN-FM for drivetime rock. WNTN eventually "wimped out", going to MoR; then WCAS-740 took over in the progressive AM field. WCAS had a softer sound than WNTN, however, with lots of folk and jazz, but no heavy-metal rock. Donna Lee Halper was a well-known WCAS DJ in the early '70's. Top 40 radio was dominated solidly by WRKO-680, with WVBF owning the Top 40 FM market. Pop/contemporary-adult personality-oriented stations WBZ-1030 and WHDH-850 rated consistently high in the Arbitrons; their regular DJ's like Carl deSuze & Jess Cain have long had loyal audiences in the 30 to 50 age group. Country music was absent from the dial for about 4 years after WCOP dropped it. WCOP became WACQ with T-40, then WHUE w/Muzak. WDLW-1330 recently came forward to fill the C&W void; WDLW had previously played classical music as WCRB and big-band/pop music as WHET. Robin Young did a soft-rock show during the wee hours of weekend mornings on WBZ; later, she became a local TV star. Disco swept in during 1979: soon WILD, WBOS-FM, and WXKS were boogying-down with the disco sound. Also, it heavily invaded the Top 40 stations. Suburban WGTR-1060 was startlingly progressive on owner John H. Garabedian's afternoon shows in the mid-70's. WUNR-1600 held down the ethnic programming slot. WRYT-950, and, later on, WEZE-1260, supplied religion. WEEI-590, with all-news, drew high ratings consistently throughout the decade. WMEX-1510 was the best Top 40 station in the early '70's; later it changed to WITS and featured talk shows. The real ratings war now is being fought on FM, which during the last 10 years has become the city's dominant radio medium. Steve McLean on WCOZ-94.5 and Mark Parenteau on WBCN-104.1 battle for the domination of the massive afternoon rock audience. WBOS and WXKS-FM vie for the disco crowd and WJIB jousts with WHUE for control of the "Muzak" segment.

Craig Healy-Box 182-Cumberland, RI 02864
As I have never submitted a Forum in the few years I've been in IRCA, an introduction is in order. I'm 32, married, one child, been DXing on and off since around 1960. I presently am CE at WJAR-920 in Providence, although I'll be leaving there shortly. I am at the dials every night for at least a fast bandscan, but not much new is showing up. The main purpose of this Forum is to put a proposal to the Board of Directors. There has been much talk in official circles about extending the BCB. It appears inevitable that some increase in channels will happen. Therefore, I propose to the Board of Directors that we enlarge our definition of the BCB to include the frequencies up to 1700 kHz or so. This would give us a period of information gathering of stations in this range, propagation characteristics, etc. This might take up a little room in the bulletin, but it should be worth it in the long run. Other bits and pieces: Although the new format of DXM is harder to store, it's a whole lot easier to read. And that's why I subscribe, to read. I like it. The equipment here is an R-390A, TRF, 5 foot loop, and a 70 foot top loaded vertical, listed in no particular order, by the way. Question 1: Has Radio West got a digital readout for the TRF yet? WDGS-1290 New Albany IN (Louisville) has left the PROGRAMMING air after several months' try at an all-news format.

NOTES

The owner had a staff of five fulltime newscasters, a hefty number for a daytimer. He saw that sales volume even in the Christmas season, was going to leave the station in the red, and decided to pull out of the broadcasting business. The station sits silent while the owner looks for a new owner.

KFGO-790 Fargo ND recently sent a letter of protest to the Tranian mission to the UN. It was signed by 5867 KFGO listeners in 28 hours. A copy service called "Lively Wire" has gone into syndication. It's designed to be the radio version of the National Enquirer tabloid newspaper.

A syndicated traffic-reporting network called "Shadow Traffic" went into business in the New York and Long Island markets in November. It uses a combination of aircraft, spotters, and remote-control CB transcievers called "shadow boxes" to keep tabs on area roads. Reports can be delivered to the subscribing radio stations by either voice or teletype. Shadow requires that the reports be aired within four minutes of when they are sent for timeliness. Subscribers include WGLI-1290, WHLI-1100, WNBC-660, WCBS-880 and WINS-1010.

The Kenwood R-1000 still hasn't had a formal review yet--I'd hoped to get my hands on one locally, but so far, no luck. Grant Manning passes on the word that it has no tunable preselector

because it has a number of bandpass filters at the front end. These are apparently all that's needed as Kenwood used some good FET balanced mixer circuits, which make this much better at strong signal handling than one would first expect. Also, my original figure of 200 uV sensitivity below 2 mHz is in error--it's 50 uV for AM and 5 uV for SSB/CW. More as it happens.

Oh Yes, Radio West is selling the R-1000 at \$430 and are wiring it so that the good SSB IF filter is used for AM 'narrow" as well as SSB, and AM "wide" is the old "narrow" AM filter. The wide filter is wired out. Perry Ferrell of Gilfer Associates says they're doing much the same and that Kenwood will be wiring the newer R-1000's this way.

(from the Marketplace Report) To shorten the AGC decay time on this receiver (if you have an earlier model) replace capacitor C2 with one of approximately 1 uf. A selectivity modification kit may be bought from Kenwood (Parts Department/ Shortwave division, Trio-Kenwood Corp. 1111 W. Walnut St., Compton, CA 90220)


If the instruction manual contains a sheet indicating that selectivity may be

improved by moving the "3" connector, then it is one of the later sets.

Phased Longwire Antennas (from Mark Connelly)

Some may recall seeing Chuck Hutton's article in DX News of September 25, 1978 (now available as NRC reprint A28) which discussed "Two Wire Phased Antennas". He was referring to Beverage antennas in this article, but Mark Connelly has found that it's possible to combine the signals of two longwire (rather than Beverage) antennas and obtain nulls on some signals using a phasing unit. A respectable degree of nulling can be achieved with wires as short as 20 meters in length. Wires of equal length should be used, although nulls may usually be obtained regardless of the directions of the two wires. Nulling high angle skip is difficult because of the constantly fluctuating arrival angle (the same applies to loops). The best nulls are obtained with long wires over 200 meters in length. These are usually run parallel to each other, about 5 meters off the ground and 10 meters apart. These may be terminated (grounded either direct or through a resistor) or floating; optimum configurations consist of one terminated Beverage and one floating Beverage, such as Bill Bailey's system described in Hutton's article.

The phasing system:



Notes:

- A) Switches must be of a type suited to RF work; in other words, they must have a low open-condition leakage capacitance. (most types would be OK at these frequencies--ed) B) Note that neither side of the capacitors are grounded. Most types therefore must be mounted on wood or plastic rather than a grounded metal case.
- C) L1 and L2 are slug tuned types mounted in grounded aluminum cans.
- D) All parts are mounted inside a standard aluminum box
 E) Adjusting R1, R2, C1 and C2 may become quite touchy. "Fine tuning" controls may need to be added. C1 and C2 could be paralled by 5-20 pF variables and R1 and R2 could have 20 ohm pots placed in series with them.


Procedure:

- 1) Switch in Ant. 1 with SW2 to open. Set R1 ant minimum resistance. Tweak C1 for peak
- signal, note S meter reading.
- 2) Switch in Ant. 2 with SWI to open. Set R2 at minimum resistance . Tweak C2 for peak signal, note if S-meter reading is higher or lower than peaked Ant.1 reading.

 3) If Ant. 1 reading is greater than Ant. 2 reading, adjust R1 to equalise the readings,
- then go back to step 1. If Ant 2 reading is greater than Ant. 1 reading, adjust R2 to equalise the readings.


4) Flip SW1 and SW2 to connect both Antl 1 and Ant. 2 to the balun coil (null mode). Carefully adjust the pot just used to equalise signals to reduce the strength of the undesired station. If no null is obtained, re-equalise strength (step 3). Adjust the other pot with both Ant. 1 and Ant. 2 connected for a null. Touching up the capacitors slightly (here's where the trimmers come in handy) will deepen the null. Continue adjusting R1 or R2, C1, C2 to obtain the best null.

The balun transformer can be wound on a 125 permeability ferrite core as follows.



A 1:1 turns ratio will work. Some experimentation will be required as to the number of turns. Try 10 on each side for starters. This is used with the balanced input of the R-390A, but it might be interesting to try a receiver with an unbalanced antenna input on this set up. Or a bifilar 4:1 balun (see the Radio Amateur's Handbook


or the ARRL Data Book for further info) might be used.



Another article by Chuck Hutton on phased beverages appeared in December 17, 1979 DX News. He describes Mark's system and his own balun transformer using a trifilar winding on a toroid. This winding is made by taking 3 pieces of enamelled wire, each one foot long, marking the ends with tags of tape (1A, 1B etc.) and twisting the three wires together. Wind the twisted wires around a toroid core (type not specified, but one best for a BCB frequency range), solder 1B to 2A--this is your center tap to ground. 1A and 2B could be connected to SW1 and SW2. 3A and 3B are connected to the receiver. This is used with two Beverage antennas, so there may be room for


experimentation if you use longwires.

A phase reversing transformer might be switched into one of the sides of the phasing unit for added flexibility. Switch it in after step 4 of "procedure" to see if it gives a better null; if not switch it out. Again, consult the "Handbook" or ARRL Data Book for further details; 84 turns of wire center-tapped on a toroid core works fine



Phased wires used at West Yarmouth, MA: This is an aerial constructed initially for amateur band use. It takes the form of a halfwave dipole for 3.8 mHz. On medium wave, with the phasing unit, the feedline and element of one side of the dipole (18 m feedline and 19 m flat-top), effectively a 37 m long-wire, is worked against the other side of the feedline and the other side of the flat-top to produce nulls. Yard space does not permit the dipole to run in a straight line. Average height of dipole approximately 9 m.

Some comments on military surplus (from Ed Satterthwaite)

All the military surplus that I've seen has been conservatively designed and beautifully built (MIL specs, etc.) slthough some of it has been physically abused. Much of it is very specialized, however, and the apparent "bargains" are likely to require a great deal of reworking before they are useful to DXers.

The designs (and in many cases, the actual manufacture) of many items go back to WW II. This is a mixed blessing. The "old-fashioned" designs (with many tuned stages, low gain per stage, low IF frequencies) actually have many advantages in dealing with today's BCB conditions. On the other hand, components are large, heavy and practically impossible to match (except on the surplus market) if repairs become necessary.

Although odd-ball items appear from time to time, the consistently available equipment seems to fall into the following classes:

Militarized communications receivers. These include the well-known R-388, R-390A etc., as well as military versions of the Hammarlund SP-600 and its predecessors. In good condition, these apparently are among the best receivers ever built for the BCB DXer. Unfortunately, I have no first-hand experience with them (sigh).

Specialized communications receivers. Unlike the general coverage receivers, these have limited tuning ranges and just those features that apparently were thought necessary for the intended applications. The best examples are the aircraft "Command" sets, which are compact, well-designed and relatively easy to find. Receivers in this class are often easy to convert (usually just requiring a straightforward power supply to replace a dynamotor). With the exception of models offering limited, low-frequency coverage (such as the BC-453 "Q-5er"), selectivity is likely to be inadequate for current band conditions. In addition, the tuning ranges tend not to correspond exactly to present assignments.

Radio Compass receivers. Superficially, these seem ideal for the BCB enthusiast. Unfortunately, there are a number of problems in the areas of power requirements (many require 115V, 400 Hz AC and 28V DC), packaging, and control (most are designed for remote control only). These sets are for the confirmed experimenter and can most usefully be viewed as collections of hard-to-find (and high quality) parts waiting to be reused. Again, odd tuning ranges can be a problem.

The RA- and RB-series receivers used by a few DXers remain a mystery to me. They are evidently Navy surplus, and some must be quite suitable for BCB use. I myself would like to see something on specifications and possible sources of supply. (Jim Hill, where are you?--ed)

For many DXers, the surplus market is probably a better source of parts than of complete receivers. For example, the latest catalog from Fair Radio lists the standard radio compass tuning capacitor (5-gang, 13-402 pF/section) for \$5.95; it should make a fine antenna tuner or preselector.

what is said about the low frequencies is also applicable to the medium waves. Also, there is an obvious slant toward those who are interested in operating low-powered transmitters in the low and medium frequency ranges.

The SCRAPBOOK begins with a description of the general types of receivers (from crystal sets to the superhets), briefly discusses low frequency converters, and provides some suggested schematics of same. Chapter Two is a nice discussion of the various types of coils and the mechanics of winding them but, in my opinion, could have been strengthened by a more detailed description of the characteristics of the various types. Included in this chapter is a nomograph relating coil diameter, coil length, number of turns, inductance values, capacitances, and frequency. Chapter Three deals with antennas and is a bit of a disappointment in that the air-core loop is discussed almost exclusively...not a word about the Beverage as a medium-wave receiving antenna. Chapter Four provides some guidelines and detailed tips for legal, low-powered broadcasting in the extra low, low, and medium frequencies and is the "meatiest" chapter in the book. A concluding chapter is a potpourri of information and contains schematics for RFI and audio filters, a low to medium frequency receiver, and a low frequency transmitter. Several pages of FCC guidelines round out the SCRAPBOOK.

The ADDENDUM also emphasizes the low frequencies and is comprised primarily of schematics of interest to LOWFERS (Low Frequency Experimental Radio Station (operators)) although a solid-state Q-multiplier is described and reference to a symposium on electrically small antennas is made. The ADDENDUM concludes with a brief description of Jim Hagan's large aperature ferrite loop and a mention that Radio West and Palomar have introduced ferrite core loops. One page of the ADDENDUM is, interestingly enough, devoted to the prospect of using a kite antenna on the low frequencies but no performance data are provided.

In conclusion, the SCRAPBOOK and ADDENDUM were not all that I, as a BCB DX'er, had hoped they would be. In fact, articles in IRCA's and NRC's reprint list contain virtually all of the information relevant to the BCB DX'er that was present in the SCRAPBOOK and ADDENDUM. However, if you are thinking about venturing into the frequencies below the BCB or are contemplating building a low-powered transmitter for this general frequency range, these two publications should prove to be quite valuable.
