Radio His Life-Long Hobby

Once upon a time lots of people used to gather around the living room radio for hours at a time. They would sit and listen to the antics of Amos 'n' Andy, the villainy of the Shadow, or the pronouncements of Franklin Roosevelt.

Times have changed Today radio is competitive.

Times have changed. Today radio is something we sort of listen to while we're eating breakfast, driving to work, cleaning the house, or doing our homework.

These days very few people are mesmerized by radio. But there are exceptions ... like Howard Kemp, Evening Citizen columnist.

Kemp, a 66-year-old Laconia resident, has been hooked on radio since he was a teen-ager growing up in Waterbury, Com. It was in 1932 the Kemps got their first radio — a used RCA Victor floor model set with a slide-rule dial.

The radio hadn't been in the home very long before Kemp became an obsessive listener. "My dad died when I was young, so we weren't too well off." he said explaining how listening to radio developed into a full-fledged hobby. "When other kids were running around at night I was at home." Since those days during the Great Depression, Kemp has passionately explored the standard AM dial. Over the past 51 years he has listened to roughly 3,600 different stations located on every continent except Asia. As proof of his efforts, he

continent except Asia. As proof of his efforts, he has cards and letters from over 3,200 of the

stations confirming what he heard.

While there are thousands of broadcast band hobbyists in the country, Kemp believes he is the

only one in the Laconia area.

Almost every evening he will ensconse himself in a wing-back chair in the living room of his Court Street, home and witch on his Kenwood radio and begin turning the dial slowly. Always he hopes to discover a "new" station. On Feb. 1, he heard WWWG in Rochester, N.Y, for the first time and six days later he picked up XERN in Mexicali, Mexico.

What makes Kemp's hobby possible is an atmospheric phenomenon which permits AM radio signals to "travel" much further at night than they

signals to "travel" much further at night than they can during the day.

Kemp's says his distance record was set sometime in the 1940s when he picked up a station in Perth, Australia. One night in 1947 he spent some time listening to KULA in Honolulu.

He often can tell where a station is just by listening to the music. "The French Canadian rock in' roll stations seem to have a really heavy bass beat," he explains, adding: "Now when you listen to the Arab stations, there's depressing music for you."

Whenever Kemp hears a station for the first time he writes a letter telling them what he heard and when. Most stations answer with a confirmation. But sometimes a reply from foreign stations can take a while because the letters often need to be appeared to the confirmation.

One of the best times to listen, Kemp believes, is in the wee hours of the morning. For years he has regularly gotten out of bed to listen to the radio for a couple of hours. He laughs when he recalls how his mother worried that habit would hurt his studies. "She used to put newspapers on the floor, hoping the sound (of rustling paper) would wake her up so she could send me back to bed," he told a visitor. "After a few years she just threw up her arms and said, 'What's the use."

Kemp says he enjoys his hobby as much today as he did half a century ago when he heard station YVIBC in Caracas, Venezuela. "It's just as fascinating," he said, "partly because it's getting harder to find new stations."

Hargeisa, Somalia, on 1341, in Somali until s/off 1800 UTC, which is only 2100 local time. Seems as if people in Somalia go to bed early, or possibly retune to the station in the capital Mogadishu, if they can get it on 963, where Sudan is also active. IDed by announcement and by SW // 7120 (which WRTH 1982 says is reported inactive; WRTH 1983 not yet received). Somali music is very enjoyable. This newie was quite easy to ID, unlike the Ethiopian-language stn reported in a Forum a month ago, on which I am still working, on 801. So, two exotic, non-Arab musics can be heard simultaneously on 1341 at 1500-1800; Pakistani music from the Urdu service of R. Kuwait, and Hargeisa. I suspect this activation is linked to recent political unrest in northern Somalia, the former British part, linked since independence with the former Italian south. Our local grocery checker comes from there, and I will tell him about this new station. Everything is moving ahead for my summer back in the U.S. and Canada, and I have booked a flight Abha/Jeddah/JFK/LaGuardia/St. Louis for 6/17. Busy with my new semester here and not much DX. Did buy a JVC speaker which does justice to the audio on Hargeisa and other enjoyable stns. The post office here now has lovely giant-sized commemoratives for King Fahd and Crown Prince Abdullah, and anyone who wishes to trade them for mint U.S. postage is welcome to write me. 73. 
Several people have asked about KIXI's verification policy recently.

"The Big Bands, contedy and dramatic serials, Eivis, The Twist, Beatles, disco, Metropolitan Opera, In-depth news, and sports reporting are all parts of a tradition-rich industry that has brought information, entertainment and education into American homes for decades.

Radio has been both successful and profitable in its willingness to experiment, and to change from one format to another in a continuing effort to fulfill its obligations to its listeners. We think of radio as an old friend. It's loyal and dependable; always available when we need it — for news, weather, music or conversation. In return, the stationahope to achieve a habitual listening pattern, either for a specific time period or an on-the-air personality.

As the San Diego market continues to grow, we find the competition becoming more and more intense. Following a year (1981) in which the radio market produced record revenues, 1982 presented an even greater challenge as stations competed for the threshold of the audience (the ratings), and advertising sales.

At XTRA FM (91X) where its format recently changed from album-oriented music to 1980's modern music, and at XTRA AM, general manager John Lynch believes radio has done well in 1982 in spite of the recession. "They've turned to radio in droves," he says of the advertisers. "I think television faces real problems' because of the unbelievable fractionalization of the television market-place caused by cable's growth."

Hal Rosenberg, vice president and general manager of KFSD-FM, shares an optimistic view for radio. Rosenberg, who says his station is the highest rated classical music station in the country, puts KFSD's advertising sales in 1982 ahead of the year before. Explains Rosenberg: "1981 was a record year for advertising revenues in San Diego radio. But every year recently has been in that category because of the market growth."


Unfortunately, not everyone shares the same encouraging outlook about the economic growth of the marketplace. Says Tom McMillan, general sales manager of KSDO-AM, news, sports and talk radio, "We projected increases that we didn't achieve. I think everybody in the radio business projected increases in 1982 that were not achieved."

1982 that were not achieved."
At KFMB-AM, home of the morning drive-time ratings leader, Hudson & Bauer, and KFMB-FM, Peter Hallisay, general sales manager, believes radio advertising has been hurt partially by the recession.

But despite the recession (and many believe because of it), advertising is still a necessity in creating and developing most business. The problem or question therein lies — where and/or when does a business advertise its product or service?

With several stations broadcasting similar formats, radio advertisment must be based on a careful examination as to each station's ratings, advertising costs, audience targets, promotions etc.

The number one radio station in San Diego, according to last fall's Arbitron ratings survey, is KJQY-FM, an easy listening music format and perennial first or second place finisher in the ratings derby (taken quarterly). "One of the strong points of our format," says Jerry Lee, general manager of the station best known as K-JQY, "is that we've been

able to build a very loyal and conservative audience. Once you get that kind of audience they stay with you."

Lee also labels as a "myth" the belief that an easy listening format relies heavity on an older audience to develop a following. "We have a very wide demographic spread," he says. "In fact, we were also number one in the overall ratings last fall in the 25 to 54 age group."

A significant and important change in the San Diego radio market in 1982 was the emergence and sudden popularity of station XHRM-FM, a black-oriented disco station transmitting from Tijuana. XHRM finished third in the ratings behind KJQY-FM and KGB-FM, numbers one and two respectively. Fourth through 10th included KMLO-AM, KPRI-FM, KSDO-AM, KFMB-AM, XTRA-AM and KFMB-FM (tied for eighth piace) and KYXY-FM.

In general, radio's best programming times are morning drive (6:30 a.m. 6:30 a.m. 6:00 p.m., 6:00 p

Most stations sell 60-second spots primarily. Larry Thomas, sales manager of KUDE-AM and KJFM believes that 60-second spots are definitely the best value. "Your 60-second spot is not twice the cost of a 30," Thomas explains. "It's usually a third higher. To have an effective advertising program, I try very hard to pitch 14 to 21 times (advertising spots) per week. When you increase your frequency, your results definitely increase."

At XTRA-AM & FM, John Lynch talks in terms of 12 units (spots) per week minimum with a 13-week run.

The toughest sell in radio is the socalled "graveyard shift," midnight to 5:00 a.m. "At KUDE and KJFM." Thomas explains, "we're giving the advertiser two spots between these times for only \$2.00 more, which means advertisers running spots during our regular schedule pay only \$1.00 more for each spot on both AM and FM during graveyard." At EXTRA-AM & FM, overnight spots cost the advertiser only 25% of the daytime charge.

When discussing the San Diego radio market, one must include the Spanish audience as well. The population of San Diego is about one milion persons and San Diego County approximately 1.9 million. Of this growing population, at least 20 percent is Hispanic.

"The local advertisers are slower to buy Spanish radio," explains Bob France, head of U.S. sales for XEMO-AM and XHFG-FM broadcasting out of Tijuana and covering south of the border. San Diego, Orange County and parts of Riverside County and Los Angeles. Los Angeles advertisers are far more cognizant of the Spanish presence in San Diego," France continues. "Despite the peso devaluation, our regional and national advertising increased. We had a better year in 1982 than we did in 1981."

Several San Diego stations have found music formate both popular as well as profitable. But it is apparent that allnews programming has not achieved similar success here as in such larger markets as Los Angeles, New York and Chicago.

"The day of the 24-hour news station is gone," says McMillan of KSDO, which carries news, sports and talk programming. "You have to consider how much audience you are going to appeal to between 9 a.m. and 3 p.m.," he adds. "With an all-news format your ratings are going to suffer during this period by virtue of the work-flow."

Bob Iafrate, general sales manager of KCNN, which launched an all-news format in San Diego last March via cable, believes all-news programming locally is viable. However, in January, after experiencing poor ratings, KCNN changed its format to news and talk, adding ABC as its primary talk source, and using CNN in a secondary role. The television audio vehicle did not lend itself to radio programming, another factor in KCNN's switch from all-news, according to Jafrate.

Finally, in a further effort to achieve a better ratings mix, KCNN has added Big Band music to its weekend schedule.

Despite hard economic times, San Diego radio continues to prosper, and to succeed in its obligation to serve the public. Penny for penny and dollar for dollar, it's hard to beat the impact that radio carries.
