For those of you who do one know me, I am 29 and have been a member since 1969 (except for a couple of gaps). I have a degree in Tele-

communications and am presently working on a second in business.

I support the expansion of the club's coverage to the areas above and below the BCB 9500-1700) and am totally against the addition of FM. Even though the programming types of BCB and FM are similar, the propagation is not, and inclusion of FM in IRCA would mean the addition of an entirely different form of DXing that would be greatly prohibitive to the club's finances and publishing operations.

An area of great concern I believe the club should examine is the poor image of BCB DXers in the broadcasting industry. Suppling the larger stations with information sheets to send to DX reporters could help to clear upthe problems created by poor reports that many stations are receiving. A committee could be created to organize such a program or it could become part of the CPC's activities. Another promotion idea would be the creation of professionally produced PSAs on 9CB DXing and the IRCA that could be aired on cooperating stations.

The support of the IRCA publications such as the TECHNICAL GUIDE and ALMANAC is essential and I feel the FOREIGN LOG could be revived now that home computers are becoming quite common. Computer processing would be the solution to the information compiling problems related to the publication of the FOREIGN LOG.

A new area I feel we should explore is the use of the home computer in DXing. I would like to eventually see a column on it in DXM.

Emergency Communications Divi-FCC and Federal Emergency Management Agency officials have forwarded drafts of the still incomplete proposal to members of the National Industry Advisory Committee, a board of radio and television representatives.

The committee may act on the proposal soon, officials said. But they said the plan is meeting resistance from at least one of the national television networks, which claims such tests bother viewers.

KORK radio seeks higher ratings with 'real music' format Las Vegas Review Journal, April 14, via Thomas Nyquist

onfronted by a number of radio stations battling for the same Las Vegas market, KORK-AM completely has switched its programming strategy. The station hopes its departure from the "adult contemporary" format will change sinking ratings into gold.

The Midas touch called for a switch to what the station calls "real music" - music long gone from most radio-dials, music aimed at a 35-and-older crowd, with 90 percent of the on-air songs coming from the 1943 to 1957 era

In trade parlance, the mix of postwar hits is known as "nostal-

MOR (Middle-of-the-Road)"; at KORK it's known as "real music" and it's proving to be a real hit with listeners.

There was a void in the market and we filled it," claims Jack London, KORK operations manager.

Since the switch, London says the station has been deluged with letters from listeners expressing pleasure about the format change. In a market filled with Top 40 tunes, where a twist of the tuning dial gives a continual sense of mediocre deja vu, the "real music" is unique music with unique appeal.

"We got over 250 calls the first week after the change," says London. All of the calls were congratulatory.

"We're positioning ourselves as the 'real music,'" he continues, "and people are calling to say, 'Gosh, you're not kidding. I've been with KORK for a long time and you're playing my music again.

The search for a unique format began last year with an eightmonth-long marketing research study by London and Gene Spry, the station's general manager. After determining that postwar

> hits filled a vacancy in available Las Vegas programming, London and Spry studied various syndicated packages of "nostalgia"

The package they selected, "Prime Time Radio," is the successful brainchild of Larry Anderson, the operations manager at WDAE in Tampa, Fla. Already playing in 17 markets across the nation, one of Prime Time's most attractive features, to London, is its "flexibility."

Like many syndicated formats, Prime Time breaks songs into programming categories. Each category of song is played a certain number of times and at certain times each day. Unlike many format packages, individual song titles are selected by the operations manager and slipped into its category's time slot. Disc jockeys are given format sheets telling them what song, by what artist, to play at what time.

But, since London does the individual song selection from the 2,180 possibilities in the format, Prime Time allows "flexibility if we need the opportunity for special programming."

Also, he explains, "One of

the things we were concerned about was the longevity of the programming.

What we needed was a format that would also allow songs of the contemporary period."

With Prime Time's flexibility, newer hits by artists such as Engelbert Humperdinck, Petula Clark and Ann Murray are played, along with the postwar songs that make up the majority of KORK's air-play.

KORK's daring new format stands alone in Las Vegas and listener reponse is proving that old hits can be a big hit once again.





A Large Area Loop

by Steve McGreevy

I know that the larger a loop's area, the greater the signal pickup it has. Even though the idea of a room-sized loop struck me as being a little ridiculous, I went ahead and made one. I took about 35 feet of speaker wire (Radio Shack #278-1385) and used it to make a two turn loop, 10'x 8'. The twin wires of the speaker cable are not separated; one wire forms the first turn of the loop, and the other wire forms the second turn. See diagram below:



To support the loop, I put two small brads near the ceiling on opposite walls of my DX room. I knotted a thick rubber band on each of the upper corners of the loop so that the bands could be hooked onto the brads. The rubber bands are secured onto the loop with electrical tape. The loop now hangs from these brads in a more-or-less rectangular shape, following the contours of the room; the bottom of the loop lies on the floor. A hook on the ceiling can support the center of the loop if it sags too much. Naturally, I oriented the loop in the direction of the desired DX.

The variable capacitor which I used to tune the loop had a total maximum capacity of about 720 pF. This tuned the loop from 650-1700 kHz. I can also convert my loop to a one turn model, with the second wire of the speaker cable acting as a pick-up turn for coupling the loop to the receiver. In this case however, my 720 pF variable tunes the loop from 1300-5000 kHz.

Here's a list of advantages and disadvantages of my loop: Advantages --

Large signal gain over my 3½' spiral loop (about 15-20 dB)
Very portable--can be folded up and stored.
Good for those who lack room for a longwire or short Beverage.

Can null if oriented properly.

More signal output than my 200' wire (using no antenna tuner)

Good for those who want to TP DX, but live on a cliff over the water, hi! Very quick to put up and take down (for me, under 3 minutes)

Disadvantages--

A bit less "Q" than some smaller loops.

Nulls are hard to find. Placement is critical.

Large wide lobes (i.e. not very directional -- somewhat, but not great) Can pick up excessive noise if placed near house wiring.

Receives high angle skip as opposed to a Beverage (may sometimes be an advantage though)

Not rotatable.

My "floppy loop" has been a boon for weak signal DX, especially when used with my tuner/preamp, and I would highly recommend it for those whose only other alternative would be a ticky-tacky short wire, which it will greatly outperform; the extra tuned stage also helps reject receiver spurs. It is a super easy loop to construct for beginners and really does a commendable job. I'm very happy with mine.

Thanks Steve. Here's a bit more about large loops from the editorial "desk". I don't have room in my DX cubicle to duplicate the 10'x 8' loop, but I did make a 6'x 6' loop out of 3-conductor power cord, forming a 2-turn loop with 1-turn pickup, and found it only roughly comparable to my unamplified 3-foot square box loop in signal strength produced. However, the 3' loop had been optimized for signal pick-up; see article below for that... Then I constructed a 3 turn loop with a one-turn pick-up--it was about 18'x 6' and ran from my DX cubicle's window to a nearby tree; it was resonated by a "730 pF" variable capacitor--two 365 pF gangs in parallel. Oriented at 2700, it did give me from 12-15 dB more signal strength on DU's and JJ's, at least some of the time, when compared with my box loop. Distributed capacity in the turns of the loop limited it to below 1300 kHz, and its size really meant that it was approaching a random wire in its action, or so I would think. However, a 50' random wire was consistently outclassed by the big loop when it came to the strength of DU's and JJ's, especially in readability..less noise and splatter were heard on the big loop. On the other hand, stronger signals were heard from the western clears, semi-locals etc. when using the random wire, so it would appear that even that big a loop favors a lower angle signal than a short random wire.


The loop had reasonably high Q, especially when it was matched to the receiver with a toroidal transformer. It was interesting that signal strengths of any individual DU or JJ station were not consistently better on the big loop compared with the 3' inside job. Certainly there were times when a substantial difference was noted, yet moments later signal strength would be about equal on both loops. So the large loop may make a difference on a weak signal in some circumstances. My large loop had to come down (the tree wasn't a very stable support in a wind) so the observations relate only to a few DX sessions.

For those interested in other kinds of large area loops, Glen Kippel wrote an article on his large loops in the tech column in the March 20, 1982 $\overline{\rm DX}$ Monitor. This article will also appear in the upcoming second edition of the Technical Guide. Dave Dobson, a Medium Wave Circle member in Britain uses a 7' spiral loop phased against a 100' random wire. This arrangement allows nulls in almost all directions while keeping the loop stationary.

Optimizing an Unamplified Loop Antenna

A 3' square box loop antenna (the NRC alt-azimuth design) has been in use here for a number of years now. Although it originally used a direct coupled arrangement with a balanced FET amplifier (Jim Hagan's design-NRC reprint A17), moving to a house nearer powerful locals meant that the amplifier had to be removed due to overloading problems.



Standard link-coupling was resorted to, and a single-turn link has been used with a good deal of DXing success (see left). But it seemed that the loop wasn't being matched too well with my homebrew receiver. In fact, the receiver input impedance was "loading down" the loop's tank winding, resulting in a somewhat lower "Q" of the winding, with resulting degradation of loop selectivity and strength of received signals.

Interestingly enough, moving the pick-up link to a position about six inches inside the tank winding

(see diagram next page) resulted in an increase of signal strength of about 6 dB. Moving the link in this way presumably loosened the coupling between it and the loop's tank enough that the receiver input no longer loaded down the loop so much. It seems that the extra signal strength caused by higher loop Q was more than enough to compensate for the loss introduced by the looser link coupling. However, Bruce Portzer tried

this trick with his 4' box loop and didn't get my results, so it won't work in all situations.

Another approach, and one which I now use, is to place a matching transformer between the link coil and the receiver input. The loop with its one turn link can be looked at as a transformer, and the loop's tank circuit will have an apparent resistance at a given frequency determined by its Q and inductive reactance. If mathematics horrifies you, whin the next section as it's not really vi



pick-up winding 6" inside tank. (Tank windings omitted for simplicity)

skip the next section as it's not really vital to the exercise.

To determine a loop's Q (if only approximately), one needs a calibrated signal generator (preferably to fractions of a kHz--a frequency counter helps), and some form of sensitive RF (milli)voltmeter--I used an oscilloscope as my "voltmeter". Joe Worcester in IRCA reprint A9 "The Shielded Ferrite Loop: Principles and Practice" suggests connecting the signal source to a single turn of wire and radiating to the loop from a few feet away. I found that my generator didn't give enough signal this way, so ended up with a broadband amplifier and whip antenna a few feet from the loop. Now connect the loop's link to your RF millivoltmeter, tune the signal generator to the desired frequency (fpeak) and tune the loop for maximum signal as indicated on your scope, sensitive VTVM or whatever. Now detune the signal source first on one side, then the other of the peaked frequency and note the upper (fupper) and lower (flower) frequencies at which signal strength is 3 dB less than the peaked frequency. (A voltmeter will indicate about .7 of peak voltage at these frequencies). Now subtract flower from fupper and there is your loop's 3 dB bandwidth, fbw at that frequency.

Now, $Q = \frac{f_{peak}}{f_{bw}}$

For my loop, Q came out as 223 at about 1000 kHz; Q was lower as f_{peak} increased, and higher as it decreased. This is the loop's unloaded Q; connecting a receiver to the loop's link will lower the Q even if it's a perfect match.

Inductive reactance (X_L) can be approximated now, if you know the maximum capacity of your loop's variable capacitor. Tune the capacitor to its maximum, then tune the signal generator until a peak appears on the voltmeter; note the frequency (f) at which the peak appears. The resonating capacity (C) of the loop at this point should be the variable capacitor's maximum value plus, say 25 pF, for distributed capacitance in the loop winding's etc. The inductance of the loop is:

 $L = \frac{\left(\frac{1}{2\pi f}\right)^2}{C}$

where L is in Henries, C is in Farads and f is in Hertz


 $\rm X_L$ in ohms at a specified frequency is now found: $\rm X_L$ = 2 TFL And the loop tank's apparent resistance R at a given frequency is calculated thusly: R = Q $\rm X_L$

My loop was about 210 uH, and its resulting R at 1000 kHz was about 300 kilohms. Something around this value is probably about par for loops of this type.

would mean a 100:1 turns ratio between the loop tank and the link coil would mean a 100:1 impedance ratio (impedance ratio equals the turns ratio squared) if the loop antenna were a perfect transformer. It's not, but if the link is embedded in the tank winding, it's close enough. If the impedance ratio is 100:1 and the tank appears to 300 kilohms, then the link is presenting an impedance of about 3 k Ω . If the receiver input impedance is lower than this (and it usually is) then you will reduce the loop's Q by loading down the tank.

So, we use a matching transformer. Because receiver input impedances are not often accurately specified at MW (and the shielded lead-in complicates things further), it's best to construct a transformer

which has taps on its secondary; one chooses the tap which gives best signal strength or sharpest tuning. So, the preceding discussion of loop \mathbb{Q} , resistance, impedance ratios etc. is largely academic, except in determining what toroid core to use in the transformer, as \mathbb{X}_L of the transformer's primary should be four or more times the impedance of the link coil. I found that about 100 turns of #30 magnet wire on an Amidon FT83-72 ferrite core was fine for the transformer primary (which connected to the loop's link winding). A 30 turn secondary winding tapped at 20, 10 and 5 turns gave me a variety of possible matches to the receiver. A 50 turn primary may work fine in some cases also.



Although I've since put a two-turn center-tapped link on the loop, and put a center tap on my transformer primary (see dotted line in diagram above) I still haven't succeeded in balancing the loop entirely--too much angle iron, i.e. receivers, in close proximity to the loop perhaps? But a better balanced loop should be possible using this arrangement than if the link coil is directly connected to a receiver's unbalanced antenna input.

This matching transformer with tapped secondary has given me an added signal strength on received signals over what I heard connecting the link winding directly to the receiver (6 to 10 dB in some cases). Loop selectivity also increases as fewer turns are used on the secondary, although there is a slight loss in signal strength at 5 turns compared with other switch positions.

Incidentally, this matching transformer (perhaps with taps on its primary as well) might be used to match a variety of amplified or unamplified loops to various receivers. This might help solve the problem mentioned by Neil Kazaross and others of certain loops delivering poor signals to certain receivers. I'd like to hear from anyone who tries this approach.

KFJZ first link in planned chain

Radio station KFJZ-AM of Arlington has been sold to a New York venture capital group that plans to build a national chain of Spanish-language radio stations.

Spanish-inguige ratio saturdistics. KF1Z, which has a 5,000-watt signal covering the Dallas-Fort Worth market, will be the first link of the Spanish-language chain. Founders Communications Inc., a recently formed venture capital firm, has agreed to pay \$2 million in cash for the station, pending approval by the Federal Communications Commission, Founders Communications officials said.

Swanson Broadcasting Inc. of Tulsa, Okla., has owned KFJZ since 1967. Ron Blue, Swanson executive vice president, said the station has been marginally profitable. A 24-hour station broadcasting in English, KFJZ's current programming emphasizes music from the 1940's and 1950's.

A Spanish-language format will be introduced shortly after the FCC

approves the sale, according to John Teeger, president of Founders Communications.

The venture capital group has raised \$3.5 million for initial financing of the radio chain. investors include Mercantile Texas Corp., the Dallas-based bank holding company, and some partners in Allen & Co., a prominent New York Investment firm. Approximately 5 percent of the \$3.5 million came from Mexican nationals, whom Teeger declined to identify.

The KFJZ purchase will leave Founders Communications with about 51.5 million to invest in "a few" more stations. Teeger said. The firm expects to have a publc stock offering within a year, and more stations will be bought with those funds, he said.

Founders Communications plans to own 10 stations — all broadcasting in Spanish — within three years.

Teeger said the company is "actively in the market" for stations in areas with large Spanish-speaking populations. These regions are concentrated in California, Florida and the Southwest. "We have spoken with several station owners

about further acquisitions and expect to be in a position to complete acquisitions in the near future," Teeger said.

Dallas Morning News 6/6/83, via Charles George

The Spanish speaking radio audience is rapidly growing and is attractive to advertisers, Teeger said. The market's size and spending power have been underestimated, he said.

The stations in the Founders Communications chain will not share programming. Tegger said. "It's not a network, but a group of stations," he said.

The Dallas-Fort Worth market aiready has two Spanish-language stations, KESS-FM and KUQQ-AM. "There's room for more," Teeger said.

But Dennis Roberts, general sales manager of KESS, disagreed. While there is a big enough audience to support another Spanish-language station, there are not enough advertisers, Roberts said.

Advertiser awareness of the Hispanic market "is coming around very gradually," he said. The Hispanic market "does not have the drastic advertiser awareness that the black market has," he said.

its supporters call it, is basically not a political (in the conventional
sense) but rather a cultural issue. And culture doesn't have to be with
a capitol "C" to be serious: rock (or gospel for that matter) is just as
much a part of contemporary culture as European classical music. Nor are
there any higher percentages of phonies playing rock than traditional
classics on the air (the latter often at public expense). In Europe both east and west - most pirates aren't political either but on the air
in response to state monopoly of electronic media (just as the fastest
buck possible mentality tends to monopolize the NA media). But of course
there are political European pirates ranging from liberal reformer R. Solidarity in Poland to far left XMSNs in France to neo-facist R. Enoch in
England. And, yest, the Enoch variety can be found in NA (e.g., the storm
trooper who is on the air calling himself R. Free C.M. Stanbury, hi).
However, cultural or political (which ultimately interact upon each other),
I believe DX publications have a journalistic responsibility to provide a
full and balanced account of pirate radio - we should apply the same in
depth standards as we would to any other newsworthy station, such as R.
Marti, VOA Marathon, or Cuban jammers. Best.

<u>During Easter Week</u>, Farch 27 to April 3, I was able to visit San Antonio, one of about twenty Garifuni villages scattered across northern coastal Honduras. The Garifunis, or Black Caribs, were deported from their St. Vincent home by the British in the mid 1800's to Roatán, from where they spread to Belize and coastal Honduras. San Antonio is about 12 km west of Trujillo, which is also the nearest town with electricity - making San Antonio a bit of a DX Paradise (as if palm lined beaches mean nothing). There are no local stations in Trujillo. Several La Ceiba stations put in good signals, as does Radio Roatán, in the Honduran Bay Islands. Surpris-ingly though Radio Roatán broadcasts in Spanish, although many of its ads are in English. The population of the Bay Islands is about half fair skinned descendents of English settlers and half BWI Negroes; and all English speaking. The Trujillo area is much the same, although with significant numbers of Spanish Hondurans & Garifunis. This whole area was once claimed by Britain. Thus, as it turns out, the most popular local station is Radio Belize, which puts in an excellent signal all day. Radio Belize is identifiable as part of the local culture, something the Spanish Honduran stations are not. Radio Belize even broadcasts a half hour in Garifuni on Sunday afternoon, although most Garifunis speak both English and Spanish (the former as many of the men served in the U.S. Merchant Marine during WWII). Also important in an area where people earn a living by taking small canoes out into the ocean to fish, Radio Belize broadcasts extensive weather forecasts. I have never heard a weather forecast on a Honduran station & seriously believe there are none that broadcast it. Weather reports and fatalistic Latin cultures do not seem to go together. DXing was done during the daytime only, using the ICF-7600A, & yielded some interesting results. My favorite was a Radio Belize repeater on 930 kHz (have any of these ever been heard in NAm?). Also Quintana Roo was well heard on 960 & weakly on 1020 & 580. Caymans great on 1555 (although interestingly none of the English speakers I talked with was aware of the station) & weak on 1205. Aside from a few inland Hondurans the rest of the dial was filled with Cubans, with the low frequency-high power outlets, e.g. 550, 590, 740, & 760, being super strong. Jamaica, I was disappointed, was not heard even though some of their frequencies were QRM free. About 80% of those many Cubans heard had also been heard back home in Pa. A few quick scans were made during the evening, which revealed a lot of English. With a communications receiver, this would probably be an excellent place for DXing the U.S. south. Yet the most unique experience of the trip was on the road to Trujillo where my bus was attacked by a large bull that contested our crossing a bridge for about five minutes. I am quite Serious. Oh yes, Radio Roatan is now on 1220 (+ 10 kHz) per observations in Trujillo (x-1480). And Radio Yoru-805 has been off the air for two years at least. Richard E. Wood, College of Education, P. O. Without its 'miracle,' KSUN goes under

t was only five weeks ago that KSUN radio owner Michael Levin reported himself to be "heavily in deb" and on the verge of shutting down the station's transmitter and taking the station off the air.

His plan was to take one last shot at salvaging the struggling station by introducing a comedy format to replace a news/ talk approach.

"What I need is a miracle. . . If you want to call it desperate, call it desperate," he said at the time, acknowledging debts "in excess of a million dollars."

A miracle was not forthcoming, and KSUN has ceased to exist — at least for now. The station, located at 1400 on the AM dial, failed to sign on the air following the Memorial Day weekend.

As listeners who have called KSUN have discovered, the station's phone was disconfected prior to the holiday weekend. A difficient visit to KSUN's offices and studios at 3003 N. Central Ave. last Tuesday revealed the front door to be lecked and the lights off.

Levin acquired the station last August from Cave Creek Enterprises, putting down \$250,000 of the \$1.2 million purchase price. He introduced the news/talk format, asing newscasts from Ted Turner's Cable News Network, talk programs from ABC TalkRadio and, this spring, California Angels baseball games.

The abrupt shutdown of KSUN surprised many listeners. Approximately two dozen have phoned The Arizona Republic to inquire about the absence of their fixtorite network programs as well as to seek information on how they might obtain refunds for money paid to KSUN under the station's "berter bank" plan, which enabled listeners to receive goods or services at a reduced cost.

While the questions are many, some staters will only come with time. However, Levin said late Friday afternoon it is his intention to put the station back on the air, although an exact data could not be prepointed.

"I don't know that we're going to hurry. Fee going to learn from my mistakes," said Levin, who filed to reorganize his company in United States Banruptcy Court in Phoenix on May 27 under Chapter 11 of the Federal Bankruptcy Act.

Under Chapter 11, a company (in the case, KSUN Limited Partnership) obtains 22

a figderal court order that frees it from the threat of creditors' lawauita until it can develop a plan to put its finances in order.

While the reorganization proceeds, the activities of management must be approved by the court. The ultimate reorganization plan must be accepted by the majority of the creditors.

"We are definitely going to reorganize. We'll make sure we're permitted to do that. We have a plan that will work; that we will submit to the bankruptcy court and the creditors when it is finished," he said.

Levin explained that KSUN will not use a news/talk format in the future. "It will either be comedy or top 40, but very low budget," he said, adding that the Federal Communications Commission was informed of KSUN's current shutdown Tuesday.

As part of the court filing, submitted without assistance from an attorney, Levin provided a list of the 10 largest creditors. The sum of those debts alone was \$1.5 million. They are:

Cave Creek Enterprises (\$950,000); former KSUN morning host Roy White taker Jr. (\$350,000); KPHO-TV (\$25,000) for advertising time; Turner Broadcasting System (\$34,000) for CNN service; Internal Revenue Service (\$35,000); ABC Talk-Radio (\$13,000);

Mountain Bell (\$13,000); Jarretts Travel Service (\$13,000); Charles Dunn Co. (\$18,-000); and Sun Country Communications Corp. (\$45,000).

According to attorney Redfield Baum of O'Connor/Cavanuagh, which represents Cave Creek Enterprises, the situation still could be resolved in several ways now that Levin has filed with the court.

Baum detailed some of the options in a conversation prior to Levin's announce-

ment that KSUN will return:

© Levin can put the station back on the air. "If he's got a legitimate plan, we'll take a look at it," Baum said later.

The assets of the company could be sold by the court.

The assets could be turned back to the creditors, and, with Cave Creek Enterprises being first in line, the former owner likely would be able to sell the station again.

As for listeners who participated in "barter bank" and have not received the promised goods and services, such as trips, or a refund, Levin vowed that restitution will be made.

"Absolutely. Everyone will be paid back ... whether I go back on the air or not. The are going to be paid back. There are some questions on how soon or when," he said.

While the shutdown of KSUN came as no surprise to executives at CNN in Atlanta and ABC TalkRadio in New York, executives at the Los Angeles offices of Golden West Broadcasters, which distributes the games of the California Angels, apparently were not expecting the station to disappear from Valley radio dials.

"This comes to us as a big shock. We paid them for the broadcasts through the season," said vice president Stan Spero, declining to say how much up-front money declining to say how much up to get an affiliate in Phoenix one way or another."

Spero's sentiments were echoed by the executive producer of the Angels Radio Network. "We're dying to have an affiliate in Phoenix, by all means," said Steve Railev.

ABC TalkRadio, which supplies talk shows hosted by Michael Jackson and Dr. Toni Grant to stations in 32 out of the nation's top 50 cities, was not caught unaware. Ed McLaughlin reported Friday that efforts are already under way to bring the talk shows back to area listeners.

"We're going to be looking for an affiliate. We'll get back in the market somewhere," said McLaughlin, who is president of ABC Radio Networks.

Bob Pates, vice president of CNN Radio, wasn't surprised by KSUN's failure, either. "We knew there were a lot of financial problems going on. Our people told them to take the programming off the air.

"We didn't do anything legal about it. We were just trying to get them to pay," said Pates, who likewise will attempt to get his network's shows back on the air locally on another station.

Ratings for KSUN since the station's inception have been low. In the fall rating period, the station's first, KSUN only pulled a 0.6 share of audience, according to Arbitron statistics. Market-leader KTAR had a 10.1 share.

In the winter survey, KSUN dipped to a 0.4 share; KTAR had an 8.6 share.

Howdy. The 28 May issue of DXM was a great one, thanks to those who contributed. Virtually no BCB DX has been done around here the last several months, due to preoccupation with several other activities. I intend to fire up the HQ-180A this summer, however, to check for DU activity. I also want to try for some short skip DX around sunset. In my experience, summer is a good time to try for those geographically-close but previously unheard stations that you can't ordinarily hear in the fall and winter months because the skip from the normally dominant stations is so strong that the weakies the skip from the normally dominant stations is so strong that the wearies just get totally buried. Although thunderstorm QRN is heard here all summer, it's nothing like back east, so BCB DX is still possible. I've also found summer to be a good time for analyzing long-range groundwave reception, because there's little danger of any midday short skip confusing things.

On 27 May I drove down to the Ham Radio Outlet in Burlingame (to buy a ham

rig) and saw the Icom IC-R70 for the first time, and I must say that I was quite impressed with it; no wonder so many people are buying them. Seems to be really solidly built and is a real beauty to the eyeball. Definitely a step in the right direction from the Japanese manufacturer. Unfortunately, being in a ham store there was no decent antenna to try the R-70 on the longwave and BCB bands adequately --- just a 50-foot longwire would have done nicely. Ham band antennas won't pick up beans on bands for which they're not resonant. It's too bad that most amateur stores don't understand that there's more to the radio hobby than just the ham bands and string up some appropriate antennas. (They used to 15-20 years ago-RtH.)

This spring I got my ham license, the call is KBSAEU. On 31 May I got on the air for the first time and had a QSO with a guy in Dallas that lasted for over an hour---a most memorable experience. One reason for the lengthy QSO was that all of a sudden I couldn't copy code anymore --- due to a sudden

attack of the beginner's jitters, hi.

Steve McGreevy's comments on his FRT-7700's preamp were interesting, might make a pretty good Tech Column article, Steve. I sure like my FRT-7700; my R-600 would be useless below 3 Mhz without it. The June '83 issue of CQ (Amateur Radio) magazine had a construction article on homebrewing a tuner very similar to the FRT; unfortunately it doesn't include a coil for BCB. And while I can't find any documentation to substantiate this, it appears that "1" prefix stations are from the top of the North Island down to 38S30; "2" stations between 38S30 and 41S30; "3" stations between 41S30 and 44S30; and "4" stations from 44S30 down to the end of the South Island. Of course if I had planned it, the 1s and 2s would be on the North Island, and the 3s and 4s on the South Island. However, there are 2s at several locations on the northern part of the South Island.

All commercial stations are 24h except 3XG-1503 (and its Rhema relays) and 4XD-1431. The letter "N" before a city indicates it is a RNZ National station. The letter "R" refers to relay stations (//). Some of the relays carry some local programming despite the fact that they are translators (see 4XA-531 for instance). Satellites would seem to be relays of translators (see 1359kHz)...

THE EARLY BIRD SHOW is on from 1700-1800 M-F and originates at 1ZB and is carried on the "Z" stations. THE TONIGHT SHOW ALL-NIGHTER is also carried on the "Z" stations 0700-1700 daily, except that 3ZB-1098 joins at 1000, and 4ZG-558 joins at 1200. It originates at 2ZB-1035 Wellington.

This list combines information from an article by Brian Webb in the July 1982 Australian DX News, and another in the N. Z. DX Times, we presume by David Ricquish. The Tatter lists 4XC-1359 Cromwell and 4XE-1359 Queenstown, which is at variance with the ADXN and WRTH lists and which I can't explain. However, this does show you the increase in activity in New Zealand over the years, and I am sure, the number of stations now operating provides you with greater opportunities of bagging a few. It also gives our N. Z. friends, beverages and all, a greater challenge!

New Zealand is a lovely country (Kristine & 1 honeymooned there in 1978) and the people are friendly and hospitable. I hope you have an opportunity to visit there some day. Thanks to Messrs. Webb and Ricquish for their fine work. I trust I will hear from them, and/or others, regarding corrections and clarification.

How to tune in those station signals from afar at night

Nighttime listening to distant stations is apparently a popular pasttime. Several readers have responded to our recent reports on picking up signals as far away as Oklahoma, New York and Canada.

Jim Hilliker, Anaheim, and Richard Maertin, Fullerion, are two radio hobbyists who have been logging faraway stations for several years. If you want to know how to receive such signals on your radio, read Maertin's comments:

"DX (shortwave) radio signals travel this far by an effect called 'skip' or 'skywave propagation.' With the absence of sunlight, the iconosphere of the earth becomes charged in such a way to allow AM radio signals that are headed into space to bounce back to earth. Sometimes the signal can bounce off the earth and back up to the iconosphere for another trip.

However, these skywave signals are subject to fading. Skip conditions change frequently during the night, so if you are listening to a signal from a great distance away, you will hear the signal get weaker and weaker, and then slowly recover, and after a few more minutes the cycle will start again," he writes.

The absence of interfering stations is essential to DX radio, adds Maertin. The government established clear, regional and local channel classifications. The clear channels, often 50,000 watts, can be thought of as superstations with signals received in dozens of

"Clear channels allow one or two dominant (AM) stations to have a very large service area protected from interference by other stations. Many smaller stations operate (on these channels) but must either sign off at night or lower their power or change their broadcasting (directional) pattern to avoid interfering. For example, KIEV/870 (Glendale) must sign off to keep from clashing with WWL in New Orleans, KNWZ/190 (Anabeim) must change its pattern to

avoid KEX in Portland, Ore., and KGRB/900 (Los Angeles) must sign off to avoid XEW in Mexico City," says Maertin.

Hilliker and Maertin say reception depends on the type of radio you have. Maertin says a pocket model may pick up KDWN/720 (Las Vegas), KCBS/740 (San Francisco), KOB 770 (Albuquerque), KGO 810 (San Francisco), KOA 850 (Denver), KSL/1160 (Salt Lake City) and KFBK/1530 (Sacramento).

Hilliker uses a ferrite-bar loop antenna with a pre-amp to boost weak signals. "Loop antennas are directional and block out adjacent channel interference," he adds. Here are additional stations you may

Dailey's determination brings gospel

If experience and perseverance count for anything, then surely Ralph Dailey's endeavor to bring a 24-hour Christian radio station to the Tri-Cities should be a success.

Dailey, 59, and an active voice in radio for 35 years, saw a need for a gospel radio station in the Tri-Cities while working for KSMK (now KOTY) during the late 1960s and early '70s

The Tri-Cities has had its share of country and western music along with middle-of-the-road, rock and adult contemporary. However, it has lacked a professional, Christian station, he said.

Now, nearly six years and reams of paperwork later, Dailey's hope to attract listeners from the estimated 150,000 people in the Tri-Cities area will be tested in just 2½ months.

Beginning June 1, Gospel West Broadcasting, KGWB-AM, 1600 on the dial will go no the air serving the Tri-

dial, will go on the air serving the Tri-Cities and a 50-mile radius as a 5,000 watt station.

Initially, KGWB will broadcast from 5 p.m. to midnight seven days a week. However, Dailey plans to expand the non-profit, interdemoninational station to 24 hours, seven days a

KGWB's antenna and offices will be in West Richland. All radio stations must be base in an incorporated town. Since Fasco, Kennewick and Richland had their allotment of stations, Dailey, president and general manager of Gospel West Broadcasting, chose 10 acres of land in West Richland as a site.

Dailey, known on the air and around the Tri-Cities as "Cuz" Ralph, began the legal and paper work it takes to get Federal Communications Commission approval for Gospel West's application on Labor Day of 1977.

After two years of preparing the ap-plications, Dailey spent almost four years battling the Canandian government over what was believed to be the last remaining AM frequency available in the Tri-Cities. Dailey and a man from Calgary, Alberta had both applied for the last frequency.

Our signal would have lapped over the signal out of Calgary at night and since we applied for that frequency first we were finally given it," Dailey

Along with the frequency came the long-awaited approval from the FCC on Dec. 13, 1982

The normal FCC approval process usually takes one to three years, Dai-

ley said.

KGWB received its construction permit Jan. 12 and on March 4 received a building permit.

Within a month, KGWB's antennas and studio will be anchored. The station will work out of a trailer until it's feasible to build.

"I know the Tri-Cities can support a Christian radio station," Dailey said. "I've worked in the area some 12 years selling advertising and I know the bucks can be gotten. There's been a need for a gospel station in a large area like the Tri-Cities." KGWB is the first new Tri-Cities

AM station in 27 years. KORD-AM in 1956 was the last to acquire an FCC li-

cense Dailey vows that KGWB will be a full-service station, serving the Tri-Cites with a blend of music including Southern gospel, traditional and the newest in contemporary Christian music, now the fastest-growing segment of the American music industry He also plans to broadcast high school sports, local news and national news from the Mutual Broadcasting Sys-

A native of Tulsa, Okla., Dailey began his career in music and radio singing in gospel quartets. He's had experience as a disc jockey and a radio advertising salesman from Stockton, Calif., to Eugene, Ore., to the Tri-Cities.

"Our staff will be comprised of experienced radio people who have had major market experience," Dailey said. "The sound will be professional. Our goal is to edify the Christians and to be an evangelistic outreach to nonbelievers.'

KGWB, Dailey says, will be alive, topical, fun, exciting, interesting, vibrant and clean.

The target audience of KGWB will be an adult age range of 18 to 54.


Despite a sagging economy and a high unemployment rate, Dailey has faith that the station will take off.

The only other Christian station in the Tri-Cities is KOLU of Pasco, affiliated with Riverview Baptist Church.

It is Dailey's long-range plan to promote big name gospel music and ministry entertainment in the Tri-Cities.

He also wants to start an FM station. Donations and contributions to the non-proft corporation are being accepted, Dailey said. Gifts, which are tax deductible, can be mailed to: KGWB, P.O. Box 1510, Richland,
