British Pirates: We reported several weeks ago that the British Offshore Pirate, Radio Laser, was off the air. The full story is that on November 6, the ship raised anchor and was escorted into Harwich by a government surveillance ship. The station had had generator problems for several weeks and during a Force 9 storm on the evening of Nov 5, they suffered a complete power failure and requested assistance from the British government vessel. There had been rumors of unrest on board for some time, including reports of unpaid wages and horrendous living conditions. Food and equipment for the ship were smuggled in under cover of darkness, but the station was "out of everything, even toilet paper". There were also reports of unpaid avderts and other deals that fell through. In the aftormath, Radio Caroline, the only other offshore station, took over Laser's old frequency of 558 kHz. (Info condensed from recent Review of International Broadcasting.)

The period which a permittee now has to construct a radio station has been increased from 12 months to 18 months. The FCC, in making this rule change, also put the broadcasting industry on notice that strict guidelines would be applied to anyone who asks for an extension of time to construct, i.e., that abuses of the relaxed rule would not be allowed. (BC)

Canadian death row update: Two CBC-owned AM stations not mentioned in any earlier lists have been given short-term renewals: CFGB 1340 Happy Valley NF and CBDP 1490 Wabush NF. Providing that adequate FM service of the CBC mono network is available in those areas in a year or two, the Canadian Radio-Television and Telecommunications Commission will order these two stations off the air along with those already mentioned. Also, the CBC has surrendered the license for CBNC 1190 Stehphenville NF. It went off the air 7/1/85; service now provided by CBNC-FM. (MSJ)

<u>Networks</u>: Dr. Sonya Friedman from WXYT 1270 Detroit will fill the Monday-Tuesday 1700-1900 ET slot on <u>ABC Talkradio</u> recently vacated by Dr. Toni Grant. (BC)

The <u>Mutual</u> Radio Network was officially bought by <u>Westwood One</u> on 12/2 for about \$39 million. The seller was Amway, the home products concern. Mutual is now a sub-network of Westwood One. Mutual will keep its name and will continue to concentrate on news, talk and music shows geared for older adults while Westwood One continues to concentrate on rock and country music, Spanish programming and specials for younger audiences. Mutual's "<u>Larry King Show</u>," currently fed 0006-0500 ET Tues-Sat will be extended to feed 2306-0500 ET beginning 2/3. The 0306-0500 portion will be a repeat of the 2306-0100 portion each day and live interviews with newsmakers and reporters will often be heard in the first hour, giving it more of a current-events sound. (BC and Monti)

Otherness: With <u>General Electric</u> swallowing up <u>RCA</u>, including RCA's subsidiary <u>NBC</u>, in a \$6.3 billion deal, expect some or all of NBC's radio stations to be up for sale to comply with the FCC's one-station-to-a-market rule. (Existing AM-FM-TV combinations are grandfathered until ownership changes.) Assuming the sale goes through and unless GE applies for (and gets) a waiver of the rules, WNBC 660 New York, WMAQ 670 Chicago and KNBR 680 San Francisco may all be sold by the end of 1986. (BC)

The offshore pirate Laser 558 went off the air for ship repairs and was confiscated when it sailed into British waters. Radio Caroline, Laser's offshore competitor, is duplicating its programming on $558~\mathrm{kHz}$ to fill the gap. (MSJ)

Statistical Research's RADAR 32 report on national radio listening reports that AM listenership is at a new low. Of all radio listening done on the average day in the US, only 28.2% is to AM stations. However, radio continues to reach 95% of all persons in the US aver the age of 12, a cumulative audience of 185 million people. (BC and MSJ)

Due to a slight mix up in my membership renewal, I have not been contributing on a regular basis as I have in the past. This has been going on for over a week so perhaps they will be receiving a visit from the FCC. Propagation from the south is unusually good for this time of the year and one can often hear stations from Central and South American during the dark hours so this is your chance to catch some unheard stations. A few DXMs ago, Bill Hardy mentioned that the western boundry of CDXR is no longer the Rocky Mountains. I thought it had been changed but I don't have even an outdated copy of the Editorial Policy here. However, technically he's right about the 85th meridian, and I'm wrong about the eastern boundary of CDXR following a line running north/south thru the Indiana/Ohio state line. However, a check of the map at work shows that the 85th line falls only about 12 miles west of the Chio state line. The Ind/Ohio line makes a good reference point that most can easily use. And that should be the major deciding point: What is the easiest thing for the members of the club. I feel the current way of doing things is the easiest. The time question got started this time around by the suggestion that each member use his own local time when reporting to the columns. Now that we realize that no one column involves only one time zone, shouldn't we put the question to rest, and go back to passing on DX information and encouraging others to DX the AM band. The rest was taken up by pots. And also again, as with last year, KTMS 1250 carried the entire program. Owever, KTMS was being severely ORM'ed by KEDL Hermosillo and another unID exican this year. Program was primarily about SWL, though they did touch on AMX a bit. It happens that I disagree with Briem's opinion regarding the reakdown of the Clears (and Regionals). He feels that it's good as it permits ore stations to come on and that smaller communities will thus be served. One aller from Canada stated my opinion beautifully. He pointed out that although a PW people in the small communities might benefit, thousands more people who sed to listen to the "clear" station, now actually lose a station. How ironic nat as that point was being made, I was struggling to hear it through the 1250 ess. . .when KTMS used to be a semi-local here - and other callers were omplaining that KABC had lost its Central California/Bay Area reach due to KXTC Lovis-Fresno now fulltime.

A good friend of mine just started college up in Thousand Oaks. (OK Ric, ou're always claiming to be such an expert on California. What college would nat be? (How are things at Cal Luthren these days? Next, hi-RtH.) I visited him scently and the first thing I noticed was that you can see Comedy Radio kMDY's owers from his dorm. Funny — when I estatically pointed that out to him, I oticed that he didn't seem to be (shall we say) "overcome with emotion," hi. Then I further informed him that a station in Denver operates on their frequency and if we were back home we'd be hearing the Denver station instead, that piece for news didn't particularly excite him either, hi. Odd. But here's the clincher: after on I told him that I wanted to excuse myself as I wanted to DX from my car or a couple of hours. (Surely a perfectly normal request!) He just had this lank look on his face, hi. Oh well — we DX'ers know what is truly important in ife, hi. Anyway, the results are in WDXR. Although Thousand Oaks isn't too far om L.A., it's just far enough away for the L.A. stations to be weak, and (in y opinion, if not perhaps legally), for Thousand Oaks to warrant itself as a istinct market. (Legality has nothing to do with markets, at least FCC-wise; ney could care less-Rth.)

I would like to imput on the time zone usage discussion. Some would like to ee all columns use Eastern time, some would like for all to use UTC/GMT, and till others think that each column should use local time. I think that this mportant point should be kept in mind: Whatever system is used, supposedly that ystem should be the simplest system for the greatest number of people. nerefore, what is the simplest system? My hunch is that it is simpler for most eople to convert to Eastern time than UTC. However, I also think that it's impler for <u>most</u> people to use their own time zone, rather than to convert to nother one. To resolve the issue, a ballot should be sent out for everyone to ote. Additionally, whatever the outcome may be, I think that after the club has oted and used the system for a year, ANOTHER ballot should then be sent out sking people if they think it's working, or should they try another/the old ethod. Often times it seems to be human nature to leave things as they are. (as ill Harms put it: "If it ain't broke, why fix it?") However, people - and clubs must grow and evolve. To do so effectively, people need to know that they need ot fear that if they try something new and it doesn't work, they're stuck. As ong as people know that if a new way doesn't work, and they can always return o the old way or a different way, they will usually be willing to try something

It's just off I-10 north of the freeway between 1 nm Drive and Date Palm Drive. Believe access is off Date Palm on a dirt road. Here are five towers in all. After seeing them, I passed by KKAM's four towers 66998 Vista Chino. Apparently no road to them so access must be via a 4MD. I opped by KKAM and found rear door unlocked so went in and met the DJ, Gary ne and spoke with the CE who was preparing the FM van for a remote later on in

Palm Desert. We talked of radio and I showed him a copy of DXM; says he's seen the IRCA logo before. KKAM is C&W and their FM is rock. Left KKAM to find KPSI's tower. It's off El Cielo Road near highway 111. Someone at another station mentioned they may have to find a new site due to construction in the area.

After KPSI I went over to KWXY - front door unlocked, so went in. Talked to announcer who says I could come by during business hours for a tour. Stopped by KNWZ 1270 and spoke to sports program host who gave me stickers. Was thinking of going by KRCO but since it's SS, doubted if I could go in. (Why?-RtH.)

Stopped at KGUD transmitter but no one there — I tried an old address, 101 E. Nicolete, but found Banning H.S. instead. (Did you at least DX a pom-pom? Hi-RtH.) Called an old number and was referred to an Arizona number. Called another and was transferred to KOLA-FM Riverside where I found out KGUD is operated from KOLA on weekends. KGUD transmitter is at 527 N. Omar. Stopped in at KCAL Redlands. Was told long ago they had three towers on Greenspot Road, but after driving the length of road, came back to the building at 29800 Greenspot and door was unlocked. Talked to the FM research director who says there's three towers off Boulder Avenue, East Highlands, so found them on Boulder north of Baseline. I got no bleedover on nearby frequencies, so believe this is a nighttime transmitter. Daytime transmitter (one tower) is located at

approximately 27101 Lugonia Avenue near Alabama in Redlands.
Found my way to the freeway to head for KAVR. While on Barstow Freeway near
Devore heard the KAVR s/off so knew I missed chance to see "AM 96 all oldies."

Jim Hilliker told me during recent call, KKAR 540 was building towers in desert. Decided to search for them. While in Victorville, tried locating KVVQ AM/FM. Two addresses in local phone directory - one on Civic Drive. No answer at that number so tried finding address. They're in a new building at 11920 Hesperia Road, Hesperia. Stopped, but unable to get a response. One thing I know. 910 is NOT on the air yet.

I went to KAVR @ Apple Valley Inn, but DJ told me by phone it was his first night there and was going by the books regarding station rules, so I headed east on highway 18. Had looked for and found KKAR 540 at 14901 Barstow Road, Lucerne Valley. Decided to find transmitter and sleep in car. About 15 miles from Apple Valley came to Barstow Road and could see two towers lit up north of the area. Ended up six miles north of highway 18. Wow! Both were spread out on open land and tall.Checked AM - lots of SS in well. Nothing to speak of that was new. 540 vacant, of course. In the morning discovered not two but six towers (only two were lit up); they're impressive. Listed power is for 1,500 watts and wonder if I'll be able to hear them when they go on. Transmitter building very small. Site is near or maybe part of Lucerne Dry Lake. Had thought towers would be close or in Hesperia.

On return trip stopped by KFXM 590 and talked briefly via phone to the DJ.

On way to L.A. cut across Ontario to Chino, past KTSJ transmitter at 3990 Riverside, and up past KWDW site to I-10 where I returned to Burbank. JH says KWRM has to move transmitter because of I-15 freeway next to the site.

Finally, and so late in the season, this year's first opening to Europe, as distinct from already-logged North Africa. It was 19 December, just a modest opening with two definite, DW Malta 1557 and WDXR Langenberg 1593; unIDs were Brazilians, the East Coast, many Asians and a rare log of WXLG Kwajalein 1224, relaying AFRS Los Angeles - the West Pacific is generally difficult here in east Hawaii.

My thanks to all who asked me questions or otherwise participated in the successful ABC TalkNet Ray Briem show. Compared with December 1984 it was an effortless night, as the audio piped via KABC landline was superb; thus I didn't have to tune to KGU (or in the first two hours, before KGU joined the net, direct to KABC) and then race back to the phone whenever a call seemed to be directed to me, and coming to a close, to beat the seven-second delay. Just as well, because, as Bruce Fortzer noted in 14 December DXM, conditions the night of the Ray Briem show were northerly - while he was getting northerly CFCW 790 and only a trace of his usual KGHL, I was getting KGHL rather than my usual KABC; also the Cuban, but at least not much KKON on the mainland Beverage.

December looks like the best DX month since record-breaking June; fall here, with no Europeans, no WDXR, no CBJ, no WRVA, nothing much of interest, was a washout, but with Europe and a slew of Brazilians now back, I can't complain about December. Latest verie is XEND, La voz de Hildago, Culiacan, Sinaloa 1580, where the station accountant, saying it was unlikely any other staffer would answer me, took the responsibility of answering me. Interestingly, he said the only other non-Mexican report XEND had had was from Japan, in the same time slot. Though I have seen, alas, many questionable reports from Japan at US

stations, this seems like a possible reception; I know XERF and other high-end Mexicans are heard in Japan.

Thanks to Roy Millar for his appreciation of my "Lapland" book review; also to Randy Seaver for pointing out that KSDG 1040 San Diego, which seemed to be listed in the Finnish booklet as already received, but rarely, in that country, is not on the air yet. I found a few other listings like this - CF's, silent stations, etc., which I might have queried in a longer review. No specifics of reception - date, time, name of listener or DX'pedition, etc., were given, and there may well be errors. But in its broad outline, the booklet seems accurate, and is in accord with many Finnish DX'ers. Don't hold your breath, but I really do plan to spend some future winter in Finland, probably teaching English at a college in Lapland, and originate some of that DX myself. I wonder how my bones will react after Hawaii - especially the warm, dry winter we're having. Aloha

Active Short-wire Phasing System Using Modified Hagan Amp
by Mark Connelly

A modified version of Jim Hagan's 2-FET loop amplifier has been found to be useful in phasing very short antennas (e.g. car whips or the whip sections of a "TV Rabbit Ears" type antenna)


The amplifier card including phase-reversing transformer can be assembled on a 1.9" x 1.4" vectorboard for a very compact installation. The design eliminates the need for a balum transformer: resistive summing of the "Line 1" and "Line 2" outputs is done instead (with about a 6 dB reduction in achievable output level into 50 ohms.) If the loss is a problem, use of a BBA-1 broadband amplifier module (March 2, 1984 DX Monitor) may be used between the phaser's output and the receiver's input.

Figure 1 shows the schematic of the modified Hagan amplifier card.

Figure 3 shows module hook-up to receiver and aerials.

Customary phasing procedures (peak each line at maximum tank ${\tt Q}$, equalise levels, decide null mode to use, tweak controls for null) are employed.




Broadcasting, 11/11/85 via Robert Wien **Format experimentation on the AM band**

With a steady decline in listeners over the past 10 years, the AM dial is seen by many today as primarily featuring news and information. While that approach has been successful for many stations, there is little doubt among industry executives that many other AM outlets will have to cave out a new programing niche to survive. As BROADCASTING has reported throughout the year, AM broadcasters have begun to experiment with format concepts.

In Los Angeles, RKOS KHJAM) swiftched from an all-music, adult contemporary format in 1984 to one centering on local traffic reports, which has been appropriately dubbed "Car Radio." "We work under the assumption that all fadio listeners in Los Angeles are in their cars because there is no real mass transportation system," said Walter Sabo, New York-based consultant to RKOS owned radio stations. The first thing we did was go to the American Automobile Association and the Department of Transportation to gather information about drivers in Los Angeles and built a format from that data," he said.

According to Sabo, the format is targeted to the average age of the licensed driver in Los Angeles, 31, and the average one-way communing time in that city, an hour and 40 minutes. Traffic reports, said Sabo, are aired every 10 minutes. Along with the traffic reports, eight adult contemporary songs are played every hour. Local newscasts are only aired at the top of each hour during drive time. This is one of the few formats requiring the programing and sales departments to work closely together, said Sabo.

"In order for an AM radio station to be financially viable, it must have a logical and immediate sales hook and it must be entertaining enough to eventually get good ratings," he said. Sabo noted that many of the stations accounts are automotive-related bytenerger.

Last April, Sabo also helped to establish the "Game Zone" format over RKO-owned adult contemporary KFRC/M) San Francisco. The station programs a block of game shows from 9 a.m. to 3 p.m. each weekday as well as a two-hour dating call-in show each night, Affair on the Air. These formats are viewed not as programing entities but as "marketing concepts," according to Sabo.

"One of the greatest myths of our time was that listeners began to tune to FM radio because it was in stereo," said Sabo. "The real reason they switched was because FM programing was different and better. It all comes down to programing. The reason why stations like wcco(AM) Minneapolis-St. Paul and WGN(AM) Chicago remained so strong is because they offer something of value to the listener. The challenge facing AM radio today is getting listeners to sample the band," he said.

Another new experimental AM format in San Francisco was launched by Bonneville International last summer. "Trendformation" made its debut on July 15 over Bonneville's KKRIRAM) which was formerly airing Bonneville's easy listening format under the call letters of Kort.

Trendformation was conceived by Jack Adamson, former president of the California division of Bonneville and currently a senior vice president of the company, and developed by Norm Woodruff, a radio programing consultant now with the station full time. The station features information on news events and emerging trends along with a combination of "light jazz" and "new age" music. There are no conventional newscasts, but rather, as Woodruff calls them, "facts of the hour." These are

described as uncolorful, concise reports with clear text. The trend information basically comes from six-minute hourly interviews with experts in a variety of fields.

Adamson said trendformation was inspired by the notion that today's baby boomers are getting into the corporate mainstream and are looking for information that will affect their lives and careers." He added that rour is the pilot for a tight, lean budget-ed information station that could be sold in combination with an FM music station (Bonneville airs a solt contemporary format on its rottrew there.)

Airing another format first is wwrc(AM) Minneapolis-St. Paul, which last September abandoned its urban contemporary sound that had a last-place 12-plus rating of 0.3 in the spring Arbitron report, and adopted "Weatheradio."

The staple of the format is local weather reports that air every five minutes, according to wwrc General Manager Sam Sherwood. But the station takes its reporting a step further with regional, national and international weather forecasts. Additionally, wwrc airs extensive traffic reports and updated airline departure and arrival information.

"I heard so many horror stories about AM radio that I decided the direction to go is not redesigning the wheel, but redesigning the product." said Sherwood, who created the format.

Sherwood acknowledged that the station has experienced "a lot of refluctance" from ad agencies. "They are not sure how to use us," he said. "We don't have any target audience demographics because weather is sensitive to everyone in this city. We are a concept self. "Sherwood said that the station has had "mild success" in persuading local retailers to buy time.

There are still many AM music stations across the country, such as WNBC New York, that are establishing themselves as full-service outlets with strong personality lineups.

In addition to adult contemporary other proved AM music formats include country and big band/nostalgia. Al Ham's "Music of Your Life" format was one of the first programing alternatives offered to AM stations in the late 1970's when FM listening overtook AM. Today, "MOL" is aired by more than 150 stations, the majority of which are AM's.

On the syndication side, the Radio Group, a subsidiary of the LaMarca Group, a New York-based media and marketing service company, will soon offer AM stations a 24-hour, tape-distributed format entitled "Comedy Radio." The format, conceived by company president Jim LaMarca, will cover the "entire spectrum" of comedy including contemporary satire, stand-up bits and classic comedy routines.

Celebrating one year on the air on Dec. 1 is Marina del Rey, Calif. based Children's Radio Network, headed by Bill Osewalt. The network, which is targeted for the preteen-age audience as well as 18-49-year-old mothers, currently has an affiliation base of four AM stations: xsux Phoenix; wrxs Grand Rapids, Mich.; wram Indianapolis, and wxoz (formerly wext) Jacksonville, Fla. (the last owned by the Children's Radio Network). Osewalt describes his programing as both entertaining and educational with "an electic blend of music." It is distributed on tape to stations. The format is an alternative to more registrional programing, especially for AM stations, said Osewart. "But it was not designed to save AM radio."

Many radio executives also noted that AM stereo, especially with what they saw as a lack of interest among both receiver manufacturers and listeners, will not be AM radio's salvation.
