WEAT 850 West Palm Beach FL will receive \$14,397 in government funds to help in its fight against Cuban interference. WINZ 940 Miami FL will receive \$31,460. (BC)

With the State Department making ready to negotiate with other countries over how to use the new 1605 to 1705 kHz extension of the AM band, the FCC has made its recommendations including one that power on the new channels be limited to no more than 10000 watts in the Western Hemisphere. (MSJ)

The FCC has also proposed changing the protection and power limits for certain subclasses of Class III (regional) AM stations in the US and posessions. Under the old rules, there were Class III-A stations with powers between 500 and 5000 watts and Class III-B stations with powers between 500 and 1000 watts. Under the proposed new rule, there would only be "Class III" stations with no subclasses, powers would be between 500 and 5000 watts, and stations would be protected to their 0.5 millivoit per meter (mv/m) coverage contours in daytime and to their 2.5 mv/m contours at night. This night protection is better than that provided to III-B's under the old rule, when they were protected only to 4 mv/m at night. All of these signal levels, by the way, would be considered "excellent" by DXers. (Radio World)

The FCC has also proposed increasing the upper power limits allowed for Class IV (local) stations in Alaska, Hawaii, Puerto Rico and the Virgin Islands. It proposes doing this by reclassifying the four local channels as regional channels in those states and territories, thus making the old Class IV stations into Class III's. Since Class III's are already allowed 50000 watts in these four areas, the old Class IV's would be allowed 50000 watts day and night as long as they protect the class IV stations on their channels on the mainland. (Radio World)

The National Association of Broadcasters and the Association for Broadcast Engineering Standards have petitioned the FCC to expand on the above. They want to allow all Class III (regional) AM stations to use up to 50000 watts as long as they don't cause interference to each other or to adjacent channels. The purpose of this would be to help the stations overcome local man-made noise which has destroyed AM coverage in many areas. They've also requested that Class III daytimers be allowed on the air all night with whatever power level they now use during the second hour after sunset under the existing post sunset rules (BC)

The FCC has dropped the AM-FM nonduplication rules. These rules, in effect since the mid-sixties, have required that not more than 25% of the programming of an FM station be allowed to be simulcast with that of a co-owned AM in the same market. The rule only applied if either station was licensed to a community of 25000 people or more. The rule is widely perceived as having forced station owners to program their FM stations differently and more creatively than their AM's, ultimately resulting in the huge success FM stations now enjoy. With the rule dropped, expect some marginally profitable AM stations to quit doing their own programming, and simulcasting their co-owned FM's complete with the FM's slogans or ID's. In some cases, the only way to positively ID the AM station might be the legal ID each hour, assuming the AM's remember to do them at all. (BC and Monti)

In addition to the solutions to the AM problem listed in this column several months ago, the FCC has released a list of possible other ways to make life easier for AM station owners: (1) elimination of all protections afforded to so-called "clear channel" stations to allow more fulltimers, (2) elimination of requirement that AM stations originate their programming at studios in their communities of license, (3) extensive use of AM "translators" (repeaters on different frequencies), (4) eliminating the minimum operating hour requirements which generally say that fulltimers must be on the air from 0600 to 2200 local time Monday to Saturday, (5) allowing AM stations to broadcast computer data or other ancillary services on their main channels (audible on ordinary receivers) when they are not on the air with broadcast programming, (6) forcing manufacturers to make high fidelity AM receivers by making narrowband AM receivers illegal and allowing newspaper publishers to own AM stations in the same cities where they publish papers (currently illegal). Note that a combination of items and (5) above might allow any AM station to broadcast computer data 24 hours a day with no broadcast programming sent out at all. (MSJ and Monti)

As of 25 February 1986, the FCC reports that there were 4718 AM atations on the air in the US. An additional 170 had construction permits but were not officially licensed yet, giving a total authorized figure of 4888 AM's.

A new full-format satellite network will go into business Networks: in September, Beathoven Satellite Network, a classical format provided by WFMT 98.7 Chicago. It will be different than WFMT's air signal. (BC) will provide daily 60-second "Constitution Minutes" hosted by Willard Scott between September of this year and September 1987. September 17, 1987 marks the 200th Anniversary of the U.S. Constitution. (NBC) Satellite Music Network launched its sixth full-format radio network on 4/10: "Pure Gold," a rock oldies format. In June, it will begin "Z-Rock," a heavy-metal oriented album rock format. (BC) Westwood One, which recently bought Mutual from Amway Corporation, is now suing Amway for starting its own radio network in competition with Westwood's Mutual. Supposedly, one of the conditions of the deal was a "non-compete agreement," i.e., that Amway would not start or buy a business that would be a competitor to Westwood for the first three years after the Mutual sale. An injunction has been filed in court against Amway. (BC)

Syndication: The Broadcast Group is syndicating a series of 90-second programs intended for broadcast between 4/7 and 7/4 entitled "The Statue of Liberty: An American Story." The Statue itself will be rededicated on 7/4/86, its 100th anniversary. (BC) The prestigious Washington public relations firm of Gray & Co. is syndicating a free daily feed of interviews with political and business leaders called "CapitoLink." is an example of the currently booming business of producing "electronic press releases" which client companies can use to boost their images with the public without paying for advertising time. (BC) The North American Network, a syndication company, is offering "Soviet Life," a series of 4-minute programs drawn from the pages of Soviet Life magazine. Oddly enough, the magazine is published by the Russian embassy. But Americans get equal time since the US Embassy in the USSR circulates America magazine there. (BC) There's a new weekly series called "The Elvis Hour," of memories, music and trivia about Presley. (BC) There's also an "American Museum of Natural History Radio Series" of 3-minute interviews with museum staffers. (BC) A new format in syndication is Burkhart & Abrams' "New Age," featuring jazz, easy listening and adult contemporary music, most of it instrumentals, designed to be a contemporary version of an easy listening format. (MSJ)

DXINT: a DX Intelligence-Gathering Effort

Mark Connelly, WALLON -- 25 APR 1986

I'm undertaking a medium-wave DX information project. This effort will probably run for a year or more depending on the magnitude of response and the amount of time I can find to process the information into a database.

Project Phase I will be to assemble a comprehensive list of books, periodicals, and other publications of use to DXers. Of course, materials directly related to medium-wave DXing - e.g. (in the book category) the NRC Log and the World Radio-TV Handbook - are the obvious starting points. Also, publications relating to other aspects of radio communication (technology, history, programming content, personalities, popular music, frequencies other than MW, etc.) are of considerable interest if material gleaned from them can benefit one's MMDX operating skills or technical expertise. All should be mindful that publications not related to radio / electronics can still act to improve DX ability. Reference works such as atlases, dictionaries (English and foreign-language), zip-code directories, etc. would certainly fall under this category, as would periodicals that increase knowledge of geography and world events (Newsweek, National Geographic, foreign newspapers).

The "Compleat DXer" (Page Taylor's spelling), much like a private investigator, must be multidimensional. A working knowledge of all of the following can increase one's loggings totals: business aspects of broadcasting and related media, electrical engineering, ionospheric physics, geography, world history, climate / weather patterns, current affairs, sports, popular and traditional music, religion, effective use of English and at least one foreign language, and regional characteristics (in advertising, local holidays, food, speech patterns, etc.).

The DXer, therefore, should be well-read, and not only in DX-specific literature. Even novels could conceivably offer insights, especially when they are of the international-intrigue type which deal with actions occurring in a number of different countries. Bible knowledge can enhance one's ability to send intelligent reception reports to religious broadcasters.

Catalogues can be valuable for reference as well as for ordering parts. Of course, the catalogues of receiver vendors (Radio Shack, EGE, Radio West, etc.) are considered first, but general-merchandise catalogues (e.g. J. C. Penney, Sears) can increase brand-name knowledge: this is the knowledge which scmetimes makes the difference between determining the product in an interference-garbled commercial or missing forever this important piece of reception reporting material. Catalogues from merchants that don't sell DX receivers can still produce some useful 'shack' enhancements. DXers have built homebrew loops and other antennae from plumbing-supply and boating-supply hardware and from automotive parts ordered from J. C. Whitney. Many times a mechanical or electrical part never designed to be used for a DX application will serve better than pieces available from electronics-supply houses such as Mouser and Dick Smith.

The serious DXer does well to adopt a holistic approach to the hobby. A wide variety of life-experiences (rather than a singleminded obsession with DXing) benefits one's enjoyment of DX and builds the knowledge base so useful to effective pursuit of new stations. A good question to pose (at least subconsciously) when faced with new knowledge-sources is "Can this (book, product, tool, store, location, person, software program, etc.) expand my ability to DX effectively?" This question should be addressed even if, on the surface, no immediate DX-related relevance is perceived. Of course, such ability-expansion should be legal: knowledge from one's job about how to build a "crunchproof" RF amplifier is one thing; walking out of the factory with pilfered RF amplifier hybrid IC's is quite another.

The DXer must be organised. This point was well presented in Page Taylor's classic "Compleat DXer" article, written well before the home computer came along to take much of the drudgery out of data-organising. During a DX session, materials of immediate value should be readily accessible: these include previous loggings lists, recent DX magazines, and NRC Log/w. R. T. V. H. and the like. Otherwise, finding out if someone had previously

reported the station you think you're hearing (or if that station has a parallel or if it's supposed to be on the air at that time) may take so long that you could blow the catch or waste time during which other DX catches could have been made. It's one thing to have a wide variety of DX-related and quasi-DX-related reference material; it's another thing to be able to put your hands on the right information quickly enough to meet the challenges of "real-time" DXing. Books and periodicals should be arranged in a hierarchical fashion: references used daily should be right at the receiver, those used once a month or so a bit farther away, and those rarely used could be in a different part of the house, but still accessible within a few minutes.

Phase 1 of this DX intelligence-gathering effort, determining which books and other publications are of value to different DXers, should elicit responses of titles / authors plus a rating of the given publication's relative importance to the particular DXer responding. A 'thumbnail sketch' of the operator's specific DX tastes (domestic, international, DXing-for-program-content) and operating times / habits (sunset skip on a daily basis, a Monday morning once every 2 months) could be of value in assessing the reasons why certain publications are assigned their relative levels of importance.

Responses to this study could be sent directly to me (at 30 William Road / Billerica, MA 01866), but for the benefit of all, it would be better to direct the responses to NRC's Musings and IRCA's Forums.

Subsequent phases of the DXINT project will probably deal with DX Techniques (random scanning vs. checking 'propagation indicator' stations), physical / mental preparations for a DXpedition or a home "all-night" session at the dials, favourite receivers / antennae, and elements of a good location.

Computer programs that apply to DX'ing were appearing in the DXM until recently. One of the problems with computer programs is they aren't written in English, and therefore aren't easily understood by the average member. I think the decision to not publish program listings was appropriate; if the reader wishes a listing, the can probably be obtained from the author or the Goodie Factory. Showing the capabilities of the program is essential to understanding its use, and the output from a program is very helpful.

I'm still working on several computer programs in BASIC that are running on my IBM PC. The first program is a Sunrise/Sunset program that calculates the great circle bearing and distance, and the sunrise and sunset times at the transmitter and receiver, and also at the ionospheric control points nearest the transmitter and receiver. It assumes an E-Layer reflection mode at low elevation angles. It's more sophisticated (and longer) than the program Marc Connelly published last year.

The second program calculates MW field strengths using the Cairo Curves, the CCIR and Wang methods described in my recent article in the 21 December 1785 DXM. The input includes transmitter location, power, frequency and receiver location. The output is the great circle distance and bearing, number of hops, and the field strength estimates.

The third program calculates the MW field strength of a given transmitter using the Knight equations, tables and curves that was published in the 23 March 1985 DXM. The input data for this program includes the frequency, power and antenna height of the transmitter, the transmitter and receier locations and ground conductivities, and the ground conductivities at the intermediate reflection points. I'm also in the process of delving into the equations used to generate the Knight curves, hoping to understand them better.

I'm slowly working up articles for each of these programs plus the ray tracing studies I've been working on over the last seven years. My problem is time to so the research required and time to write. This is definitely a hobby and not a fulltime or even part-time job.

These programs in their present state (which is not necessarily complete or documented) are available to those interested. I can send a BASIC listing and/or will copy them onto a diskette (PC-DDS 2.1 formatted DSDD), if you supply the diskette and mailer.

I would also like to know what programs other DX'ers have and use, especially micro-computer programs. Please write and let me know! 73.

Hi folks. Just back from the NAB convention in Dallas and here's a rundown on the "AM Improvement" technical session.

The problems with AM were recognized as natural interference, man-made interference and overmodulation. It was pointed out that not much could be done about the first interference problem, the National Radio Systems Committee is recommending that the FCC should take a hard stand on man-made interference, especially from RF lighting devices. The NAB has commissioned Hammett & Edison of Burlingame, California to study the effects of AM overmodulation.

Papers were presented by Richard Biby and Ogden Prestholdt on the so-called "new wave" antenna systems, which can be made directional in the vertical plane. Richard Biby, in explaining the design of the vertical monopole—and—ring radiator said about 85% of the radiated energy goes into the skywave, and his antenna design should put the same percentage into the groundwave, or an improvement of about 20 db. He noted that there would be an improved signal strength at distances greater than 2,000 miles due to the increase in low—angle radiation. I asked Mr. Prestholdt if his VH antenna could be used to improve groundwave coverage in the nighttime selective—fading zone through the implementation of a null at about 60 degrees above the horizon and he said that theoretically that would be the case, but it would have to be proved out in practice. Anyway, it would be possible for stations to give nighttime protection to stations a few hundred miles away and yet provide omnidirectional groundwave coverage to their local areas by using a vertically—directional antenna system. And they could save on towers and real estate too.


