

ANOTHER SHOT IS FIRED IN THE U.S. - CUBAN BROADCAST RADIO WAR: by John Demmitt

On the evening of Dec. 2, 1906, Radio Taino which normally signs off the air at 6:00 P.M. to avoid causing interference to U.S. broadcasters, remained on the air until 11:30 P.M. causing alarm for the Federal Communications Commission and U.S. broadcasters. The high powered Cuban station was operating with the power of 75,000 watts at the time but could raise it to 300,000 watts at the press of a switch.

The unusual event was to celebrate the 30th, anniversary of the Cuban revolution. Castro could be heard blasting Cuban workers for not doing enough for the country. He recalled the time he walked into a factory unannounced only to discover that some workers were using their work time to take a coffee break. This works against the country he warned. He recalled the days he served the Cuban people as a revolutionary leader in getting rid of Batista and making Cuba the strong country it is today.

The Cubans were not the only people to hear this broadcast as radio listeners as far away as Salt Lake City, Utah called VSL, a 50,000 watt station serving the area and surrounding states to complain about the Cuban interference.

About the same time, the watch commander of the Federal Communications Commission was alerted to the after hours broadcast by Cuba on 1160 FHZ. He contacted the legal representatives of stations operating on the frequencies of 1160 KHZ and others which Cuba has been known to use high powered transmitters on in the past and advised them that the FCC monitoring team was standing by to measure for possible interference and requested the stations to sign off the air at pre-arranged times so tests could be conducted.

WHO-1040 out of Des Moines, Iowa which was a target of the Cuban interference in the past received a request from the FCC at 7:35 PM EST to sign off the air for five minutes and this was started at 7:48 PM in the middle of the Tom Davis Show, a talk show featuring the head coach of the Iowa basketball team. At 8:05, 9:05 and again at 10:05 PM the station went off the air for eight minutes during each sign off. Dozens of calls were received but those really hearing Spanish music were really hearing Radio Victoria over 1040 KHZ as unusual radio propagation favored signals from the south during that time creating havoc on the already congested AM band.

Cuba has one request and that is, they want a frequency so they can transmit programming to the United States. Until they get this, they will continue to jam various U.S. broadcasters. The radio war is on.

C's Format: Yes, We Have No Nostalgia OON after KFRC became "Magic 61," a directive ap-

peared in the announcers' studio: Never say "nostalgia." But the new format, of pop and big band music from the years before rock 'n' roll, is directly aimed at older people, many of whom love to take reflective strolls down memory lane

I, for one, am glad they're around

When KFRC dropped out of the rock race, Phil Stearns tuned in. For him, it was like going home. Stearns was a news reporter at that station in the '30s and had the honor of introducing to the listening public Borden Dairy's new mascot: Elsie the Cow. He writes a letter that should strike a couple of chords with fellow first-generation KFRC listen-

"KFRC was a dominant radio outlet from its inception in 1924. Its transmitter was on the roof of the Don Lee Cadillac building on Van

Ness Avenue between Geary and O Farrell, across the street from old St. Mary's Cathedral.

The station was owned by Fred Pabst, who also owned the Cadillac agency on the ground floor KFRC occupied the second floor. It was the first San Francisco station to open its doors to studio audiences. Radio fans flocked into Studio C to watch the 'Blue Monday Jamboree' while listeners all over Northern California gathered around their super heterodyne radios to listen to their favorite entertainers.

"KFRC was an anchor station for the Mutual, Don Lee Broadcasting System, a coast-to-coast network. It was the springboard for many iljustrious careers. Meredith Willson of 'Music Man' fame got his start at KFRC. John Nesbitt's 'Passing Parade' graduated from KFRC to MGM Studios in Hollywood, where it was transferred to feature films

"Many great program ideas were hatched at KFRC but for some reason they failed to attract sponsors. Their originators took their creations to New York or Hollywood, where they attained enormous suc-

"One example is This is Your Life, created by Pat Weaver, who tried to air it on KFRC. Another is Mery Griffin, who started at KFRC as a singer with Cy Trobbe's orches tra on a program hosted by Mel Ven- gone forever, to be remembered ter. The show was Feminine Fanalso hosted 'The Breakfast Club' fea - fection and great nostalgia turing Tommy Harris . .

"A young announcer named Mark Goodson broke into radio at KFRC. He had a bundle of program ideas, but there were no takers so he went to New York. His first big hit was 'What's My Line?'

"One of the most successful radio performers to begin a career at KFRC was Art Linkletter. He had an audience-participation show called 'What Do You Think?' in which he posed a controversial, topical question and let the audience battle it out. He later took the show to Hol lywood and quickly rose to the top.

"World War II changed just about everything, and KFRC fell into the mold. Then came television, and the great old days of radio were now by the dwindling remnants of cies' and aired at 1 p.m. daily. Venter an older generation, with much af-

In closing, I wanted to congratulate the editors and, particularly, the crew in Seattle for putting out a very impressive looking publication week after week. DX Monitor is consistently well assembled with a minimum of filler (newspaper clippings, etc.). I was sad to see Gardner Smith resign from EDXR. His columns were particularly well done (not to take away from all of the other editor's fine work!).

Vancouver 1987 news. The owner of the station with no name, CIOF, "AM 10-40," Don Hamilton, once fired ABC's resident Canuck, Peter Jennings, and told him to become a butcher. (And the only way he kept his job was to start a radio station, hi-RtH.) CJOR 600 Newstalk lost ex-BC Premier Dave Barrett. He quit despite good ratings. CJUP 800 droppped country for "AM 800" "All Hit Radio" except for about three hours of ethnic 2100-0000. They now gear for metro Vancouver with rush hour traffic just like the rest.Semi-local CFVR 850 reaches most of Vancouver, but dropped out of the race. They carry WIN Midnight to 6 AM from satellite (CKNW 980) and other such NW stuff. So does their mother, CHWK 1270 (and CKGO 1240). They also have "Star FM" (CKSR) in the valley which reaches here.

CKWX 1130 (and CKIS-FM "Kiss 97") now use full calls during news and sports. But at the stroke of Midnight, it's "Nightshift" MoR to 6 AM live via satellite to so far 22 AM'ers in BC. Down the hall at Kiss FM they beam up Scotty to 17 more in BC. Both in stereo on Anik D Satellite.

This means that except for CJVE 1470 all private AM and FM'ers in BC are NSP! CKNW 980 beams up to the rest. The list is coming. It'll be tougher to ID now unless you catch the two minutes at the top of the hour of local spots.

Some of the WX 22: CJVI, CJAV, CJIB, CKOV, CKQR, CKKC, CFKC, CJAT, CKRX, CKWL, CKCQ, CJCI & Network (switched from CKNW). This leaves CJJR FM (CJOR's sister) "JR Country" the only country voice Midnight to 6 AM

for Vancouver/Victoria or about 1,700,000 folks.

And for those of you who can't wait to hear Newfoundland or the Yukon, just tune your dish (doesn't everyone got one yet?) Comments on the forums in DXM of 17 January by Dale Park and Ric Heald.

Dale is right. Publixity is the most likely way to attract new members. We will have a Publicity Director. That position will be the focal point, but every member should help in the publicity effort. Just as important as attracting new people is keeping them. The DXM needs to be interesting and understandable. It's good now but could be better. The new DX Techniques column has great potential. I believe that DXM would be more interesting and comprehensible for new people is we used fewer abbreviations especially in the DX Roundups. Maybe there should occasionally be printed a list of acceptable abbreviations. (There is! Called New Member Packet-RtH.)

Ric's forum mentions daytime signal dead spots near power lines. I'm not sure of the cause of what Ric sees; however standing waves from broadcast station signals occur on overhead power and communications lines. The lines act as longwire antennas and receive radio signals, of which part is re-radiated. If the line is long in terms of wavelength and contains a discontinuity (such as the end of the line) a standing wave pattern forms along the line with minimums or nulls located each half wavelength.

The best example of this which I've noticed was while on an AMTRAK train running along the Upper Klamath Lake in Oregon. The tracks parallel the lake shore for about 25 miles and are on an embankment which they share with an overhead pole-supported line. I had a pocket AM receiver tuned to a strong signal and noticed an evenly spaced series of alternate signal maximums and nulls repeating each few seconds. The nulls were quite sharp. For a signal frequency of 1000 KhZ they would be 492 feet apart. A similar effect might be obtained by walking along an unterminated Beverage antenna. Regards to all and 73.

This is the first in what will be a monthly series of columns on DX Techniques, an attempt to address the "How to" aspect of our hobby. I plan to start this column by addressing the basics of DXing and then move into specifics.

I will start by asking you to write the next column. What I have in mind is for you folks to send me a short paragraph on the subject "How I DX". This exercise is intended for DXers old and new, and, when published, will give others ideas about techniques that other DXers use for logging new stations. I plan to type my next column in the middle of March, so the deadline for submission is March 20.

Regardless of how you DX, there are two things you can do to help you log new stations. 1) Know what you have heard. 2) Know what you have **not** heard.

The first, though obvious, is often times overlooked when starting out. Then, almost everything is DX. But, as you hear more stations, there will be more "regulars" and fewer "newies" heard. If you can keep track of what you have heard, by frequency, then you will be in a much better position to know if you have just tuned into a new station, or if it is something already logged. I would recommend a list with call, location and format at a minimum. I can assure you, that your frustration level will always go up when you finally discover that you have spent 20 minutes listening to something you have already heard! A quick way to get started is to use your BCB station logbook, and cross out the station listing as you hear it with a yellow felt marker, noting format in the margin. As time goes on, you will probably want a separate listing of what you have heard, since logbooks change and it can take a long time to mark up a new one. I now have all my DX on a computer at work, and keep a printout of what I have heard, in frequency order, right at the radio. I consult this often while DXing.

The second item may take a lot of time, but I assure you, it is well worth it, and can even be done during the daylight hours when you are not DXing. The IRCA is geared to provide you with the information you need to identify stations when you hear them. Why should you be thumbing through bulletins looking for information, when it can be easily compiled? It is well worth the effort to keep track of likely targets, changes in the band, and what is being heard. I use the "Broadcasting Information" column to see what might be coming up and the "DX Roundup" and "DX WorldWide" columns to see what is being heard. Your logbook can be consulted for likely targets, like the stations in your state, and the surrounding states. My hit list is tabulated in a special book, with a page for each 10 khz frequency (it is an old desk callendar from work).

If you are getting started in the hobby, these two tips are well worth considering, and you'll thank yourself in a couple of years for being diligent at the start, especially keeping track of what's heard. Don't forget to send in your "How I DX" articles. Take care phil

Radio Monte Carlo Brings Arab World Latest Local News

French-Owned Station Sways
Mideastern Governments;
Yasser Arafat's Bulletins

Staff Reporter of The Wall Street Journal PARIS—In a studio off the fashionable Avenue Raymond Poincare, disk jockey Salma el-Shamma waves to her sound man and leans over the microphone. "Dearest listener," she whispers in Arabic, "in about four minutes from now is our rendezvous with our news."

Thousands of miles away, her words flow from table-top portables in the sidewalk cafes of Cairo, from pocket transistor radios in the crowded tenements of Arman and from hi-fi speakers in luxurious Jidda palaces. They float above Beirut's battered terraces; and with the volume turned low, they play softly in many a Damascus or Tripoli living room, where listening to anything but the home government's propaganda is a crime.

Propaganda Organ

This is Radio Monte Carlo. Conceived by the late French President Charles de Gaulle in 1968, the station, owned by the French government, got under way in Monaco in May 1972 but moved to Paris a short time later. It retains the name of the gambling resort because by so doing it distances the French government from what, in effect, is its own propaganda organ.

Whatever its bias, the station has grown into the world's most widely heard Arabianguage broadcast. Its catchy brew of news, music, sports reviews, talk shows and advertising reaches 12 million to 16 million Arab adults daily throughout the Middle East and North Africa, according to Pro Media, a Paris-based Arab advertising agency. In times of crisis, such as the assassination of Egyptian President Anwar el-Sadat, the audience may swell to as many as 20 million.

The station's fame parallels growing French influence in the Middle East. Area specialists say that as Britain withdrew from the region and the U.S. became increasingly identified with Israel, France emerged as the Western power many Arabs look up to. France's immigrant population includes 200,000 Lebanese civil-war refugees, primarily businessmen and intellectuals, plus more than two million Arab North Africans.

Delicate Delivery

While Radio Monte Carlo is undeniably a French-government medium, the packaging is subtle and the delivery delicate. There is no attempt to expound the French line on Arab affairs, for example. The aim, rather, is to build Arab affection for France. "We are an Arab station working as a Western media organ. The BBC is a British station trying to act as an Arabic one," explains station manager Antoine Nofal.

On the air, Ms. el-Shamma yields to Panorama, a serious half-hour Arab news and press review. It is just one of 19 news programs—not to mention frequent bulletins—spotted throughout Radio Monte Carlo's 16-hour broadcast day. Primary beneficiaries of the programming are the many listeners who live under regimes that starve them for objective information. "For news junkies like me, it is an essential diet," says Rene Shiniara, a retired civil servant in Cairo.

Station manager Nofal, a Lebanese, presides over a freewheeling staff of 100 Egyptians, Palestinians, Lebanese, French and Syrians among others, including some 20 overseas correspondents. Staffed by confirmed Francophiles, the station broadcasts a heavy dose of Western music and advertises Western consumer goods. Yet it is thoroughly Pan-Arab in character. For example, during Ramadan, the holy Moslem month of fasting, liquor commercials are banned.

Radio Monte Carlo has influence with Arab governments, whose officials monitor it carefully and seldom refuse an invitation to be interviewed. Even more telling, during the December 1983 siege of Palestinian guerrillas by Syrian troops in Tripoli, Lebanon, Yasser Arafat, the head of the Palestine Liberation Organization, became, in effect, the radio's correspondent. For days, until he left the city, he gave numerous live interviews and conducted his negotions with the Syrians over the airwaves.

"The overwhelming impression is not that it is as credible as the BBC, but {Radio Monte Carlo's} persistence in following news items is remarkable," says Nabil Osman, Egypt's press counselor at the United Nations.

Radio Monte Carlo is "fast and, when it comes to Arab news, more relevant," notes Rashid Khalidi, a professor of political science at the American University in Beirut who survived the Israell invasion of Lebanon during the summer of 1982. "I was tuned in to Monte Carlo at home, in the car, and at school. They had nonstop news. No one who lived through this experience could do without it." When a Kuwaiti tanker was bombed recently in the Persian Gulf, Kuwait's deputy information minister called Radio Monte Carlo for a fill-in on the facts.

fast-paced program of mostly English, French and Italian music sprinkled with occasional Arab tunes.

Ronald Pharaon, the Lebanese who directs Radio Monte Carlo's advertising sales, says star disk jockeys and broad-casters receive a total of 1,000 to 1,500 letters a month and countless phone calls from fans. Most of the letters come from Egypt, where people live on modest means. The phone calls, many from automobiles, come from Saudi Arabia, Kuwait and the Arab oil emirates. Ms. el-Shamma says an admiring listener once sent her a BMW, which she refused.

The stars' monthly salaries vary between \$1,666 and \$2,060. According to Mr. Pharaon, those earnings can be substantially supplemented by income from commercials, voice-overs and participation in tours of Arab countries. To many, however, the chief attractions of working at Radio Monte Carlo are fame, a pleasant and dynamic working atmosphere, and the fact, noted by Mr. Nofal, the station manager, that "it is nice to live in Paris."

The broadcasts travel via submarine cable to Cyprus, from where they are beamed over medium wave—the equivalent of the AM broadcast band in the U.S.—to Libya, Egypt, Sudan, Saudi Arabia, Jordan, Israel, Syria, Iraq, Kuwait, Yemen, Qatar, Bahrain, the United Arab Emirates, Oman and parts of North Africa. (Apart from its Arab-language service, Radio Monte Carlo also broadcasts a mix of rock music and news to the French.)

To present a rounded view of the news, Radio Monte Carlo retains correspondents in Arab capitals who are known to closely reflect the opinion of the local governments. But it balances their reports by airing all opposing sides without censorship. "You can hear all the different views," says Prof. Khalidi.

When the news is over, Radio Monte Carlo returns to projecting a likable image of France. The chatty Ms. el-Shamma, a former Cairo television anchorwoman, returns the mood from somber to frivolous with her popular "Disco Monte Carlo."

She teases listeners with filirty monologues; tells them what the weather feels like under a cloudless night in Paris; and recalls her argument with a taxi driver who cursed at Arabs after the wave of terrorist bombing in Paris, illuminating this story by staging an impromptu interview with a studio visitor. "I try to make the listener live in my ambiance, feel the air of Paris, share my experience of being here," she says during a pause in her three-hour,
