Coming Events

October 14 marks the 95th birthday of Harold Beverage, the inventor of the Beverage antenna. As a way of marking this occasion, Nick Hall-Patch has suggested having a series of Beverage antenna expeditions around that date. Speaking from experience, a Beverage expedition is a lot of fun and a great way to start the season. If you go through with it, be sure to report your results to DX Monitor. (And for the newcomers, a Beverage antenna is a long straight wire a few feet off the ground. It's highly directional if you make it long enough, like 1500' or longer. It was first developed in the early 1920s, and saw practical use in the 1920s and 30s practical use in the 1920s and as a receiving antenna for trans-atlantic telephone circuits! It was later picked up by hams and BCB DXers as a DX antenna).

If you need something to reel up those hundreds of feet of wire, try home improvements centers, garden stores, etc. Some of them sell reels designed for hoses and electrical cords that also work well for antenna wires. This is a good time to buy one, since the stores are running end of summer sales. Phil Bytheway found one at K-Mart for about \$7 recently.

THE 1988 MEMBERSHIP SURVEY RESULTS

The 1988 membership survey is complete. A total of 47 responses were received. That's a bit-lower than the response from previous surveys in 1976 and 1982, but still quite good. I was really impressed by the caliber of the responses, some of you put some real thought into your answers. I've organized the results in the order they were presented in the survey form. Where appropriate, I've also compared them with the previous (1982) survey.

· 1. Vital Statistics

Our average age is 38.8 years, up slightly from 37 in 1982. We've only aged 2 years in the last six, hi. The median age was 35. Two percent of the respondents were in their teens, 25% in their 20s, 40% in their 30s, 16% in their 40s, 9% in their 50s, 4% in their 60s, and 4% were over 70. The oldest was 81.

The average IRCA member has been DXing 19.75 years and has been in the club for 10.6 years.

33% of the respondents live in the EST time zone, 16% in CST, 7% MST, and 44% PST. Nobody said "other".

2, What receiver do you use?

The average respondent listed 2.5 radios, ranging from small portables to the NRD525. Here are the radios mentioned most often, ranked in order of "popularity". The first column on the right is the number of people who said they have one, the next column is the ranking in the 1982 survey.

Half of the above receivers didn't even exist in 1982! Some receivers, such as the Drake SPR-4 and Panasonic RF-2200, made good showings in the 1982 survey, but were mentioned, at most, once in this one. Tube type communications receivers made up 15% of those mentioned in this survey, compared with 25% last time. Of the rest, 27% were AM or AM/FM portables.

state communications receivers, 8% the receiver section of a ham transceiver. One person said homebrew and one mentioned a car rx.

Twenty of the receivers were made by GE. 19 by Sony, 12 each by Kenwood and Realistic, 11 by Icom, 10 by Hammarlund, 9 by Yaesu, and 17 by others.

When asked to name their main receiver, the respondants said 1.Superradio: 9, 2.Sony 2010: 5, 3.R-71: 4, 4.FRG-7 & R-2000: 3, 6.R-1000, NRD-525, & R-70: 2 Manufacturers of the receivers "used most often" were 1.GE: 9, 2.Sony: 7, 3.Kenwood & Icom: 6, 5.Yaesu: 4, 6.Hammarlund: 3.

The "used most often" receivers, by type, included 17 solid state communications receivers, 11 AM or AM/FM portables, 7 shortwave portables, and 5 tube-type communications receivers.

The GE Superradio and the Sony 2010 seem to be quite popular. But their high rankings seem to be due to a lack of other good receivers in their categories. As a group, comunications receivers are much more popular, and generally offer better performance.

3. ANTENNAS

Several people said they only used the internal antenna in their recei-Of those who said they use an external antenna, 23 mentioned a ferrite loop of some kind, 20 listed an air core loop (wedge, box, or spiral loop), 22 said longwire or something similar, 6 said Beverage which were used only on (most of DXpeditions) and 9 mentioned a vertical or active antenna. The most popular loop antennas were the Radio West Loop (mentioned 11), box loop (11), Space Magnet (SM1 and SM2) (5), wedge (4), and Palomar loop (4). When asked to name the antenna they used most often, the leaders were the Radio West Loop (8) and longwire (6). The box loop, Beverage, wedge, and Space Magnet tied for third place with three each.

6. DXM FEATURES

This is the question where you were asked to rate the individual columns. We assigned points to each response as follows: A-Very interesting/useful - 4 points, B-Somewhat interesting/useful - 3 points, C-Neutral - 2 pts, D-Don't Like It - 1 point, and then ranked them by adding up the points, finding the average, and ranking them in order. We also found the net differences between the number of people who said a column should appear more often, and the number who said it should appear less often.

A couple of features were accidentally overlooked when the list was made: Kanadian Korner, President's Report, Unreported Stations, and DX Techniques (which sort of fits as "DXing in General). Two people gave Kanadian Korner an "A", and one gave Unreported Stations a "B".

It looks like there are two things we most like to see: 1.Information to help us hear more stations (DXR, DXWW, etc), and 2.Articles by and for BCB DXers to increase our knowledge of the hobby.

7. HAPPY ANNIVERSARY

What should we do as part of our 25th anniversary celebration next year? We received a variety of answers. Four types of answers showed up most often:

1. Reprint the first DX Monitor: Maybe I put words in peoples' pens by using it as an example. But About a third of the respondants said it was a good idea. A few qualified their statement by saying "if there's room" or "parts of it".

2.History of IRCA: Several others suggested one or more articles on the history of the club. Some said it should be brief, others said comprehensive, others were more specific, such as "How the Club was Formed."

3. Diving Signe 1964. How the boddy

3. DXing Since 1964: How the hobby has changed, reminiscences of early members/DXers, a comparison of DX in the 1960's versus now, etc.

4. Reprint Articles From Early
Issues of DX Monitor: Some said
reprint selected DX tips from the
first volume or two, others were more
general.

Several other ideas were mentioned by one or two people: a membership drive, print music surveys/radio catalog pages/station ads from the 1960s, a special issue of DX Monitor, ads on clear channel stations, a list of charter members, photos of DXers, a special convention, multiple conventions, a book like NRC, a history of DXing, and several others. One person suggested rolling dues back to 1964 prices, which we will definitely do if the post office and our printer roll their rates back to 1964 prices.

8. THINGS WE'D LIKE TO SEE

Several good ideas for articles were suggested. Some were pretty general, others were rather specific. Some folks even suggested who should write the article! In the list below, I've grouped ideas on related topics to save space and to ephasize the interest in certain topics. The most

frequently mentioned seemed to be equipment reviews and bolts" of DXing. Here they are. Do we have any volunteers to write them?

More info about network programming.

Updates on expansion to 1750 kHz, now that Rio conference is over. (See page 20 of the July 9 DX Monitor for the latest word. bp)

Updates on Canadian stations more often than current once-in-a-while Kanadian Korner.

9. IMPROVEMENTS AND CHANGES

The answers to this question seemed to show a lot of satisfaction with the way the club is operating. There were only a few words of discontent, and lots of answers saying IRCA is already a great club and no changes are needed. Several people put forth ideas, and others provided some constructive criticism. The quotation marks are used to separate individual thoughts, which are grouped by topic. In some cases I rephrased comments to save space or improve clarity, but as far as I know, the basic ideas were preserved.

"I think the club is operating pretty well." "I like it pretty much as it is." "Things are going fine." "None, raise dues if necessary to keep a full publishing schedule." 'Encourage more reports/contributions by overseas members; try for a more 'international feel' than NRC."
'More member interest and reports in roundups and forums (including myself)." "I enjoy it in its present form, just wish members would contribute more articles, logs, etc. other than the small percentage that do (true of all clubs unfortunately)."

'More members would be nice, but how to attract them? Advertisements in VRTH, PopComm etc?" "Probably more ads in other publications to bring in new members. Research areas whewre there might be future members waiting for the club to find them." "We need nore members. Maybe advertising on Twe stations (SW programs). There nust be 'new blood' out there."

'Fewer gripes about contents - the club members come from varied phases of the radio hobby, and have many likes and dislikes." "More professional attitudes in DX Monitor (admittedly not a requirement for club such as ours)." "Less bad-mouthing of NRC."

'More about DXing, less about the proadcasting industry." "No really Dig changes. I like it pretty much is it is. Maybe more technical columns (as opposed to more technical columns." "...a column for FM staions." "More DX tips, less 'otherness'". "Delete the April Fool's hess". Detect the april 1001 ssue." "Verie signers list every other issue." "Photo reprints of DX shacks, stations, etc." "More info on sports teams, and perhaps a complete listing annually of networks or all sports major & minor." Fewer newspaper clippings on aspects of BCing remote from DXing (e.g. adio station willed to a pet cat fter death of owner)." "Perhaps a najor realignment of the domestic clumns (forums and roundups), in erms of the boundary lines." "Breakng into FM stations, FM programs, nd FM DX." "FM columns for the easern states, centralstates and wes-ern states."

The print quality could be improved s it is bad from time to time." Better printing quality." "Less loppy, better put together."

There are still some reporters who re not reporting as they should or s the columns are intended. i.e. outine reports of Unids without any dditional information, such as 'LA x' on 600. If an article on the tandards of reportability could be repared, members might benefit."

I would like to see more articles,

including newspaper articles in DXM. Since these usually appear in the "double" bulletins. perhaps we could have fewer weekly bulletins — ad then increase the number of 'double' bulletins. This would also save \$\$\$. The material found in the double bulletins is generally much more interesting than just the usual roundups and forums which make up the weekly 'single' issues."

"Stabilize publishing in hopes that bulletins can arrive about the same day each week, instead of varying from 2 to 13 day intervals. Continue the trend away from jargon and abbreviations towards simple English. Get all column editors to proofread what they type, before they send it it. Ideally, all columns should be the high calibre of John Johnson's CDXR."

10. ANY OTHER COMMENTS?

We asked this question as a catchall, in case somebody thought of something that wasn't covered by the previous questions. Several people used it to reiterate some of their earlier comments, others decided to finish with words of praise for the club or certain members. Here are the responses. Some are paraphrased to save space or improve clarity.

"As long as the editors, contributors, etc. keep the DXM to the fine standards it's been at, we will continue to be the better MW club to serve BCB DXers."

"Since there are Eastern, Central, and Western DX Roundups, it is quite interesting to read these columns."

From several people: "Keep up the great work".

"I would like to see the Constitution and Bylaws published on a regular basis, both for the new members and for us old-timers. It's beenfive years or more now. Perhaps another award - like the TVA - is in order, but one to be decided on by the editors or publishing crew instead of the membership. This would be in addition to the TVA."

"More information about receiving AM classical mx stations, both domestic and foreign."

"New Broadcasting Info is great."

"Forget about NRC (as NRC should not worry about what IRCA is doing) — concentrate on the purpose — DX — not attitudes." "Overall, a real nice organization. One heck of a lot more polished than the competition..."

"Any articles removed from reprint lists should be 'archived'. A list of these possibly-obsolete-but-of-historical-value articles should be offered as a reprint itself. Old (deleted) articles should be made available at a higher cost to cover the higher single-copy duplication charges."

"I like the fact that actions by the BOD haven been in the bulletin more frequently and quickly after votes are taken, and frequent President's messages."

"All editors and staff are doing a fantastic job." "Some of the (DXR.bp) columns have been too 'elitist', others have been too 'simplistic'. We need a balanced approach where the newcomer feels welcome, yet the veteran isn't reading a bunch of 50 kw pests all the time. John Johnson is on the right track. Let's continue the trend." "I would like to recomment that when an editor puts a comment in someone's tip or statement, that they put their initials at the beginning rather than at the end. For example: (NH:WHAS is no longer silent MMs) instead of (WHAS can be heard here often - RTH)."

"Consider 3 month shutdown during summer to reduce costs and give editorial crew a vacation." "If money is a problem, I can see nothing wrong with cutting bulletins back by 50%, larger bulletins every two weeks." "It may be my personal schedule but it seems I get swamped under by weekly issues, thus I would not object to dropping a few issues to cut costs."

"My only dislikes are the increasing trends towards station formats/personalities news. Clearly, some of this is useful to help ID stations, but I've never thought of DXers as AM radio station groupies."

"Nice friendly atmosphere in the bulletin." "I am generally pleased with the quality and creativeness shown in DXM. A lot of effort comes together here and it shows." "I believe we have the best AM DX club in North America." "I think everyone is doing a terrific job, but would like very much to see increased member participation in club reporting and activities."

Greetings to one and all. Well it seemed like it would never come back but at last the rain is here. We've had rain for the last 3 weekends making it impossible to put up my antenna system which is now all over the garage floor. Besides the BCB DX I do a fair amount of ham banding and the antenna should improve reception on those bands as well as making for a good long wire on BCB. I've been using a Grove Mini Tun 3 to help get rid of the spurs from locals and it works fairly well.

The conditions here seem to come in two varieties; very good and totally terrible. Last Saturday (18 September) was the very good variety and after trying for 4 years, I've finally added Florida to the list of states heard. WIN? 940 came through for all of 4 - 5 minutes around 0530 CDT. No sign of CJGX, the pest from SK. First time in quite a while. That puts me at 41 states heard. If I can get MS, it'll leave the Eastern seaboard states such as NJ, DE, VT, NH, ME, RI and, of course, AK and HI to try to get if I live to be a ripe old age, hi! (Gee, Shawn, I didn't know VT was on the "seaboard," hi-RtH)

On the local scene, we haven't had much happening. All of the stations are boring save for the CBC and CKJS. The latter is our ehmic station by day and after midnight local time, the play light rock like everyone else. So if you are on 810 and hear a foreign voice, it just could be them. The languages, such as Hungarian, German, Tagalog, Czech, Yiddish can be confusing, but the music is a refreshing break from the "greatest hits of the '60s' 70s and '80s.

One little experiment I've been trying that seems to work is using a red light bulb in the lamp over the radio. The light is softer and gives a nice glow that is easier on the eyes. You might want to give it a try.

So long for now and for those of you out there in the west you might try 1030 when KTWO is off. There have been some interesting signals of late. Check CDXR for details. 73 and good DX'ing de Shawn.

Hello again after a substantial absence from these pages. I've just been too busy the past few months to get in much time at the dials. Sometimes when I'm working 'til way past midnight doing maintenance at KAMB or KSNN, I come home still running on adrenalin I'll do a little DX'ing just to help unwind. Haven't heard much to report. Just New Zealand on 756 and even that isn't new. I spent a week at Mt. Hermon (north of Santa Cruz) and brought my RAX-1 and a floppy loop. There was some intermittent powerline hash that would wipe out everything on the dial, but I did manage to hear KMDY 850 which I hadn't heard before. I helped proof out their directional array when they went on the air in 1971 as KGOE. Around the end of August, I took the family to Disneyland and on the way back we camped at Emma Wood State Beach near Ventura. Thinking that it would be a good chance to try a little coastal DX, I pulled the Superadio out of the van only to discover that someone had left it on and the batteries were dead. The radio in the van deing digital and tuning in 10 kHz steps didn't lend itself too well to TP's, so I had to give up on that.

I was surprised recently when I was putting new batteries in the Superradio and tuning across 1030 heard a station saying "in downtown Reedsport." So I stayed with that and eventually heard a loud s/off from KBUF in KS, then a KDUN ID.

For those of you who are thinking that AM radio is all talk programming, these stats from the Radio Advertising Bureau are interesting: the most common format on AM radio is AdCom at 18.3%, followed by Country at 17.8%, REL 14.1%, MoR/NOS 11.8%, NWS/TLK 7.0%, Oldies 6.6% and a few other

miscellaneous categories.

Greetings and all that other stuff. Now this is a clumn I like to see: from the Canadian midwest to Alaska to the Mexican border. Great work guys!

Oddly enough, all above forums arrived on the same day.

I now know who belongs to those 4 towers in Sloughouse. Remeber I said they were on Glory Lane. Sure 'nuff, they're KEBR's daytime site. KEBR at 0003 PLT on 26 September did a full s/off-s/on type message and said, "with daytime transmitter located in Sloughouse and nighttime transmitter in Roseville. "Mystery solved, but I'm thinking it's a little expensive to maintain two sites, but maybe that's the only way they could get on.

Tim, or for that matter any other DX'er, if you're looking for help with Valley stations, don't ask a Valley DX'er, hi. I'll tell you why. The Valley runs N/S, and most nighttime signals, in whole or part, are sent in a westerly direction, basically putting me at a null. It's easier to hear them in the Bay Area than here. Sacramento stations are the only strong ones at night, and I can get rid of KXOA. But I can put good nulls on Stockton, Modesto and Marysville/Yuba City. There's a few exceptions like KMJ and KFRE, and KERN is often atop 1410 rather than nearby Marysville. Chico the strongest in the north valley, but can be easily nulled, Redding, Red Bluff, Oroville have never been heard here at night.

With regards to KMIX 1390, I have this noisy problem on 1380 and really have to work at it just to hear them. In the other direction, I've never heard an ID from KEEN. At night, I'm lucky to hear Butte on 1370 and KGER

maybe on 1390.

A good example of two stereo AM stations - one clean, one dirty, KSMJ is 10 miles away with 5 kw. I put put a small null on them, but the hash still extends up to 20 kHz each side, only slightly on 1360 and 1400, but it's there. On the other hand, KRAK 1140 is 12 miles away and beaming their 50 kw right smack dab at me, possibly an ERP of 100 kw. Yet, I can pick out Vancouver 10 kHz away and 1150 occasionally comes through.

Noted something unique: KPLA 770 now has tele-talk in PP! Noted midday

on 24 September.

And on 1270, ex-KCOK - are they KFYI or KFIY? Noted them on SSS, also on the 24th. They're a hard one to pull in thanks to KPLY and KWTR, and KPLY owns the channel at night.

RW, your comment in last issue of DXM in WDXR re KLOK. I too have noted a change. They "sound" stronger and much more crisp.

Guess that's it this time around. Going into the weekly issues so keep those cards and letter comin' in. Best of DX and see you in Sacramento, the River City, in '89 de RtH...
