# Notes from HQ

News from the Big Apple: Radio New International was testing on York 1620 kHz from 2100-2400 EDT on 10/14 & 15 from the Good Ship Sarah, just outside US territorial waters. They were using 1000 watts at the time, and Karl Zuk says they put a great signal into downtown Manhattan. Karl also says the station has been sold to a group of British subjects, and the ship has been re-registered to the country of Sealand. (If you can't find Sealand in your atlas, it's a WWII gun emplacement off the British coast, which a group of squatters are claiming as a separate country!). No word on when or if RNYI will begin regular broadcasts, or when/if they'll start broadcasting on FM or shortwave.

WNBC-660 in New York became history 10/9. The 660 spot is now occupied by WFAN. WFANs old 1050 spot is occupied by a new station WUKQ, which will exist as an AM station only from 10/7 to 10/21, when they will swap spots with WEVD-FM, which will move their big band format to 1050. Thanks to the multitudes who sent newspaper articles on the subject. A couple of them appear elsewhere in this issue.

## TRIVIA QUESTION OF THE MONTH

Answer to September's question: the cities with the most stations licensed are New York City & Honolulu, 16 each; Los Angeles County CA has the most of any county with 26, followed by Cook County IL (Chicago) with 23.

October Double-Header: It used to be that Wyoming was the state with the lowest AM station on the band highest on the dial - KROE-930 starting its band. With KUYO-830 on the air, though, that honor now belongs to a different state. Which one, and what's IT'S lowest station? And, while we're there: when KIBG-1550 comes on the air or KSHY moves to 1530, Wyoming will also cease to be one of the states with no stations above 1490 KHz. Three other states - Idaho, Montana and Vermont - still have their highest stations on 1490 KHz. The highest station of one other state is even lower - name the state and its high station.

My mind really is cluttered with this sort of junk...and I can't be the only one who tends to spend 2:00-3:00 AM with a road atlas and station log while waiting for that @\$\^T@\&\alpha\ 1000 Hz tone to ID. (It never does, of course). If you'd like to send in trivia questions to boggle your fellow IRCAns with, please do! And, if you want to see your name in lights, send in the answer to the question before next month's deadline and you'll get credit for it (e.g., JOHN DOE correctly solved the August question...) Who knows, this may even turn into a real contest, hi.

Small antidote to the numerous stations that went silent this month:  $\text{KELY-}1230 \; \text{Ely NV}$ , which had been on specified hours operation, was granted full time operation.

"I wonder what they'll do with their new station" dept: one of the promotional exhibits at the recent Nat'l Ass'n of Broadcasters convention here in DC was a big billboard for "66 WFAN." Eccchhhh.

Yet another new satellite-delivered format: Opryland and Group W Satellite Communications go in together on a new country music service; the overnight "Music Country Network" now offered by Opryland will be folded into the new service, with AP Network News (now run by MCN) also to be retained. The first two affiliates: WSM-980 Nashville and WKY-930 Oklahoma City, both owned by the same folks who own Opryland. Also in dish doings, KMNY-1600's "Money Radio" network finally has affiliates. The first two are KDB-1490 Santa Barbara & KRYN-1490 Colo. Sprs.

How The FCC is Killing Radio (Part 62 in a Series): The new owners of WGMS-570 Bethesda MD are widely rumoured to be considering taking the station off the air when they assume ownership. Real estate prices are so high in this prestigious suburb of Washington, and AM listenership is so low (WGMS has been 100% simulcast with its FM for most of its history), that the land on which WGMS's multi-tower array sits is worth considerably more than the station - and no comparable, affordable site for the towers could be found.

The taste of bile in all this comes from the FCC's 20+ year hounding of the previous owner, RKO (which has kept up a strong commitment to AM radio), as being allegedly unfit to hold a broadcast license. Instead, the FCC has forced sale of the station to a real estate operator who will probably dismantle it. In the FCC's eyes this appears to be a much more proper way to run a station. No wonder AM radio has become so unlistenable...

The FCC has also denied license renewal for struggling KUKQ-1060 Tempe AZ and given its license to a competing applicant. Expect this one to languish in the courts for a long time, too.

How Bad Audience Research Is Killing Radio (Part 127 in a Series): The owners of KCPX-1320 Salt Lake City UT decided to split off from their simulcast FM (hooray!), and wondered if in doing so they should change back to their former calls of KBUG. They commissioned a research firm to poll Salt Lake radio listeners to see how many remembered the old KBUG, and were astonished and delighted to learn that a remarkably high percentage of listeners did indeed recall the old calls. So, they applied to change calls back to KBUG.

What the owners and research firm forgot to ask was whether all those folks who remembered KBUG  $\underline{\text{liked}}$  KBUG. After investing beaucoup time and \$\$ in planning the new format, someone remembered to ask this question. Turns out just about everyone hated KBUG. Instead the calls are now KEMX...

# radio flagship is signed off

NEW YORK (AP) - Friday was the last day on the air for radio station WNBC, for 62 years the flagship of the NBC radio network that was home to Jack Benny, Bob Hope, Fred Allen and the NBC Symphony conducted by Arturo Toscanini.

Its spot at 660 on the AM dial, a clear-channel signal that could be picked up in as many as 35 states at night, is going to an all-sports station.

WNBC was descended from the station that was the first to broadcast a World Series, the first to run a commercial, the first with a coast-to-coast hookup and the first to broadcast a national political convention.

The end of an era came as a result of the \$6 billion deal in 1985 in which General Electric Co. bought RCA Corp., the NBC's parent com-

A Federal Communications Commission regulation prevents a new owner from keeping both a TV and radio station in the same market, so GE decided to sell its...

new radio properties and keep the more profitable WNBC-TV.

The NBC radio network went to Westwood One for \$55 million, and five stations, including WNBC, were sold to Emmis Broadcasting Corp. for \$121.5 million. GE has one station left, KNBR in San Francisco, which is for sale.

Emmis decided to ditch WNBC's call letters and format and move in its WFAN, a local all-sports station that held the less desirable frequency of 1050.

About 50 WNBC employees, including its on-air personalities, have known since February they would be out of jobs, but none jumped ship ahead of time, said general manager Peg Kelly.

"People sort of want to be here for the end," she said. "No one's thrilled about it; no one even likes it. But it's kind of a piece of history, and people want to be here for

WNBC said goodbye with a 90minute retrospective program Friday featuring clips from programs with Benny, Hope, Allen and Fib.

ber McGee and Molly.

NBC also had such classic shows as "Amos 'n' Andy," "Your Hit Parade" and "Information, Please." There were also the original soap operas, like "Ma Per-kins" and "Mary Noble, Backstage Wife."

The station, then owned by AT&T, went on the air in April 1922 as W2XY. It became WBAY in July that year and was changed to WEAF the next month.

RCA bought the station from AT&T for \$1 million in 1926 when it formed NBC to help sell the radios it was making, but it didn't change the call letters to WNBC until 1946.

The first radio commercial was broadcast on WEAF on Aug. 28, 1922, when a real estate developer paid \$100 for a 10-minute announcement to advertise apartments.

"Up to that point radio was for experimenters and people were still thinking of ways to make money with it," said WNBC pro-gram director Dale Parsons, one of those losing a job.

The Reference is an indispensable guide to what was reported the last three years, and where to find specific information about the receptions.

## WNBC R.I.P., 1922-1988

It's all over! They pulled the plug yesterday on WNBC-AM at exactly 5:30 p.m. — after 66 years of broadcasting. The call letters and the familiar NBC chime (the notes 6, E and C) have been sent to the archives. All that's left is "Imus in the Morning." which will heard on the same dial position (660), but as part of the new lineup of WFAN, which has moved down the dial from its former home at 1050. That position was taken over by the Spanish Broadcasting System (WSKQ), which subsequently made a swap deal with the Jewish Forward's WEVD (97.9 FM). That switch is expected to take place Oct. 21. In the meantime, Spanish music will be played on 1050 under the call letters WUKQ.

WNBC's history dates back to 1922, when it began as an experimental station, W2XY. The call letters were changed to WBAY when the owners received a permanent license. Later, it became WEAF and then WNBC. For a while, it was known as WRCA (a nod to the then-parent company, RCA) and switched back again to WNBC in 1960. Its roster of personalities ranged from Jack Benny and "Amos "n' Andy" to Wolfman Jack and Elg Wilson. On hand for yesterday's finale were Bill Cullon, Gene Rayburn, Ed McMahon, Lee Leonard, Bob Fitzsimmons and Buffalo Bob Smith, among others. Imus himself performed the ceremonial switch throwing, out at Shea Stadium, after which WFAN took over with its regular sports coverage.

I got to one convention this past summer, that of the NRC in Milwaukee, where it was great meeting many IRCAns as well as NRCers. I particularly enjoyed seeing again our distinguished editor of this section, who lives "around the corner" from the NRC's convention site. (It was only 20 miles each way, hi-rce) Now that you've shaved the beard off, Rich, you no longer look like my cardiologist, hi! Greetings from ol' Mizzou! I arrived here on August 26 and pretty much settled in. My parents are still back on Long Island and are planning to move to New Wells, MO on or about October 28.

The dorm, Mark Twain Hall, is located on the corner of Stewart Rd. and Fifth St., and is a 7-story concrete and steel DX block-buster. It's one of two air conditioned dorms on Campus and has a private swimming pool and is wired for CATV. Those are the good points. The University power plant is located across the street, which I'm sure isn't helping the DX, which is just about non-existant. I'm picking up quite a bit of electrical hash which could be either the power plant or the CATV or a combination of both. The rig here is the Bearcat DX-1000 and the antennas are the Palomar Loop and about 60 feet of wire going around the ceiling of the room. Hopefully by the time the winter DX season rolls around I'll be set up DX-wise. I'm looking forward to the challenge of a new QTH. New York wasn't bad for DX and I had quite a few good catches from there. The one thing I'm sure I'll miss is the morning show on WWVA, which I doubt will make it out here.

Does the FCC have any regulations anymore on the mileage separation between AM stations on adjoining frequencies. I'm talking about the assignment of WKKQ 650 Hibbing, MN and WVAL 660 Sauk Rapids, in the same state. The separation between the two is about 125 miles if the two transmitters are located in each city of license, which I doubt.

WKKQ transmits a strong signal that was able to reach Denver daytime when it first went on the air more than two years ago. It can't be heard daytimes now inasmuch as KUUY Cheyenne, WY shifted to 650 about a year ago.

KUUY was on 870, 20 kHz away from Denver's KOA, and KOA found that it was interfering with reception of KOA in the Cheyenne area. The mileage separation between the two stations is about 110 miles.


So, KOA footed the bill for the KUUY expenses involved with moving to 650, and the FCC gave its approval. I have no idea what KUUY's costs amounted to, but I doubt if the FCC of ten years ago would have permitted that kind of transaction between stations.

But back to Minnesota: WKKQ and WVAL cannot help but interfere with each other. Could 10 kw stations in Albany and New York on the same two frequencies coexist without generating lots of mutual interference. Those two places are about the same distance apart as the MN pair. (Yes, Gene, go 90 more miles and two 50 kw station exist on the same frequency and don't interfere with secondary coverage area. And Albany to New York is 90 mi-RtH)

What we have learned from all this, I suppose, is that 110 miles apart is too close when the stations are separated by 20 kHz, but 10 kHz separation is enough when the two stations are 125 miles apart. I will just continue to believe the FCC is staffed by lunatics. 73.

# SOME THOUGHTS ON A SUBTERRANEAN ANTENNA SYSTEM FOR BCB DX'ING

Having moved into a new home this year I was afforded the oppurtunity to set up a whole new antenna system. As I listen to frequencies as wide ranging as 500 KHZ to 30 MHZ I needed an all purpose antenna. Upon moving into the house I put up a long wire in the basement to use until time and the weather permitted me to work outside. After a delay longer than I had planned I was able to put up an outside 140 foot longwire. It worked very well, in fact too well below 2 MHZ as I had very large problems with over-loading and spurs and birdies and all manner of images that I did not need in my life. Now I had been using the indoor wire and had not experienced these problems as badly as with the new out-door antenna. I decided to do a bit of experimenting with the two antennas and even threw in my 3 foot passive loop to keep things confused. All three were put into a n antenna switch so I could do instant comparisons of the frequencies I was listening to. I noticed several things: 1- The 140 foot outdoor long wire gave me the strongest signals.
2- The 140 foot outdoor long wire gave me the most images and spurs. 3- The 100 foot indoor long wire gave me signals that were about 3 S units lower than the outoor antenna. ( I used the S-meter on my R-70 as a unit of measure.)

4- The 100 foot indoor long wire had very few if any images or spurs un-

til the sun was fully up.

5- The 3 foot loop had the weakest signals of all but did allow me to null out stations and was more useful in pulling out stations that were weak. 6- That the 100 foot indoor long wire is very good on the graveyard frequencies where the directionality of the loop is not always a big factor.

I will at this point mention that neither the 140 foot outdoor nor the 100 foot indoor long wires are straight. The out door wire is a "U" shaped antenna that is about 18-20 feet off the ground. The basement wire is a 100 square shaped antenna. It is wound around the entire outside wall of the basement. I built it in the following manner: First of all I attached a coax connector to a 10 foot length of 50 OHM coax. I always use at least 10 feet of coax to feed any antenna to shield it from all of those wonder city noises we are prone to. I then started to run the wire ( I used plain old lamp cord about 18 guage coated ) around the basement. I attached the two wires from the lamp cord to the center of the coax. I attached nothing to the coax's braid as I found that it cut the signal strength by about 1-2 S-units. I used a staple gun to staple the wire to the floor joists as I ran the wire around the basement. By around I do mean around as the wire starts and ends in the area of the basement that my equipment is in.

Now I am sure that the antenna isn't perfect. Far from it but it does an adequate job and is very cheap. Also to my wifes delight it is almost invisible. I have two other thoughts about such an antenna. First of all it might work well outdoors if it were to be buried under the lawn. I at this time have no intentions of digging up my new lawn as I have put too darn much work into it. You would however have to use a wire that could be buried and be water proofed so as not to rot or short out.

The other idea and it is one I may try out this winter is to leave a length of wire on the ground in late fall and allow it to be buried by the snow. This wire would also have to be coated so as not to short out. Since prime DX time is the winter why not let Mother Nature do the burying for you. As for you people in warmer climates that don't see snow I suppose you will have to dig just like we do after it snows. It will make us even.

I hope that this short little piece proved to be, if nothing else, food for thought. I am not big on therory nor do I have a background in electronics but over the years I have found antenna building to be a " Black Art". That is to say it may work for you for reasons beyond explanation but it won't work for others. You will just have to try experimenting to see what works for you. Have fun and good DX.
