When you see a new station whose CP is denied or request for extension of time is refused, don't get your hopes up that the CP is a moot point. Even though the decision sounds final, a licensee can and usually does apply to have the decision reversed, and those applications are often granted...and, of course, if a CP truly is revoked, anyone else can come along and apply for the same or a similar facility. The effect of one of these denials is usually to delay a new station's appearance - not a permanent cancellation.

### TRIVIA QUESTION OF THE MONTH

KPLA

Some housekeeping from past questions...Bill Hardy notes one other set of formerly co-owned clear channel stations: Westinghouse Broadcasting owned both WOWO-1190 Fort Wayne and KEX-1190 Portland until selling the latter in 1962....he also correctly points out that the Columbia River has its headwaters in B.C., not Montana (and I've been misreading my atlas all these years!)...TOM LASKOWSKI of South Bend took a stab at October's question that arrived just after I mailed off the November column--he nailed WSEA-900 Georgetown DE but missed the Alaskan on 1450. Anyone can send in their suspected answers to any of these questions, of course, and, hey, contribute some column info if you can, too...thanks!

Answer to November's question: The ten pairs of doubled frequencies I've found are: Birmingham AL (610/1220); Washington, DC (630/1260); La Grange GA (620/1240, only two stations in the city); Baltimore MD (680when it's on the air/1360); Binghamton NY (680/1360); Knoxville TN (620/1240); Nashville TN (650/1300); Edmonton Alta. (two pairs! 630/1260 and 740/148 St. Catharines Ont. (610/1220, only two stations in the city). Anyone know of any others?

There are, of course, other types of harmonics that give lousy AM receivers fits and are thus usually avoided. One is stations separated by 910 KHz; another is stations equidistant from 910 KHz on either side of the AM band. For example, before KANN-1120 recently moved from Ogden UT and 1090 KHz, Ogden had an equidistant harmonic (730/1090 both being 180 KHz from 910). I found eighteen of these equidistant harmonics, and twelve cases where stations licensed to the same city are 910 KHz apart. Same rules as last month: must be licensed to the same city, not just in the same area.

The ambitious (or those truly bored with a non-IDing test tone at 2 AM) can come up with all thirty pairs if they like, but I'll confine myself to two brain-teasers:

- 1) Only one AM in the U.S. or Canada is a party to  $\underline{both}$  of these types of harmonics it has companion stations 910 KHz away  $\underline{and}$  equidistant on the other side of 910 KHz. Who?
- 2) Before one of the four stations involved changed frequency and city of license in the mid-70's, one unfortunate AM had all three types of harmonic interference: a station on its doubled frequency, one 910 KHz away, and one on the opposite side of 910 KHz. Who?

MISCELLANEOUS NOTES: Steve Mittman characterizes the new format of KIIS-1150 Los Angeles as "all rap," which is a bit different than the dance/funk description we gave last month; and notes that the new owner of KAZN-1300 Pasadena CA (ex-KWKW), scheduled to come on with KWKW's move to 1330 in early January, owned KFAC-1330 until a couple years ago. Sort of a time-release capsule version of a station swap. Also from Steve, this ID for the new KVEG-840-NV: "500000 watts" serving the west "from the tundras of Canada to the deserts of Baja California." These bozos wouldn't know tundra (or CKBX) if it bit them in the transistor... Speaking of tundra, scratch that apparent frequency move for CHAK-860 Inuvik NWT, reported a while back in Robert Kramer's travels through the area. Apparently his 690 signal was an LPRT & CHAK remains on 860 KHz.

Another new satellite radio format (yawn): Satellite Music Network has unveiled its third rock oldies format after Pure Gold and Heart & Soul. This one is "Kool Gold," concentrating on 1955-1963 (pre-Beatles) rock era. It's run from the studios of KOOL-960 Phoenix AZ; other early affiliates are KQUL-1590 Seattle and WKLL-590 Wood River IL. And a familiar voice returns to the overnight airwaves in an unfamiliar format - Wolfman Jack has signed to do the 2200-0100 (Eastern) shift on the newly 24 hour Nashville Network, a syndicated satellite country music format that has already been airing overnights. Check out Wolfman on WSM-650 - it's a howl...(hi)...another new business news network, the

Boston-based Financial Business Network, is now scheduled to debut in February. That makes three business news formats and counting.

Bill Hardy wonders why I haven't been running more info on syndicated programming (e.g., Casey Kasem's and Watermark's new countdown shows, Tom Snyder's ABC talk show, etc.) I'd love to, but I can't be everywhere--I don't subscribe to trade publications which carry that sort of info, so if anyone wants to pass it on to BI, I'll be pleased to run it!

The FCC has suggested a couple more interesting technical changes for AM stations...including a newer, more generous way of calculating nighttime interference patterns and allowing class II and III AMs to waive city of license coverage and minimum operating hour requirements in applying for separate day and night antenna systems. And, they nixed a technology, concluding that the performance of experimental synchronous transmitters thus far does not warrant their permament authorization - but (go ahead, you explain it!) the dozen or so synchronous xmtrs already on the air will continue to operate and the FCC will continue to accept new apps.

More tidbits: following the fine lead of the FCC, we typoed WKTP-1590 last month as being in Johnson City TN. It's in Jonesborough TN. Hot breaking lukewarm kinda flash from the CRTC: CHRL-910 Roberval PO has applied to simulcast CKAC-730 overnights. (Now, if only they'd choose to relay KMJC-910 instead, So. Cal. DXers would have a much easier time logging Quebec...) More license revokations: KKZU-1510 Mountlake Terrace WA (off the air since 1984 or so) and WMJM-1490 Cordele GA + FM (circa 1985) are gone, and KRGL-1360 Myrtle Creek OR (off since Sept. 1986) has been ordered to show cause why its license shouldn't get the heave, also.

Finally, to point out the obvious,  $\underline{\text{Broadcastinq Information}}$  is getting to be a very long column that costs IRCA a good deal of money to print. It's longer this time due to two additional weeks of material and lots of DX season contributions, but on average it's running five or more pages a month anyway. Is BI worth this much DXM space, or are there parts we should consider trimming or condensing further? Your feedback to me or to bp - is appreciated. (And thanks again for the support!)

### Proceedings 1988 Review

An entirely new concept in the list of publications for DXers is fine tuning's new book Proceedings 1988. This book was designed to fill the need for an in-depth study of various subjects pertinent to the short wave hobby and is targeted at "hard core" short wave listeners. Several articles are of interest to medium wave DXers as well. John Bryant, fine tuning's special publications editor, pulled together a myriad of "experts" from the ranks of the club to write on various subjects of appeal to the short wave listener. Each article was written by one or more of these experts and then reviewed by an eleven member editorial review panel for content, grammar and intelligibility.

The book is 8 1/2 by 11 inches, plastic spiral bound and about 3/4 inches thick (there's quite a bit of information in there!).

Proceedings 1988 is divided into five main divisions: Propagation, Antennas, Receivers, Peripheral Equipment and Computers, each of which has from one to eight articles. In addition, there are four special features at the end of the book.

The Propagation section consists of the "Terminator Mechanics and Trans-Polar Solar Blanking" article by John H. Bryant. This article describes, in detail, different types of maps that are available and how to use them to determine the terminator, and clarifies how such knowledge can help or hinder your foreign DX. It also explains how Trans-Solar Blanking can reduce DX target areas. This knowledge is a must for any medium wave DXer interested in foreign DXing.

The Antenna section consists of three articles. "The Delta Loop, an Alternative Antenna for Tropical Band DXing" by David Clark, describes the use of a triangular shaped antenna to enhance Tropical Band DX, its considerations and construction. There is considerable discussion on polarization, noise response, and radiation patterns as well as comparisons with other antenna types. There is even an extensive explanation of impedance matching and lead in, as well as some discussion of the results of the antenna's use. The second article in this section is "A Ferrite Rod Shortwave Antenna" by Chuck Bolland. This article describes the construction of a small ferrite core antenna that can be put almost anywhere. Several suggestions for placement are made, plus detailed discussion on lead in. The third article is "Impedance Matching a Beverage Antenna to a Receiver" by Nicholas Hall-Patch and John H. Bryant. This article describes John's experiments with Beverage antennas and impedance matching, with some technical inserts by Nick. It also includes the results of the experiments in the form of graphs, and schematics. Any medium wave DXer that has, or is considering, a Beverage antenna will benefit from this article.

The Receiver section consists of six articles. "Just Because it Has Handles Doesn't Mean it's a Portable, An Informal Review of the HQ-150" by Dan Sheedy heads the list. This article talks about the set that Dan purchased, sent off to be worked on, and now uses. There are many details on the specifications for the HQ-150, as well as some examples of DX with it. The second article is "Sizing Up the Hammarlund HQ-180 in the 1980's" by Mitchell A. Sams. This article, like the first one, describes the author's set that had been completely gone through and "tweeked" for perfection. Specification information and discussion of operation is included. Third is "A Highly Modified HQ-180 Versus a Modified NRD-525" by John H. Bryant. This short article is a side-by-side comparison of two excellent receivers from a subjective point of view. Sensitivity, selectivity, audio and stability are discussed. "A Review of the R-390A Receiver" by John R. Tow follows. This article, in detail, describes the receiver, its controls, and use of this fine set. In addition, there is a complete description of how to find a set and get it in tip top shape. There is an addendum by Kevin Atkins on "Why I Love My R-390A" which describes a comparison of the R-390A with an ICOM R-70. "Once a Good Receiver, Always a Good Receiver: The Drake R7 Communications Receiver Revisited" by Jerry Strawman is next. This is another detailed review with many specifications. Also included is an in depth discussion of the radio's features. Last on the list is "The Japan Radio Company's NRD-515: A DXers Perspective" by Kirk Allen and David Clark. This article discusses the features and use of the radio, with some practical examples of tuning around. This section on receivers, although not focused on medium wave, has some valuable tips for those medium wave DXers in the market for an excellent receiver.

The Peripheral Equipment section consists of eight articles. "Antenna Tuners: An Overview" by John R. Tow heads the list. This article describes several different types of tuners and discusses the pros and cons of each. "Constructing an Antenna Tuner with Plug-In Toroidal Cores" by Chuck Bolland talks about the construction of a "T" tuner that has plug-in coils for band selection. The next article, "Two Tuneable Pre-Amplifiers by Ameco: The PLF-2 and the TPA-1" by Jerry Strawman and John H. Bryant, is a detailed review of both pre-amplifiers. "A Close Look at Two of the Best Portable Cassette Recorders" by Fritz Mellberg, John H. Bryant and R. Charles Rippel discusses the Marantz PMD-220 and PMD-221. These are two "professional" model portable cassette recorders often used by DXers. Each type is reviewed for features and hands-on use. R. Charles Rippel provides a detailed technical review for the PMD-221, complete with measurements on tape speed, frequency response, 3rd order distortion and signal to noise. The next article, "Audio Filtering: A Variety of Approaches to Improved Audio" is by John R. Tow. This article discusses the advantages in adding an audio filter to a radio, with some suggestions on how to find the right filter. "The Autek QF-1A: An Active Audio Filter" by Jerry Strawman is a review of this commercially available audio filter. It includes specifications, schematic and response curves, as well as some hints for its use. The next article is "The Ultimate Shack Clock" by John H. Bryant. This article details the author's search for the perfect clock, and how he found the Seiko World Time Clock. The last article in this section is "The Heathkit HO-13 Hamscan: One Way to Watch Your Radio" by Jerry Strawman. This article describes the Ham-Scan unit which is attached to the Intermediate Frequency (IF) of the radio. The unit then gives the listener a picture of the radio's frequency response around the IF. There is also some discussion about how it is used to DX, and techniques used for attaching it

The Computer section consists of two articles. "Miniprop2 and Lowband DXing: A Review of Two Propagation Prediction Computer Programs" is by Mitchell A. Sams. This article describes the two programs in detail, with many examples of their use, and includes several sample outputs. Also included is the information for obtaining the programs. These programs can be used by medium wave foreign DXers to get a better understanding of the conditions necessary for DX. "Writing Reception Reports Using a Personal Computer" by Jerry Berg rounds out the section. This article describes a structured approach to reception report writing with a PC that focuses on standard forms with many examples of their use. This article is a must for anyone who uses a computer to write reports.

The first Special Feature is called "DXing New Guinea" by Dr. Harold Cones, R. Charles Rippel and John H. Bryant. This article is a complete description of New Guinea history; political and weather environment; and the people of Papua New Guinea and Irian Jaya. Also included is a very detailed description of each short wave radio outlet, and pointers for hearing them. There are some detailed maps, sunrise/sunset times, as well as last minute information on the new frequency plan which took effect on September 5. It is a very thorough article for those interested in DXing New Guinea.

The second Special Feature, "Radio Southern Highlands" by Jack Bata (Station Manager) is somewhat shorter. Some pictorial information is included, as well as various details about the station's schedules and programming.


The third Special Feature is "In Progress... A Report from the Committee to Preserve Radio Verifications" by Jerry Berg. This article outlines the thrust of that ANARC committee, which has been working since late 1986, and outlines the tasks that are being done at this time. There are six pages of verifications, some very rare, from the committee's archives.

The fourth Special Feature "A Resource for Shortwave Broadcast DXers: Medium Wave DX Publications" is by John Bryant. An introductory article explains John's search for information and discusses the different types of information available from the medium wave clubs in the areas of antennas, propagation, receivers, peripheral equipment and tuning strategies. This is followed by a special edition of the IRCA Reprint list. John Bryant reviewed all the IRCA reprints and selected those to be of interest to Shortwave listeners. The results were then compiled into a special listing of reprints.


A detailed biography of each of the major authors is next, followed by a short insert about fine tuning's other DX publications.

They drank their hot cocoa and ate Oreos,


Then wiggled their "ears" and rubbed on their noses,

### THE RIGHT STUFF

To be a DXer

by Glen Kippel

To be a successful DXer, a number of items are necesary. Some are optional, but most are absolutely essential to the hobby.

To begin with, a radio receiver is usually necessary. Unless, of course, you happen to have a very sensitive gold filling that could possibly demodulate radio waves. A communications receiver is generally considered superior to others. More than one receiver is nice to have, as one could be running into a recorder while you are hunting up another station with the other.

You will also need an antenna. Portable radios (and some others) have a built-in antenna. This has some directional effect, and rotating the radio will sometimes cause a strong station to fade out, revealing other stations. An outside antenna will give increased signal pickup and is generally necessary with a communications receiver.

A cassette or reel-to-reel recorder is a handy device to have for recording what you hear. It is especially useful to play back that ID you didn't quite make out the first time. The simplest way to connect it is across the volume control — across the terminals that are farthest apart. If it doesn't work the first time, reverse the connections. This mode of hooking up a recorder will provide a constant level unaffected by the setting of the volume control. Use shielded cable, of course, and if you are plugging into the MIC input on the recorder, an attenuator (Radio Shack 274-300) will be necessary.

You will definitely need a few pens and a couple of spiral note-books. Use one as a chronological list of what you hear. Write the date, time station, and programming notes and other remarks. The other notebook should be divided up by two 10 kHz channels per page, both sides of the page. This will be a listing-by-frequency of what you hear, and it will be one of the most valuable tools you will have. List the frequency, call, slogan, city, state, country, and format info, and perhaps the time you heard it.

If you want to, you could replace this notebook with a computer system — at considerably more cost. You could go bonkers and get an AT with a megabyte of RAM and a hard disk, but a practical system would be an Atari 800XL or 130XE, disk drive and a printer. You will need a color or monochrome monitor or use a black and white TV that you don't have much other use for. I use a data manager XL for a database and it works pretty well. Synfile+ is also decent and sells for under \$35. The whole system comes in at about the same price as an IBM-compatible software package such as Dbase III.

You will need to know what those stations are out there, so a few current station listings are pretty important to have around. For foreign DX (and to a more limited extent, domestics) the World Radio TV Handbook is a must. For stations in the US and Canada, a listing such as the NRC Log or Broadcasting Yearbook is preferable as it lists all the low-powered stations that aren't covered in the WRTH. Of course since stations keep coming on the air, you will need to be a member of the IRCA to keep up with the latest developments.

Headphones are useful so you can listen to the din of 174 stations on 1400 kHz and not disturb the rest of the family. Stereo headphones may have too broad a frequency response and will give you a good deal of noise in addition to the signal you want to hear. Headsets designed especially for shortwave listening/DXing are better. Mine have been cobbled up from a Navy surplus headband and a pair of Western Electric U-1 units, the same as are in most telephones, and are the best I've ever used.

You probably will need a table to hold up the receiver, notebook, etc and a chair to hold you up. However, I started out DXing with the receiver on the floor and survived, so you could too.

Proper lighting is helpful so you can read your log, station lists, etc. If having a bright light on in the middle of the night is bothersome to the rest of the family, use a desk lamp with a low wattage bulb. Better yet, get a variable transformer (not a solid state lamp dimmer — they generate too much interference) and plug your lamp into it. Sold in most places which cater to the TV repair industry, you could ask for a "Variac" and they would probably know what you wanted. Another technique borrowed from the aviation industry is to use a lamp with a 25 watt red bulb. The red light does not affect you night vision as much as white light. I have used these for years when mixing large concerts and other sound-reinforcement gigs and it works well.

Some snacks are helpful to keep you blood sugar up during long DX sessions, and these will be discussed in more detail in the forthcoming article, "DX Snacks".

Now to the appropriate attire for the master DXer. You will need a good heavy-weight, velour robe to keep you warm during those long late night DX sesssions. Cotton flannel pajamas are also a must. Consider some comfortable, well-worn, terry cloth slippers too.

Consider getting a dog to lay on your feet and keep them warm. Remember, the best DX is in the middle of the night, in the middle of winter! And a cat to lie on your lap is nice too, provided it doesn't purr too loudly.

Now you're all equipped, what do you do first? Well, first pick a Saturday or other day that you don't have to work, and start at the bottom end of the dial and tune up, logging each station as you go. Around 10 AM to noon is a good time to do this. You will get acquainted with your local and semi-local stations and add them to your totals. Most of them will be on at night, so you will be able to recognize them and know they aren't really exotic if they happen to be really hardf to hear later on.

Your next step is to tune around in the evening, say 8 to 10 pm. You will be able to hear some of the stations on what formerly were clear channels, and get to know how to recognize them. Most of these stations you will consider "pests" later on, but right now you are getting familiar with the band and building your station totals.

Next, try tuning around the band — especially the top half of the band — just before sunset to an hour or so after sunset. There will be some stations you will hear at this time that you just can't hear any other time, and sometimes conditions will favor a specific area one day and another the next. East—coast DXers may also be able to dig around between the 10kHz channels we have in the US and hear some highe powered Europeans and North Africans. Now we're getting down to some hard—core DXing!

Once your familiarity with the band is pretty good, stay up past midnight some night — especially a Sunday night — and see what can be heard. Monday morning is traditionally the time some staions go off the air for maintenance — changing tubes, sweeping Black Widow spiders out of the antenna tuning units and so on. Not as many stations go off at midnight as they did a few years ago, but the band may be somewhat less clogged up with your local and semi-local stations. This will provide opportunities to hear some otherwise unhearable DX. From the east coast, US stations further west may be heard before they sign off. West coast DXers will have a bettewr chance at logging Hawaii, Alaska, Australia, New Zealand, and the Far East.

Finally, the time just before dawn can provide some really interesting catches, as stations to the east will be signing on, then fading out, allowing stations to the west to appear.

### SOME RANDOM THOUGHTS ON A LISTENING POST SET UP BY SHAWN AXELROD

Over the years I have tried various set ups to suit my listening as well as my living situation. This has ranged from my bedroom at home to my present radio room in the basement of our house. I have never come up with the perfect layout yet but I'm getting there. Now I do not want anyone to think that I am an expert at this or that what I say is written in stone. It is just some ideas that I have come up with over the years.

1- Get a comfortable chair. What ever you find to be comfortable is up to your tastes. I use an old armed tilter chair. One thing I will recommend to you is that you use a padded chair (especially if you are like me and don't have any padding HI!!). Also try to avoid chairs that have leather or vinyl seats and backs as they will make you sweat and get uncomfortable after a while.

2- If you are short on space and long on equipment try purchasing new or used a computer table or desk with a hutch. These are designed to take several pieces of equipment but are set up in such a way as to be user friendly. I am at this time using one that allows me to have my ICOM R-70 and the external speeker on the shelf that was designed for the monitor. To the side there is room for a clock and books and my tape recorder. All of this leaves the desk top clear for log books target sheets and the candy dish. Hey a guy's got to eat.

3- When placing your equipment no matter where try to keep the pieces as close to you as possible. If a piece of equipment gets put up on a high shelf the odds are it will go unused. If you use a table top receiver and it is digital read-out keep it at an angle that makes operating it and reading the numbers easy. I've always kept mine on a slant with the front 2-3 inches higher than the back. Just seems easier to get at those little buttons.

4- Have some decent lighting. In case you haven't noticed you DX during those hours that the sun is down, just going down, or just coming up so you need extra lighting. I prefer a lamp to a ceiling light because I can adjust it to shine where I want it. You don't want a glaring light or Flourescent lights because the latter will cause noise on your radio. I have been using a lamp with a red light bulb the last while as I found it gives off a soft glow that is not hard on the eyes, but suit your self.

5- Keep a sheet of paper with your targets on it and keep it near your log sheets. You can organize these targets by frequency or by the best time to hear them. I have also gotten into the habit of taking a highliter pen and marking off the stations I have heard in my NRC logbook. That way I can look at a page in the logbook and know in a flash if I've heard that station before. Also by going trough the log you might spot some stations that you thought you had but did not or stations you should have but do not. By the way if you go for the red light in the lamp don't use a yellow highliter pen as the yellow disappears (This is the voice of experience HI!!).

6- If you have your choice ( you should be so lucky ) of where to set up a listening post try to place it some place where you can run wires outside with ease. You may or not have a radio that needs grounding or you may at some time wish to set up an antenna outside. It is a lot easier if you are at an outside wall or if in the basement near a ready made hole in the wall. By that I mean a drier vent sump pump line etc, where the house builder has cut a hole that you could use to run wire outside. Drlling through a few inches of concrete is not a great deal of fun.Trust Me!!!!

7-Try for a place where you won't bother or be bothered by others. Now if you have children as I do there is no place they will not bother you!! On the other hand if you are in an apartment it might be better to be in the living room than in the bedroom. This is from personal experience. My wife rather have " That Stuff " in the living room than me in the bedroom with a light on at 3:00 A.M. listening while she and " The Rest Of The NORMAL People" were asleep!!! This is supposed to be a hobby not a way to get out of a marriage HI!!!

Well think about it and try what you feel is appropriate to your situation and I wish you the best of DX in a nice comfortable spot ( not the tub you goof, you could ruin the radio!! )

Hello again. I've had some time lately to do some DX'ing and in the past two or three months have upped my loggings from 369 to 455. A lot of those have been call changes, though.

Some news: local KYOS and KMYT (FM) has been sold, and there may be a

format/call change in the offing.

A note for Jim Hall and any others trying to ID the TP on 738: Tahiti is typically poor modulation except when they s/off they crank up the French

national anthem pretty loud. Try then (0930 UTC according to WRTH).

Ever try DX'ing with a 250-foot vertical? One night when doing some maintenance for KSNN (FM) I took along the RAX-1, intending to hook it up to the FM antenna transmission line on their 500-foot tower. Well, unfortunately my repairs took much longer than expected, and just before dawn I hooked on to and unused STL transmission line that goes midway up the tower. Nothing new heard, but XEVQ 830 was pounding in. Long vertical antennas reduce the signal coming in from higher radiation angles (i.e. favoring long-skip rather than short-skip signals) and can produce some interesting DX. I once heard

Peru on 854 from Sterling, CO with KOA 850 on, for example.

There was a ham in New England who lofted 1,100-foot verticals using box kites (two at the top and one in the middle). Balloons filled with hydrogen or helium work well in areas without enough wind to loft a kite. Watch out for airspace clearances or some airplane may snag your antenna! (When you can read "United States Air Force" without squinting, you know you can't

raise a vertical antenna, hi. Mather's close by to me-RtH.)

An interesting idea to save the AM band is from George Yazell, an engineering consultant in Lakeland, FL. He suggests using narrow-band FM on the MW band. Any transmitter is already FM and AM modulated simultaneously. If it's an AM transmitter, it's called "carrier shift" and in an FM transmitter "AM noise." Anyway, he suggests using a first IF of 430 kHz, then multiply-ing by 25 times to get an IF of 10.75 MHz. A 428 kHz would give an even 10.7 MHz. The frequency response, signal-to-noise, capture ratio, etc. would be the same as the VHF "FM" band. The stations could broadcast both AM and FM simultaneously until enough receivers were available to receive the FM component. Older AM receivers could still demodulate the FM signal by tuning to one side and slope-detecting.

Another idea is to move the MW stations to an "FM2" band at 220 MHz, but that really gets into the problem of having receivers. Another idea is to use the longwave band in North America for broadcasting, as it is in Region I. But I don't see how either of these proposals would "save" AM broadcast-

ing. 73.
