Helping travelers tune in

If you like listening to radio when you're on the road but hate searching the dial to find your kind of station, Alicia O'Drago has the book for you.

It's called Radio Dial, O'Drago's compendium of more than 3,506 AM and FM radio stations in more than 300 large and medium-sized cities in all 50 states. The book, organized alphabetically by state and city, lists call letters, frequency and format for each station. It also tells whether a station broadcasts during the day, night or both.

Radio Dial was born out of a cross-country trip O'Drago took a

while back when she had a car radio that only received FM. Preparing for her trip, she could not find a traveler's guide to radio stations. So she created her own, "I like to tune in local stations, but I've never been able to figure out where to look or what they are," says O'Drago, a former elementary-school music teach-er who lives in Denver.

Radio Dial can be ordered from O'Drago's company, AMP Publish-ing, 456 Corona St., Denver, Colo., 80218. The price is \$9.95, including postage.

One weakness of Radio Dial is that it does not include public radio stations. O'Drago says she omitted them because they're covered in

another book - the Corporation for Public Broadcasting Directory, which is available for \$10 from the Corporation for Public Broadcasting, 1111 16th St. N.W., Washington, D.C. 20036.



from Franklin Roosevell's fireside chats, likes to air

shows were a way ne could regularly scratch them. Michael Deaver, ex-deputy staff chief, says the shows capitalized on a slow news day. "Regardless of how many listened on Saturday, on Sunday we usually made Page One of The Washington Post."



This week William P. Townshend has a Latins report for us. I also have some LADX this week but nothing spectacular -- most are not very rare but worth reporting from time to time. Much of the higher latitude TADX seems to have been weakened by continued solar flares lately (week of 15th). I did mention several issues ago that we have passed our sunspot minumum, so several days of relatively low A Index #'s from WMV might indicate possible propagation from higher latitudes. However, when solar flares are announced on WMV be sure to note the time as this usually is indicative of increased geomagnetic activity within the next 24 to 40-hours. The K Index #1s then can determine the intensity of possible auroral activity which produces the Latins. Usually, K #'s of around 4 or higher are equivalent to the storms associated with AUcx. 

Frank Merrill, P. O. Box 669, Macomb, Illinois 61455 Bon Jour! Who says that diligence doesn't pay off? Between that, my prior DX techniques and a lot room for very long antennas, I managed to sprint from ZERO to 1002 stations logged in less than 39 days! Is this some kind of record? My best antenna is the 1200-footer that is virtually WSW, and now on stakes to keep it out of the snow. Another 1200' wire going SF does wonders for SRS from the Southeastern US, and it brought my my first South American (total is now 3): Brazil-1280: I've heard this unusual "first" two or three times now; they're 200 kW with no other really strong Latins on the frequency. Their slogan is "tupi" (to urinate?) and, if your 1280 isn't blocked during Auroras, this may actually be the best Brazil bet from the Central or Eastern US, because most other powerful Brazilians (740, 860, 940, 1180, etc.) are blocked by other, nearer powerful Latins, usually Cubans or Venezuelans. Actually, Haiti (the only other Latin on 1280 with much power) is more common here during Auroras. Some people wrote me with comments like "I'm sorry to hear that you lost all your old logs, Frank", etc. All of my old logs are actually VERY MUCH "alive" and accessible; I only "lost" my old location. Moving nearly 400 miles west of my old digs, I started my totals anew. But, God willing, I'll still have my old logs 20 years from now, and I may even add to them occasionally in the form of DXpeditions when I revisit my former Toledo/Michigan areas. Am still trying to receive HI in Macomb, hi - but I feel there is hope because I thing I've heard adult contemporary music under WCCO, and I've definitely had religion far under WWL. I guess it could be KROL. Perhaps my 830 was XEVQ, which is heard here occasionally. I'll always feel fortunate that I experienced the end of the Golden Era of nationwide clear regionals on MM's (such as 1420 after KSTN s/off, 950, and 1460) when I lived 40 miles from Detroit. With only 40 feet of wire draped in a second-floor attic, I managed to hear Hawaiians and even-farther TP's, using a HQ-129X, between 1962 and 1965. My wire must've been near something that made it heavily favor the West, because I rarely heard TA's, and I even went 5 or 6 years without hearing WMID-1340 (a very common catch of that era) even once. Seven tea trees.

After several calls to Commonwealth Electric's offices in Hyannis, they finally sent a man in a truck here to try to trace this terrible buzz I've been experiencing every evening. Of course, when he came, the buzz was not on, but it soon started. He said he would be driving around the area looking for its source. He never did come back here to tell me if he did or did not find anything - and the buzz continued merrily on. I called again, and just before Christmas, Com Electric sent another fellow here and he drove around, and the buzz was in full swing. He came back and told me it was coming from a pole about one mile from here; that they would be back to fix it the next Monday. This they did, but in the meantime I drove up to where he indicated the trouble was, and I found the buzz disappeared as I got about 100 feet away from my house, but there were similar noises noted here and there along the way, on the AM dial. I had it on 540 kHz where very little signal is heard on the car radio. At the point where he said the trouble was originating, there was only a faint buzz on my radio! I again called the head honcho in Hyannis, and this time, a more experienced person came, and after driving around a bit, and then taking a hand-held receiver and walking the neighborhood, he came up with the answer! It was coming from the house directl across the street from me! He knocked on their door, was admitted, and there he found it to be some sort of intensity lamp whose glow can be raised or lowered simply by putting one's hand on it! These folks agreed not to use that lamp anymore, and they had had no idea it caused any problems. They are what I call "teleholics" - they never use their radio, but the TV goes from 0600 till whenever. When their son was on a radio program on WOMR from the school, they sent him over here to ask me where


on the dial WOMR was! So, I would assume, that as long as we stay friendly, I'll again be able to do some twilight DXing. I MAY have a lead on a used Hammarlund HQ-180 - more as it happens - or doesn't happen. I hope everyone had a great holiday season! I was driving home a few weeks ago and on the car radio heard 66 WNBC's "final farewell." The entire staff was gathered around for the final seconds countdown to the end. "What's that again?" you ask. Are you wondering how I possibly could have heard that on my car radio? Easy. . . a local FM station, KOLA 99.9 San Bernardino, played a tape of WNBC's final seconds on the air during their newcast that evening, hi (Steve, it wasn't too long ago you could hear WNBC on your car radio, hi-RHH. I was very sorry that the end had come to that very historic station and I was quite pleasantly surprised that KOLA's news staff also appreciated the "historic significance" of the occasion! Interestingly, KOLA isn't even affil iated with NBC - they carry (occasional) ABC news. If anyone happened to tape WNBC's end, please contact me. I would be interested in obtaining a copy of it, and can either pay you for the tape and postage or tape swap with you.

Speaking of NBC, in what might possibly be a FIRST - Los Angeles now has two NBC network affiliates. KrWB 980 had been L.A.'s only affiliate for at least ten years (maybe 15 +-), though they only carried selected NBC (and ABC) news reports during their all-news format. They never carried those networks at the top-of-the-hour five-minute newscasts. However, KMPC 710 has now also just signed up with NBC and they now carry the five-minute newscasts overnights and weekends when their regular news staff is off. This, therefore, marks the first time in many years that Los Angeles has had an affiliate carry the five-minute hourly newscast (even though it is only during obscure hours). Per call to KMPC, NBC now has two separate "feeds," ilar to ABC's separate network feeds, which is how L.A. (and presumably other markets) can have two affiliates. This is especially interesting (and newsworthy) in that once before NBC had two feeds (called the Red and Blue networks) and they were forced to sell one due to an anti-trust lawsuit. In 1943 they sold the smaller one (Blue) which became ABC. (Remember when KFI was NBC under Earl C. Anthony?-RtH.)

To tie up a couple of loose ends with the KGRB 900/KBOB 98.3 story: I was going through my files and found an old newspaper article from 1982 about KCRB's having just boosted its (daytime then) power from 250 to 500 watts.

Per the article, the correct spelling of the owner's name is Robert Burdette. The call letters reflect the initials of (Mr. and Mrs.) Gloria and Robert Burdette. KBOB is, of course, infromally "Bob." Also, Gary Larson phoned me and informed that he was mistaken when he reported in the same issue that KGRB's new night power is 250 watts. I'm sure, though, that one way or another, we'll eventually find out what KGRB's new nighttime power is - and then we can all write to Mr. Burdette and have our letters thrown in the trash bi (Better yet publish new nighttime power in DVM and send him a trash, hi. (Better yet, publish new nighttime power in DXM and send him a copy - to be thrown in the trash, hi-RtH.) More next week. 73 de SMM.

Not much DX happening here lately due to the birth of future DX'er Jeremy Ray Kippel on 19 December. Because he already is much more awake at night than during the day, he already has a built-in talent for DX'ing, hi. (Congrats, Glen - and you're suppose to be turning the dials while he's being fed, ya know, hi-RtH.)

The NAB's experimental "anti-skywave" project is being held up by the Prince George's County (MD) Planning Commission. When they get on the air, look for them at 1660 kHz with call sign KA2XXB and powers up to 5 kw. I

don't know for sure, but they may like reception reports. More later.

I was just thinking about the changes in DX'ing over the years. In the
'50s and early '60s there weren't nearly as many stations on the air as there
are now, and most of the fulltimers went off at midnight. Most of the remaining AN ers signed off MM for maintenance. Therefore it was possible to hear stations in Australia and Japan, even from the eastern part of the US (east of the Rocky Mountains, that is!), long before TP-land went to 9 kHz spacing.

Even as recently as 1982, there were a few US Clear Channels left and, from California, stations such as Radio Coro (Venezuela) on 1210 and Cuba 880 were heard almost nightly. Peru on 880 was also in fairly often, but not often enough to be a pest. But now? rorget it! (Don't forget Bolivia 1020-RtH)

Certainly the proliferation of interference from various sources, including broadcasters themselves, has been detrimental to AM listening and the

economic viability of AM broadcasting.

Now if George Yazell's NFR ("Noise rice Raulo," i.e. MW-FM) ever comes to pass, we may be able to hear lots of now DX. Here's how. At present, if you're listening to a GY channel with 157 stations skipping in from every direction, nulling one of them 20 or 30 db with a loop isn't going to help much. But with FM, capture ratio comes into effect. Whichever station is the strongest will be the one station which is heard. Nulling that by even a miniscule amount would make the next strongest station come in clearly. No more trying to make out that elusive ID amoung a Babel of other stations. (But Glen, that takes out the fun and challenge of hearing five signals on one channel and staying with the weakest one - and I also lie a lot, hi-RtH.)
MW FM would have a profound effect on DX'ing.
Thanks to Ben Peters in Holland for the beautiful card and comments on

large-aperture loops. 73 all.

Was told back last year by our engineer their pattern was supposed to be very tight to protect 1380. Also, after noticing KCTY 980 off after midnight recently, I called the station to see what's going on. They now s/off at 0000 PLT. Last year they were on a 24-hour schedule after getting the go-ahead to use lower power after sunset. Forgot to ask about s/on time, probably between 0500 and 0600 PLT. A few weeks ago with KCTY off I was able to hear KrWJ AZ under KFWB.

Being the stickler I am for details, I have a few loose ends to tie up from recent article on KFAC/KWKW/KAII. I mentioned a KNRC becoming KTM 780, then KEHE and finally KECA, now KABC. Let me offer you my pet peeve this week.

Because I've been a professional writer for more years than most members of IRCA have been around I pay close attention to spelling, the use of language, how abbreviations are formed, what is correct and what is not

So when I run across abbreviations like kW and kHz in the club publica-

tion, I wonder what is going on, why do they do it that way?

There's no justification in the language for the capital W in kW. No justification for the capital H in kHz.

Broadcasting magazine is quite close to radio and it doesn't use these weird abbreviations. I opened their yearbook and the first thing my eyes fell upon was the following:

"KCBN AM-Oct 30, 1963: 1230 khz; 1 kw-D, 250-w N, - that is a Reno statior but that's enough of the listing to demonstrate how Broadcasting handles thes

abbreviations.

I know what the argument is to justify the capital W in kW and the capital H in kHz. Watt was a person and his name is a proper noun and Hertz was a person and therefore his name or its abbreviation should be capitalized.

Neither one of these contentions makes any kind of sense - every dictionary I know of spells watt with a small w and hertz as a unit of frequency is spelled that way, a lower case H, in my 15-pound Random House doctionary

published about 15 years ago.

There's a guiding principle in the English language that whenever a proper noun becomes a well-known word the former capital letter is dropped. Gerry was a former Massachusetts political figure, but gerrymandering is spelled with a lower case G. Maverick was a Texas cattleman but maverick is spelled with a small M. Bikini was a place and a proper noun before it became a bathing suit with a lower case B. Vulvan was a proper noun but vulcanizing drops the capital V.

Volta was a person and a proper noun but voit is spelled with a small V. Samuel F.B. Morse invented the telegraph, but we spell it morse code, minus

any capital M.

There are thousands of examples like these in our language, where the capital letters once attached to a name are dropped when the name becomes a

part of ordinary speech. Can't we remove etymological monstrosities like kHz and kW from the club pulication? (Gene, I've always used kw and still prefer kcs as opposed to kHz - cycles is what radio waves do - Hertz rents cars, hi-RtH.)

My recent visit to Sarasota, Florida 17-31 December provided lots of warm, sunny weather and good times at the beaches but unfortunately not a whole lot of good DX. Certainly no where near the amount heard during my '81 visit. There seemed to be quite a few new stations on the Clears, splatter was higher and not much was heard on the splits. Maybe conditions were down and probably I don't DX with as much intensity as I did in '81. The strongest split heard was R. El Salvador 655, heard quite loud and a good bet for the WC. The Caymans 1555 was also noted most evenings at fair strength. No audio was heard from any other splits although lots of weak carriers were spotted. The Cuban on 830 was very strong indeed from 12 to 24 December, pegging the S Meter and impossible to null. At this strength it should be widely heard. From 26 December until my departure it was either off the air or at greatly reduced power. The Turks and Caicos outlet on 1570 was extremely strong at night and should also be widely heard. They ID'ed as the "Atlantic Beacon." In '81 KFI 640 and KNX 1070 were both eaily heard with good signals in Sarasota, but there was no sign of them this visit, the co-channel QRM was too strong.

Greetings from Pike's Peak! After several months as an IRCA member, it's about time that I introduce myself. I'm 48, have been MW and SW DX'ing off and on since my grandparents bought a Zenith Transoceanic in 1948. I got my novice ham license in 1955 and have been fairly active in ham radio ever since, concentrating on VHF/UHF DX and contesting. But I always did some MW DX with whatever receiver I had at the time - the HQ 150, HQ 180A and SPR4 being my favorites over the years.

About ten years ago I joined NRC and logged over 800 MW stations in 42 states and 30 countries from Schenectady, NY during a four-year period using a HQ-180A, SPR4, SM-2, 160 meter dipole and 40-meter loop. From 1983-87 I was very involved in coaching x-c, x-c skiing and track, competing in running and skiing events and starting a new business. I sold my SPR4 and HQ-180A and MW

DX was on the back burner for a while, Last March my wife and I moved to Colorado about eight miles north of Pikes Peak. For the first time I had enough land to erect some short Beverages. But until late August I concentrated on TV, FM and ham VHF DX. Our 9,000-foot elevation is a pretty good VHF location and we ID'ed 21 states on TV, 20 On FM and worked 48 states on 6 meters and 23 states on 2 meters. My main MW interest was receiving Cincinnati Reds BB on WIW or other stations.

In mid-August I put up a short, unterminated E/W Beverage to try to get WIW before local sunset so I could hear more of the games. I started MW DX the third week in August using that antenna and the 160 meter dipole. My receiver is a Kenwood TS-430-S transceiver, adequate, but probably not as good as what I used in Schenectady. However, there I had several local powerhouses to contend with; here there aren't any stations within 15 miles. I

have many more "open" frequencies here.

After four months of fairly intensive evening DX and a few early morning and sunrise sessions, I've logged 516 stations in 36 states, most of which I've reported to Nancy Hardy. It's primarily a cerebral activity as I don't write for veries (my ham band QSL'ing takes an enormous amount of time and money). I also don't count call changes (with one notable exception - WNBC and WFAN). In fact, my logging is not so rigorous as those who don't log unless they hear the legal ID, and because I don't need a lot of info for a report, I usually "hit and run" looking for other new stations as soon as I'm sure of whom I've logged. However, because new stations are harder to come by now and because I realize it's more helpful to others, I try to record some significant info about stations I report.

For the past month I've been using two Beverages, both unterminated, a 1,000-foot NE/SW wire and a 600-foot WSW/ENE wire. They're both fairly straight, but low, even lying in snow in places. I have a coaxial switch by the receiver to easily switch between them and the 160 meter dipole.
