TRIVIA QUESTION OF THE MONTH

Answer to last month's two-part harmonics question: 1) WCHS-580 Charleston WV has a station 910 KHz away (WXIT-1490) and on the opposite side of 910 KHz (WVSR-1240); 2) before WAMB moved from Nashville to Donalson TN and from 1170 to 1160 KHz in the mid-70's, WSM-650 had stations on its doubled frequency (1300 KHz), 910 KHz away (1560 KHz) and on the opposite side of 910 KHz (1170 KHz).

For this month, we'll keep it simple (maybe!): In terms of population, what is the largest U.S. city without a currently operating AM station?

STATION SALES THAT PAILED: WREN-1250-KS

MISCELLANEOUS NOTES: Station switches: the sale of silent WREN-1250 Topeka KS to KTOP-1490 has apparently fallen through; on the other hand, WPEN-950 is considering buying WFIL-560 Philadelphia and moving to the better frequency.

The new station grant for 990 KHz in Miami replaces the old WFAB-990, whose license was yanked by the FCC nearly 15 years ago. The facility has been fought over ever since; meanwhile, power increases to the 980 in Pompano Beach FL (which now calls itself a Miami station) mean the new station won't be 50 kw and the two stations, only 30 miles apart, will interfere quite severely with each other throughout the metro area. Meanwhile, another new station replacing a previously revoked license, KRCK-1500 Burbank CA, is apparently still alive; there's been no word on them for several years, but this month they were granted reinstatement of their CP and an extension of time to build it.

Yet more on would-be offshore pirate Radio NY International: a Boston district court has granted the government an injunction against the ship and station operators. RNI had sought to prevent the injunction on the grounds that first amendment rights of free speech included the right to broadcast without a license. Incidentally, for those of you with long memories, one of the prime movers behind RNI, Alan Weiner, was the same guy who tried to set up a station in Yonkers NY on 1620 a few years ago, claiming he could do so through a station he legally owned, WOZW-710, in upstate Maine. Eventually the FCC pressured him to sell WOZW under threat of revoking WOZW's license. He's baa-aaaacccckk....





As I had hoped for, numerous recent January solar flares (mentioned last issue) seem to have been responsible for some extraordinarily good Latin American DX conditions at various times between 1/18-24. Conditions were quite good and have improved drastically enough to curb the MWA (Midwinter Anomaly - see cover DXM #15 Jan. 7). Although paths to most of Latin America were outstanding, Central America was seemingly in much better than usual with a few good ones logged here, like TGY-880 Guatemala City with their possible spur on 892.7a, and Zacatecas state Mexico on 890 among others. There were also a couple of intriguing unID's heard here, mostly via a 2000' beverage oriented to western South America/ eastern Central America. Belize-830 is still experiencing xmtr difficulties and are heard easily in the 825 area (spur) totally swamping usual St. Kitts R. Paradise on the freq. Anyway, (although I enjoy Trans Atlantic DX immensly too) 1989 looks like the year for serious Pan American DXing since we have passed our sunspot minimum and extensive solar activity is expected to peak as early as the end of this geophysical year (per Lee Dye in article in DXM #15 Jan. 7). George Hakiel-NY has also reported to me by phone a month or two ago that he is anticipating the improved Pan American conditions as well, so I trust we will be receiving many reports this year for the LA sections. At my deadline only Tom had reported this week, so any loggings without a credit at the end belong to your editor (or let's just say that Tom has loggings on 580 and 830 this week). Speaking of 830, the R. Taino Cuban has not been noted lately using the channel much -- look for this during Holidays or special occasions, such as the next big tirade from Fidel Castro which receives national airing on most Cuban AM's. To all who have sent Holiday greetings, a belated thankyou. Times and dates are UTC:

EDITOR'S NOTE: Regarding my loggings this week, I did quite a bit of extensive DXing (and taping of freq's on the automated recorder) which explains the host of loggings. However, to abbreviate the list most Cubans (and a few others like Cayman Islands-1205/1555, Antigua-1165, St. Kitts-555/825, Anguilla-1610 or Dominican Republic-1565) have been totally excluded because of commonplace reporting when heard often, and most of the information, especially Cubans, would have run at least another page. I can mention, however, that nearly every one of the nearly sixty Cubans. I heard last May (all frequencies were listed in the Aug. 6 #34 DXM) were heard at one time or another (I rake the band for them to keep the Cuban AM BC List updated), excluding a few such as 950, 1000, 1430 & 1560. A few new ones were noted, too, like 890-R. Musical Nacional. The memory & keypad entry on the ICOM make it very simple to jump back and forth on different freq's to enable me to check their (or any) parallels. I am still amazed at the number of Cuban stations that are routinely heard in suitable cx (I know it seems unbelievable!). Of course, a beverage or two make clearing the band for LA's much easier if you have the space, and inland I will continue to prefer a wave antenna over a loop for foreign DX, especially splits.

Tom Nichols doesn't get that many calls from Little Rock on his daily "Ask Your Neighbor" program, Most of the callers live closer to Glen-wood, where he and his wife Polly own and operate KWXI, at 670 on the AM dial.

That people do call from Little Rock, as well as Booneville, De-Queen, Camden and Sheridan, is evidence that the tiny station reaches many more people than live in and around Glenwood.

It has to.

"The town itself has only 1.400 people, therefore many people have considered putting a station here, but backed away," Nichols said. "What they failed to realize is that there are 73,000 people within a 30-mile radius of the station, so it's a

bigger market than it appears to be."
Nichols and his wife Polly, both
Hot Springs natives, started KWXI in

May 1980, Nichols, who had worked for various radio stations at Hot Springs for 20 years, said Hot Springs was already crowded with stations.

But Glenwood represented a relatively untapped market, especially since it is a regional trade center with two banks, three auto dealers and an active city government.

Since going on the air, the station has become a popular voice in southwestern Arkansas. The programing is varied, but it all tends to emphasize the informal good-neighborliness that is typical of its listening area.

On his morning show, Nichols slurps his coffee, exhorts listeners to get out of bed and does many of his commercials live. He also helps listeners exchange household hints and recipes during his "Ask Your Neighbor" show, and the station has an incoming WATS line to encourage listeners outside of the Glenwood area to participate.

The station also offers, among other shows, a "Swap Shop" radio bulletin board for listeners to buy and sell things, and a daily episode of the classic radio series "Lum 'n' Abner," set at Pine Ridge, about 40

miles away in Montgomery County.

"We're not just playing music at them all the time," Polly Nichols said. "They have a chance to talk back to us. We have a very interesting blend of people here, and that shows by the people who call

The station's big break came in 1983, when the Federal Communications Commission decided to release 25 clear channels around the country to daytime stations. The channels had previously been the domain of powerhouse stations from big cities that broadcast for thousands of miles after sunset.

The new rules allowed local stations to broadcast on the stations' frequencies as long as they did not interfere with the large stations' own local daytime signals.

KWXI was one of the first stations to apply for a clear channel, and moved in February 1984 to 670 AM, occupied during the night by WMAQ at Chicago. The station also doubled its power to 5,000 watts, allowing it to reach to Fort Smith, Texarkana and Little Rock, a move that both expanded its audience and changed the type of advertisers it attracted. Nichols

"That put us into a different ball game." Nichols said, "While we still had to serve this area, we also began reaching a much broader area. Because we are a regionaltype station and we have a different type of programing [than more local stations, we know that we'll attract a different kind of advertiser, so we look for regional-type

businesses."
KWXI's position is further strengthened by its affiliation with the NBC radio network. which gives the station hourly national news broadcasts. The station also features the Steve Allen show, an NBC experiment that the network is dropping next month because not enough stations sub-scribe to it. Nichols said many stations are too locked into their formats for Allen's show to fit.

"That's the problem with radio these days," Nichols said. "It's all formatted, and there's no room for experimentation. So what we'll do lwhen Allen's show is canceled! we'll try another experiment. One of the things we've learned is that nothing is written in stone.

Nichols said the FCC would soon be releasing an FM frequency in southwestern Arkansas and he hoped to take advantage of the agency's policy of giving preference to local owners of daytime stations in granting license applications.

He said however that KWXI was holding its own quite well as an AM station, despite FM's current recent dominance.

"Radio is still basically radio, and people will listen to a station whether it's AM or FM if you give them something to listen to," Nich ols said. "The trick is program ing.

I have not sought written verifications for years, but decided these would be worth having. There was lots of Christmas music on the tape, and I told them both to keep the tape. Last excerpts on the tape came one hour after Denver Sunrise. (Good going on both of these Gene. It is amazing how far those 500 watters do get. All the RPHs are good QSLers, but some are slower that others, bepending on how much help they have, being listener supported. I have all OSLed, here and 4RPH was the most slow and get took a f/up. Good luck. PM)

Also a card from Jim Hall: "A note regarding Nick's (Nick Hall-Patch) tenative 594-JOAK-Tokyo in DXWW-West of 12/24 DXM Vol.26 #13. I phoned WIGG-1420 Wiggins, MS to follow-up on a reception report and talked to a fellow named "Kenney". He was quite cordial, but said the reports they received ocaissionally were not taken seriously. In fact, he said he thought they were a"bunch of Bull" and so much "malarky" because if their signal couldn't be heard county-wide, how could it be heard 300 miles away? At that point, I told him in very layman's terms (which is about all I know anyway, hi) about skywaves and the ionosphere, etc etc which enlightened him a little, I think. I also assured him I was not a crackpot and had been doing this for 20 years and had 1,400 verifications and so on. Next, he questioned whether I could accurately say I heard WIGG when they are satellite-fed and any number of stations might be running the same feed. Well, I just reminded him that I was lucky enough to have heard a local break with a "WIGG" ID. (Why not tell him that those other stations carrying the same feed aren't all on 1420--rce) The upshot of this all was I think he was interested in what I was doing, and we also talked on a more personal level about our respective jobs and lives. I came out of it with the promise of a verification, which I won't hold my breath for! It is interesting how we DXers are perceived by broadcasters, and it is apparent that many either don't understand (my case) or dislike (Steve Mittman's) what DXing is all about. I can understand why we are seen as a bother, when some of these people are trying to keep marginal operations on the air, but I do wish they could see us as allies and supporters of their embattled medium; if AM goes down the tubes, then so does this particular part of the DX hobby and we all lose. Tom Laskowski, 1334 East Miner Street, South Bend, Indiana 46617 I enjoyed reading the forums of Gary Seigel and Rick Evans in the Jan. 7 EDXF concerning my local WLLJ. Let me add some more info to the two forums. Back in May before WLLJ went on the air, I called the station and talked with the owner Larry Langford, Jr., hence the calls WLLJ. At the time I called, they were doing an antenna performance check. I had a nice long friendly talk with him about the station and what he was planning. If I remember correctly, he told me that WLLJ was replacing the

expired CP which existed for some time for Mishawaka, IN. The original CP was supposed to be for 910 kHz and was intended to replace WAMJ, which is still on 1580. That CP was held by the previous owner of WAMJ. Apparently that station was never built and WAMJ was sold to a new owner. WAMJ used to have a format of Urban Contemporary music in the afternoons, but when the station was sold, the format became all talk. This left the sizable black population here in the Michiana (pronounced mish-ee-anna, i.e., Michigan and Indiana) area without such a format. So Mr. Langford decided to put his station on 910 to replace the expired CP previously issued for Mishawaka. WLLJ is very strong here during the daytime as the main lobes are toward the southwest and northeast. I don't remember exactly what Mr. Langford told me about the technical aspects of WLLJ, but he did mention that the .5 mv/m contour passes through Chicago. At night the power is cut back to 37 watts and is easily nulled here. Cassopolis is only about 20 miles from here so the 37 watts hardly covers South Bend at night. I don't know how well the station is doing in the ratings but since everyone here listens to FM, I can't imagine it is doing well. I listened to about the first fifteen minutes of the Ray Breim DX special. I could only stand so much of hearing Mr. Breim refer to shortwave as World Band Radio. As somewhat of a purist, I find the term World Radio Band to be stupid and insulting to those of us who have taken the time and effort to learn what shortwave radio is all about. I take offense to being called a "World Band Listener" as a certain person who publishes a reference manual of shortwave frequencies likes to call us. I sure hope this phrase doesn't catch on. That's all for now. 73's to all de TML. (Tom, that repeated and repeated and repeated phrase bothered me also, and helped persuade me it was time to go to bed -- rce)

Mark Connelly, 30 William Road, Billerica, Massachusetts 01866 Recently, Neil Kazaross made a trip to New England from San Diego, He and I got together on 07 January 1989 and took a ride out to the shore at Swampscott, MA for an impromptu DXpedition. Neil, as you may remember, logged a staggering amount of Trans-Atlantic, Caribbean, and South American DX from Narragansett, RI and Ogunquit, ME a few years back. Neil's a great guy & a super DXer: we could use him back in New back. Neil's a great guy & a super Dace: we could use nim back in New England. He's considering a full-fledged D^pedition to Maritime Canada (NF or NS) in autumn '89. On 07 January (08 January / GMT), we logged a good assortment of southerly TA's and Caribbean stations between 0130 and 0230 GMT. The DXpedition QTH favored east / southeast & conditions were semi-auroral. Log info. was taken casually: detail isn't sufficient for a report to DXWWE. Azores on 1566 had a potent signal; as we listened to it, a het from something on 1565 became apparent. The first thought was a low-powered St. Lucia outlet; eventually, Spanish-language audio could be pulled by 1566 by manipulation of the MWT-2 regenerative tuner and by a favorable fade. The 1565 thing was probably a Dominican Republic split. Antigua on 620 was generally dominant, with soca / calypso music and accented EE talk. Big signals were noted from a good number of Carib. splits, including Grenada - 535 and the new Nevis - 895 (from which a fine ID was heard). Venezuelans were all over the place: 600-790 and 1000-1200 are the prime frequency ranges for these. Neil's excellent DX memory helped log YVOD (Ecos del Torbes) which was ruling 780: Neil recalled the parallel 4980 kHz outlet which, upon investigation, had the same program. Jamaica on 750 was atop the YV and WSB: Saturday-nightparty DJ shows from Jamaica are always welcome listening for me. Turks & Caicos was awesome; its preaching was blowing away all competition on 1570, even usually-pesty CKLM. Spain was tentatively noted on 999 (the talk sounded Spanish, not the expected Arabic from the Moroccan). Usual "mouth-of-the-Med" TA's were good, with Algeria-891 leading the pack strength-wise with its typical cruncher signal. The "travelling DX setup" with the (Gerry Thomas - modified) Sony ICF-2010, regen. tuner, and 100 ft. (30m.) wire on the ground proved quite capable. The last time I'd logged this much in an hour was on a sunset TA blitz from Brant Rock (Marshfield, MA) a couple of years back. The same gear was used. Average equipment and a good QTH will outperform good equipment and an average QTH for foreign DX. 73 .

Karl J. Zuk, 154 Old Post Road North, Croton-on-Hudson, New York 10520 Happy New Year, everyone: Over the New Year's weekend, I visited Dillon, Colorado, which is about 70 miles west of Denver. This gave me a great appreciation for all the arguements about having one station, with primary service, in a community at night. Coming from a market with about 90 available stations day and night, I was amazed at how little really was available in this little town in the mountains. During the daytime, stations like KOA were slightly noisy, but reasonable reasonable received almost everywhere. At night, KOA was hit with a severe battle between skywave and groundwave, and a simple lack of signal. There were no lower

powered local AMs in the area. The stations that stuck out on the band was KKOB on 770, who was really dominant and nice. I also heard power-house KTNN, Window Rock, Arizona, with a truly youthful and amateur disk jockey announcing country and western records, KTWO in Casper, Wyoming, with its egotistical "We're the most powerful in Wyoming" ID, KFI from LA, and quite a few stations from Texas and Mexico. Granted, my traveling DX machine was a five transistor pocket radio, but you really couldn't listen to something on AM in these parts without being at least a casual DXer. The FM was also interesting. The two locals had several translators all over the band to compensate for those big bumps in the ground that blocked their line of sight signals. I think they call them The Rocky Mountains. The reach of a truly lousy car radio is improved at 12,000 feet. KKOB was heard with some signal all day and night. The most interesting stations I heard, at least to me, were the two TIS broadcasters on 530 kHz I encountered. I have an interest in 530 kHz because I experimented on it with my flea-powered transmitter. Denver's Stapleton Airport had a typical boring loop announcement about where to park and lose your luggage, etc. The Town of Breckenridge, a ski resort area, had a dandy TIS with a beautiful self-supporting tower, about 100 feet tall. My recent vacation allowed me plenty of time to give my new Sony 2010 a thorough try-out - here are some comments.

This is a slick radio and I'm glad I bought it. It does have some short-comings, the main one its relatively low sensitivity on MW and SW with its built-in antennas. You're pretty much forced to use an external loop or wire antenna to obtain adequate sensitivity for DX. In my opinion this partly defeats the reason for having a portable radio. If the memory batteries (2 AA cells) don't fit tightly the programmed memories may be instantly lost if the radio case is flexed (it flexes easily - definitely not a rock-solid design,) I had this problem even when using the recommended "Energizer" batteries that aren't suppose to slip. A simple solution that has worked for me is to wrap a few turns of masking tape around the batteries before they're installed. Battery life of the D cells is not extensive so alkalines are recommended. As

the D cells weaken audio quality drops off but sensitivity isn't reduced that

much (my Sony ICF 6500 behaves oppositly in this regard).

The sunchronous detecter is of no use in digging out weak DX but works well in cleaning up medium-strength signals undergoing distortion from selective fading or suffering from strong adjacent channel interference. The "sync" is useful in listening to talk shows or news from out-of-town stations at night. Use of my homebrew shotgun loop really perks up the 2010's MW sensitivity. Use of the shortwire included with the set also improves MW reception but not as well as the loop. When plugging in an external antenna for use in MW, do not insert the mini plug all the way into the antenna jack or sensitivity will drop way off. On SW this makes no difference.

Does anyone know if 2010's are supposed to behave like this? The manual makes no mention of this. Tom Laskowski informed me his 2010 does the same thing. The January 1989 Monitoring Times mentions that 2010's have problems with their antenna jacks. On SW, use of the shortwire is a must in order to get decent signals from weak stations. When DX'ing in remote areas I clip a I ounce lead fishing weight to the shortwire and throw it over a tree limb and results are excellent. (What was the weight of your catch?-hi-RtH.) I like to use the shortwire as a vertical if possible. I really dislike the "synthesizer pop" the 2010 makes while tuning with the knob but am slowly learning to ignore it. The narrow IF filter is a pretty good one for most MW use. Reception of SSB and CW is truly excellent for a portable. A tight IF filter and being able to switch off the AGC for CW would be nice but you can't have everything at this price. The 2010 has a bit of really usable features that most receivers don't. In spite of its shortcomings my reaction to it is "how did I ever get along before I had this radio," hi. 73 de RET.
