All existing TIS stations would be relegated to 1700 kHz. We hope to have a more official version of the story soon.

FCC Denies New License For a Small Radio Station

By a Wals. Street Journal Staff Reporter WASHINGTON-The Federal Communications Commission, at a closed meeting, denied Henry Serafin's application to renew the license for WBUZ, the only AM radio station in Fredonia, N.Y., marking the first revocation since 1981 on ground of character.

The FCC cited lying to the commission on a wide range of matters, racial bias in hiring, and a contest in which WBUZ kept the grand prize—a stereo re-ceiver and tape unit—for its own use. Mr. Serafin, sole owner of the tiny


station in western New York, denied any wrongdoing and said he intends to appeal the decision. WBUZ will remain on the air during the appeals process.

An administrative law judge and a yiew board found Mr. Serafin unfit to Wall Street Journal 2/23/89 be a licensee nearly two years ago. The station's license was challenged in 1981 by three local groups that have been represented by Media Access Project, a public-interest law firm in Washington.

According to testimony in the case, Serafin had told the local office of th. Comprehensive Employment and Training Administration that a black woman sent to apply for a secretarial job "would make charcoal look white," and then he said, "Don't you have any white girls to send me?" The FCC said the case was compli-

cated but "the pattern of deliberate mis-representations" was "sufficient representations" was "sufficient grounds for denying renewal." The bias issue and contest violations, it said, "only reinforced the conclusion" that Mr. Serafin was unqualified.

Unfortunately, I've spent no time doing propagation research or articles recently. I would be happy to answer any questions about nighttime shywave propagation for any of the members. One issue that actually may enhance long distance propagation is the new "anti-skywave" antenna system; these direct more energy along the ground and at low angles to the ground at the expense of high incidence angle skywaves (that typically travel only 100 to 300 miles). The net result may be marginally increased field strength at distances over 1 000 miles because the skywaves we're receiving are "errant" tances over 1,000 miles, because the skywaves we're receiving are "errant" ground waves. (Hey Randy, how about a talk at the Convention?-RtH.)

In April 1988 I had a business trip to Toronto and was able to spend an

evening with Gray Scrimgeour. Gray DX'ed from La Jolla in the mid '60s and was a big influence in my DX life. He and his wife and two grown sons are well and happy, and it was great to relive some memories of the good old days of DX. Gray and I put together the IRCC (IRC of California) editions of the mid '60s, the first April Fool's editions.
