Here is the voting results of 5 proposals placed before IRCA's Board of Directors recently: 13.2.1: Move publishing from Seattle to Riverside. Al

members voted yes. PASSED.

13.2.2: Increase dues to \$24 a year, proportionate increase for international and trial members. All voted no, except Ric Heald who voted yes. DEFEATED.

13.2.3: Increase dues to \$25 a year, proportionate increase for international and trial members. All voted yes, except Ric Heald who voted no. PASSED.

13.2.4: Make dues payable in one yearly sum, or payable in two installments of 1/2 that rate plus \$1. All voted yes, except Ernest Cooper who voted no. Ernest objected to paying dues in this way because the yearly total would be \$27. PASSED. (First 4 proposals prepared by Phil Bytheway, Ralph Sanserino, and Don Erickson).

13.2.5: Install "Hearing It Through The Grapevine" as a monthly

column, with Shawn Axelrod as editor. All voted yes, except Ernest Cooper who voted no. (Proposed by Karl J. Zuk). PASSED. My best wishes to Don, Ralph, and Phil in their new publishing venture! Also, please welcome Shawn with his new column and support it (along with all the others!). Please remember that the club depends on input from you, the members. The information we print comes out of thin air...but you have to receive it with your radios and tell us about it. Please don't hesitate to scribble something down and send it on to an editor, or me. We are dying to hear what's going on with YOU! Best of DX and 73. KZ.

TRIVIA QUESTION OF THE MONTH

Cleaning up the mess I made in July: NRC's Jerry Starr sent along an amusing letter from the CE of KTGG-1540 Spring Arbor MI, detailing the

trials the stn went thru to find out why the FCC ignored their requested call and randomly assigned a "K" call instead. OK, I'm convinced, hi!

Cleaning up last month's mess: I stated California had 6 three letter calls, and once had 9. My original notes said they had seven - but didn't list the old KHJ-930 anywhere, so I assumed I'd forgotten to subtract them. Wrong. As Ty Thormahlen (Billings) pointed out, what I'd done is omitted KNX-1070, a very hard station to ignore. Oops. So California DOES have seven, more than any other state. Happily, that doesn't change any of the answers to last month's questions, which are:

1) 20 yrs ago Washington state had eleven: KVI-570,KXA-770,KJR-950,

KTW-1250, KOL-1300, KMO-1360, KIT-1280, KHQ-590, KGA-1510, KUJ-1420, KPQ-560.

2) California lost KRE-1400 (twice, actually); KYA-1260; and KHJ. Bonus) KWG-1230, KXO-1230 and KDB-1490 are the only 3-letter-call graveyard stations in the U.S. All in the same state!

Another Bonus) The other state with six, oddly enough, is Iowa. WHO-1040, KSO-1460, WMT-600, WOC-1420, KMA-960, WOI-640.

Next Question, aka Pressing My Luck, aka Squeezing Trivia from a Turnip: As you might note above, Seattle was the last city with five 3letter calls (three no longer exist: KTW, KOL, KXA). What was the last city to have FOUR? (It wasn't Seattle!) (Hint: one survives on FM.)

MISCELLANEOUS NOTES: Dead Stations that were Middle of the Road: WBUZ-1570 Fredonia NY has lost its final appeal of an FCC decision stripping its license for various ownership abuses. WBUZ should now be silent. Another stn lost its license, but noone will notice: WLTA-1500 Clarkesville GA had renewal denied and the license given to a competing applicant, but new owners plan to keep WLTA on w/its current gospel format.

Another waiver to cross-ownership in one city: WDAF-610-MO and WKRC-550-OH will be able to stay co-owned with their FM and TV stations.

Year-parting: KLPZ-1380 Parker AZ changes its format regularly. It's country early AMs, then satellite AC in summer and satellite adult standards in winter. Reason: changing population in the area, which is a lakeside resort by summer and a haven for elderly snowbirds by winter.

With a huge format change section this month, it's a good time to take a look at where AM radio formats are going. Greetings again from Big Woods country. A few reports in for this issue. With the current and predicted continuing high levels of solar activity George and Rich have managed to log in some fine TA's this mid-summer, including USSR & Ireland in late July from George. I have also been able to hear a few TA's this summer, namely regulars from the usual summer best Iberian Peninsula on the BCB's high end including Spain-1575/1584/ 1602 & Portugal-1575; also, West Germany's WDR on 1593 and the Saudi on 1521 have made it in a few times. But these are not all that spectacular although considering the projected increases in solar activity may very well be some of the few that do make it in with any consistency this season. I'd advise heavier concentration on LA's, from Sept. and especially October on. Pan American DX should be quite good this season considering the circumstances - that being the solar maximum's peak by the beginning of 1990. For those who enjoy DXing Caribbean, Central & South Americans on BCB this upcoming season may very well be a rather productive one for us. Of course, I will still monitor for TA and even TP DX (time permitting) in hope that during the interim openings will occur. I am already getting some good LA DX, however, and believe this is a sign of things to come.



The truck was waiting downstairs. After years of operation, WHOT was being dismantled by the FCC in Coney Island. They took down the antenna, the feedline, and the transmitter. console, the turntables, the disc players, the phone interfaces, the reconsole, the turntables, the disc players, the phone interfaces, the feature cords, the signs, the microphones, headphones, and all the wiring was seized, and within an hour or so, the operator of WHOT had a newly vacant room, and a receipt of the seizure. They had operated every Friday and Saturday night, and on many others. They had an incredibly slick and professional sounding oldies station, complete with jingles and a large staff. They also had a long-term battle with the FCC. They had constantly slandard for the constantly slandard for the state of the dered specific agents, by name, on the air. They had refused them entry. they had chased the FCC's monitoring vehicles through the streets, terrifying the occupants. As Peter Finch said in the movie "Network": "I've had enough, and I'm not going to take it anymore." The FCC went to a judge and got a search and seizure warrant. The news travelled fast. Suddenly, the very active pirate radio scene in New York City had been squelched. At its peak, there were as many as two dozen active pirates. They even created, out of necessity, a frequency coordinator to avoid interference with one another. So far, the feds have not prosecuted the operator of "The Hot One" was cold enough as it was. Life goes on. heard from a fellow in the Chicago area who was operating a three watt "beacon" on 530 kHz. It seems that the FCC had been called in because a nearby airport had just established a TIS on the same frequency, and he was interfering with their field tests. He was not home when the FCC came to visit. They left him a polite note, and asked him to call when he had a chance. He answered, and was immediately fined \$750, although he still has his gear. Maybe there should be an amateur broadcasting band. Maybe you disagree. Regardless of its legality, it continues to be a worldwide phenomenon, and unusual material for DXing. Personally, I like to stay on the better side of the law, and watch with amusement. (cont. next time)

Hello to everybody in the IRCA. I joined the IRCA earlier this year, but due to a very busy schedule this is the first chance I have had to write. I've enjoyed reading the DXM and always look forward to receiving it. The 25th anniversary issue was impressive and I'd like to take this opportunity to thank Gary Siegel for extending a welcome to me in that issue's Eastern DX Forum. I'm 36 years old, and I am employed at the Toledo Main Post Office where I operate a monorail system that distributes amil sacks throughout the facility. I also have a small TV repair business which I work part-time. Although I have never had DXing as an outright hobby, I've always been interested in receiving distant stations, mostly for program content. My main DX set is a Panasonic RF 5000A shortwave; pending IRCA's shipment of DX modifications and tech papers, I'll have Late in the spring I noticed that WOWO-1190 Ft. Wayne extended their oldies format through the night, dropping Larry King (hooray!). However when listening to them at 0200 ELT, I've noticed that I get interference froma VOA transmission that starts at that time. It can't be Radio Marti since I'm sure they wouldn't put any signal in this direction, and the broadcast is in English. It appears to be a spur since it is easily tuned out. The only VOA frequencies that come close as harmonics of 1190 at that particular time are 7170, 9530, and 11915. The RF 5000A is a single conversion receiver and does tend to have image problems. However, this is the first time I've ever had SW spurs appear on the MW band. If anyone else has experienced this interference please let me know. Canal Corridor. This area runs from Chicago to LaSalle, Ill., and covers about 100 miles. There are plans for 4 such TIS's to be spread out over this area. All were scheduled to go on the air by June 1st. The two stations on the air are in Joliet and LaSalle. The stations in Morris and Lemont will be on the air in a few weeks. Their transmitters were reported to have been hit by lightning and put out of commission before ever going on the air. The two stations on the air must be powerful. I can hear the LaSalle station (50 miles to the west) under the signal from Joliet at high noon. When driving 1/2 way between Joliet and LaSalle, the two signals are of equal strength and mess each other up. This will be worse when all four stations are on the air. As for the 1200 kHz station in Chicago, still not on the air as of 7/23. This one was noted testing with OC on many occasions in the past, but I never heard any test tones. When first heard they were running an ID every 3 1/2 minutes. The last time they were heard testing was on July 2nd with an ID only on the hour.
