BIG DEAL, EH!

Five of Canada's biggie broadcasters are dealing in what is the largest takeover in Canadian broadcasting history.

Southam Incorporated, owner of about 16 daily and many weekly Canadian newspapers recently sold their 47%(20% voting) shares of Selkirk Broadcasting. Maclean Hunter, also in the newspaper and publishing business, and much cable/AM/FM/TV, bought Selkirk for \$606 million. Listed stations was Selkirk Broadcasting.

Maclean Hunter then sold CHCH-TV for \$70 million to the London Free Press(CFPL--CKNX). WIC(Westcom) bought the 37% & 50% of CHAN/CHEK/& CHBC. WIC already owned the balance.

Victoria....37%

Kelowna....50%

The CRTC frowns on cross media ownership in the same market. Maclean Hunter now owned CJCA/CIRK and CKNG-FM in Edmonton, CFAC-TV/CFCN-TV Calgary/Lethbridge, and CFAC/CFCN-CJAY-FM Calgary. WIC then bought CFAC-TV and CJCA/CIRK for \$217 million(including the balance of CHAN/CHEK/CHBC).

Ted Rogers stepped-in to help out. He bought the rest of the above list for \$24.5 million. Maclean Hunter kept CFNY as they wanted a Toronto FMer for their sister, CKEY. Rogers already had CFTR/CHFI in Toronto. Rogers sold its cable TV interests in the USA to Texas (M. Ind.) for \$US 1.365 billion and its 9.3% interest in Moffat Brg. for \$12.3 million. Moffat then bought CKNG-FM Edmonton from Rogers.

All sales are subject to CRTC approval, and at "press time" all were approved except: Maclean Hunter must keep CHCH-TV and CKVL/CKOI, and WIC can't buy CJCA/CIRK. Both will reapply.

Well, who's on first? Maclean Hunter now ranks #7 in Canadian private TV(owning CHCH-TV), and #3 in cable/AM/FM in Canada. With perhaps a couple of errors here is what who is on second.

Trans-Pacific

Australia - According to Melbourne Age, 3KZ and 3AK in Melbourne have been granted moves to fM later this year. According to the paper, "As part of the conversion deal, the AM stations will have to hand over their transmission equipment to the government for the establishment of a parliamentary broadcasting astation and improved AM facilities for Radio for the Print Handicapped" (DXA via NZDXT). 5MU-1125 relays 2UW-1107 from 1030-2000 UTC; 3UL-531 relays 2WS midnight to dawn, in mono. When 3KZ and 3AK vacate medium wave, 3PB-1539 will move to 1503 and 3RPH-1629 will change to 1179 (Bryan Clark in NZDXT).

Bangladesh - An UnID station noted on 846 (ARC).
Burma - This country is now called The Union of Myanmar. Rangoon is called Yangon (several sources, via FERC).

Cambodia - The name of the country has changed from Kampuchea to Cambodia. However, the state radio still calls itself "V. O. the people of Kampuchea " but refers to the country as Cambodia (SCDX via FERC)

China, PR - Xinyu PBS-1026 and Bengbu PBS-1165 heard on these frequencies, but Xinyu-1386 not heard (T. Gima in ABI via FERC).

Guam - KUAM- 612 Agana was on 610 (Y. Sano in FFRC)

It was quite a surprise to hear that Don Erickson would again be taking over the publishing chores. I remember being surprised back in 1973 when the publishing moved from Toyland (do they still call it that?) to San Diego after DEE had been publisher for a number of years. I've been traveling quite a bit in recent months, with trips to Washington state, Hawaii, and Minnesota/Ontario/Manitoba. I spent a week in Hawaii in mid-September, mostly on Maui. I didn't do any serious DXing, but it was interesting to hear many of the local BCB stations. Almost all of the Hawaii mediumwave broadcasters put a decent signal into the Lahaina/Kaanapali area, where I spent most of my time. During a trip to northern Minnesota, northwestern Ontario and Manitoba in October, I also did some listening, and was surprised by the signals some of the Chicago stations put into Ontario and Manitoba, even during the day. I didn't visit any radio stations, but I did catch a Blackhawks/Jets hockey game in Winnipeg. I also visited North Dakota, which was the only state I had never been to. I can't claim to have heard all 50 states on mediumwave (I need Alaska) but I can say I've been in every state! Another interesting experience happened back in July, when I drove down to Springfield on I-55. At about Pontiac, Illinois, I noticed a strong Eskip opening affecting most of the FM band. I heard a number of station from Texas, New Mexico and Colorado. This is the second time I've had an "Interstate E-Skip" opening. One of the things keeping DX at bay recently has been a serious interference problem. The man from Commonwealth Edison came out one day (there was no interference during his visit, of course) and he said that the problem could be a fish tank, electric blanket, or even a butter warmer in a refrigerator. "A fish tank can take out a couple of blocks" he said. Great. I finally traced the problem to a malfunctioning streetlight nearby. The noise was transmitted through the powerlines, and was especially bad on some of the shortwave frequencies. It took a couple of phone calls, but the light has been fixed. 73.

R. Caroline - According to various reports, R. Caroline was put off the air August 19 by a combined operation of the British and Dutch governments. The station, aboard MV Ross Revenge, was in operation 14 miles off the British coast in the North Sea (ARC).
