Next in line is the filter mod for better selectivity, this looks like it should also work fine. When I get finished with the drawings they will be published in the bulletin with complete instructions for doing the mods, and building the loop. With suppliers for the parts listed.....Ralph.

SANGEAN ATS-803A by Ralph Sanserino, IRCA Publisher

I got to looking around for portable radios to use on the BCB and not to my surprise there are not too many around. The GE Superadio seems to be disappearing from the marketplace, so I took a look at what was left and I had to go up in price to the Sangean ATS-803A; there is not much below the \$190 price tag for use on the BCB. If someone out there knows of a real good portable for BCB in a lower price range, please let me know. I have been checking out the 803A for awhile and it was just fair on the BCB. So off to get a service manual to see what could be done to make this go better on the BCB. The people at Sangean were thinking of the BCB DXer when they designed this radio; they put in an FET RF amp just for the BCB and LW bands. Here is this ferrite rod antenna hooked directly to this nice looking FET RF amp and I knew right off it was going to work great when I got done with it, and sure enough I was right; it does work great. I added an external 15" tuned ferrite rod antenna, the plug-in type, so when I unplug it, the internal ferrite antenna is back in use. The external antenna improves the 803A about 200% or more. Stations that could not be heard with the internal antenna were now audible using the external antenna. Splits were readable and you have a digital readout and a BFO with pitch control to help you tune them. I am not going to list all of the specs here; all I know is the radio works. You can get all the specs from a Sangean brochure.....Ralph Sanserino.

WALT BREVILLE, P.O. BOX 13008, ST. LOUIS, MO 63119 1989 marked 22 years since I first joined IRCA and 25 years since discovering the AM DX hobby. I'm now past the half century mark, still happily single. Have a new setup consisting of a 1986 Ford AM/FM/cassette receiver, a 12v RV battery and a 10 amp charger. This has almost eliminated the problem of CATV leakage messing up even the weaker local AM stations in my home, even with all TV sets off. Turned out 95% of the noise was in the power line. The new car radio using a plain car whip antenna is more sensitive on weak stations, epsecially on the lower half of the band, than my R-1000 was during rare noise SPs whether the R-1000 was using the SM2 or the 60-foot longwire. Going to battery power was the answer to my noise problem. I have a GESuperadio, but it has fallen into disuse with it lacking digital readout which has become a must for me in recent times with so many new stations and call changes. Like the Superadio, the car radio makes DX'ing more fun with its greater audio output, rich low tones, compared to the R-1000 feeding a 5-inch speaker. That's one thing that hasn't changed in 25 years, then and now communications receivers had and still have skimpy audio output sections, with scattered exceptions such as the Hallicrafters SX-62 which had a ten-watt built-in "hi fi" amp, and today's Grundig portables. Does anyone know how well Satellit 400, 500 or 650 does on AM? Back in the early '60s good car radios gave the most bang per buck spent in DX performance - it's still the case today. My car radio has digital tuning, is great for domestic DX, but like most digitals, cannot tune foreign splits, but those seldom make it this far inland unless you live in a DX enhanced area such as Denver. I was saddened by WLS going all talk, but as late as 29 October they were still running a Sunday morning pop music and low-key preaching program 0600 to 0630 CLT called Powerline with uptempo secular as well as Christian AC/CHR type music much of what WLS played in recent time before subcoming to talk fever. Maybe they still run this fine Southern Baptist produced program, try it. Locally, I lost the fine oldies WKLL 590 Wood River, IL, they're now WCEO, obviously for Chief Executive Officers, with all business news from the Business Radio Network. That leaves KGLD (ex-KWK) and KLOU 103.3 battling for the oldies audience of St. Louis. To reduce financial pressure

My current setup is an early '80s vintage Realistic TRF (12-656) modified with a couple of Radio West "trans-filters," along with a 4-foot spiral loop. But it work quite well. I also do some SW DX and have my Ham license (Tech class), call KAØRNF. . .I operate 2-meter FM phone on our university club repeater. Like most of you, I wish I had more time to listen and have sent what little I've heard recently to CDXR and DXWW editors. Hi again. Before I run out of time, I'll wish everyone a very happy holiday season from my family to yours. KSUR Soledad 700 finally came on the air 27 November, simulcasting their FM. Their schedule is also the same, 0900 to 0000 ELT with CLA. (Did you mean 0900 to 0300 ELT?-RtH.) It's a weak but solid signal here at home, OK on the Monterey Peninsula, but subject to powerline noise and KNBR QRM in the car. Good luck on hearing it as it's likely to get buried at skip times. Weird part is on their legal ID, KSUR FM gives ID first, but doesn't mention the AM. Then, at exactly :04 a separate ID from the AM XR fires, saying "KSUR 700 Soledad, simulcasting with KSUR FM Greenfield-Monterey." Sometimes the modulation is low on that ID or runs over a PSA! Seems they should simplify things and run dual legal IDs from the studio like KXDC does for their AM and FM, which have separate cities of license. I wonder what the owners see in having such a low-powered AM station? (Do I hear "tax shelter"?-hi-RtH.) KNRY back to 1 kw, their XR problem was fixed within 2 weeks. KLAU 1540 is now AN7 again after having at midnight (local) s/off as KNZS. All I got was constant KSKQ and once, KXEL. Was told by KRML's CE that the station (on 1410) doesn't have the funds to build a new antenna site for their 3-4 year-old CP to boost power to 5 kw fulltime. MISCELLANEOUS NOTES: The FCC has begun granting waivers to its cross-ownership rules that prohibit companies from buying or operating TV and AM or FM stations in the same market. First off the hook are KYW-1060 Philadelphia and KAKC-970 Tulsa. Owners of both stations successfully petitioned to buy television stations in their cities.

Testing of the NAB's new experimental anti-skywave antenna on KA2XXB-1660 Beltsville MD should begin in the next month. The station has already been on the air testing with above-ground radials, and should have a buried radial system in place to begin tests by the new year.

One more backhanded indicator of how low AM has sunk in the marketplace: the FCC this month busted two more pirate FM stations. They don't seem to bother to bust AM pirates any more — and most pirate station operators set up on FM, where there will be an audience.
