John is asked to remind him that Convention bidding process is behind
schedule and that, if he is still planning to host the Convention (in
Chicago) to submit a formal bid form to Karl Zuk, IRCA President. In the
meantime, if someone else is willing to host the IRCA Convention,
preferably but not limited to Kast of the Missispipi, please contact Karl
without delay. If all else fails, there will be an IRCA Convention in
Riverside/Ontario. The Convention date should avoid the traditional NRC
Labor Day weekend and should also take into consideration any already
announced dates for other ANARC club conventions, particularly WTFDA which
is usually mid-August.

MISCELLANEOUS NOTES: The Maryland State Network, a talk network based at WITH-1230 Baltimore, has collapsed. The parent company is facing criminal charges regarding misleading and/or fraudulent financial offerings. WITH reverts to its previous standards format, and MSN is dropped from each of the other dozen or so stations that carried it. At the other end of the spectrum of health for state networks, the Texas State Networks and their offshoots have been sold, along with KRLD-1080 Dallas and an FM in Houston, for a combined \$86 million.

The death of WGLI-1290 marks the first time under new FCC policies that a co-channel or adjacent channel station has been bought out and shut down by a competitor. WGLI was purchased last year by WADO-1280, which ran the station until WADO could make signal improvements to preclude someone else restarting the abandoned 1290 facility.

The big news here is that, officially, WOPA-1200 "Radio Exito" is on the air with a Spanish format. It began broadcasting at noon on New Year's Day (1/1/90). Reportedly, it's the first new "radio frequency" to go on the air in Chicago in 35 years, but a quick glance at the 1974 Broadcasting Yearbook seems to indicate that the last new Chicago proper AM came on in 1941—the one on 820. If you count the suburbs, the stations in Chicago Heights came on in 1959 (WCGO) and 1963 (WMPP), neither of which I can hear here. WOPA-1200 "R. Exito" is attempting to program to the Hispanics who have lived in the Chicago/Milwaukee to program to the Hispanics who have lived in the Chicago/Milwaukee areas for 10 or more years, but not to the new arrivals or to the teen "WOPA is seeking listeners between ages 25 and 50 who are accustomed to living in an urban environment and who are fairly settled -- they have steady jobs and their kids are in school." It means that during drive time they will have the announcers who talk and play music once in awhile like many other stations, except WOPA will be doing it in SS. WOPA is also planning on doing SS play-by-play of the Chicago Cubs. They're 10,000 watts day, 1,000 watts night. WIND-560 "La Tremenda" isn't happy with the news that WOPA can be heard in Milwaukee since WIND carries spots for Milwaukee businesses. WIND focuses its programming on the Mexican Americans who make up a majority of the SSspeaking population in Chicago, and they tend to play a lot of the traditional music. WOPA is headed by Arthur Velasquez, president and owner of Axteca Corn Products, of Chicago. WIND is owned by Tichenor Media, of Dallas, the largest operator of SS-language stations in the U.S. (The above information is from the "Radio Zahn" column, which is in the Sunday Milwaukee Journals. This column was in the 1/7 issue.) Incidentally, WIND-560 was off the air MM 1/15. The only thing I caught was an unID Canadian with a syndicated music program. I'm assuming CFOS but not put in the long. A cood TT on 1600 but no ID for it. 72 but not put in the logs. A good TT on 1600 but no ID for it.

Greetings. One of those interesting little stations you don't hear much about anymore, KPPC 1240 Pasadena, CA had its 65th anniversary Christmas about anymore, KPPC 1240 Pasadena, CA had its 65th amniversary Christmas Day. Since 28 December 1924, the obscure stations has also continued to this day to broadcast the 11 AM Sunday services of its founder, Pasadena Presbyterian Church. I recently got an update on what KPPC's been up to

these days from Operations Manager Bob Gourley. You may recall KPPC had been 100 watts and specified hours on Wednesday nights and almost all day and night on Sunday. During KPPC hours, KGFJ 1230 had to use 100 watts, 1240 in San Bernardino used 250 watts and on Sunday and the second seco 1260 had to use their night pattern to protect KPPC. No more! Since 1985 KPPC has been 250 watts and is now licensed to operate from sunset to sunrise only, Monday through Saturday; possibly the only night time only station in the US. Sunday schedule is 0600 to 0200 PIT. Also, KGFJ and KLFE 1240 can run their full power and KGIL stays on day pattern. Apparently, testing done in 1984 and '85 showed that KPPC can run at 250 watts and won't suffer interference from the other adjacent channels. The KPPC transmitter is now in the Star-News newspaper building, was in the church basement. KPPC format is now SS weeknights and Saturday. They also carry some Hindi programming. The rest of the time it's religious. Mr. Gourley tells me the station's doing well financially and sometimes gets reports from New 7ealand, and recently got a letter from a woman in OK who said she heard the station on her teeth, hi. (Sound like a potential customer where I work, hi-RtH.) As for KPPC's unique antenna system, it's coming down soon. The current single wire flat-top T longwire system has been used since 1936, and was replaced last time in the '50s. But, they've had a wire up since 1931, when the Star News station KPSN went silent. Originally, KPPC had a longwire on top of the church between 50-foot high masts, running 50 watts, which was raised to 100 watts in 1936. Anyway, the newspaper wants to tear down the antenna and historic 90-foot self-supporting towers. KPPC will move the transmitter out and doesn't know where they'll put their next antenna or if it will be a wire type or vertical. Since Mr. Gourley admits the antenna and ground system have deteriorated over the years, it's hoped a new antenna system will give improved signals, but testing will be done again to see about interference problems. The date for the antenna to come down has not yet been set. Also, I heard KGFJ for the first time here in November. Mr. Gourley confirms they still use a four-wire inverted L horizontal antenna on a 4-story building at the intersection of Washington Blvd. and Oak St. just off the Harbor and Santa Monica Freeway intersection. That was their studio site in 1928. Hope you enjoyed the KPPC update. 73 de Jim.

IRCA Improvements and Computer Volunteer Needed IRCA is already in the process of converting to the use of a hard-disk CP/M computer system, a Kaypro 10. This will make it possible to maintain an on-line skeleton database for verifying CPC and other station info without resorting to keeping a manually updated paper log. And within a few months it is expected the club will have 24-hour use of a heavy-duty IBM-compatible system with hard disk and laser printer. It will take months to work out the bugs but it should provide for better quality graphics in the bulletin and the potential for other benefits to IRCA. A previous call for IRCA members with access to IBM-compatible computers and the willingness to work on IRCA projects went unanswered except for previous volunteers Albert S.
