Bill Harms, now stationed in South Korea again sent in some changes for the AFKN Network. They are as follows:

AFKN-Seoul is changing from 549 kHz to 1377 kHz at 5kW AFKN-Munsan is changing from 576 kHz to 1440 kHz at 5kW. AFKN-Taegu is changing from 585 kHz to 1377 kHz at 5kW. AFKN-Pusan is changing from 783 kHz to 1197 kHz.

These changes has been requested from The Republic of Korea Ministry of Communications as a country wide realignment of AM and FM frequencies for AFKN, KBS, and MBC.

Bill also mentions that the station that Randy Tomer heard on 657 KHZ was probably a South Korea jammer. The South Koreans have stated to use open carriers or at least a low level of modulation on some of their jammers from time to time. Thx Bill for the info and hopefully you will send more info from time to time when you get it. The same goes for Mike Hardester and any other overseas members.

Here is a reprint of a previously published request including one line which disappeared because it started with a WordStar dot command to ignore a line (the period):

Your Editor-in-Chief continues to have problems Margins for editing with some material coming in with incorrect margins. Top and bottom margins on a 14 inch sheet of paper must be 3/4" and side margins are 1/2" on both sides. In addition, the first page requires 1 1/2" for the section masthead/logo. Therefore, the first line typed should be 3/4" plus 1 1/2" (2 1/4") from the top. 14" paper is virtually a must and blue-lined masters are supplied upon request to anyone wishing to submit any kind of material. Space should also be allotted for page numbers. If you are typing what will probably be the last full page, it is a good idea to leave an extra line at the bottom to allow for continuation notation. No type character should TOUCH those side margins. An addition-al problem most issues is that some editors are not taking the time to care-fully proofread what they type. If you feel a DX tip or a Forum report is worth typing, please consider whether it is also worth making certain it is typed correctly and legibly. When sending DX catches to your editor, it would help very much if you make certain of the spelling of the cities of license. It is a lot to ask of the editor to know how to spell every city name.

Tom Laskowski, 1334 East Miner Street, South Bend, Indiana 46617 Since the pages of EDXF have been looking kinda slim lately, I thought I'd help out by sending in a Forum. The 1980's, the decade in which I started serious MW DXing, came to an end here with my last log being KOKB-1580 OK, which was heard on Dec. 31, 1989. My first log of of the 80's was KDKA way back on March 11, 1981. And my first log of the 1990's was WBGZ-1570 IL on Jan. 3, 1990. My totals now stand at 1127 logged, of which 60 are call letter changes making my actual number of stations heard 1067. I'd like to make 1100 by the end of the DX season. My state total is now 43 with the addition of ultra-rare Delaware on Jan. 15 when I logged the WKEN DX test. I also tried for the Alaska test but no luck. I never made it to Rob Kramer's GTG on New Year's Eve because the roads were very icy. My alternator also went out so I couldn't drive anywhere. So I just stayed home and DXed. I noticed in a recent issue of Fine Tuning that CADX (Chicago Area DX Club) and MARE (Michigan Area Radio Enthusiasts) are going to hold a mini DX convention on Sat. March 31 in Kalamazoo, MI. I'm going to try my best to make it. I just purchased a new Icom IC-871A to use as my main MN DX rig. I like its performance so far, but I'm annoyed by a large amount of interference which is generated by the receiver's fluorescent display. This only occurs when I use a loop on MW. I've tried using coax as a lead in, and also dimming the display which helps somewhat, but I still have trouble digging out weak signals when using the loop. Any suggestions from Icom users would be appreciated.

Gerry Thomas, 3635 Chastian Way, Pensacola, Florida 32504 Hi again. The radio scene in Pensacola is changing pretty rapidly. Within the past three months, three AM stations have gone silent (WFXP-980, WBOP-1230, WECM-1490). WBOP returned after a week of silence as 980, WBOP-1230, WECM-1490). WBOP returned after a week of silence as WTKK (*Radio 1-2-3") and a format of some of the most obscure alternative music I've ever heard. It makes for interesting listening, if only in very small doses. On other matters, I was dismayed to learn of the tremendous price increases in ferrite rods from Amidon Associates in Calif. I talked at length with them and they are equally dismayed. The 7.5" x .5" rods that were selling for around \$3 each are now \$7; the 4-inchers jumped to \$5. They quit carrying altogether the 12" rods when they jumped from \$17.50 to \$90! Wow! What's going on? These prices are making it much more difficult to be an inveterate home tinkerer, hi. Finally, I happened to be DX'ing a couple of weeks ago at the time that a meteorite swept across southeastern skies. I didn't know about the meteorite at the time, of course, but did notice a rather abrupt onset of auroral-like cx with the almost instant loss of northerly stations in the early evening. Stations to the south started booming in and stayed that way for about two hours when cx returned to normal. I'm assuming a connection between the meteorite and those never-before-experienced cx but can't be sure. That's about it from here.

Karl J. Zuk, 154 Old Post Road North, Croton-on-Hudson, New York I am enjoying one of my few free evenings, so I thought I would sit down and tell everyone what I've been up to. I recently returned from a one week vacation in Eden, Utah. About an hour and a half from downtown Salt Lake City, it is a tiny little village in a valley surrounded by big mountains. I enjoyed skiing at several local resorts, and tried to DX as much as I could, but heard nothing unknown or spectacular due to the wonderful shielding properties of thousands of feet of rock. FM was even worse, turning off like a switch everytime you drove between mountains. Many of the FM stations there had numerous repeater transmitters, very confusing to even a dtermined listener. I saw the Mormon Tabernacle Choir perform for the CBS Radio Network on a Sunday morning, and had a nice two hour visit at the KSL Broadcast Center talking to everyone I could, and exchanging broadcast biz shop talk. A very beautiful station complex, and a format that is quite ambitious. They are trying to produce a very active magazine sound, like Good Morning America or The Today Show for radio. Very interesting listening. Two things are very exci-

ting to me about AM radio listening lately. The expansion of the band will give us a really unique chance to log all sorts of strange and amazing stuff in the coming months, and leading the way are the Medfer beacons that Steve McGreevey has introduced to our club. I have experimented with beacons on the bottom end of the band, with astounding results, and learned a wealth of information about the properties of RF at those frequencies. The key to good reception at the bottom of AM is a good ground, or being near water, like a lake or a river, or optimally an ocean. Ask George Hakiel and Mark Connelly! I DXed a Medfer beacon from Ontario several months ago. It's a great feeling of achievement to catch a flea-powered homebrew station. You know that both he and you are making a mutual handshake through the ether. You know how to optimize your reception, and he's learned how to transmit with great effi-ciency. I welcome the challenge, and will continue to comb that region of the dial. One other trick is to use a loading coil to increase the electrical length of your antenna, and/or use an active preselector/preamp to drag the weak ones in. Through my magazine writing, I am discovering that there are a lot of listeners out there who like to receive unusual AM stations, but don't have much interest in technical DXing at They don't understand propagation, and don't want to. They just listening. I guess they are much like shortwave listeners who are enjoy listening. spending time with their radios for pure entertainment value. All the techniques and equipment we are accustomed to can be pretty scary to the uninitiated. If you encounter someone like this, take the time to share your skills and enthusiasm. You'll gain a pleasing sense of good will, and make a new friend, too. Happy New Year to everyone, and good listening. KZ.
