- 1560 MEXICO, Cd. Juarez-XEJPV SM 1/28 0113 very good tonight w/Nortena mx and "Radio Alegria" slogans. They left their OC on through tonights WAGL test. (TRH-CA)
- 1580 MEXICO, Durango-XEE, Exc. and atop w/ romantic vocals w/"desde Durango, Durango XEE, Radio Hacil." Ment. program from 12-7 AM,so must be AN. New station? 0824 1/14. New XE #126. See DXWW-E in 12/9 DXM. Reported by Tom Jasinski. (CK-CO)

Well, I was going to ramble about MW antennas this time, but Glen Kippel's forum in the 20 January DXM was so thought-provoking I had to make some comments of my own. Glen wonders aloud whether, like the slide rule, IRCA is becoming "obsolete" as a MW-only club. Jeez, I'd hate to think so. His idea for incorporating ALL BC stations from 150 to 5050 kHz is an interesting one, but it bothers me too. MW propagation reception techniques, etc. are extremely complex, as Gordon Nelson proved back in the '60s and '70s, and still not completely understood. If a club like IRCA were to integrate coverage of other (namely HF) DX bands, could it still cover the AM band in anything like the depth it deserves? The main reason I joined a club at all was that you simply can't get in-depth info about MW elsewhere - not from the SWL clubs, and (God knows) not from the mass-market mags . I know Karl has been blo@dying his head against that brick wall for quite some time. And Glen, w@uldn't you agree that the techniques (if not the hardware) for DX above the MW band are at least somewhat different as well? I think RtH is correct in saying that newcomers to the MW hobby probably don't worry about the "congestion" as much as @ld timers - and those, like me, have been away from the band for a long time may find it congested, but then there are a heckuva lot more targets to shoot for too. Folks, don't sell medium wave short--despite the congestion and recent poor conditions. I believe it still has plenty of life. For me there's always been a great fascination about medium wave - how a dead band can suddenly fill up with signals at sunset. Yes, I know the lower HF bands do too, but it ain't the same - some part of the SW spectrum is always open with signals, no matter what time of day. Also, MW is unique in that really simple equipment can regularly bring in interesting catches. Yes, the same is true on SW, given sufficient skill, patience, etc., but SW still requires somewhat "

I had visions of the Goodie Factory having all kinds of reprints lying around, which might be offered as package deals to members, in return for a contribution to retire the debt. The price would be much more than enough to cover postage, but at least the contributing member would get something for his bucks. After talking to DEE on the phone a couple of nights ago, though, maybe this is not a good idea. It seems that the whole Goodie Factory is contained in one rather large cardboard box. It's all originals and very few extra copies are available. So anything sent out would have to be recopied, and copy costs would be added to the postage. Unless Don, Ralph or somebody can come up with more workable ideas for paying the debt, perhaps those of us who wish to see IRCA financially solvent again should just send our checks to Don, earmarked "Emergency Relief Fund" or somesuch. Regarding the proposals to contain reception material in the bulletin on stations up to 3000 kilohertz and beyond: the 3800-4000 band (75 meters) is pretty much a regular short-wave band, and anyone really interested in it should join a shortwave club. Below that are the so-called "tropical" bands (they allegedly suffer less from thunderstorm interference) where regular broadcast-type stations are more likely to occur, although only a handful of countries use these bands. One of the appeals of our hobby is that a beginner can get underway with rather ordinary equipment, then get more sophisticated as he progresses. The high-end stuff may appeal to some when conditions are poor. I doubt if it's worth much for bringing in new members, but it may help maintain interest for some who are already well underway. 73 and good DX in the 90's.

Steve Schreiter, 104 Brookdale Drive, South Milwaukee, Wisconsin 53172 One of the engineers at work gave me his copy of the "Automotive Electronics Journal* for 1/15/90 because it had info on the AM band. According to the article, GM & Ford do not forsee any major problems in accomodating the AM expansion from 1610 to 1700 kHz. Because their receivers are digital, only software and slight micro processor changes are required. In addition, the article states that the FCC will phase in band expansion and something called the NRSC (National Radio Systems Committee) standard over the next four years. A NRSC committee member is reported to have said that TIS stations on 1610 and 1620 kHz will be moved to 1700 kHz. The NRSC standard apparently involves audio processing at the broadcast level and is intended to reduce the interference commonly associated with the AM signal.
