Just the price ya gotta pay for having the fastest, most complete station info available to DXers anywhere...

New XE #169 (TRH-CA) MEXICO, Unid-SM 2/4 0715-0915 Spent two hours trying to ID the sta-640 tion u/KFI. Faded up a couple of times w/dance mx, possible live remote from a disco. Thought I hrd a couple of "Radio Fresnillo"
  IDs, suggesting XEYQ. After 0900 I hrd completely different programing which sounded more like a Cuban. Still need XEYQ. (TRH-CA)

  MEXICO, Unid 1/31 1337 Ad read by man, then possible mention of

- 920 MEXICO, Ensenada-XESDA Extensive monitoring in late January and early February yielded the following info: Schedule is 1400-0802 w/XE anthem at s/on and s/off. Full ID at s/on and s/off, unlikely to ID more than once during the day. Power is 2.5 KW (although I suspect the night power is 250 watts or less). Address sounded like Avenida Juarez 529, Ensenada, B.C. Mentioned that they serve listeners on the Tijuana-Ensenada Highway. Best chance for WC DXers to hear this one is at 1400 s/on, when they come on w/2.5 KW and give a full ID. All other XE stations on 920 s/on at 1200 or 1300 and usually faded out by this time. 




