Bulletin Formatting Lots of letters received from members who do not like the way the bulletin is put together, particularly the continuation of a section on several pages. Given the fact that bulletins are produced in increments of 4 pages (1 sheet, both sides), and the number of pages of material held over has been less than 2 almost always (and often less than a full page), the choice is to get as much into the 12- or 16-page bulletin as possible, or to take the remaining 2/3 to 1 1/2 pages of material and combine it with hundreds of lines of HQ filler material, pay an extra \$21 printing, and run another sheet. Even if this had been done on a couple of occasions, the following bulletin would have lacked enough to fill even 12 pages. It can be easily understood that those who have never had to make these critical editing and financial decisions would dislike the hopscotching of a section through the bulletin and would complain but your editor is dismayed that several who would seem to be in a position to understand are so critical. It has been suggested that the sections be run in order with one section starting at the bottom of the last one even if that means a masthead at the very bottom of a page then the section starting the next page. If the membership really wants that, I've no qualms, but I doubt it would improve appearance. The club is in the progress of deciding whether to reintroduce newspaper clippings as a means of filling up space. Since the club's major unpaid debt is to Phil Bytheway, it will be left up to Phil to make the judgment on what best serves the interest of the club. From Bill Hardy, Almanac Project Coordinator - Feb. 19, 1990

Over the weekend, I spoke with Phil Bytheway to determine the status of

the Almanac as it nears completion.

95% of the Almanac typing is complete. The only major exception is the U.S. Broadcasting Updater. It is on computer but needs to be formatted to two columns per page and then pasted up accordingly. This should take place very soon. One other section which is being re-typed is Rich Toebe's slogans list. He will have it completely revised about the time you read this, enabling us to have an extremely up-to-date slogan list, and since his work overlaps with Phil's and mine, it won't delay publication at all.

In order to allow Phil to concentrate on the Broadcasting Updater, Nancy and I are taking over responsibility for paste-up of the rest of the This should allow the majority of the pages to be printed in March, and everything else should be printed in April. DX Monitor will no longer be weekly at that time, so collating and mailing the Almanac should be complete in April or May. Those of you who have ordered an Almanac will be receiving it very soon. Thanks for your patience!

There are many clubs which address tropicals rather extensively and to compete with them would be difficult. AM coverage is best served by clubs like IRCA. That's where the experience lies. I hope you all enjoyed my (very) informal radio survey a few issues back. As for antennas in looking through the loggings columns it seems that directional loops are the favorite by a narrow margin, with large air-core types (box/spiral/wedge/altazimuth/Sanserino, etc.) running even with the various ferrite loops (homebrew/R. West/Palomar/Selec-a-Tenna/Hagen etc.) Right behind loops are non-Beverage wires; there are also quite a few Beverage installations (would that we all had that much room)). And a lot of folks use portables, home stereos, car rx, etc. with no external antenna. Maybe I should ask HQ about creating a formal rx/ant survey in DXM, for IRCAns to fill out and mail back. Whad ya think? (Considering the results of a previous survey - 10% of members responding, but I like the idea-RtH.) A few other tidbits of interest: I can appreciate RtH's desire for a good tube rx - I've always dreamed of having a '180 or SP-600. . .but I have 2 problems with them: 1) availability of tubes/parts; and 2) I fear used radios are like used cars - too often aren't you just buying someone else's problems? Pat Martin's 10 February forum about band conditions in the late '20s was certainly food for thought. (I think you mean Gene Martin, Randy-RtH.) 22 Los Angeles stations? These days I'm thrilled to hear KNX! Speaking of 50 kw'ers, a few weeks ago WGN 720's evening talk show featured the two owners of Jazz Record Mart in Chicago, who discussed and played rare records from the late '40s beloop era (Parker, Gillespie, Monk, etc). . . a superb example of what commercial AM radio can do in terms of interesting programming. The most recent issue of the trade journal Radio World has a front-page feature about RF-emitting lightbulbs (Flourescents/sodium/mercury vapor etc) and the harmful RFI they cause to MW. Seems that utilities nationwide are encouraging their customers to use this "energy-efficient" lighting. . . they also say the available literature on the subject tens to downplay or ignore the RFI problem. And (this should come as no surprise) the FCC studied the problem for four years without making a decision, citing a lack of concrete "information" or "evidence" that RFI is a significant problem. . . UNBELIEVABLE! Broadcasters and DX'ers, who could certainly tell 'em a thing or two or three about RFI need to launch a serious campaign to encourage the FCC to review their RFI standards. . .or perhaps amplitude modulation should be abandoned altogether (I think "Noise-Free Radio" is one of the best ideas I've heard in a long time.) By the way, I'm not the only person around here who's bullish on AM radio. My boss, KSMU manager Dr. Arlen Diamond, was one of the folks who testified at that FCC hearing on AM radio back in November. More later. 73 from the Ozarks.
