We've been a Standard Broadcast Band club since the beginning, but with changes in conditions especially, DX isn't what it used to be. The tips to the Worldwide colums are generally small these days. Maybe we should look further in expanding the coverage. I've had suggestions all the way from including 120, 90 and 60 meters SW to all the international FM bands (from 66 mHz to 108 mHz). NRC has recently included regular FM in their summer bulletins when MW DX is slow. Much of the tropical bands (up to about 5 mHz) have similar qualities to MW and a lot of MW DX'ers do use those bands for //'s. I also know of several IRCAns that regularly DX those frequencies. Even I tune them from time to time when MW conditions are poor. I don't know where the membership wants to go on this, but with poorer conditions for the past several years and fewer people reporting, we do need something. Our problems now aren't money and we're mostly out of that situation, but for the club to grow we really need reporters. The DXWW columns have been better the past few months, mainly because of a few DX'ers that have been sending in regular contributions. I do get quite a few notes from people that say, "Sorry, haven't heard anything," so maybe the expanding to the tropical bands, FM or whatever is a good idea. DX Australia and the New Zealand Radio DX League have always had half of their bulletins on SW and other half MW. It sure hasn't hurt them! They're both thriving clubs with a lot of reporters. If MW is poor, the SW section is larger and vice-versa. So come on, let's hear more comments on this. This is your club and now is the time to turn this around. Good DX. 73 de Patrick.

Well, I thought that I might start a bit of controversy when I made my modest proposal to broaden the frequency coverage of IRCA. I was thinking of it as just a marketing decision. The world's best selling cookie, Oreo, recently released fudge-covered Oreos (awesome) and the #1 snack chip, Doritos, came out with "cool ranch" flavor (OK). They refused to sit back fat and happy at being #1 and sought out to develop new markets. It's not a criticism of the original product, but a fact of life that the top compa-

niwa are in constant change (they call it "renewal"). I think if we offer a product that's virtually unchanged since 1964 (or 1934), especially if there's static or declining membership and minimal participation in the columns, then perhaps we need to examine our marketing strategy. When we talk about the "broadcast band," the term goes back to the '30s when just above 1500 kHz was the police band. The when FM broadcasting began, we had the "standard broadcast band" and "FM band." Now FM is the standard and AM is becoming something of an anachronism. Even calling 510 to 1630 kHz the "AM band" is inaccurate, as all broadcasting is AM up to 54 MHz. In response to those who have forumed about the differences in listening techniques between MW and the 120/90/41/60-meter tropical bands, may I recommend the Kippel E-Z DX Technique - 1) Plug in the receiver, 2) Turn it on, 3) Tune around to see what you can hear and, 4) Write it down. I read with interest Steve Schreiter's EDXF (17 February) regarding the auto makers (GM & Ford) ability to accommodate the expansion of AM band on digital radios. Most likely this refers to future radios. Naturally, having a digital radio in my truck, my first question is whether present radios can be adjusted to accommodate the band expansion or does this mean (most likely) \$\$\$ to have the radios replaced? Does anyone have further information on this subject? Any technical experts out there have any comments? Except for a log of FEN 1575 Sasebo, no recent DX. I received a letter from Bill Harms who is back in S. Korea. He inquired about a NHK outlet on 531. Strangely, the outlet appears to be a relay located in the northern part of the island versus south as I had originally suspected: strength up north is good and only fair down south (also, WRTH-90 lists a NHK-1 relay in Nago which is in the northern part of Okinawa). And, this brings up a point. Okinawa is located in the Ryukyu Islands (an archipela go) which is spread out over a wide area. Consequently, like the Canadian LPRT system, it appears there are numerous radio and TV relays located on some of the larger islands situated outside of the normal pattern of the main transmitters. This was something I recall from my last tour of duty on Okinawa '76-'79. But then, as now, I have no knowledge of a source which might list such relays. . .besides, I sort of doubt there would be many logs of such stations, hi. Still, if anyone happens to "visit" Okinawa in the future, you might want to keep this in mind if you come across unlisted stations (most will probably be NHK relays). Finally, when I leave here this coming August or September, I'll be heading back East: Camp Lejeune, NC for a 3-year tour and retirement from the Navy. All for now. Very 73 and best of DX de Mike.

IRCA Finances

There is a lot of misunderstanding about IRCA's financial condition and it is very difficult to present the matter in a way that is both accurate and understandable to all. There are three levels of financial status. first is accounts payable (debts which are due now). IRCA has recently paid the Seattle printer IN FULL. We still owe Phil Bytheway for money loaned to the club for postage and earlier payments to the printer. We also owe for all postage used on the first 25 issues from Riverside; all of it loaned to the club at this time. The second is operating expenses. IRCA treasury contains ample money to pay the weekly expenses for printing and mailing the bulletin and we continue to move ahead financially as we publish small bulletins. The approximate money in the treasury as of 3/1/90 is \$2500, part of which is earmarked for advance orders for the 5th edition of the IRCA Almanac and for the postage mentioned above. level is net worth. This is the value of the clubs assets (supplies, publications, cash on hand) minus all liabilities (money owed to repay both loans, the cost of producing the Almanac for those who have paid, and the full cost of deferred memberships, the money paid by the members for bulletins still due). It is this third level at which IRCA has and will continue to have a negative balance for, possibly, many years. During Dec. & Jan., hundreds of dollars were earmarked as donations by members to help with the debt. A full list by name and amount will appear in DXM. SUMMARY, IRCA is in no financial danger in even the worst scenario and conceivably could be completely out of debt in a few years. The club can now turn its attention to increasing the size of the bulletin (we are budgeted for 6 sheets per issue) and the number of active, participating members. To those members who have paid their renewal during Nov/Dec and early January, your checks should have cleared by now. Because the club pays a per deposit fee, checks are not deposited weekly and because your S-T had severe time constraints late Nov/early Dec, the deposit slid until late Jan.
