The WIBV calls are no longer on the air in the St. Louis market. The calls have been on 1260 in Belleville, IL since the station came on the air. To compliment the Radio Disney format, the calls have been changed to WSDZ. Radio Disney has already claimed its main competition in the St. Louis market. WFUN-FM 95.5 has been sold to Baltimore-based Radio One, which own a chain of R&B stations, mainly on the East Coast and in the Midwest. The sale, as of this writing, is pending FCC approval. Plans are to drop the locally-originated Pre-Teen format. Since the R&B market is pretty much saturated in the St. Louis market, the new format will not be revealed until the sale closes. The sale may yet affect me, since I will be at the station, currently known as "Fun Radio", during its transition. KXEN-1010 Festus/ St. Louis has finally gone full-time. The station, which has held the CP for 500 watts at night since the mid-1980s, is airing Spanish programming after 1700 local (1800 ELT). hours have expanded to 0600-2400 local (0700-0100 ELT). They still remain brokered Christian programming during daylight hours, but that could change. This is the same KXEN a DXer tried to buy in 1989-90. The local tabloid, The Riverfront Times, along with sister publication St. Louis magazine, has named KZJZ-1380 as "The Best New Radio Station in St. Louis", in a recent readers' poll. The station pulled the plug on its free-form talk format last July in favor of a Jazz format. KMOX-1120 will likely name John Carney to succeed Jim White in the late night time slot when White retires in April 1999. If you don't recognize the name, maybe you should...John Carney's father, Jack Carney, held down the midday post at the same station during the 1970s and early '80s. KTRS-550 has inked former NFL star (and ABC-TV Monday Night Football commentator) Dan Dierdorf for its morning show. Dierdorf replaces Bill Wilkerson, who has retired. KTRS has also fired Kevin Horrigan because

of apparent differences with owner Tim Dorsey. Also gone from "The Big 550" is Dr. Laura Schlessinger, due to a change in the method of compensation provided by affiliates for the airing of her program. Kevin Slaten moves from evenings to early afternoons until further notice. WGNU-920 has picked up "Sports By-Line" (they link the satellite, located at the transmitter site, to the studio via standard phone line). And finally, look for a new occupant on 1510 in Highland, IL soon...WCBW may be bringing back a Contemporary Christian format, which it had before it was evicted from 104.9 by KMJM. The previous occupant of 1510 (WINU) is now on 880. 73 and good DX in 1999 from Eric (NOUIH).
