Pat Martin of Seaside, OR. sends along the following from Bart Cronin of Seattle, WA.:

Call letter changed noted: Seattle's 50-kw stepchild on 1090 is IDing as KYCW-AM, ex-KMPS-AM for the past several weeks, ex-KRPM since 9/95 after it swapped frequencies with 770 (now KNWX). In 3-95 the calls were changed from KINF to KNWX. KINF was used for only several months. Prior was KING-AM from 1948. Is running "Classic Country." KYCW-FM still being used on a sister station which has dropped country for Hits of the '80s and now known as "The Point." The FM calls are also to be changed to KQPT or something like that. By the way, KYCW-AM and KNWX share towers on Maury Island (attached by a causeway with Vashon Island in Puget Sound).

Ye editor passes along the following:

High-tech Silicon Valley workers will soon be able to turn off the soft rock and tune in to software news on their car radios. Technology news and information company CNET Inc. and radio broadcaster AMFM Inc. announced Tuesday (01/04/00-ed.) they will join forces to create CNET Radio, the country's first all-tech radio format. It will be launched this month in San Francisco on AMFM's KNEW AM station, and the companies plan to develop the new format in the San Francisco Bay area, with plans to roll it out nationally by the end of 2000. Broadcasting from CNET's San Francisco studios, CNET will produce daily tech-focused news radio programming, from the start of the morning drive to the end of the evening commute. CNET Radio will draw on CNET's extensive experience producing technolog, news and information online and on television. CNET Radio will have a companion Web site at www.cnetradio.com <http://www.cnetradio.com>, which will feature live streaming audio of CNET Radio broadcasts, as well as information on CNET Radio programming and talent, useful Web links, and other resources for the listener community.

``AMFM, CNET and KNEW are early movers in bringing a full day of relevant, important technology news to radio listeners enabling them to better understand the opportunities presented by new technology and the new economy,'' said Brent Osborne, General Manager of KNEW.

`With the addition of radio to our leading online and television properties, CNET is emerging as the prototypical media company of the 21st century -- a dynamic merging of mediums with the Internet at its core,'' said Halsey Minor, chairman and chief executive officer of CNET. The AMFM Radio Group has more than 440 stations in 100 markets and reaches a weekly listener base of approximately 64 million people.

Pat Martin sends along the following from Frank Aden of Boise, Idaho: KTIK (1340-Nampa, ID. - ed.) has been running announcements that they are going to 1350 00:00 MST Jan 1.

Additional info on this subject forwarded by Pat from Allan Dunn (location unknown):

Looks like (KTIK's day and night power-ed.) 5000W day non-directional and 600W night into a four tower array.

And Pat forwards even more information along from Bill Frahm of Boise, ID on this subject:

Their (KTIK-ed.) engineer claims night-time power to be 900 watts with last change in CP. The FCC database is wrong?! I'll check on that. It seems the towers were placed as specified in the first application for CP (two 1/2 wave towers & two 1/4 wave towers). The application for CP was modified to one half wave tower & three 1/4 wave towers with the towers in slightly different locations. So the last modification to the CP corrected the tower placement & changed the parameters.

Pat sends along further info on this subject from Frank Aden:

KTIK switched to 1350 at 00:00 MST 01/01/00, they did it right in middle of a commercial. No special annoucements were made. I did tape it. (I also heard them here in San Jose, they mix with KSRO Santa Rosa, CA. nights-ed.)

Rich Toebe of Davis, CA. (I listed him as Fairfield, CA. in last column, my mistake!!! -ed.) sends along the following (info also forwarded on by Pat Martin):

KUYL (1280-Stockton, CA. -ed.) did go oldies this week. They still use the KUYL calls and are now "Cool 12-80". They are live; DJ gives

lots of local references (or they've done a great job fooling me into thinking they're local, hi).

Jim Hilliker of Pacific Grove, CA. passes along the following:
Our CE tells me that 1460-AM (KTXX Salinas, CA. -ed.) should go on
the air for the first time with regular programming this coming Monday,
1/3/2000 at 1:00 p.m.!

That's tentatively the time it should begin broadcasting, if everything goes according to schedule.

The 1460 signal will be sportstalk that had been on 1380, and KTOM-AM 1380 will start at that time with its new classic country format from Jones.

And Jim sends along further information on this subject:

Looks like 1460 in Salinas, CA (KTXX-ed.) made it on the air today (1/3/00-ed.), as scheduled! It is now broadcasting the One-On-One sports talk format formerly heard on KTOM-1380, as 1380 now has the Classic Country format, which began today.

1460 will likely changel to an all talk or news-talk format later this year.

Rich Toebe passes along the following information:

1480 (KRHT-ed.) in Concord (CA.-ed.) has been silent for several months now.

When they were on, I could hear them day or night; driving around, I figured out that their puny transmitter had to be near Buchanan Field. I could hear them out to Fairfield during the day; at night they were easily overwhelmed by various stations. They were not listed in the local phone directory. I wonder if they'll ever come back; it was my understanding that they were eligible for an X-band slot, but had trouble finding a transmitter site. Running the NOAA broadcasts was apparently to keep their license alive.

Floyd Perry of Stockton, CA. sends along the following:

What is happening at KFRE-940 (Fresno, CA. -ed.) ? Most of their programming is now at KMPH-107.5 and KTRB-860. And KFRE is currently silent right now (1/1/00-ed.). (Not anymore, they're now Radio Unicaed.)

Pat Martin sends along the following from Alan Dugan (location unknown):
Crawford Broadcasting has reinstated the old WPTR Call letters at
1540 (Albany, NY. -ed.) !!!! The new format, which will be standards, is
also on their 96.7 frequency.

At least for now you can get Pop Standards a night!

Mike Brooker of Toronto, ON., passes along the following:

Infinity Broadcasting is one of several competing applications for CBL's vacated 740 frequency. Proposed format is multi-ethnic. This is a new station, not a frequency move of an existing ethnic format such as CIAO-530 or CHKT-1430. Their main argument is that Toronto's non-official language communities need a 50 Kw clear channel outlet, because some ethnic programs are even being farmed out to WTOR-770 in Youngstown NY. Dennis Gibson of Goleta, CA. passes on the following information:

KFRE (940 Fresno, CA. -ed.) appears to have gone SS with Radio Unica.

What a surprise, although KMJ has been beating up on them bigtime ratings-wise ever since they went news/talk. Take a look at their web

site http://www.kfre.com ; I can't figure out if some or all of their programming is going to KTRB/KMPH-FM. I can't hear KTRB here. Nice signal; that makes two 50 KW'ers, the other being KBLA.

Pete Taylor of Tacoma, WA. passes along the following information: KJR-950 is installing its new 50kw XR at the co-owned KHHO site near Port of Tacoma Road in Tacoma. Two towers have been added (there are now six) and they plan on testing it starting in mid-January. Look for some down time and a possible change in signal strength. They will have a fat northerly lobe (which means I'll be getting about 100kw in my face). They would have installed it at their present site but couldn't do a proof because of buildings, cranes etc. in the area. KHHO-850 is simultaneously installing a new XR. It should be stronger (the old one was operating at about 65%) and louder (new, KJR-like audio processing). They will eventually split programming with KHHO carrying a different sports format.

Meanwhile, at Salem Communications, Construction of KAZJ-1680 facilities has not yet begun (the CE says they will probably have a sports format and apply for KSEA). Likewise, nothing's happening with the KKOL-1300 power increase due to landlord and/or permit delays. And finally, KAYO-920 is still off (as of 1/1); phone calls there as to what's happening have never netted much information and my 12/30 call was no exception.

Gary Jackson of Sacramento, CA. sends along information that confirms earlier information presented on the switch of KFRE-940 Fresno, CA. to Radio Unica".

Well, it has been a long time so maybe a brief intro is called for. I am married with three kids (one of each, hi) and was a pretty regular contributor to the DX hobby (in one form or another) from 1978 until a couple of years ago. I started Radio Plus+ in the mid-eighties and have sold hundreds of Quantum Loops and other DX devices to fellow hobbyists since then. I also am a scientist for the Navy doing research in aerospace medicine, a job I had hoped to retire from last year but will probably continue for another three years. My main MW DX interests center around foreign DX but I also visit the utilities on SW from time to time. I also like the technical side of the hobby and enjoy designing, building, and testing DX-relevant circuits and talking shop with like-minded folks. The reason I have been out of touch the last

season or two has been due to a combination of factors. Working two jobs for 17-18 years had me slowly heading toward burn-out which was hastened by a head injury in a car accident. The lingering effects of the injury made it difficult to work my mortgage-paying job with the Navy, much less the nights and weekends needed for Radio Plus+. In the past few months I have started feeling a bit more "with it" so I have returned to the radio hobby and a limited "second job" schedule. I have made a limited number of Quantum Loops and have geared up for at least two new DX devices: the often-delayed Quantum Phaser (awaiting circuit boards) and a 15-inch version of the Quantum Loop that also covers LW. As I have returned to making loops, I am being reminded of the frustrations that drove me batty to begin with... finding reliable suppliers of usable parts (e.g., the first shipment of MOSFETs for the loops had an elevated noise floor... try returning a batch of electronic parts some time!). Anyway, if you have requested info on R+ products in the past months or are interested in any of them, we should have some product sheets ready around the first of the year. As far as actual DXing goes, after trying to log WI for years, I never thought that it would become a pest but WKSH-1640 pretty much owns the frequency (except for WJ Y-Dallas/Ft. Worth Airport and some Louisiana Dept of ??? station). DXing the expanded band is a real treat and must be what it was like DXing back in the 1920's. There is even some decent programming on... try the music at night on KCJJ-1630. Well, that is about it from here for now. I can be reached at email radioplus@gulf.net but my ISP is sometimes squirrelly (last summer I went almost four months without email then my ISP sent over 600 emails at once!).73's... GT
