CPC RESULTS & INFO

Here's the results of the most recent DX test that have been received here:

WVNE-760, Worcester, MA tested Monday, January 17, 2000 from 4:00-5:00 am EST:

Bill Dvorak of Madison, WI picked up WVNE's test with weak to moderate Morse code sets heard through WJR, and Steve Francis of Alcoa, TN heard several periods of slow, high-pitched code IDs that were weak but clear under WJR, but Mark Herson in West Orange, NJ was unable to hear the test, mainly due to splatter from local WABC-770 and some QRM from WJR. Tom Dimeo(K3DOL) in Harrisburg, PA says he heard the Morse code quite well most of the hour, but the voice announcements were a little difficult to hear, and the WVNE signal faded alot, though when it faded up it was much stronger than WJR and a Cuban station on the frequency. John J. Reiger in South Milwaukee, WI reports he tentatively heard WVNE with an "EBS-like" code on the minute at :04, :07, :09, and :10, with a poor to weak signal under a weak WJR. Along those lines, TJ(KE9VMO) tried for the test and reports he heard something that sounded like a Star Trek sound effect and wonders if that was the test, as he'd never listened for a DX test before. I can't really say, as I have a local on 770 here in Lafayette, LA, that splattered all over 760!

Frank Aden(N7SOK) in Boise, ID reports he tried for this test, but heard nothing under KTLK(Thornton, CO) that sounded like a DX test. However, Tim Noonan in Madison, WI heard the test with code IDs, and reports that WJR was unusually weak. Bill Harms in Elkridge, MD monitored this test and was on IRC channel #MWDX during the test - he sent in some reports about conditions on 760 before the test (R. Reloj looked good and WJR was fading up) and heard Morse code IDs from the test numerous times and voice IDs three times. He mentions that the Morse IDs were well received a couple of times. Philip Greenspan in Marshfield, MA reports he heard the test as well and sent a copy of his reception report. He says WVNE is a daytime local for him, but at night WJR usually takes over. Gordon

Bell near Troy, NY, also heard the test, with some CW IDs, and mentioned some of the station facts that were read by the announcer (Lincoln Hubbard) during the test. Barry McLarnon(VE3JF) in Ottawa, ON, says he taped the test and got a clear and steady signal over a semi-nulled WJR - some Morse IDs as well as station announcements. However, Shawn Axelrod in Winnepeg, MB was unable to hear the test but says he did hear WJR easily. Neil Kazaross reports the he heard a whole string of code IDs loud and clear from WVNE, while Tom Jasinski of Shorewood, IL says he heard the code IDs weakly under WJR. Blake Lawrence in San Francisco, CA, didn't hear WVNE due to a strong KFMB (San Diego, CA)

Humm...all these reports of WJR being weaker than usual...well, at Mr. Hubbard's request, I *did* ask WJR a couple of times if they might drop or lower their power just for the time during the test, but I never got a clear answer...y'think? Nahh...

That's all for now...

The International Radio Club Of America Convention will be held August 25, 26, and 27, 2000 in Billings, Montana. Your convention hosts will be John and Nancy Johnson. A registration form will appear in IRCA's "DX Monitor" soon. Non-IRCA members may register by mail providing your name and names of those attending, mailing address, days you plan on being in Billings, and confirmation that you have made reservations at the Quality Inn. The advance registration fee will be \$35.00 which includes the Saturday night buffet. Please make out your registration fee check to "John C. Johnson" and send it to John and Nancy's home address, 265 Waterton Way, Billings, MT 59102-7755 by July 31, 2000.

The convention will be held at the Homestead Quality Inn located at 2036 Overland Avenue in Billings. This is just off I-90 on Billings' west end. Take Exit 446 and follow King Avenue West to Overland Avenue. A map is available on the internet, or wr ite to John or Nancy. This is the same location as the 1993 IRCA convention. Their phone number is 406-652-1320. You may call their national 800 number at 800-228-5151 for reservations, but please make sure you mention the Billings Homestead Quality Inn and the "2000 IRCA Convention" for the special rates. Our special rates are \$55.00 for singles, \$72.00 for doubles, or \$59.00 for their twin suites. Cut off date for special rates is July 15, 2000. Jim Hilliker of Pacific Grove, CA. passes on the following:

Looks like KOQI-1200, licensed to Soquel, CA, has been on the air testing with continuous music since around 8 or 9 p.m. last night (1/11/00-ed.), according to my chief engineer at KTOM/KTXX, who is friends with the CE who built this station. The station was very strong driving home from Salinas to Monterey this morning.

They are 25,000 watts non-directional from one tower today, but NO STATION ID'S HAVE BEEN HEARD SINCE I'VE BEEN MONITORING THEM THIS MORNING!! (Boo!)

Night-time power is listed as 10kw from a 4-tower pattern....They are diplexing off the tower site that KIEZ-540 uses, southeast of the Salinas, CA airport.

The engineer has some CD machines hooked up and a hodge-podge of music has been heard, mostly old-country (Patsy Cline, Bobby Bare, Floyd Kramer instrumentals, etc.) has been heard along with modern country, big band/jazz, Spanish/Ranchera, and some operatic style recordings that sound like they were recorded in the 1920s or '30s. There's also lots of dead air between the cuts, but so far no IDs or legal IDs on the hour or close to the hour.

The engineer who owns this, Wayne Woolard, was the old KDON-AM CE and has worked for other stations around here. He's been anxious to get this on the air and sell it to a prospective buyer.

Don't know how long it will stay on today or if it will be on tonight and/or tomorrow. So far, I don't even know what the address for veries is or will be, but I'll try to find out.

Jim sends along additional information about KOQI-1200:

I have just found out today (1/15/00-ed.) that KOQI-1200 is testing on a 30-day test of its 10kw nighttime pattern!

So, it's been on 10kw DA pattern day and night and has not been at 25 kw ND yet!!

Meanwhile, the owner is still trying to find a buyer.

Also, I heard from a friend at my job (KOCN/KTOM, etc.) that the owner, Wayne Woolard, told my friend the FCC rule allows him to only do a legal ID while testing once every 2 hours...So, he has it on a timer and its supposed to ID every 2 hours...Rich has heard this, but I haven't yet! (I have heard ID's every 2 hours -ye ed.)

Jim Hilliker also passes on the following re KTXX-1460 Salinas, CA.:

I thought you might find this a little bit interesting....I was noticing this week that even here where I live in town, 1460 didn't sound all that "loud" or strong for 10,000 watts....My friend at KOCN/Clear Channel-Monterey gave me this answer today regarding this question. Mike and Wayne he refers to are the two engineers on the project.

Right now KTXX is only modulating between 50%60% - has something to do with some internal xmtr adj. that Mike and Wayne need to make. As soon as that's done (by the end of this week, I hope) we should have normal mod (100-125) and that should make a big difference vis a vis signal strength & loudness. (I've noticed a distinct increase in their signal here in San Jose! - ye ed.)

Curtis McMenamin of Fairfield, CA. passes on the following:

KXTO-1550 Reno may be silent.

Pat Martin of Seaside, OR. passes on the following from Nigel Pimblett of Medicine Hat, AB.:

This week the FM replacement for CKTA officially came on the air. They are on 93.3 MHz with legal call of CHHK, but the only IDs given are "93.3 The Hawk". The AM outlet on 1570 is now simulcasting the FM, and is scheduled to do so for 4 months. So, this will be the last DX season to catch CKTA. With CJCY going last year, and CKTA in 2000, southern Alberta is becoming an excellent area for DXing, as the locals are getting pretty scarce!

Dennis Gibson of Goleta, CA. passes on the following:

Today (1/19/00-ed.) the CRTC approved the move of CJOC-1220 Lethbridge AB tp FM (106.7 MHz, 100 kW):

The format of the station will change from country to AC.

CJOC was the first station in the Lethbridge market, having gone on the air in 1926, and will be the last AM in the market, CKTA-1570 having recently gone to FM (but they will also still be on AM for the next couple of months, log them now if you need them). In fact there will be no AM stations within 140 km (90 miles) of Lethbridge, the closest being graveyarder CIBQ-1340 Brooks. Calgary is about 120 miles away, and the transmitter for CHRB-1140 High River is actually almost in Calgary. The only other stations south of Calgary are CHAT-1270 Medicine Hat and the graveyarder at Blairmore. Looks like Lethbridge might be a choice DX location!

Dennis Gibson of Santa Maria, CA. sends along the following:

Daytime conditions to the north are quite good today (1/19/00-ed.). At noon on the car radio, KOQI has a quite good signal, good enough that I can hear the AC hum (that shouldn't be there) during quiet parts of songs. In comparison, KSCO (which is 10 KW ND days) is about the same or perhaps a little weaker; the same goes for KTOM (5 KW directional maily to the southwest). Still nothing on 1100 besides a weak KFAX.


