I noted KBLI-1620 in Blackfoot, ID very strong with a talk show and ID at 2300 EDT last night 8/23. On the hour the announcer IDed for affiliates KICN and KECN only, then SRN News. I suspect it might have been running 10 kw. (Ye editor also noticed them with strong signal in San Jose on 8/28, and in Billings, MT. during IRCA convention 8/27).

Pat Martin of Seaside, OR. passes on the following:

1500 kHz - CKAY-BC, Duncan, not a peep out of station all night 8/28. The audio had been distorted the past few days, so maybe they are gone.

Pat sends along the following from Eric Bueneman of St. Louis, MO.:
One of the last major market AM Oldies stations is about to go off
the air. All Access Radio (an industry Web site,
www.allaccessradio.com) is reporting that WWSW-970 Pittsburgh, PA is
dropping it's Oldies format, simulcast for over a decade with WWSW-FM
94.5, in favor of an all-sports format. The question is; Will the
Steel City support two all-sports stations? WWSW-970's new format
will directly compete with WEAE-1250.

Pat also sends along the following:

1660 KQWB ND, West Fargo, now on the air with NOS format, and IDs as "Star 16-60" not 15-50 as I first thought in listening back to the tape. They also ID as "KQWB-West Fargo on the hour, in CNN News  $(9/4/00-ye\ ed.)$ 

Larry Godwin of Missoula, MT. sends along the following addendum to

above:

I heard a new X-bander today September 4 at 0800 EDT: KQJD-1660-West Fargo, ND. I heard an ID for "Your Memories Station, KQWB-West Fargo" during a nostalgia music program, then CNN News. [KQWB is on 1550.] Miraculously KXOL-UT was running open carrier only at this time. I didn't hear an ID for KQJD but I believe this is the correct call.

Pat sends along the following addendum from Shawn Axelrod of Winnipeg, MB.:

Just finished listening to 1660 again.

1660 is playing adult standards music. Non ID's now as Star 16-60. NO sign of KQWB on 1550 at all. On the hour ID was "KQWB AM West Fargo is your memory station. It's time for CNN news on Star 16-60." They may be KQWB not KQJD as per FCC listing.

Pat also sends along the following:

1670 WNEG 268 CA, SACRAMENTO, rec. new TIS tonight, per phone call from Gary Jackson (Sacramento, CA.-ye ed.). Thanks Gary. Gave info on Watt Avenue Construction project and gave web site as <www.wattave.org>. Signal quite good at times, noted at 2330 EDT 9/1. Mentioned Sept 1st s/on in message. Some QRM from another TIS as times.

Pat sends along the following:

I heard an OC on 1500 AN last night (8/29/00-ye ed.) about 89. It was strongest off the Northern Beverage. I wonder if CKAY (Duncan, BC.-1500 - ye ed.) still has an OC, though the OC was much weaker than the old CKAY.

A DXer from Victoria does not hear any OC (from CKAY-1500-ye ed.), so I wonder if it is that TIS up North.

Pat sends along following from Jeff Multer of Fort Mill, SC .:

Noted change of calls (WTRU-830 NC.-ye ed.) from WXII in recent DXN issue. When I tuned in for the news on the way home this afternoon, I noted that the station has switched to religious talk and information programming.

Pat sends along the following info from Russ Edmunds of Blue Bell, PA.:

The info below is from various Internet sources, all attributed. It should be of some interest, and in some cases represents potential Log Update info.

The following from the DC Radio/TV Guide online:

"WKDV, 1460 AM in Manassas, was back to its relay of traditional country WKCW, 1420 AM in Warrenton, on Saturday afternoon 8/26. WKDV had dropped the WKCW relay (which has been taking place all summer) on Friday, 8/25, and replaced it with mainly musical Asian programming (either Korean or Chinese). That ethnic programming continued again on Saturday morning, but the KCW relay was back on 1460 that afternoon. DCRTV hears that the Asian programming was brokered, and when time on 1460 is not sold the station will revert to relaying WKCW. WKDV was purchased by Multicultural Broadcasting in the early summer along with Arlington's WZHF, 1390 AM, (which has a separate Chinese talk/music format) and WKCW, a long-time country station."

"A published rumor that Mega Communications, the Silver Spring-based owner of mainly Spanish language radio stations mainly in the northeast, including the DC area's WKDL, WBZS-FM/AM, WPLC, and WKDM, is on the verge of being purchased by an Anglo concern is being flatly denied by Mega officials. Inside Radio, a radio industry publication, speculated on 8/15 that Mega was up for sale. However,

Mega chief Alfredo Alonso tells DCRTV that there is absolutely no truth to the rumor. The 8/16 New York Post says that "Mega is shopping its 20 stations for \$50 million after vainly trying cost-cutting and refinancing. Spanish programming, according to Inside Radio, isn't generating enough revenue to keep Mega in the black".."

"Mega Communications has changed the calls on 92.7 FM (formerly WMJS) in Prince Frederick MD to WBZS-FM and plans to start simulcasting the Spanish dance/urban format from Alexandria's 730 (WBZS-AM) on 92.7 by late August or early September, Mega head Alfredo Alonso tells DCRTV on 8/14. The new transmitter site for 92.7 is in Sunderland MD, about 10 miles closer to DC than the previous MJS transmitter was. Alonso says that the recent bout of stormy weather has delayed work on the new transmitter site. Originally, he hoped to start his second area Spanish FMer earlier this summer (Mega's first area FMer, WPLC 94.3 in Warrenton VA, started broadcasting in early July). Alonso also confirms that 1600 AM in Rockville is now WKDM. The former WNNY calls have been moved to Mega's new Spanish all-news NYC station (formerly WKDM); more about that station in the 8/14 NY Daily News. Alonso adds that Mega has made no decision about the future of 1600 - it may continue to broadcast Radio Unica, it may become a simulcast of 92.7, or Mega might sell it.."

From the Jersey Shore Radio Guide ( online ):
"1510 WNNN-Salem, NJ has shifted to a Gospel format as "Faith
1510"."

time, and the audio needed some work. They were usually on through
the early afternoon, followed by hours of open carrier. I could hear
KOA through the OC. Then they started putting KXTA back on until it
was full time again. The audio problem when the music was on appeared
to be that some levels somewhere needed to be turned down a little
bit. The frequency response was decent. I am acquainted with the
Director of Engineering for Clear Channel Santa Barbara; maybe he
knows.

Before he went to work for them, he was CE of the FM station (KDB-93.7) where the ham repeater I used to be affiliated with is. Its antenna was on their tower. He told me if I was ever uncomfortable working on our antenna with KDB pumping out its full 12.5 kW (4.9 kW into a 5 bay antenna) ERP, to power down the transmitter to whatever level made me comfortable (he showed me how), then to call the station, tell the board op I was dropping power with his authorization and that the power might be down for a few hours, and then power back up to full power when I was done. I was shocked that he would let me do this, and it was his idea. I never did have to do it. But he must have trusted me to make such an offer. If I can contact him, maybe he'll know what's up with 850, which puts a respectable day signal up here for only 500 watts and about 60 miles away. Its day pattern is almost all to the southwest, and I am to the northwest.

# \*\*\* COMMENTS \*\*\*

September brought two good non-solo DX sessions within a week. I'd arranged to meet Kent Winrich (K9EZ) of Wisconsin while he was

in the Boston area on a business trip. On Tuesday 12 SEP, he met me out at Granite Pier in Rockport, MA for a sunset-period after-work mini-DXpedition. We enjoyed hearing numerous loud signals from southwestern Europe and northern Africa. Some of these were pushing S9+30 or better, like Morocco-612 that was totally "smoking" WGIR-NH / CHNC-PQ on adjacent 610. Kent said he'd be happy to hear even one Trans-Atlantic at his midwestern home QTH. I referred him to master foreign DXer Neil Kazaross of metro-Chicago for suggested stations and times. I know that some of the big boomers like Norway-1314 and Saudi Arabia-1521 have made it out there occasionally. Obviously you don't get Bast Coast results there on TA's, but he might hear a few of them. In other DX, he'd have at least a prayer of a chance of hearing something Trans-Pacific. I don't think a TP has been logged in New England in at least 15 years (when Ray Moore got a few Aussie X-banders before US stations started to proliferate above 1600). One thing I mentioned to Kent was that he might want to look for a lakeside site in northern MI, WI, or MN and run a Beverage due north to look for Trans-Polar Russians, Indians, etc. If he could bag some of this DX on a good night, it just might breathe life into midwesterners' conceptions about foreign MW DXing in their part of the world. Maybe Trans-Polar would be something at which they could have more success than DXers along the Atlantic and Pacific shores of North America (where loud transoceanic signals tend to cover up any weaker Trans-Polar stations on the same 9 kHz frequency spacing plan). As we wrapped up the DX session around 9 p.m. local, Kent said he had fun and that he was interested in getting a phasing unit and trying some different antennas back home.

On Saturday 16 SEP, I had a nice visit with Vern Brownell (W1VB) in Chatham, MA. Two weeks earlier I'd gone out to his excellent seaside QTH and I did a consult on a DX-worthy antenna system that would help combat local electrical noise. This time around I brought the materials for the antenna and set it up. The main element is a oneturn square loop, approximately 7 feet / 2.14 m per side. This is mounted vertically and aimed for maximum pick-up on an east-west axis. The wire is supported on a wooden frame with cement blocks to keep it from blowing away during high winds. The loop feeds a 1:1 balun whose other turn goes to the coaxial cable which runs back to the "ham shack" room of the house. Inside the house, the coaxial cable goes to the input of a broadband amplifier with about 17 dB of gain. The amplifier's output feeds channel 1 of a DXP-2 phasing unit. Channel 2 of the phasing unit is connected to Vern's multiband trap vertical (40 m - 6 m ham bands). Eventually a second loop will be installed at a right angle to the first one. That would be fed to phaser Channel 2 instead of the whip; this should reduce electrical noise to an even greater extent than the present set-up. At 2125 UTC, with the sun still well above the horizon, Saudi-1521 and other MW Trans-Atlantics were audible on my Drake R8A as soon as we were done setting up the antenna system. The next 2 hours brought in some huge signals from the Mediterranean area before conditions gradually deteriorated. Loggings are in the report above. A highlight was hearing English and French news (including Italian Olympic team results) from Italy-846. The signal was very strong: there didn't seem to be any reduction in power from any other time I'd heard this. Vern now has both a location and an antenna system that should bring him a lot of good DX. I encouraged him to join the National Radio Club since that's where most of the MW DXing talent in the eastern USA and Canada may be found. \*\*\*\*\*\*\*\*\*\*\*\*




